

## **PRIVACY POLICY**

Alameenpost.com (“the Website”) is owned and operated by Alameen Media Inc. described in this Privacy Policy as (the "Company", "we", "our", "us", “Alameen”, “Alameenpost.com”). This Privacy Policy sets out the Company's policies relating to the collection and use of your Personal Information while you use this Website.

Alameen is strongly committed to protect your privacy. This statement discloses the information gathering process and the privacy and dissemination practices for this website.

Alameen has created this privacy policy in order to demonstrate our firm commitment to protect your personal privacy.

We have adopted the following practices in order to safeguard the confidentiality of your personal information to the best of our ability.

We undertake to comply with the terms of our Privacy Policy which is located on the Website.

### **User / Member Information we collect and use of information**

Alameenpost.com is a general audience web site targeting the Sunni Muslim community.

We do not knowingly collect information on users or register children under 14 years of age. If you believe that we might have any information from or about a child under 14, please contact our Privacy Administrator.

Any Children Between the Ages of 14 and 18 is recommend that they seek their parents approval for permission before sending any information about themselves to anyone over the Internet.

The information that is collected by Alameenpost.com is: (a) data(Information). submitted by users and (b) data(Information) automatically tracked while users are online. This can be either private information or public information.

#### **Private information**

At certain occasions when we are selling certain products or services we would require Private information that can personally identify you such as your real name, email address or credit card number. When you use such service, you will be asked for some general identifying information to enable us to provide you with this customized service. We gather contact information (such as your , Name, address, email address, age, etc) and, if you choose to sign up for a Full Membership or to purchase goods and services, financial information (such as your credit card number and expiry date, address, phone number etc.).

Financial information is gathered and processed through our own secure server or it could be from any third party billing site, and encrypted via a secure server to ensure that others cannot read it. The secure site has a bold Icon about confirming the security of the site. You can click on the Icon to confirm the site security. We will only use your financial information in the course of providing our Services to you. The specific financial information we collect is not rented, sold, or shared with any third party, except to the financial institution that processes your transaction or where required by law.

With our on-site offers we will let you choose to share information with marketers or electronic commerce providers.

### **Public Information**

To provide a better interactive online experience on our websites, users are required to provide certain information for the registration process namely:- a) your name, b) email address, c) sex, d) date of birth, e) username, f) password g)education h)income and / or your occupation, interests, and the like. (All required information as supplied by the users enables us to improve our site and provide you the most user-friendly experience)

Information such as your email address, your IP address, navigational information such as your search patterns and wish lists, and your purchase information are collected as a part of site operation.

Other information such as the type of browser used, the referring URL, the IP address, the number and type of pages viewed, the date and time of visits, the exit URL..Etc. is also collected.

This information helps us personalize the website for you. On occasion, we may ask you to participate in a survey and your participation is completely voluntary. However, complete registration is necessary if you want to enjoy all of the site's features and benefits.

When you visit alameen, you may set up your personal profile, build relationships, send messages, perform searches and queries, form groups, set up events, add comments, classifieds etc, email and transmit information. We collect this information so that we can provide you a better interactive online experience.

Some Public information will be available for registered members to view. This includes your demographic information such as name, user name, gender, age, appearance or Photo, occupation, and geographical location or any other public information that you wish to disclose on your profile.

User information may be used by The Alameenpost.com for several purposes including direct marketing. You will receive information about new products, site features etc. If you would like to be removed from the mailing list, please contact our privacy administrator.

You will receive email from our administrative staff about significant changes in the website, design, or the way in which we operate, apart from emails about your account, your profile, or recent transactions on the site.

User information, including personal information, may be disclosed as part of any merger, sale of company assets or acquisition, as well as in the unlikely event of an insolvency or bankruptcy, in which User information would be transferred as one of the business assets of the company.

User information, including personal information may be disclosed if required to do so by law, or in the good faith belief that such action is reasonably necessary to comply with legal process, respond to claims, or protect the rights, property or safety of our company, vendors, employees, Users, or the public.

### **Editing your personal information**

We keep the information you have given us for as long as you are a member on the site. You can always verify or request the removal of the personally identifiable information we have collected. and change your registration information by visiting the appropriate subsection of "Edit Profile" To make changes to your profile, suspend your account, or remove your account completely, you may do so at any time by hiding the profile from "Profile options" page. Once the profile is hidden, you will no longer be an active member on our site and will not receive any electronic communication from other users and no members can view your profile information. However Alameen reserves the right to send you notices about your account even if you opt out of all voluntary email notifications.

### **Destruction of Information**

We will take reasonable steps to destroy or permanently de-identify Personal Information if it is no longer needed for any Purpose, in a secure manner.

### **Costs**

We reserve the right to charge you for providing access to your Personal Information as well as destruction of your personal information. The fees and charges will not be excessive, and will be determined by us from time to time and we shall notify you of those costs prior to providing you with access to the Information. We may require those costs to be paid prior to providing you the service.

### **Correction of Information**

If you establish that the Information we hold about you is not accurate, incomplete or not up to date we shall take reasonable steps to correct the Information so that it is accurate, complete and up to date. If we are not satisfied that the Information is not accurate, complete or up to date we shall, at your request, keep with your Personal Information a statement noting your claim that the Information is not accurate, complete or up to date.

### **Refusal to Correct**

If at any time we refuse or deny access to Information to you or refuse to correct Personal Information we shall provide you with reasons for such denial or refusal.

### **Termination of membership by us**

We may immediately terminate your membership and your access to the Service at any time if we determine (in our absolute discretion) that you have breached this Agreement. Notice of termination will be delivered to the last email address you provide to us. Any pre-paid fees relevant to the period following termination will be refunded to you after deducting any costs incurred or loss suffered by the Company in connection with your membership.

### **Request of Termination of membership by You**

You may terminate your membership at any time, for any reason, effective immediately upon our receipt of your written notice of termination. Notice of termination may be delivered to the address contained in the Contact Us section of the Website, may be emailed to the email address listed in the Contact Us section of the Website, or may be effected by clicking on the Switch Off Membership link in the members' section of the Website. Complete Termination may take upto 21 days to process after receiving your request.

## **COMMUNICATION**

The Company reserves the right to send electronic mail to you regarding changes or additions to the Service, or any products and services of the Company and its affiliated businesses.

### **Consent to communicate**

By registering with us, you specifically agree to receive communications from us, or through us, to the email address that you provide, including but not limited to: notifications of emails and instant messages you receive from other members on the site, relevant photos and profiles, updates regarding our service, special promotions and offers, and notices of changes to the site. Our site provides you with the opportunity to opt-out of receiving some types of communications from us by contacting our Privacy administrator. If you do not opt-out of receiving such notices, they will be sent to you automatically, at our discretion.

### **Monitoring online activity**

Our members may communicate with each other through our instant online interactive sessions, instant messages, email, voice mail and onsite mail, etc. While we do not generally censor or monitor any messages/comments posted online or members' private exchanges, we reserve the right to do so if we suspect users of being under 14 years or of using our Services in violation of our terms of use, Privacy Statement or disclosure agreement. Member submissions that appear on the public area of the site are moderated and, if necessary, we reserve the right to edit, delete, remove or not use any communication on a public area of the site.

## **Disclosure of Personal Information**

Alameen reserves the right to disclose any information in response to / that it is required to be shared, disclosed or make made available to any governmental, administrative, regulatory or judicial authority under any law or regulation applicable to Alameen.

Further, Alameen can (and you authorize Alameen to) disclose your name, street address, city, state, zip code, country, phone number, email, and company name to Intellectual Property right's owners, as we in our sole discretion believe necessary or appropriate in connection with an investigation of fraud, intellectual property infringement, piracy, or other unlawful activity.

## **Cookies**

To improve the responsiveness of the sites for our users, we may use "cookies", or similar electronic tools to collect information. Cookies are used identify traffic that comes through advertising and to improve user experience.

Cookies are small pieces of information that a website places on your PC's hard drive to enable the website to recognize you and to save you the trouble of re-entering some basic information when you revisit. Our web servers automatically collect limited information about your computer's connection to the Internet, including your IP address, when you visit our site.
