In May of 2022, we received ABP Investments' request for an Impact Analysis regarding the potential funeral home/mortuary/crematorium on the property at 7261 Washington St., Denver, CO 80229.

The primary purpose of a school district impact analysis is to determine whether or not the District has the ability and infrastructure to absorb any potential increase in student enrollment, and whether or not the development will have any impact on school district operations, such as transportation of students. The proposed development appears to be commercial/light industrial and likely poses negligible impact to our operations.

However, Mapleton Public Schools also works closely with families and community partners on efforts to ensure our part of the metro area is as safe, healthy, and supportive of student development as possible. To that end, we pay close attention to potentially helpful or harmful effects any proposed development may have on student learning.

With that said, it has come to our attention that there are currently at least **three** other crematoriums within a few blocks of 7261 Washington Street: Kramer Family Funeral & Cremation Center, Stork-Bullock Family Mortuary, as well as Colorado Mortuary Services. The students and families of Welby lack many services commonly available in other neighborhoods, but they do not lack access to a crematorium. Many other services would better meet the needs of the neighborhood.

Further, significant information is available online regarding the harmful air pollutants generated by corpse cremation. We strongly encourage Adams County to seek input from the Health Department and/or other experts to determine if a fourth crematorium within such a small footprint is safe for the the students and families living in our school district.
