Nils Hoffmann, Managing Director of Possible and former Managing Director of PUBLIC Germany, explains the new name: "The belief in successful digitalisation in the public sector has almost been lost - both in public perception and in the administration itself. With Possible, we are starting to restore this belief. If we want to set a new pace in Germany, we need a comprehensive, strategic and product-orientated approach to digital transformation. Possible inspires and empowers its customers to do just that."

Possible's services are aimed both at the public sector itself and at private-sector companies that want to work with the public sector. The team of administrative experts, strategy consultants, tech enthusiasts and researchers offers a wide range of services, from strategy development for innovation and transformation topics in the public sector ecosystem to the implementation of individual measures such as accelerator programmes and start-up challenges.

The partnership enables us to operate independently and still utilise the advantages of a partner like PwC, including an established network and an extensive pool of experts.
