**ANNOUNCEMENT**

**AGM AND EGM TO BE HELD ON 25 APRIL 2024**

1. **Date, time and place of Annual General Meeting (“AGM”) and Extraordinary General Meeting (“EGM”).** StarHub Ltd (the “Company” or “StarHub”) is pleased to announce that StarHub’s AGM will be held, in a wholly physical format, at Level 3, Nicoll 1, Suntec Singapore Convention & Exhibition Centre, 1 Raffles Boulevard, Suntec City, Singapore 039593 (“Suntec”) on 25 April 2024 at 10.00 a.m. The Company’s EGM will be held, in a wholly physical format, at Suntec on 25 April 2024 at 10.30 a.m. (or as soon thereafter following the conclusion or adjournment of the AGM). **There will be no option for shareholders to participate virtually.**

The Company’s Board Chairman, Mr Olivier Lim Tse Ghow, will preside as Chairman of the AGM and EGM, and together with its Group Chief Executive Officer and Executive Director, Mr Nikhil Oommen Jacob Eapen, will conduct the proceedings of the AGM and EGM.

2. **Notice of AGM and proxy form.** The Notice of AGM and accompanying proxy form will be sent to shareholders, and published on SGXNet at the URL <https://sgx.com/securities/company-announcements> and the Company’s Investor Relations (“IR”) website at the URL <https://ir.starhub.com/AGM-EGM>.
3. **Notice of EGM and proxy form.** The Notice of EGM and accompanying proxy form will be sent to shareholders, and published on SGXNet at the URL <https://sgx.com/securities/company-announcements> and the Company’s IR website at the URL <https://ir.starhub.com/AGM-EGM>.
4. **Arrangements for participation at the AGM and EGM.** Shareholders, including CPF and SRS investors, may participate at the AGM and/or EGM by:
  - (a) attending the AGM and/or EGM in person;
  - (b) submitting questions to the Chairman of the AGM and Chairman of the EGM in advance of, or at, the AGM and/or EGM respectively; and/or
  - (c) voting at the AGM and/or EGM (i) themselves; or (ii) through duly appointed proxies<sup>1</sup>.

Details of the steps for registration, submission of questions and voting at the AGM and EGM by shareholders, including CPF and SRS investors, are set out in the Appendix to this announcement.

In particular, CPF and SRS investors who wish to request their Agent Banks or SRS Operators to appoint the Chairman of the AGM and/or Chairman of the EGM as their proxy in respect of the StarHub shares held by such Agent Banks or SRS Operators on their behalf should approach their respective Agent Banks or SRS Operators to submit their votes by **5.00 p.m. on 17 April 2024**.

5. **Persons who hold shares through relevant intermediaries.** Persons who hold StarHub shares through relevant intermediaries (as defined in section 181 of the Companies Act 1967),

other than CPF and SRS investors, and who wish to participate in the AGM and/or EGM by:

- (a) attending the AGM and/or EGM in person;
- (b) submitting questions to the Chairman of the AGM and Chairman of the EGM in advance of, or at, the AGM and/or EGM respectively; and/or
- (c) voting at the AGM and/or EGM (i) themselves; or (ii) by appointing the Chairman of the AGM and/or Chairman of the EGM as proxy in respect of the StarHub shares held by such relevant intermediary on their behalf,

should contact the relevant intermediary through which they hold such shares as soon as possible in order for the necessary arrangements to be made for their participation in the AGM and/or EGM.

6. **Annual Report 2023 and Circular.** The Annual Report 2023 and the Circular to Shareholders dated 3 April 2024 (in relation to the proposed renewal of the share purchase mandate, the proposed renewal of the shareholders' mandate for interested person transactions, the proposed adoption of the StarHub Performance Share Plan 2024 and the proposed adoption of the StarHub Restricted Stock Plan 2024) have been published on the Company's IR website, and may be accessed as follows:

7. **Record and payment dates for final dividend.** Subject to the approval of shareholders for the final dividend at the AGM to be held on 25 April 2024, the Register of Members and Share Transfer Books of the Company will be closed on 2 May 2024. Duly completed transfers in respect of ordinary shares of the Company together with all relevant documents of title received by the Company's Share Registrar, Boardroom Corporate & Advisory Services Pte. Ltd., 1 Harbourfront Avenue, Keppel Bay Tower #14-07, Singapore 098632 up to the close of business at 5.00 p.m. on 30 April 2024 will be registered to determine shareholders' entitlements to the final dividend. Subject as aforesaid, shareholders whose securities accounts with The Central Depository (Pte) Limited are credited with ordinary shares of the Company as at 5.00 p.m. on 30 April 2024 will be entitled to the final dividend. The final dividend, if so approved by shareholders, will be paid on 16 May 2024.

Shareholders, including CPF and SRS investors, can attend the AGM and/or EGM in person, submit questions in advance of, or at, the AGM and/or EGM and/or vote at the AGM and/or EGM by themselves or through duly appointed proxies<sup>2</sup>.

To do so, they will need to complete the following steps:

3.	<b>Asking questions at the AGM and EGM</b>	<b>Asking substantial and relevant questions at the AGM and EGM.</b> Shareholders, including CPF and SRS investors, and (where applicable) duly appointed proxies can ask the Chairman of the Meeting substantial and relevant questions related to the resolutions to be tabled for approval at the AGM and/or EGM, at the AGM and/or EGM itself.
4.	<b>Addressing of questions</b>	<p><b>Addressing questions in advance of the AGM and EGM.</b> The Company will address all substantial and relevant questions (which are related to the resolutions to be tabled for approval at the AGM and/or EGM) received from shareholders by 10.00 a.m. on 11 April 2024 by publishing their responses to such questions on the Company’s IR website and on SGXNet by 10.00 a.m. on 18 April 2024. <b>Where substantially similar questions are received, such questions will be consolidated and consequently not all questions may be individually addressed.</b></p> <p><b>Addressing questions during the AGM and EGM.</b> The Company will address any subsequent clarifications sought, or substantial and relevant follow-up questions (which are related to the resolutions to be tabled for approval at the AGM and/or EGM) received after the submission deadline of 10.00 a.m. on 11 April 2024 which have not already been addressed in the Company’s responses published on the Company’s IR website and on SGXNet, as well as those substantial and relevant questions received during the AGM and EGM, either within a reasonable timeframe before the AGM and EGM or at the AGM and EGM itself, as applicable. <b>Where substantially similar questions are received, such questions will be consolidated and consequently not all questions may be individually addressed.</b></p> <p><b>Minutes of AGM and EGM.</b> The Company will publish the minutes of the AGM and EGM on its IR website and on SGXNet, and the minutes will include the responses to substantial and relevant questions from shareholders which are addressed during the AGM and EGM respectively.</p>

5.	<b>Voting at the AGM and EGM</b>	<p><b>Shareholders, including CPF and SRS investors, can vote at the AGM and EGM themselves or through duly appointed proxies<sup>3</sup>.</b> Shareholders who wish to appoint proxies must submit an instrument appointing proxies in accordance with the instructions on the proxy form.</p> <p><b>Voting at the AGM and EGM.</b> Upon registration at the AGM and EGM venue, shareholders, including CPF and SRS investors, and (where applicable) duly appointed proxies, will be provided with a handheld device for electronic voting at the physical meeting.</p>
