#### **Current Appropriations Clause in Bill**

The bill includes an appropriation clause that provides \$50,604 General Fund to the Behavioral Health Administration within the Department of Human Services. The provision also states that the appropriation is based on the assumption that the Administration will require an additional 0.3 FTE.

The Joint Budget Committee has proposed a budget package for FY 2024-25 based on the March

2024 Office of State Planning and Budgeting (OSPB) revenue forecast. The budget package includes \$63.1 million in set-asides for legislation outside of the package (see table below). The budget package accounts for the 15.0 percent reserve associated with the placeholders (a total of \$9.5 million).
