MLB: Cubs combine for no-hitter

Shota Imanaga and two relievers combined on a no-hitter, leading the Cubs over the Pirates 12-0 in Chicago. Imanaga (12-3), a 31-year-old left-hander in his first season with the Cubs after pitching in Japan for eight seasons, struck out seven and walked two over seven innings.

Nate Pearson pitched a 1-2-3 eighth inning and **Porter Hodge** a perfect ninth in the 18th no-hitter in Cubs history, and the first since **Zach Davies**, **Ryan Tepera**, **Andrew Chafin** and **Craig Kimbrel** combined to hold Los Angeles hitless at Dodger Stadium on June 24, 2021.

● In Toronto, **Kyle Schwarber** matched a major league record with his 13th leadoff home run this season. **Kody Clemens** and **JT Realmuto** also went deep and the Phillies beat the Blue Jays 4-2 for a two-game series sweep.

● In Baltimore, **Jonathan Cannon** pitched into the sixth inning and the White Sox homered three times, snapping their 12-game losing streak with an 8-1 victory over the Orioles.

● In Atlanta, **Jarred Kelenic** hit a three-run home run and the Braves continued their mastery of the Rockies with a 5-2 victory. The Braves are now 16-3 against Colorado since the start of the 2022 season.

● In San Francisco, **Zac Gallen** pitched six hitless innings for his 50th career victory and the Diamondbacks held on to beat the Giants 6-4.

● In Cleveland, **Tommy Pham** hit his first home run for Kansas City, a tie-breaking, three-run drive in a four-run fourth inning, and the Royals stopped a season-high, seven-game losing streak with a 4-1 win over the Guardians.

● **Yoshinobu Yamamoto** will return to the Dodgers rotation on Tuesday and start against the Cubs after missing nearly three months with a right arm injury.

NFL: Pearsall shooter arraigned

A 17-year-old high school senior charged with attempted murder in the daytime weekend shooting of 49ers rookie receiver **Ricky Pearsall** was arraigned in juvenile court Wednesday and said through his attorney that he was sorry for what happened.

San Francisco District Attorney **Brooke Jenkins** added several gun-related charges and said her office has not decided whether try the juvenile as an adult.

● Broncos cornerback **Patrick Surtain II** signed a four-year contract extension worth \$96 million with \$77.5 million guaranteed on Wednesday to become the highest-paid defensive back in the NFL.

● Sao Paulo state's government said it will deploy hundreds of police officers and provide escorts for team buses for Friday's NFL game between the Eagles and the Packers after some players expressed concern about playing in Brazil.

● Titans wide receiver **DeAndre Hopkins** participated in practice on Wednesday, marking a positive step in his recovery from a knee injury sustained in late July. Hopkins could play in the season opener Sunday against the Bears.

● A circuit court judge in Florida has dismissed a lawsuit two women filed against former NFL kicker **Brandon McManus** and the Jaguars that accused McManus of sexually assaulting them on the team's overseas flight to London in 2023.
