SOCCER: Gotham FC wins

Esther Gonzalez opened the scoring for Gotham FC with a third-minute goal and the visitors never looked back in a 4-0 victory over LD Alajuelense in the opening group game of the CONCACAF W Champions Cup in Alajuela, Costa Rica.

Katie Stengel and Jenna Nighswonger each scored in the first half and Delanie Sheehan finished the scoring for Gotham FC with a goal in the 54th minute.

MLB: Tigers defeat Padres

Parker Meadows hit a grand slam off reliever Robert Suarez with two outs in the top of the ninth inning to help the Tigers rally for a 4-3 victory over the Padres in San Diego.

Reigning NL Cy Young Award winner Blake Snell was removed after a 42-pitch first inning, and San Francisco rallied at home to beat the Diamondbacks, 3-2, on Thursday behind a walk-off double in the ninth from Patrick Bailey, who drove in all three Giants runs.

In Cincinnati, Ty France homered in the seventh inning as part of a series sweep in which he went 9-for-11, and the Reds beat Houston, 1-0, for their ninth straight win over the Astros.

In Oakland, Calif., Raleigh hit a two-run homer in the first inning and added a sacrifice fly in the fifth, Julio Rodriguez also connected, and the Mariners beat the Athletics, 6-4, in their final scheduled visit to the Coliseum.

Steelers quarterback Russell Wilson is dealing with calf tightness again, putting his status for Sunday's opener at Atlanta in question.

Coach Mike Tomlin said Wilson was limited in practice Thursday. The 35-year-old spent a significant portion of training camp dealing with a calf injury. Tomlin said the tweak Wilson felt Thursday was in the same calf.
