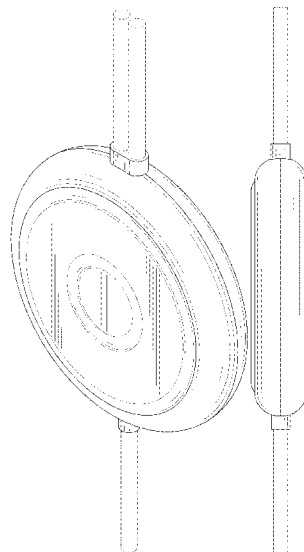
The ornamental design for a lighting controller, as shown and described.

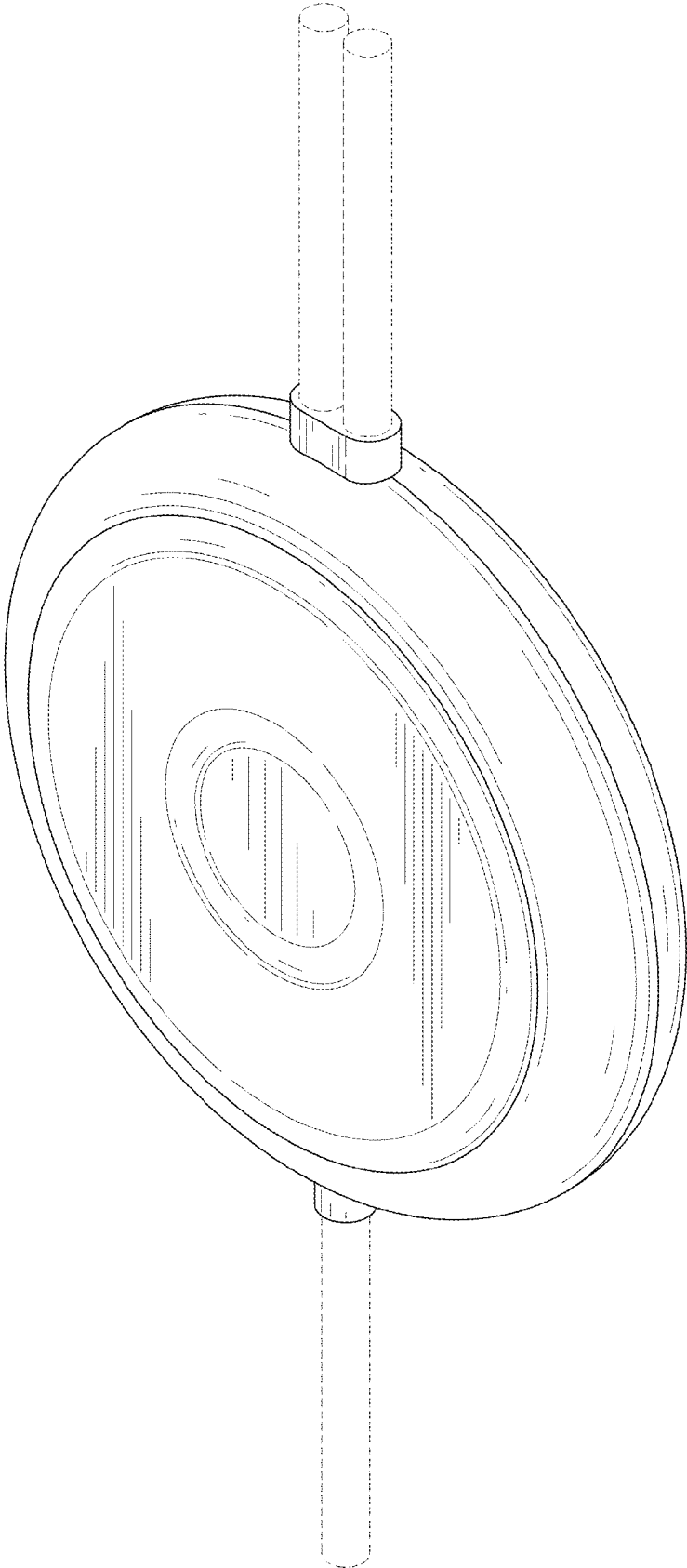

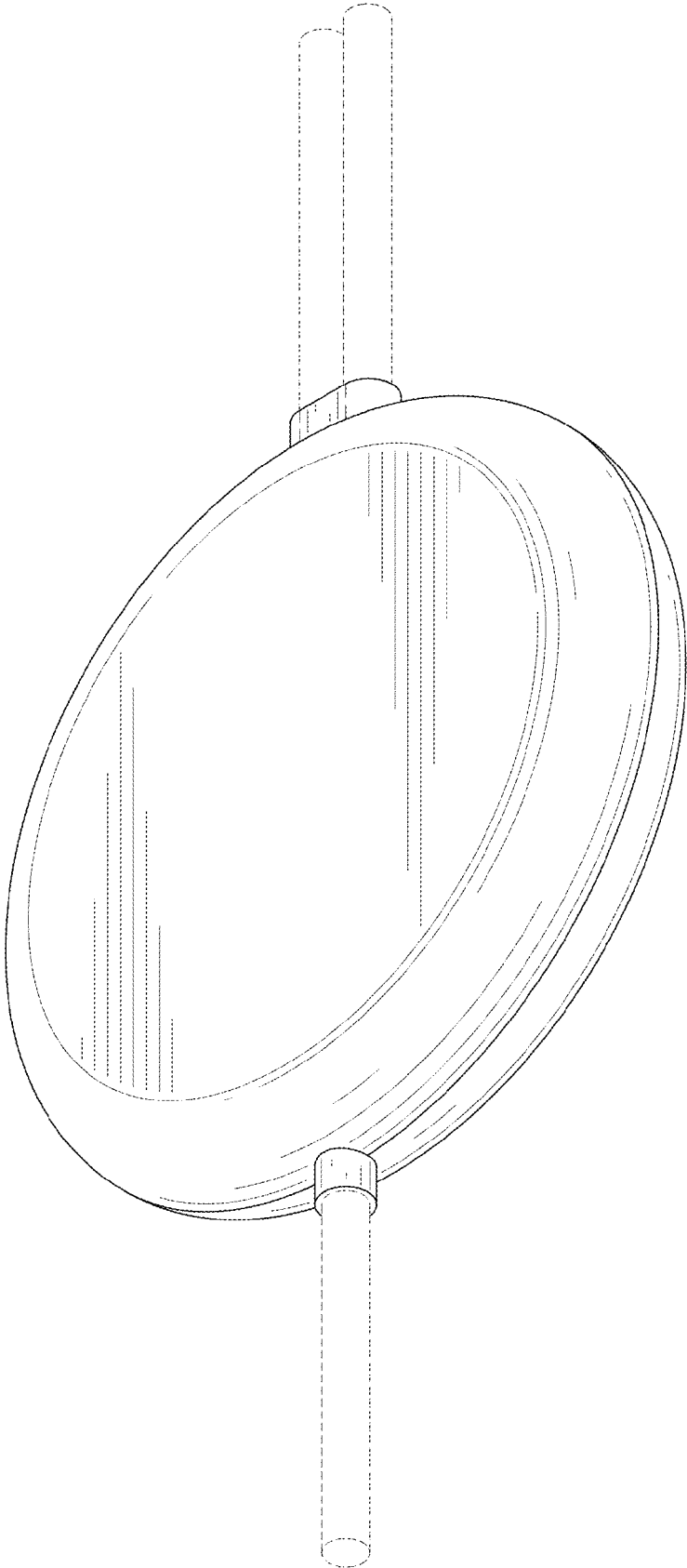

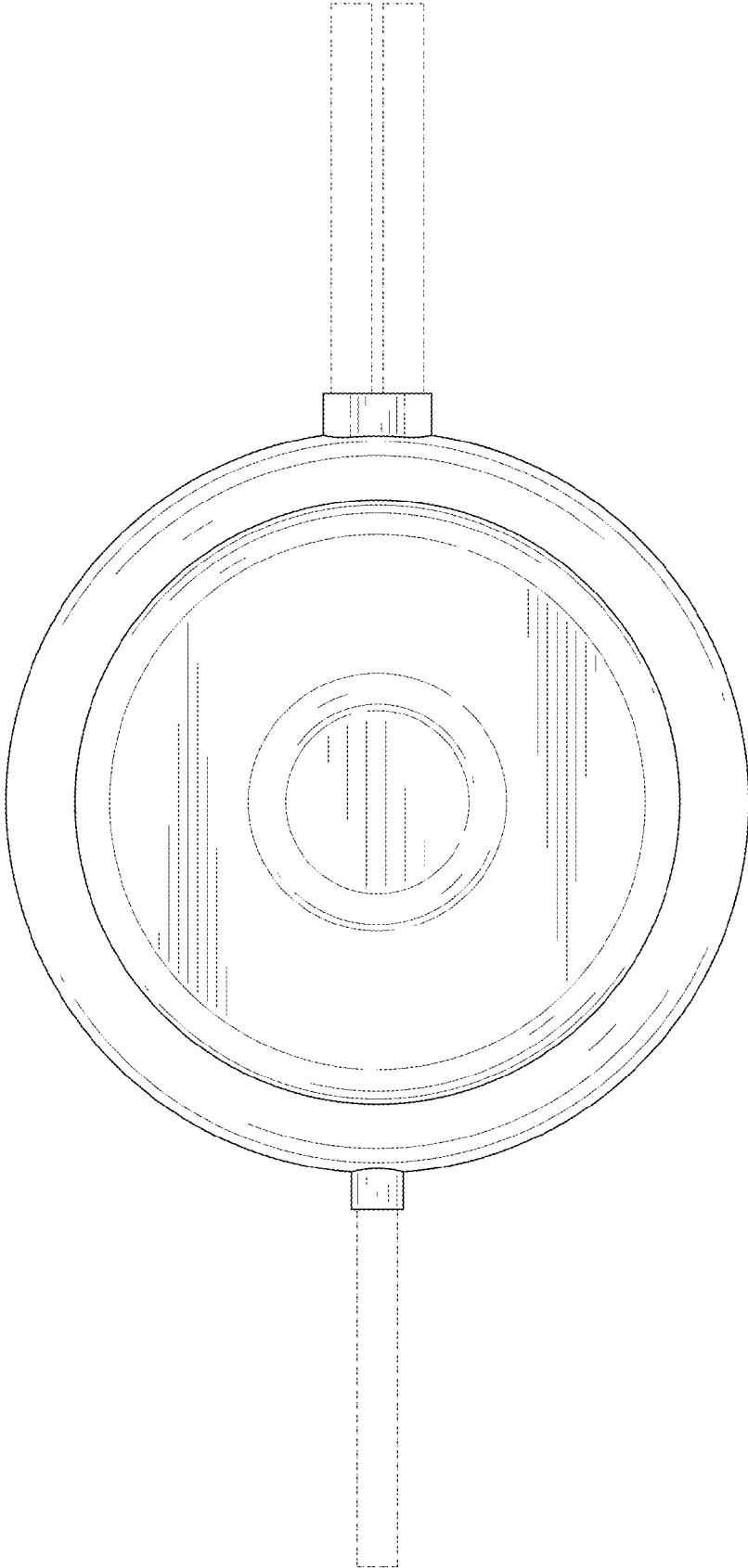

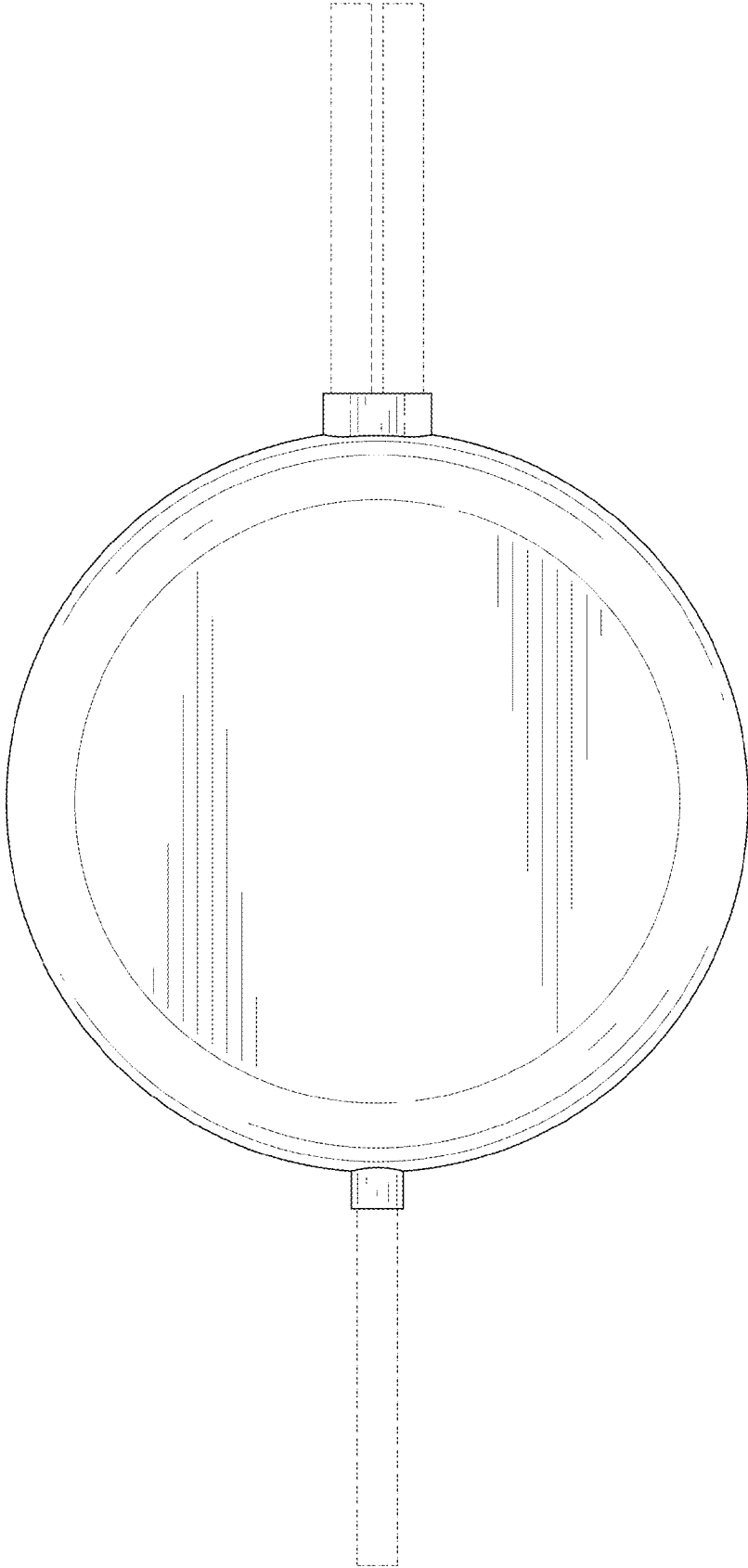

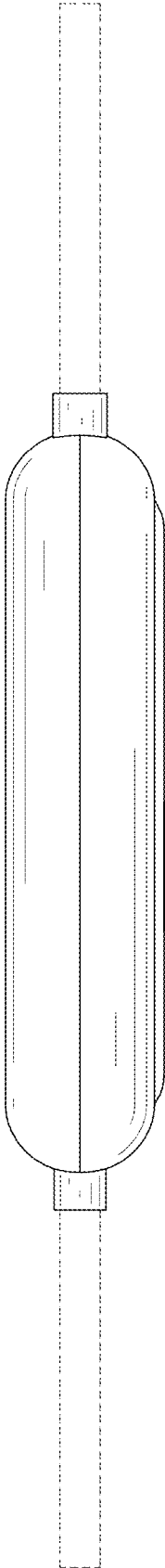

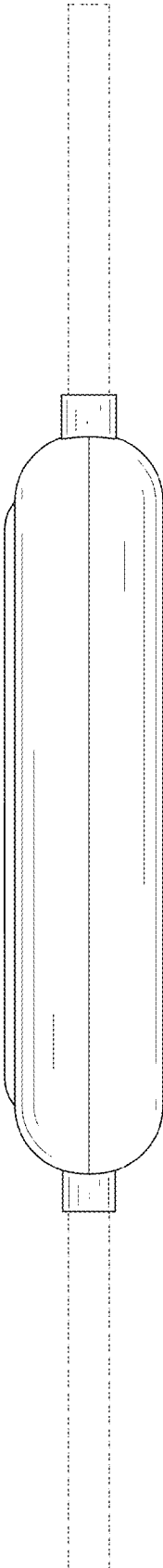

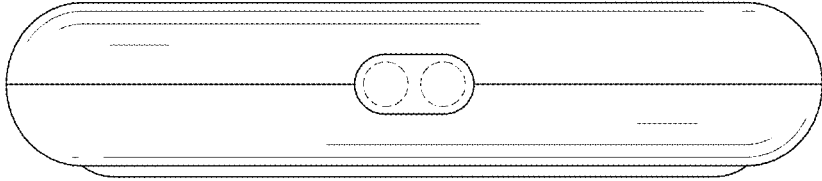

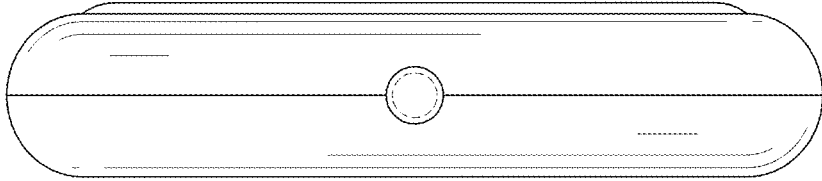
