ling a ventilator system.

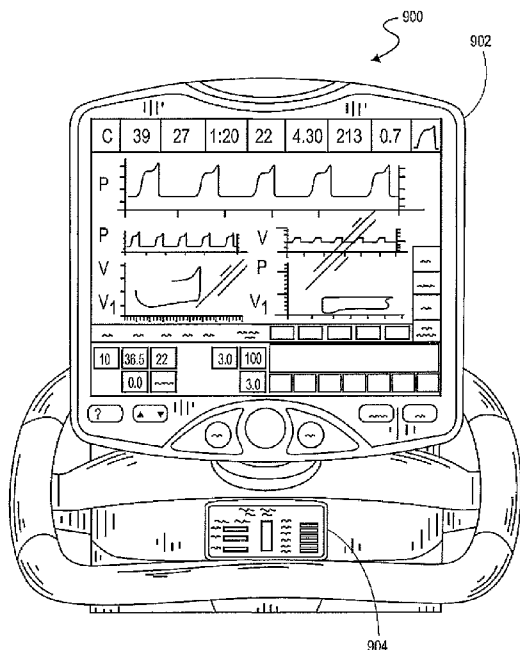
