

(57) Abstract: An acoustic device is disclosed having a variably refracting acoustic fluid interface (100) including the boundary between two separate fluid media (1, 2), means for directing acoustic waves (2) onto the interface, and an acoustic generator or transducer located (31) in one of the fluid media with the acoustic generator having an impedance that is substantially equal to the one said fluid media to minimize signal loss and reflection.
