(57) **CLAIM**

The ornamental design for a motorcycle passenger vest, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view depicting an embodiment of the motorcycle passenger vest, as disclosed herein.

FIG. 2 is a front view depicting an embodiment of the motorcycle passenger vest depicted in FIG. 1; and,

FIG. 3 is a left side view of the motorcycle passenger vest depicted in FIG. 1.

The broken lines in the figure views indicate stitching which does not form a part of the claimed design.

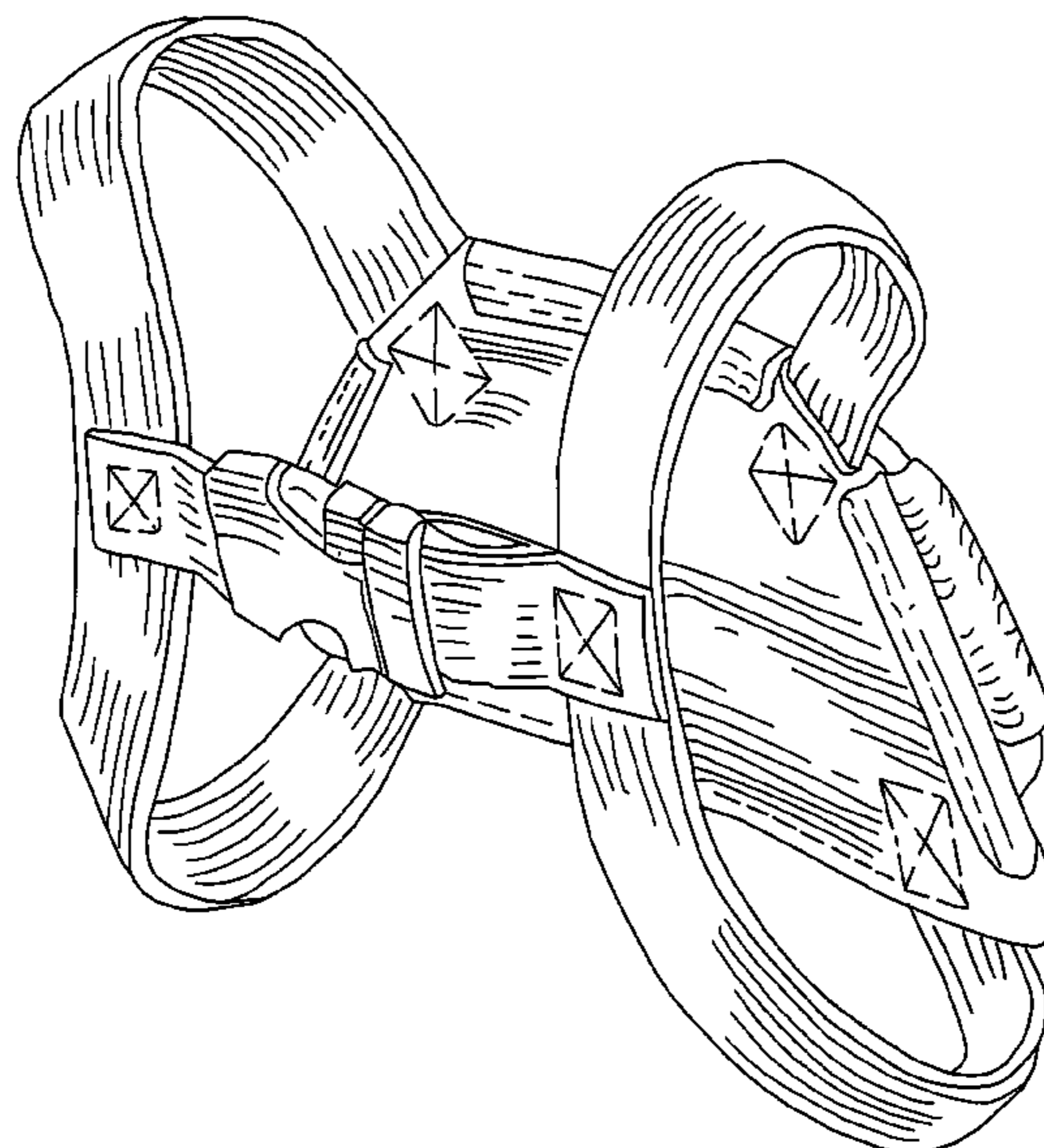

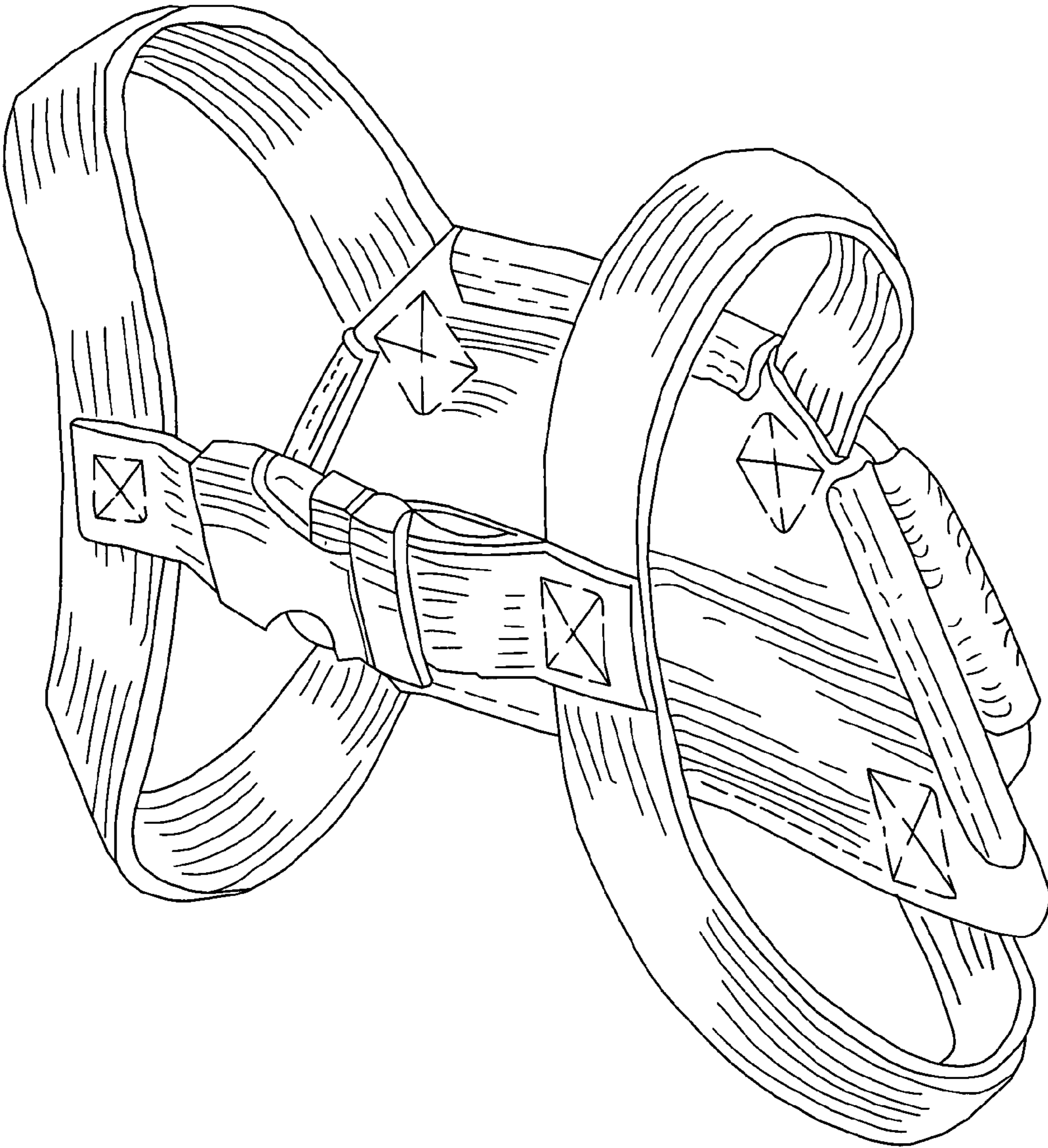
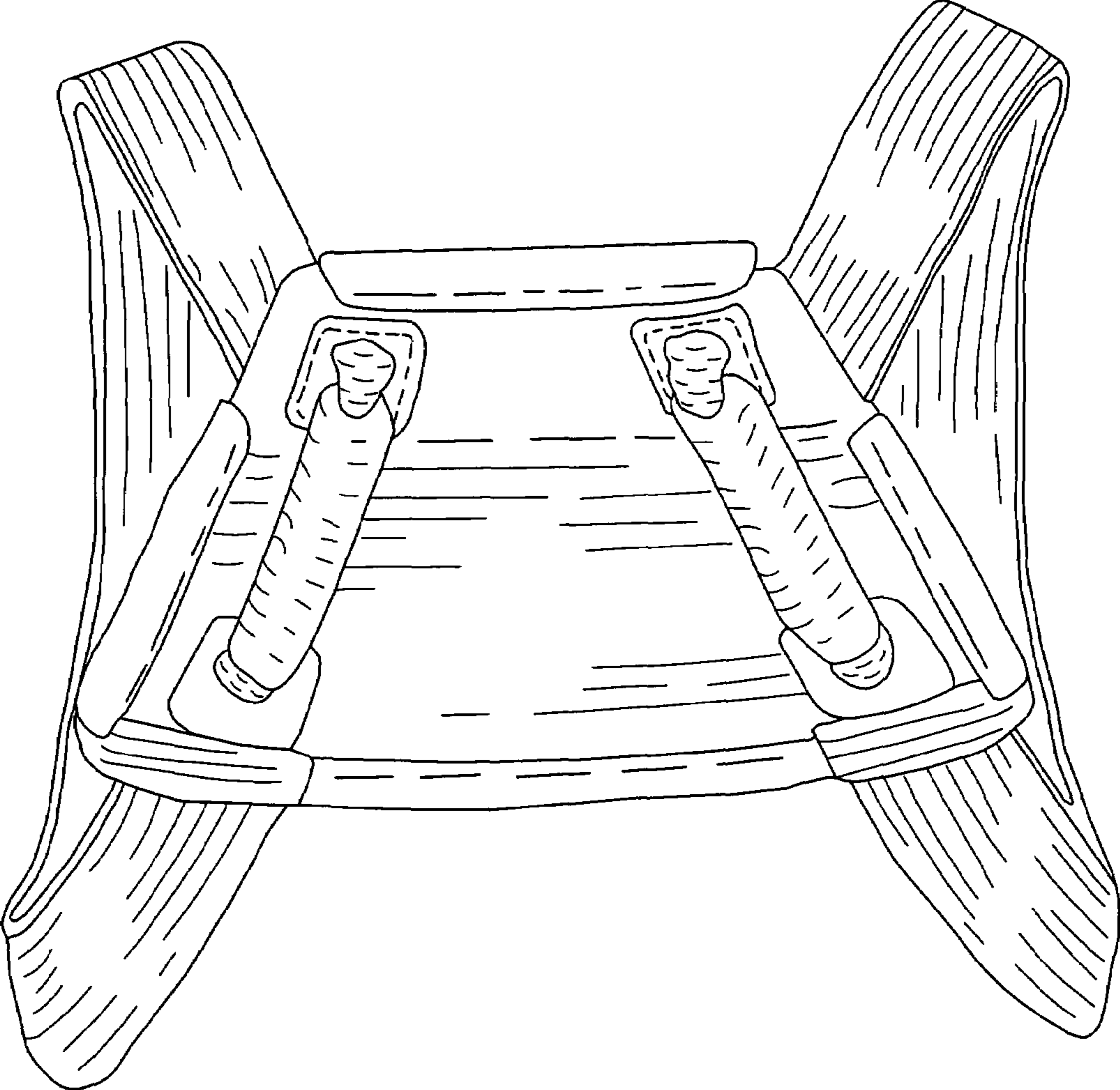

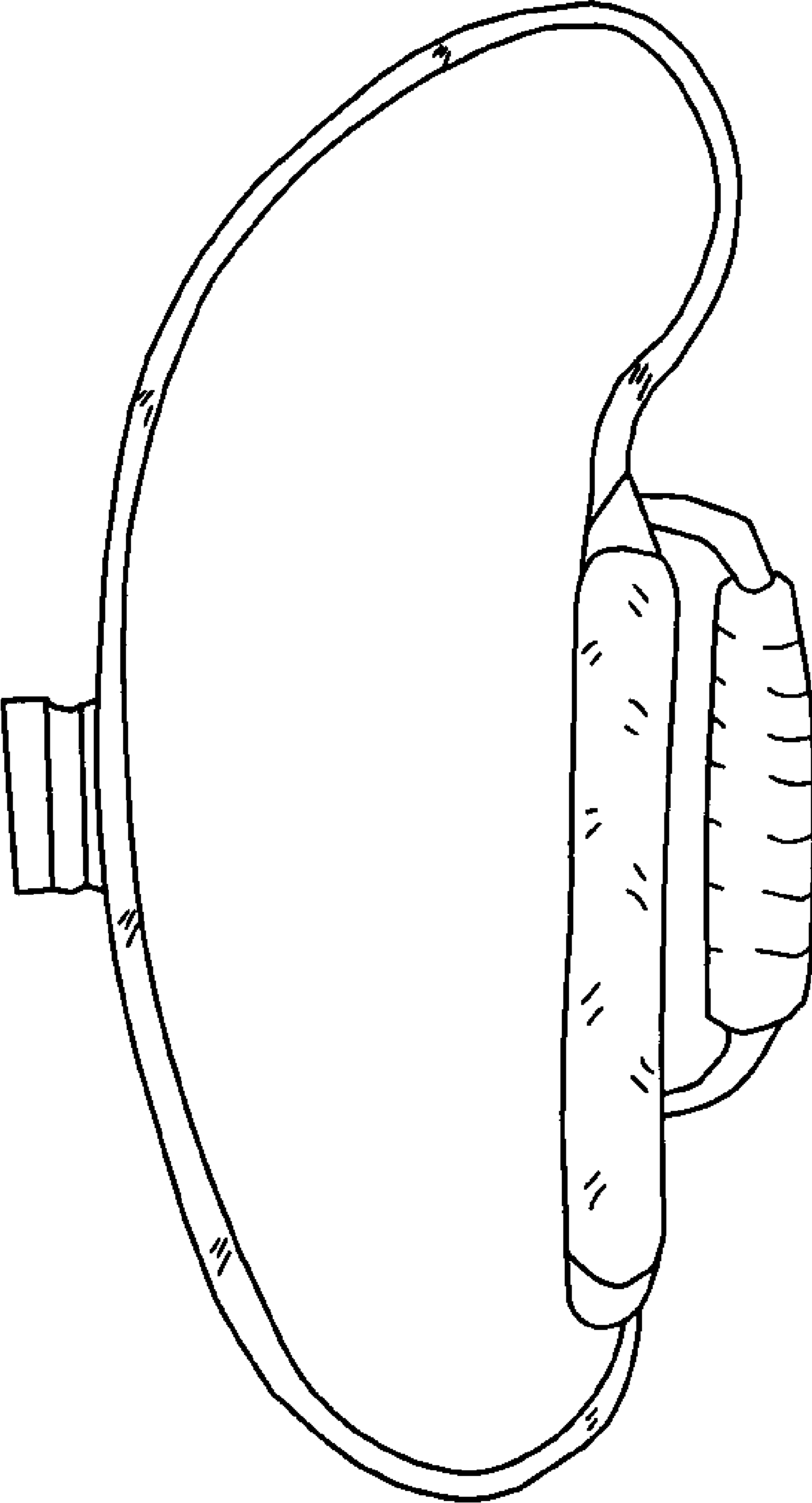
