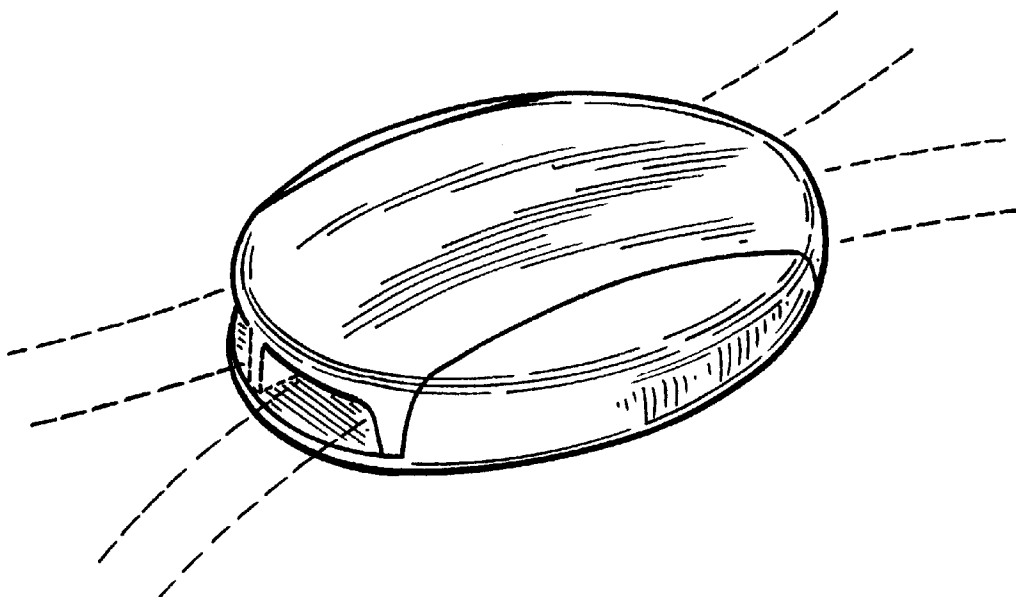

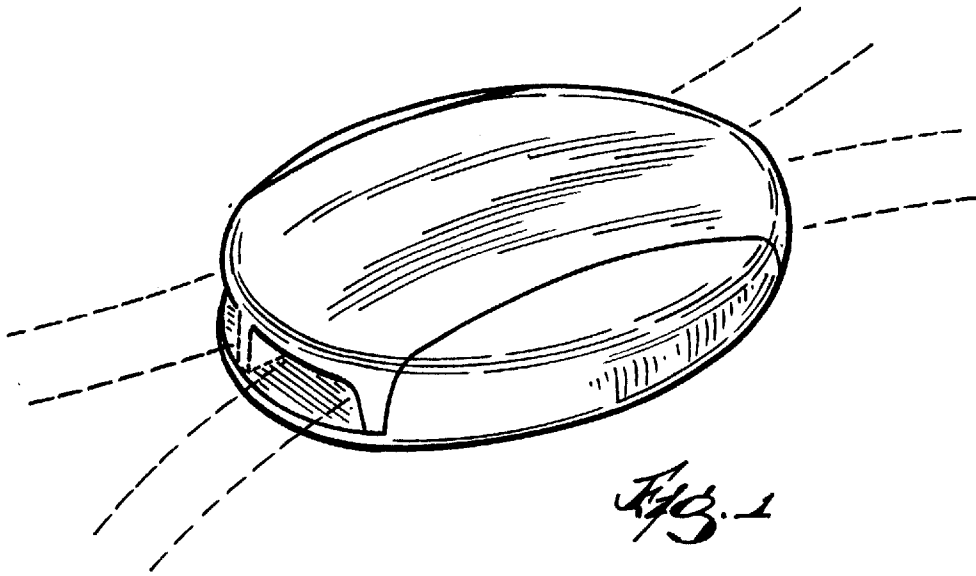

**DESCRIPTION**

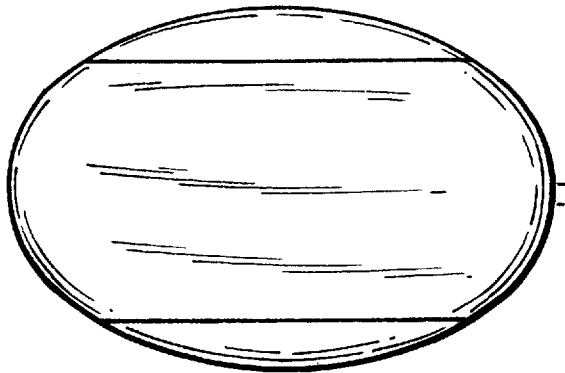
FIG. 1 is a perspective view of a cord clamp showing the new design;  
FIG. 2 is a top plan view thereof;  
FIG. 3 is an elevational view of one side thereof, the opposite side being the same as this one side;  
FIG. 4 is a bottom plan view thereof; and,  
FIG. 5 is a front side elevational view thereof, the back side being the same as the front side.

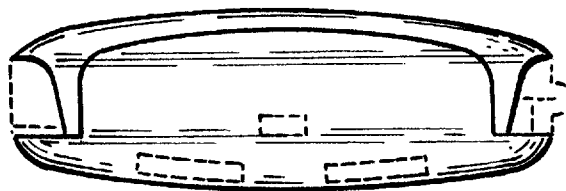




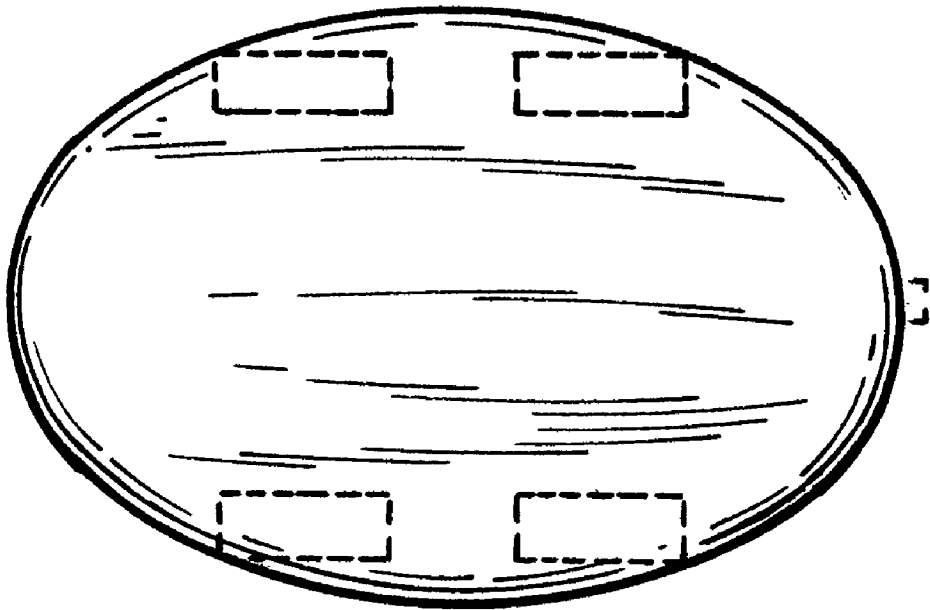

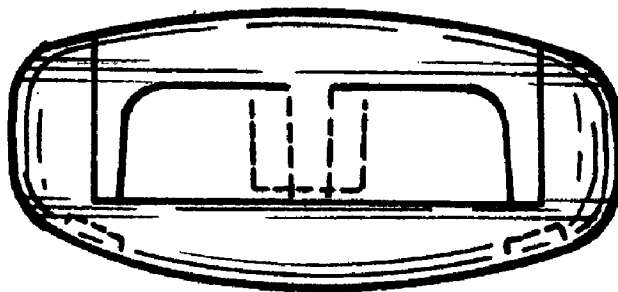
