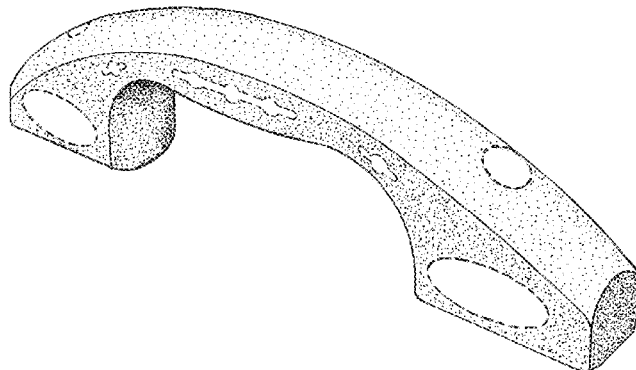
(57) **CLAIM**

The ornamental design for a handle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a handle in accordance with the invention;
FIG. 2 is a first side elevational view of the handle with the second side elevational view of the handle being a mirror image thereof;
FIG. 3 is a rear elevational view of the handle with the front elevational view of the handle being a mirror image thereof;
FIG. 4 is a bottom plan view of the handle; and,
FIG. 5 is a top plan view of the handle.

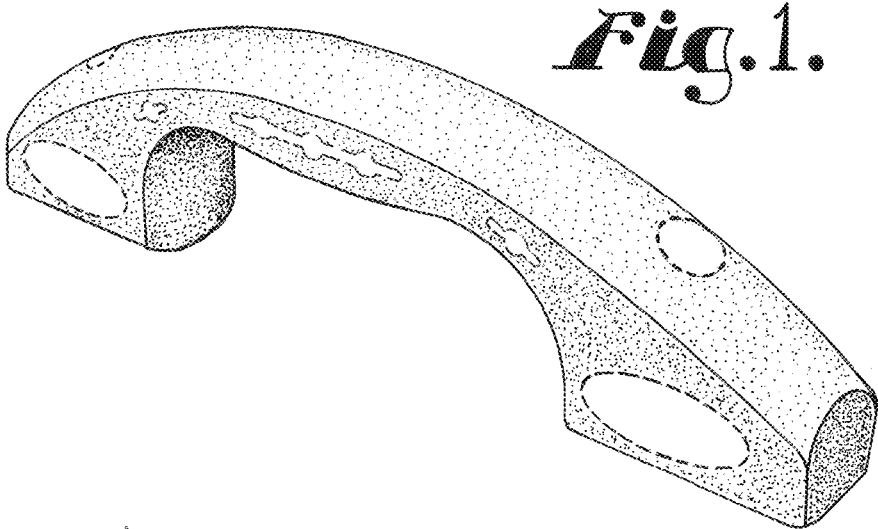

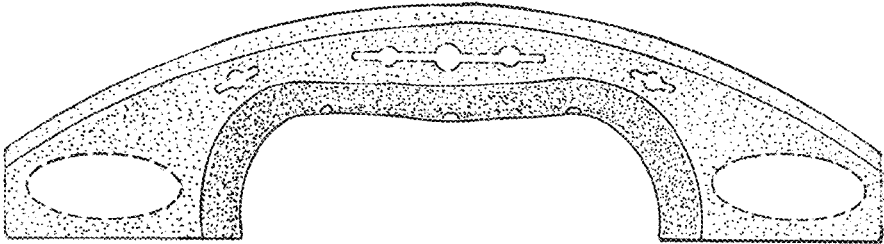

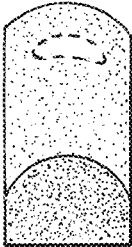

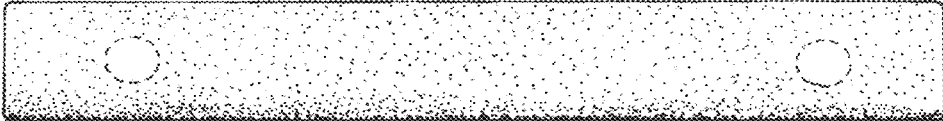
