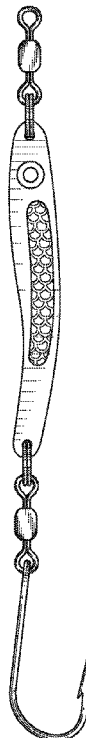
(57) **CLAIM**

The ornamental design for a articulated salmon fishing spoon, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the articulated salmon fishing spoon showing my new design in use;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a right side view thereof;
FIG. 5 is a left side view thereof;
FIG. 6 is an enlarged top view thereof; and,
FIG. 7 is an enlarged bottom view thereof.

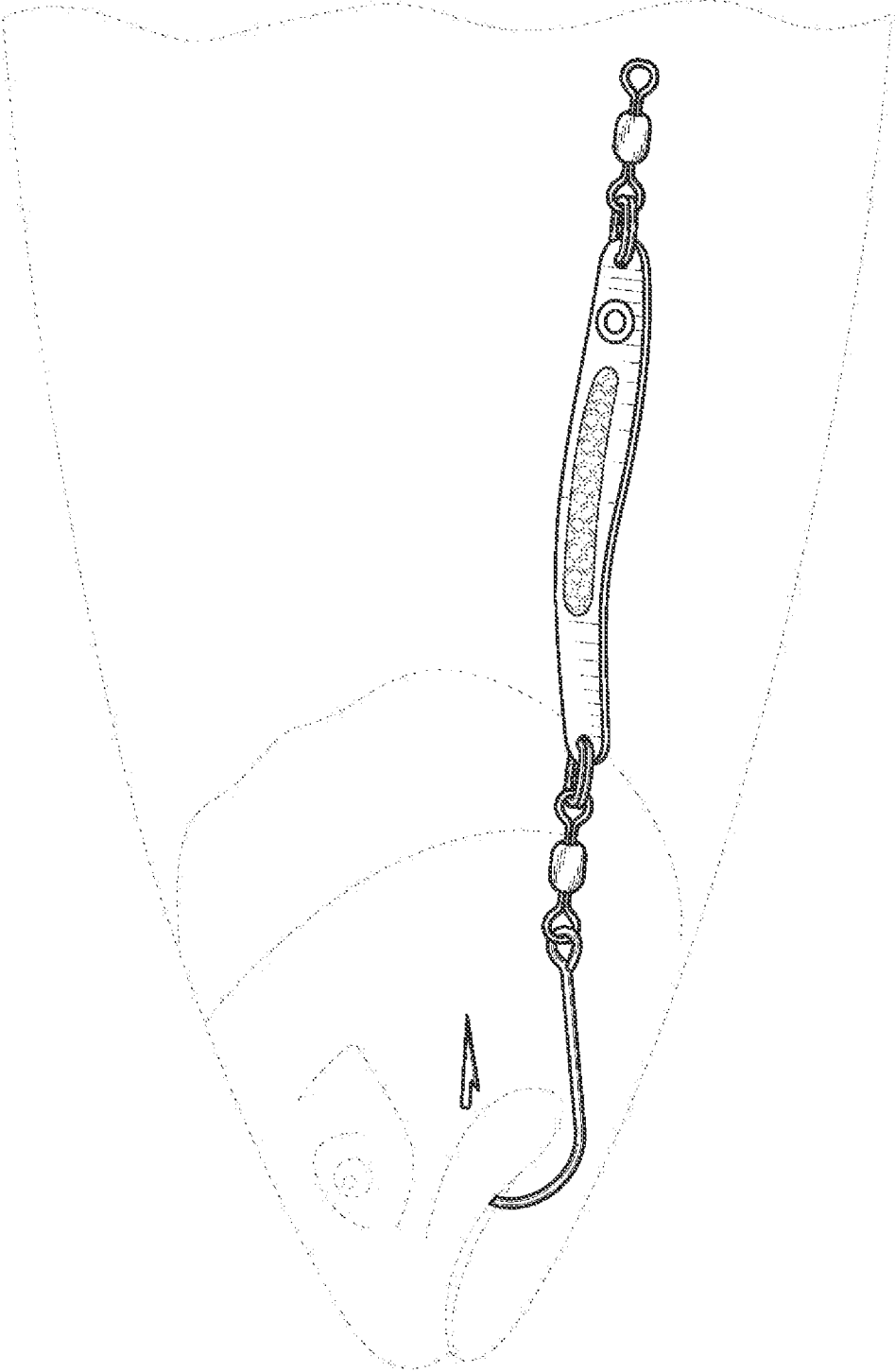

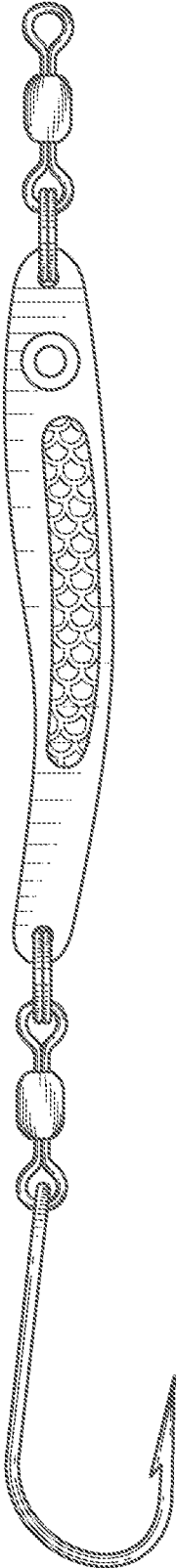

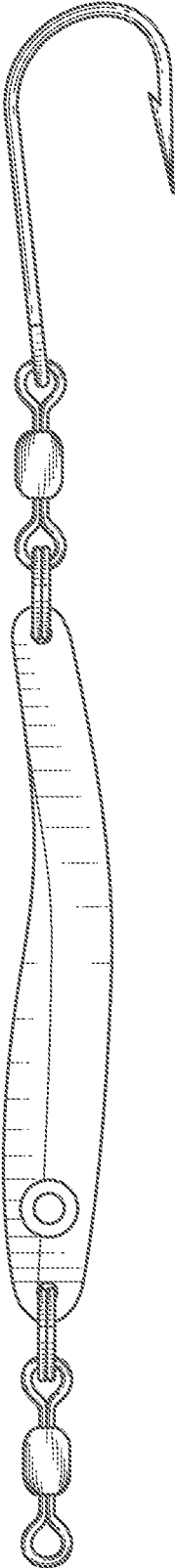

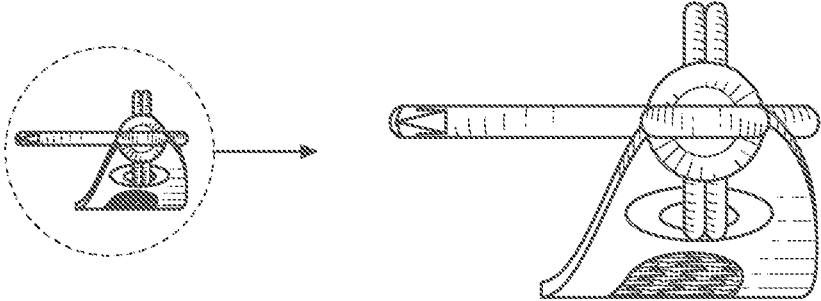

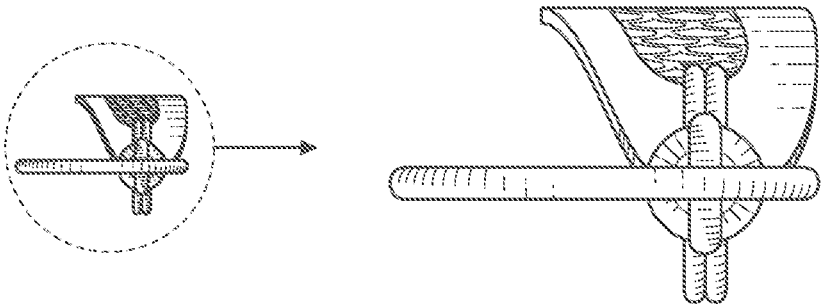
