(57) **CLAIM**

The ornamental design for a sphere mold, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a sphere mold showing my new design.

FIG. 2 is a front view thereof, a rear view being a mirror image.

FIG. 3 is a left side view thereof, a right side view being a mirror image.

FIG. 4 is a top view thereof.

FIG. 5 is a bottom view thereof.

FIG. 6 is a top perspective exploded view showing a top portion and a bottom portion of the sphere mold.

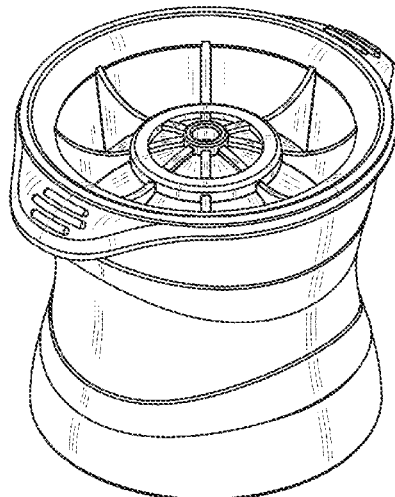
FIG. 7 is a bottom perspective exploded view thereof.

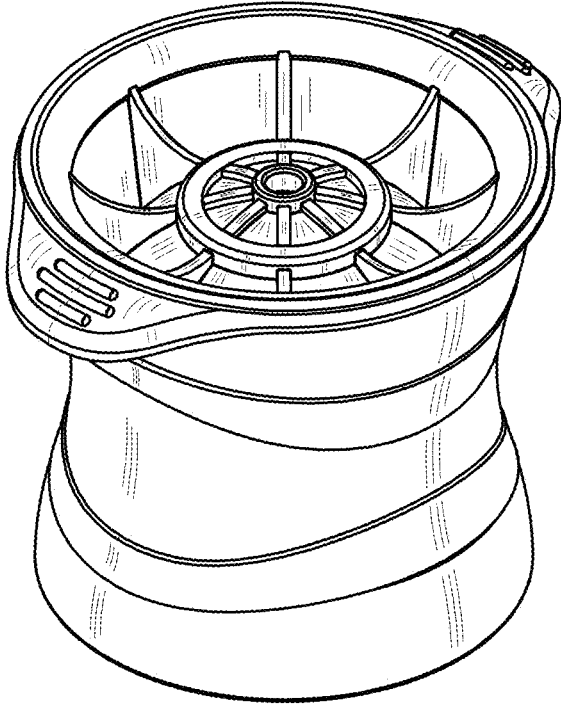

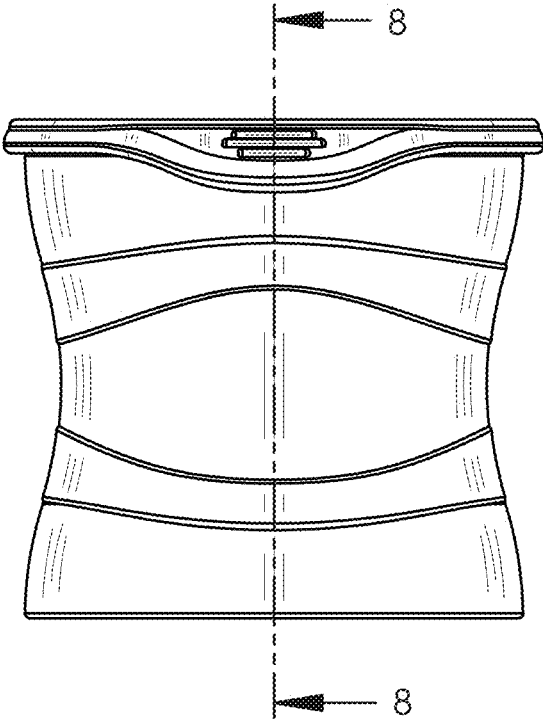

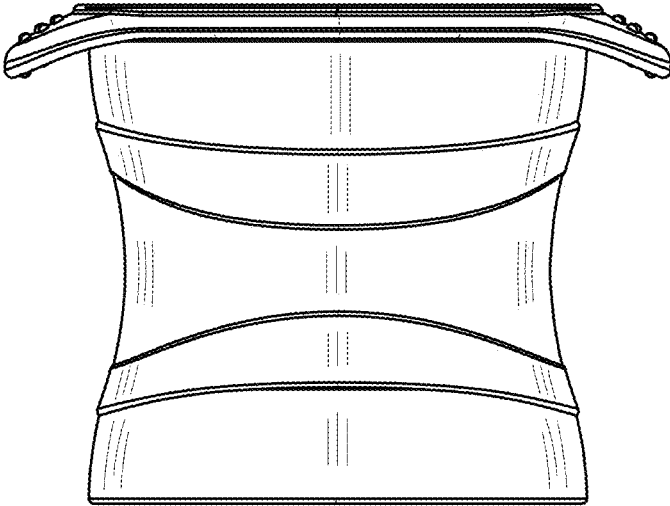

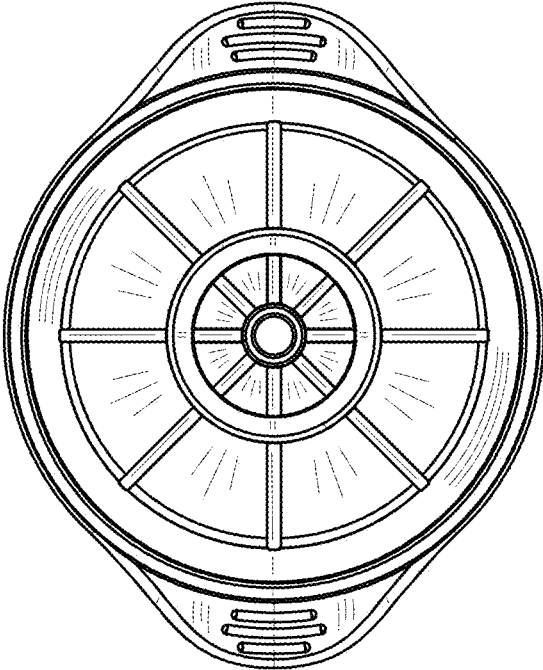

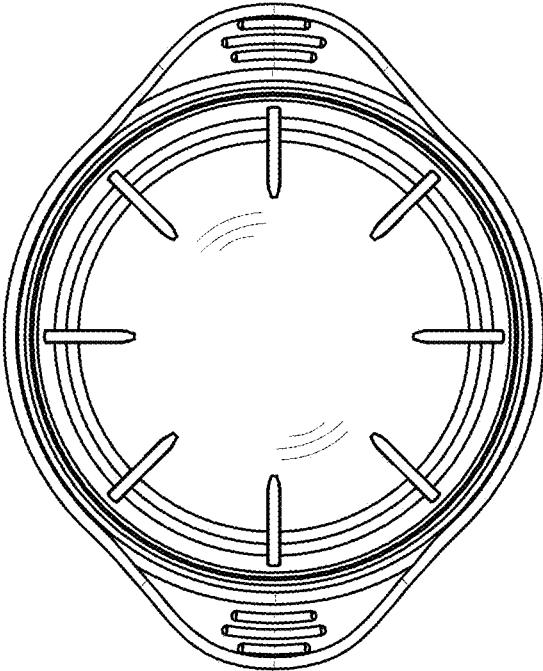

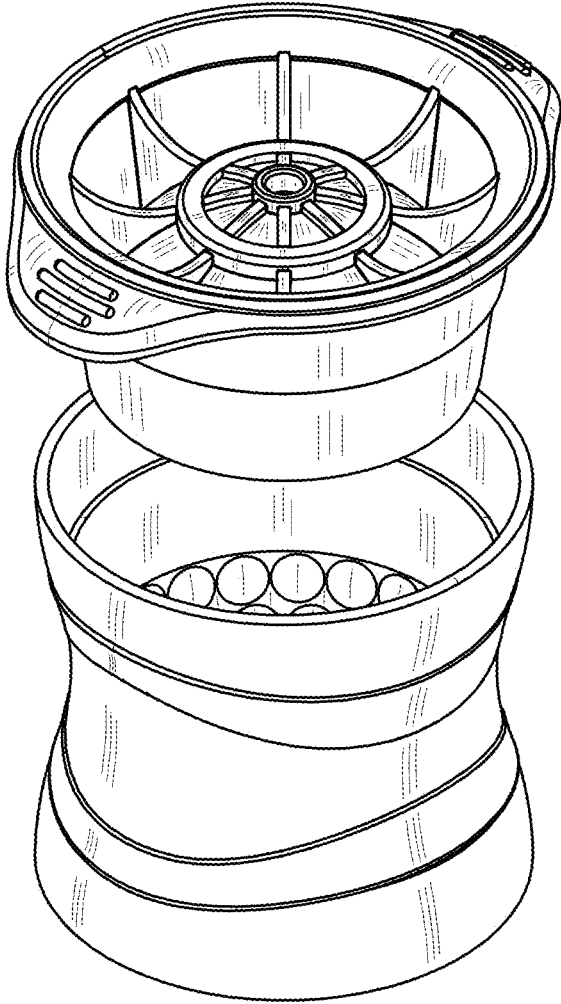

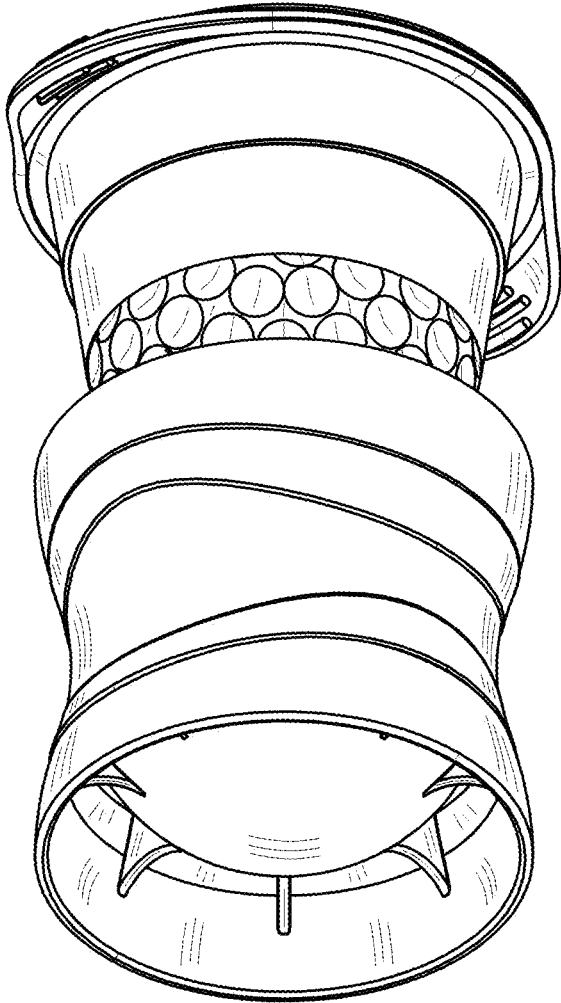

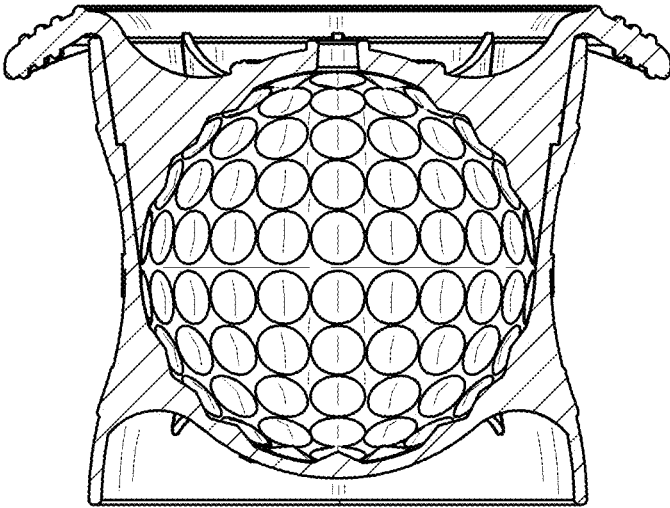

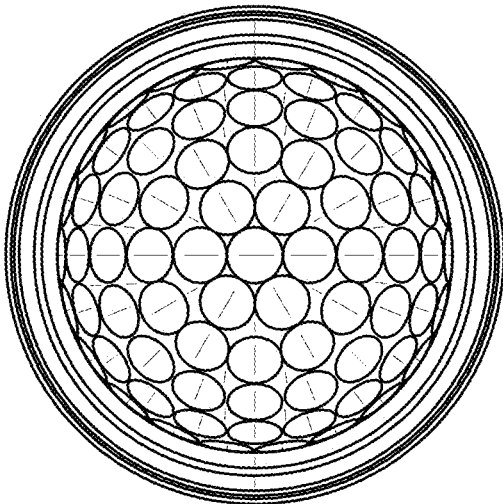

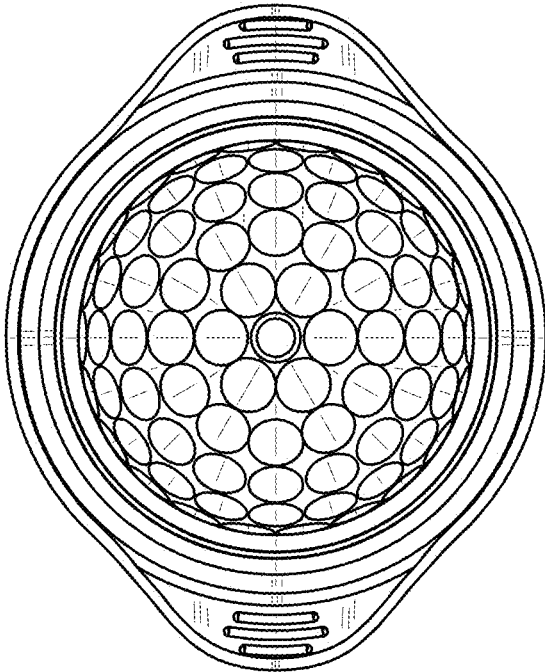
