FIG. 2 is a front view of a second embodiment thereof.

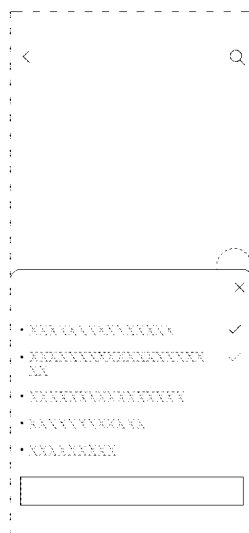

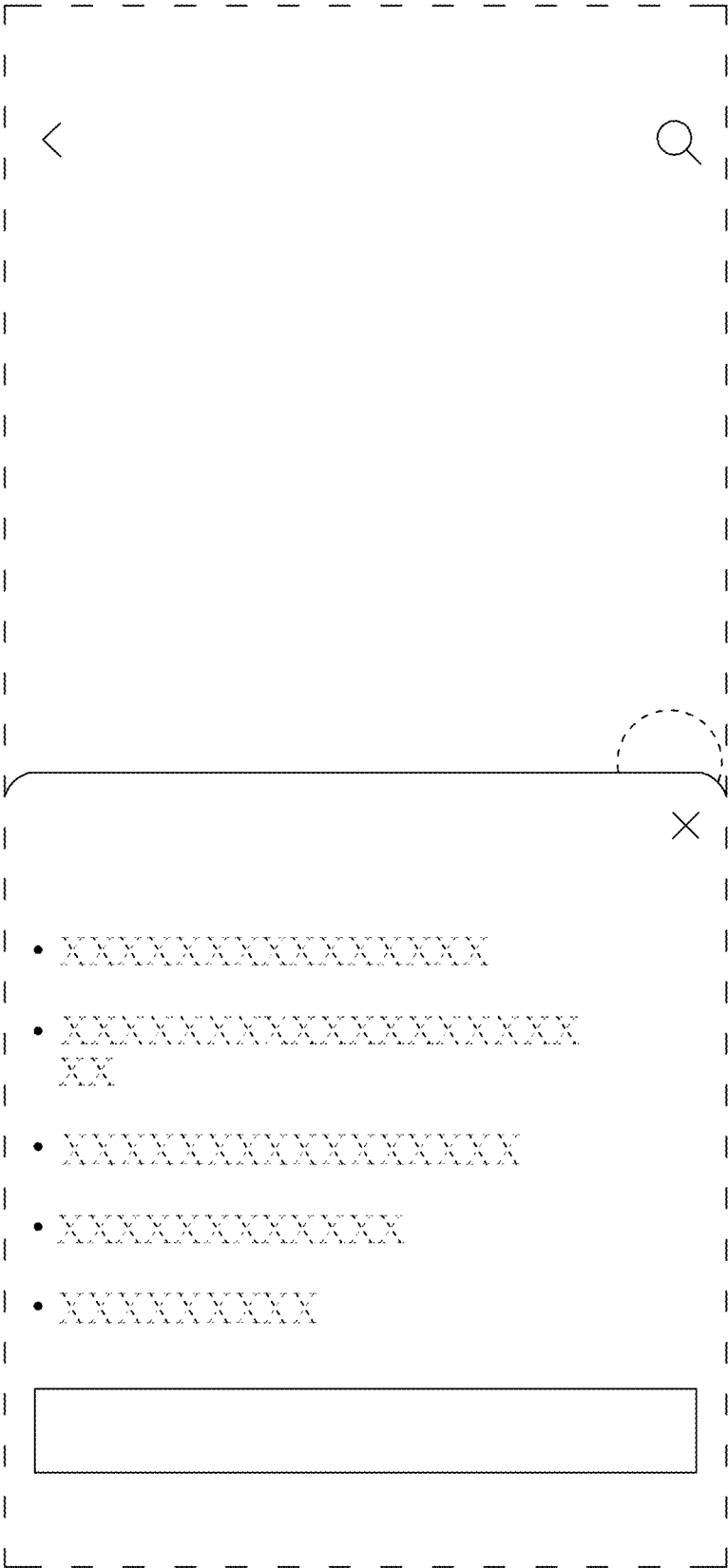

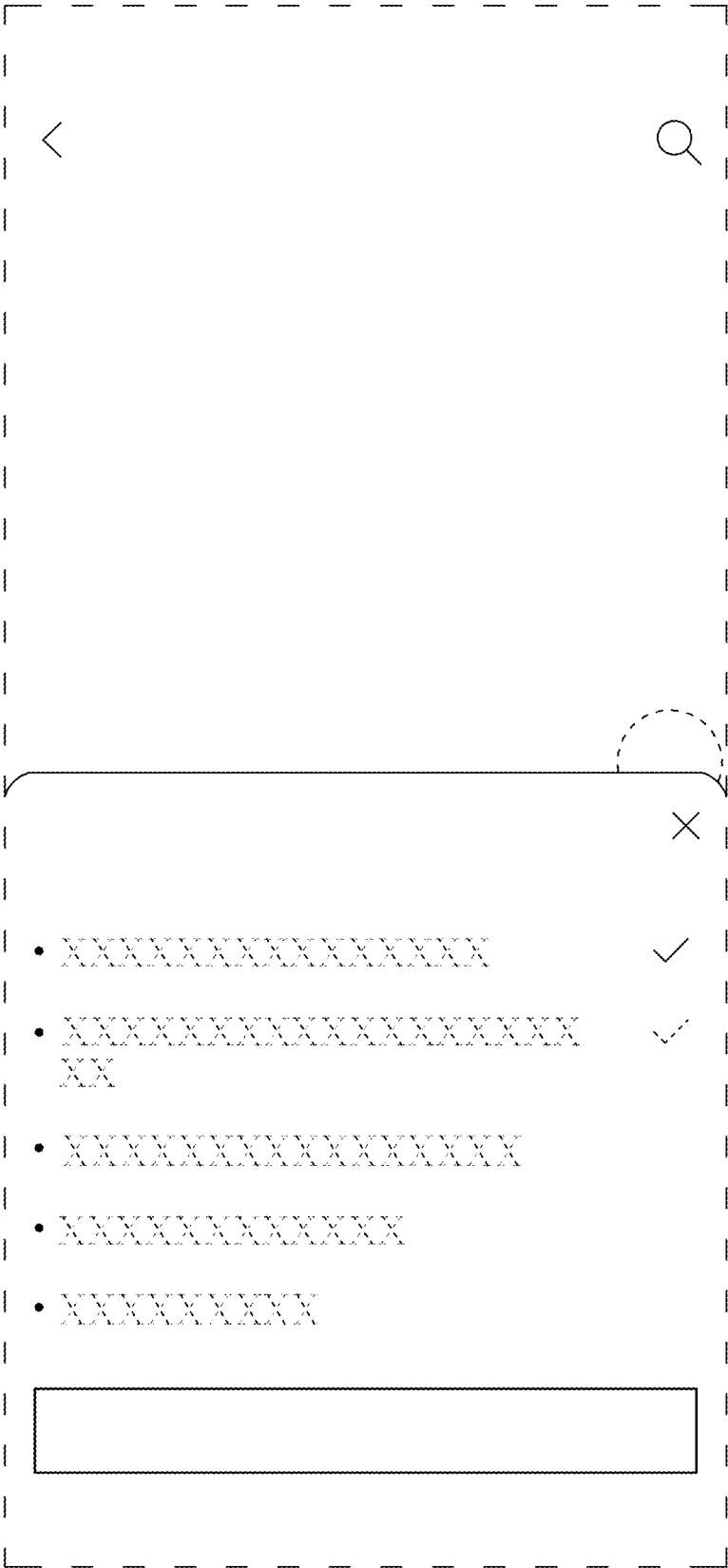
