(57) **CLAIM**

The ornamental design for a storage bin with lid, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a storage bin and lid showing my new design.

FIG. 2 is an exploded perspective view of the storage bin and lid shown in FIG. 1 with the lid removed from the storage bin.

FIG. 3 is a top view of the storage bin and lid shown in FIG. 1.

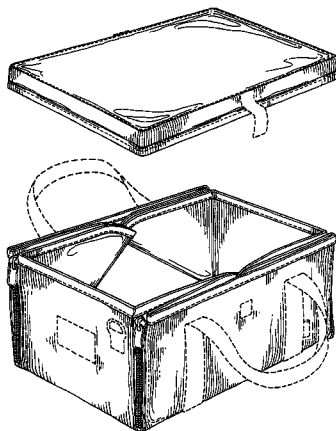
FIG. 4 is a bottom view of the storage bin and lid shown in FIG. 1.

FIG. 5 is a side view of the storage bin and lid shown in FIG. 1; the opposite side being a mirror image thereof; and,

FIG. 6 is an end view of the storage bin and lid shown in FIG. 1; the opposite end being a mirror image thereof.

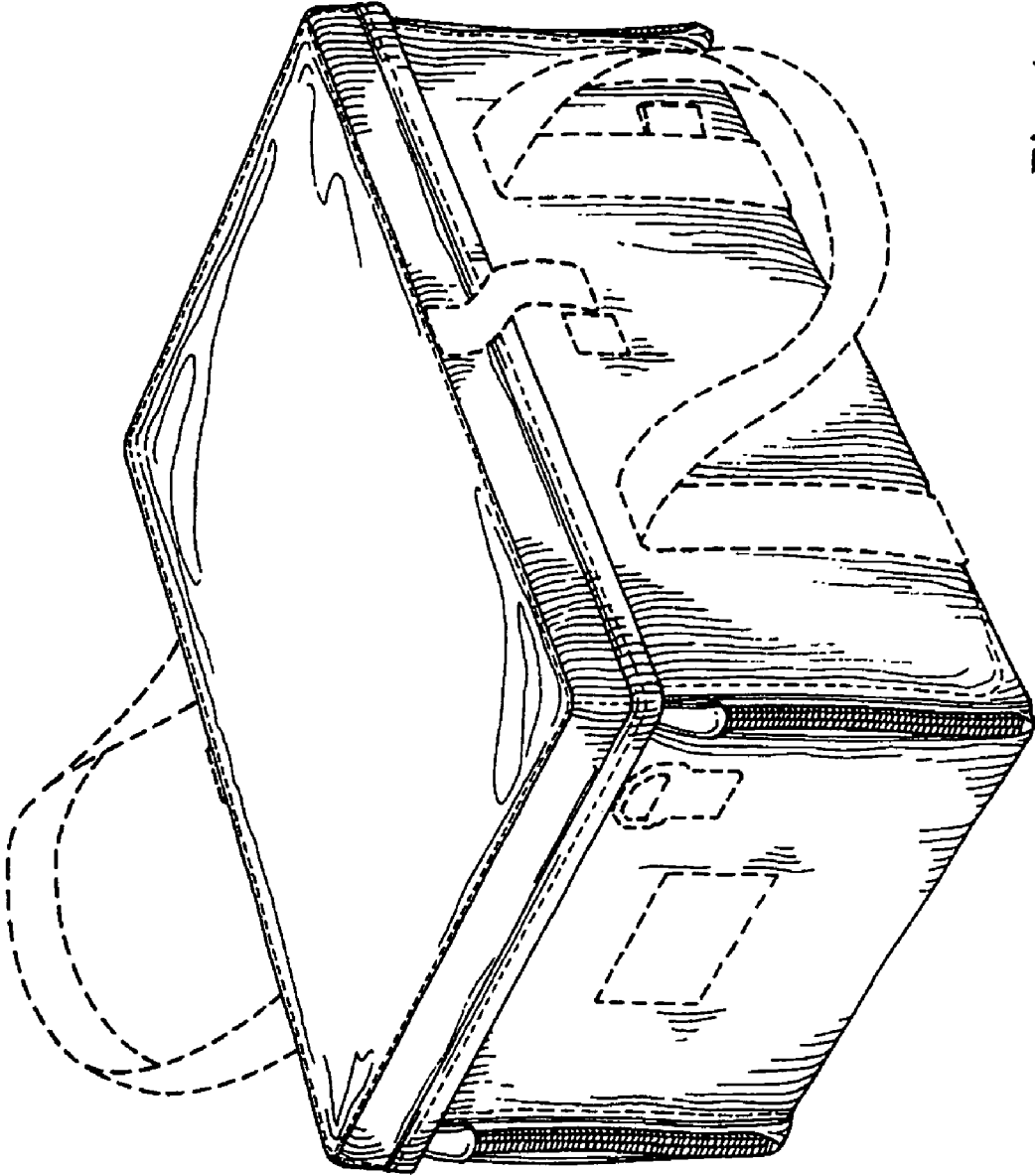

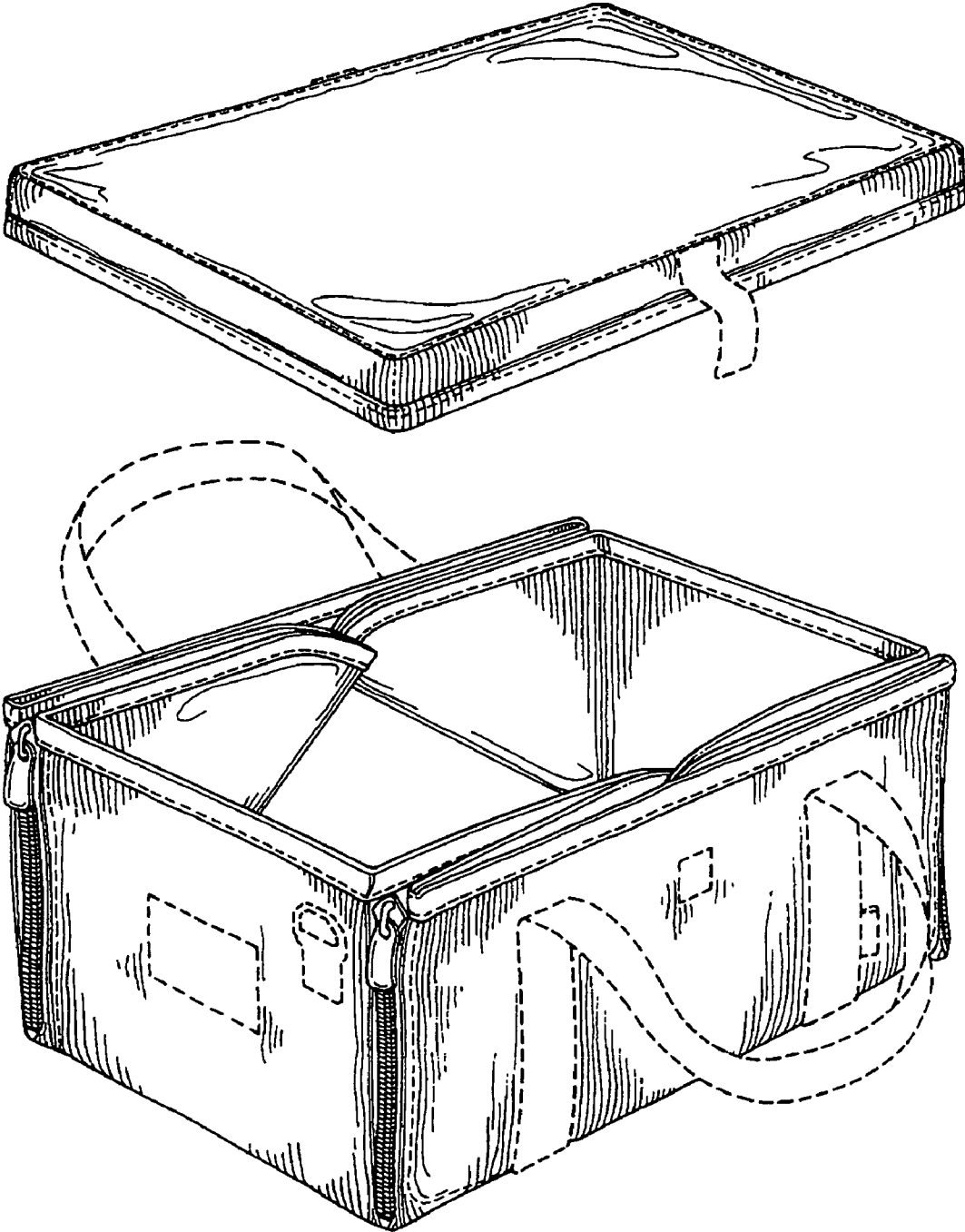

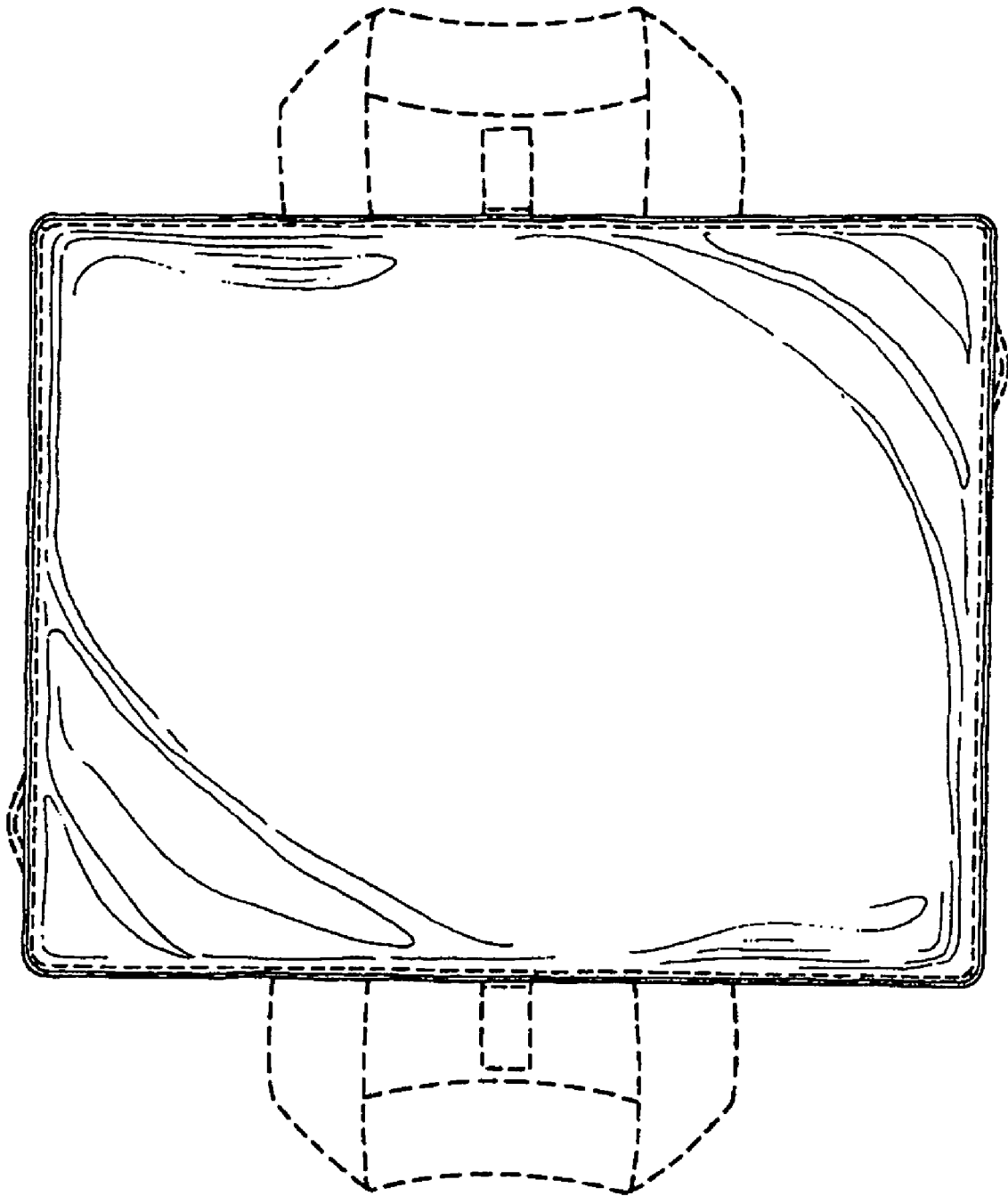

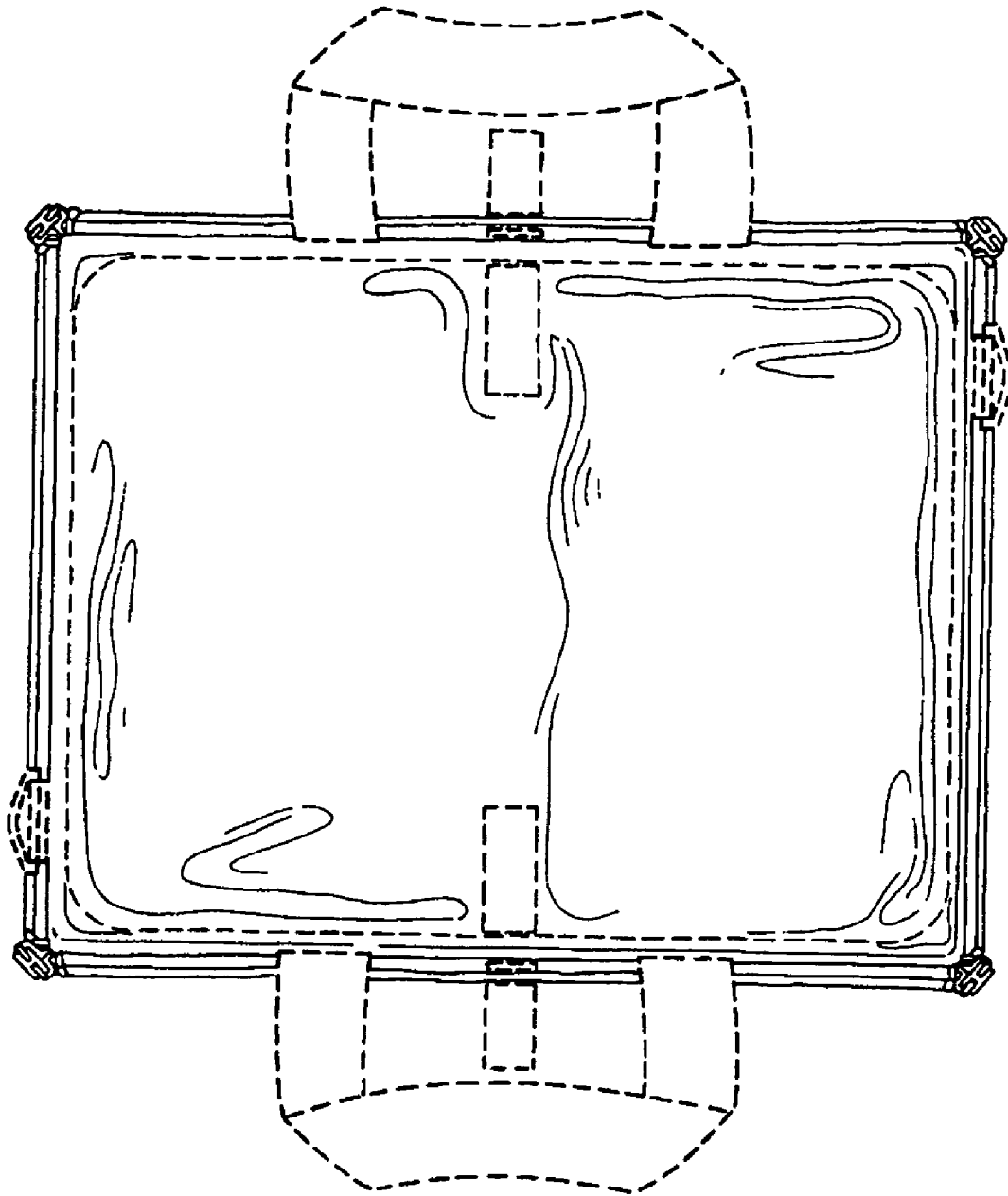

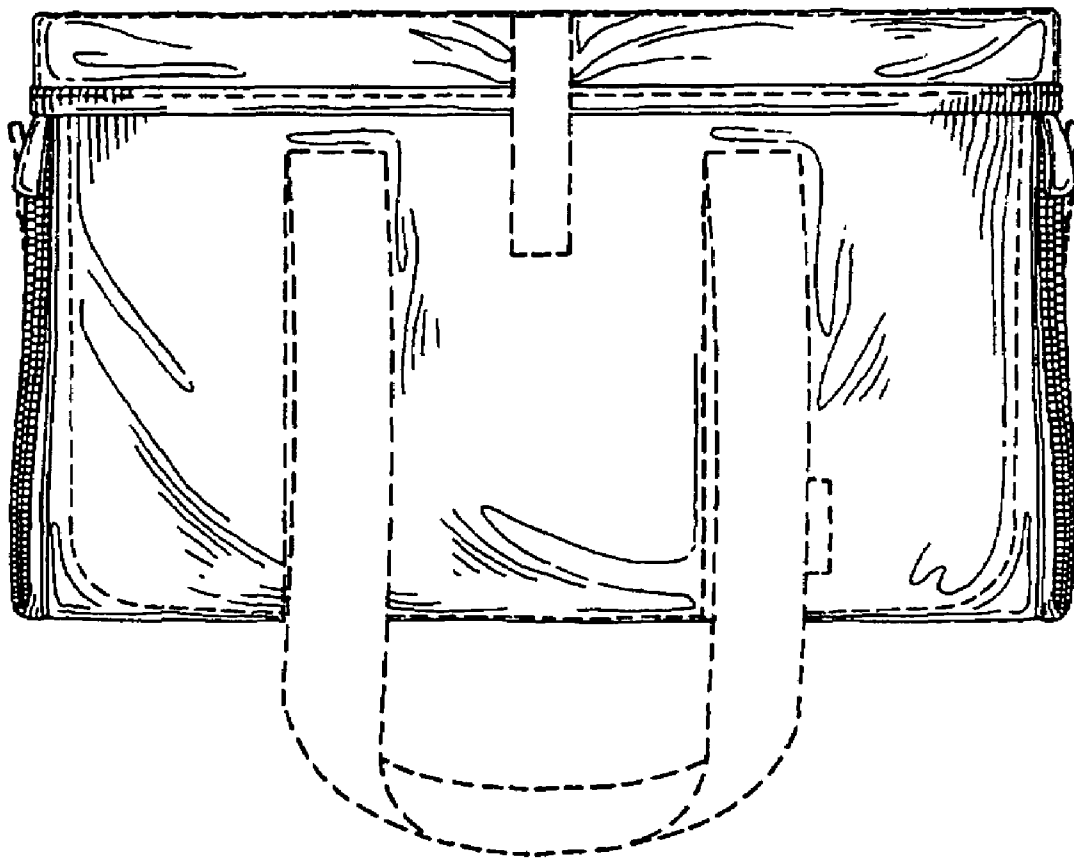

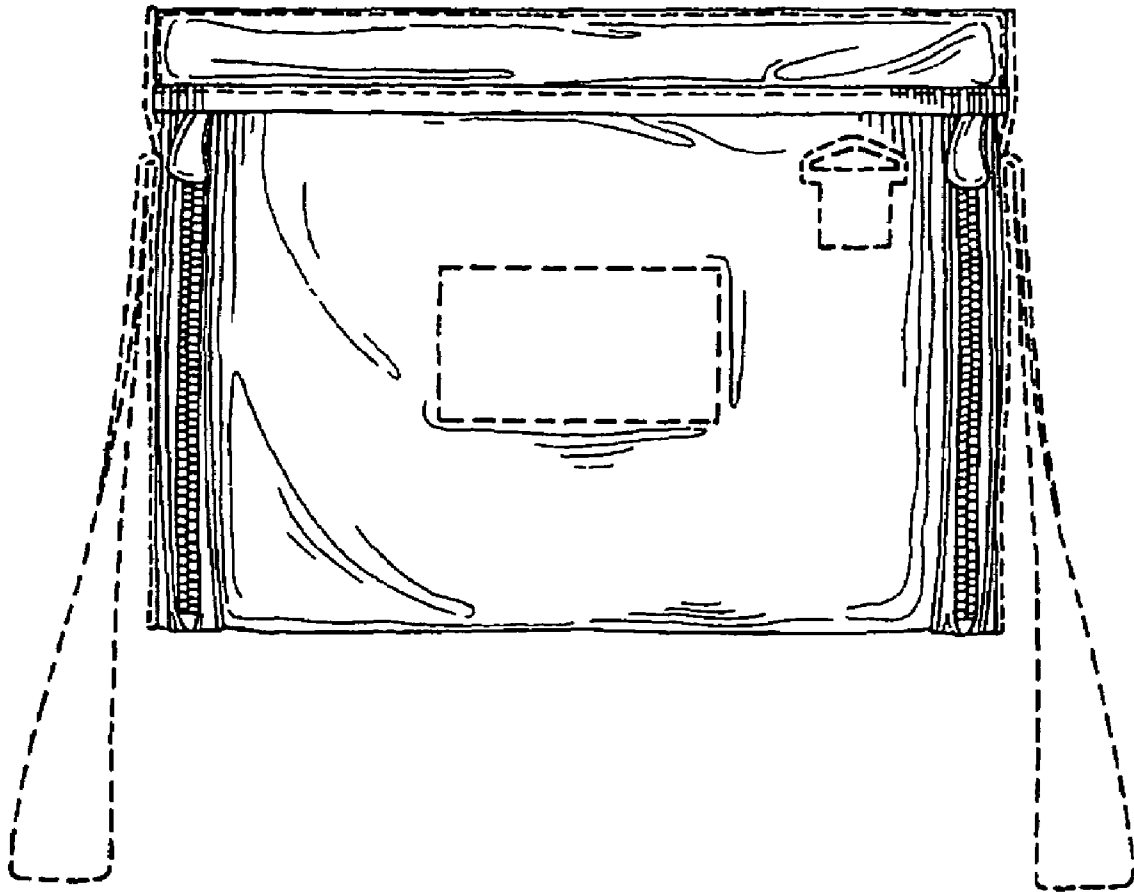
