(57) **CLAIM**

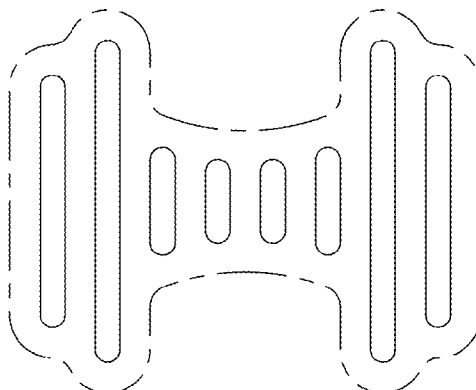
We claim the ornamental design for a display screen or portion thereof with icon, as shown and described.

DESCRIPTION

FIG. 1 is an enlarged front view of a display screen or portion thereof with icon; showing our new design; and, FIG. 2 is another front view thereof.

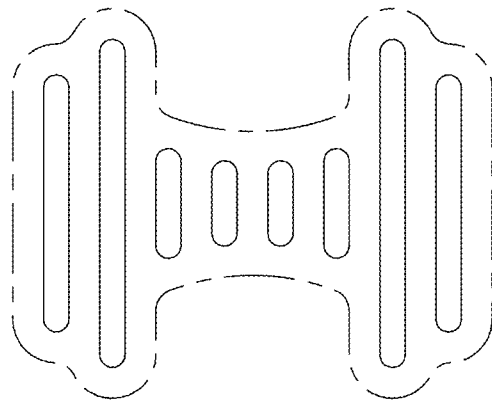
