(57) **CLAIM**

We claim the ornamental design for a display screen or portion thereof with graphical user interface, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a display screen or portion thereof with graphical user interface, showing my new design; and, FIG. 2 is a front view of the display screen or portion thereof with graphical user interface of FIG. 1 in which a mobile terminal is provided in broken lines to illustrate an example environment.

The broken line drawing of the mobile terminal, and the numbers, symbols and otherwise images shown in broken lines in FIG. 2 are for illustrative purposes only and form no part of the claimed design. The dot dash lines in the figures represent an unclaimed boundary line and form no part of the claimed design.

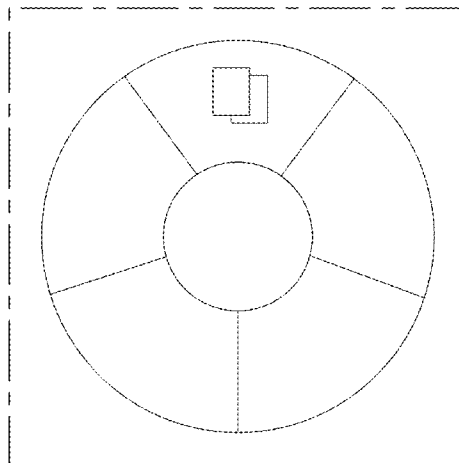

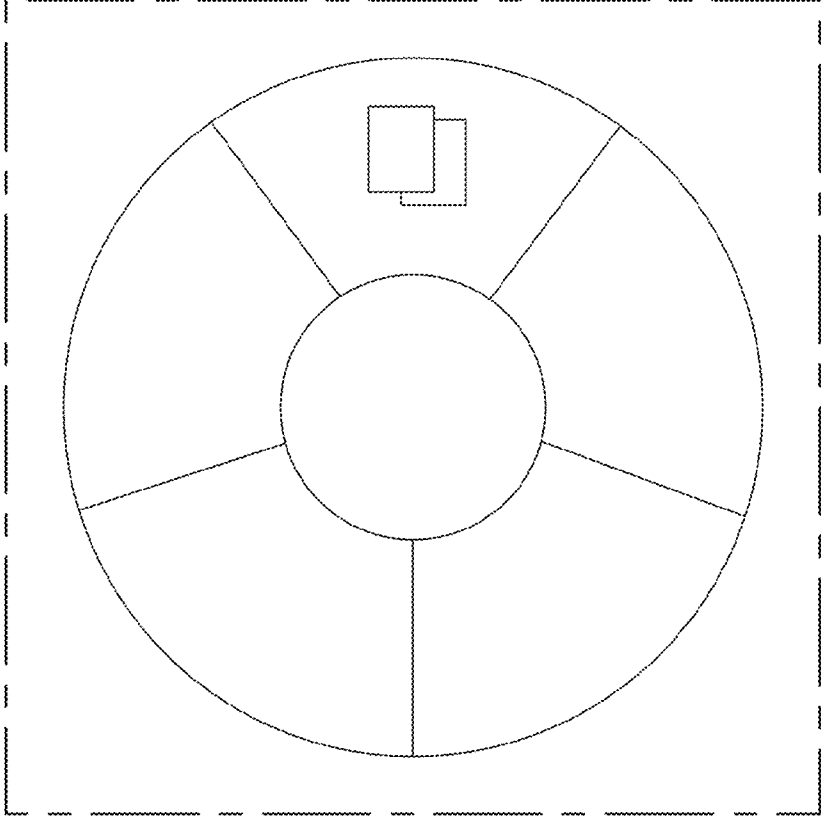
