The ornamental design for a bottle, as shown and described.

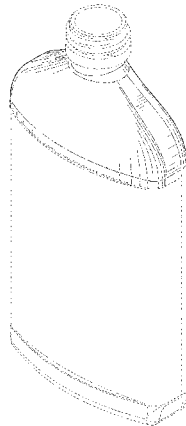
**DESCRIPTION**

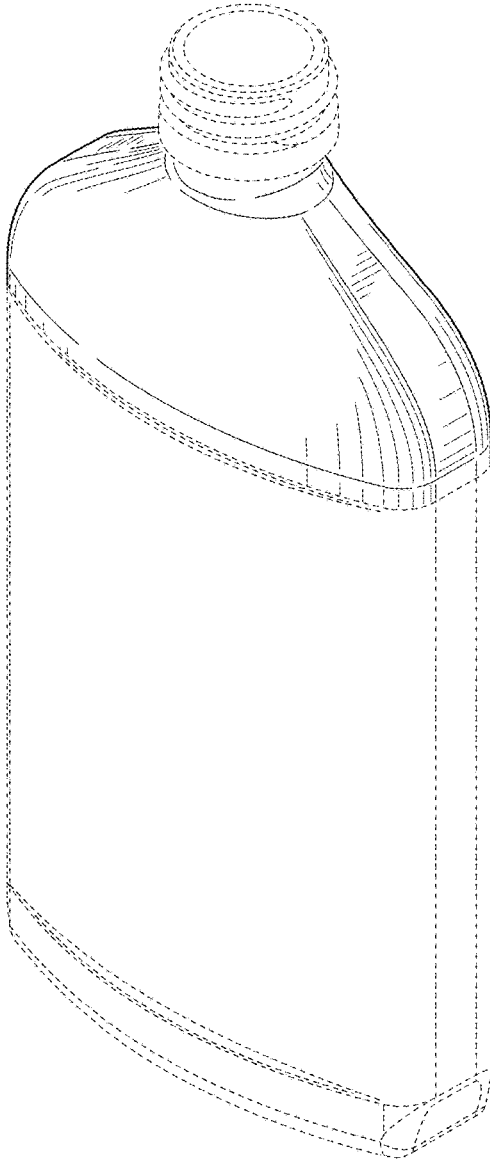

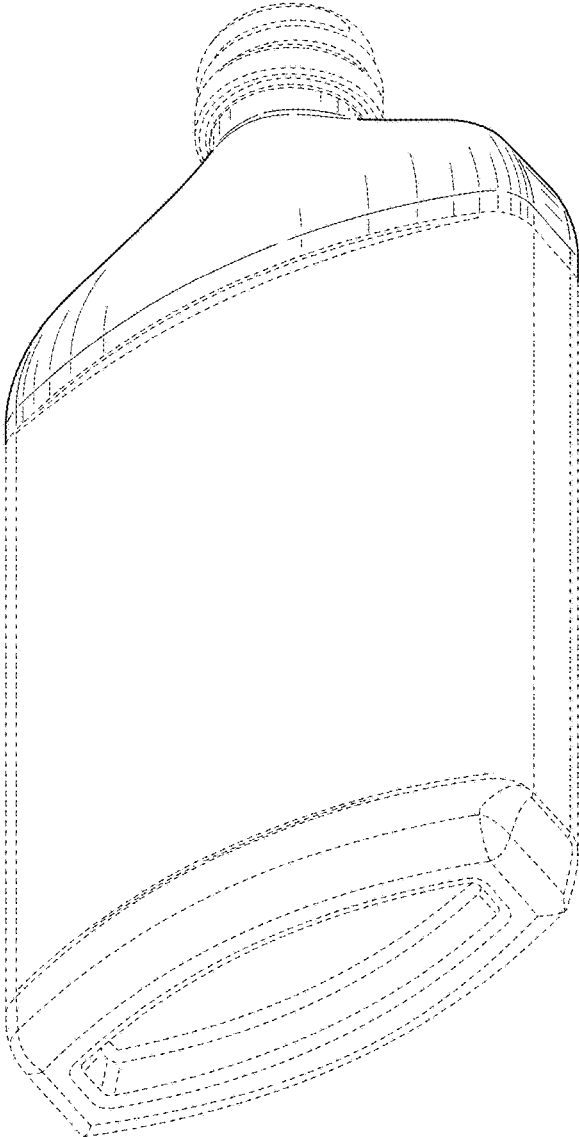

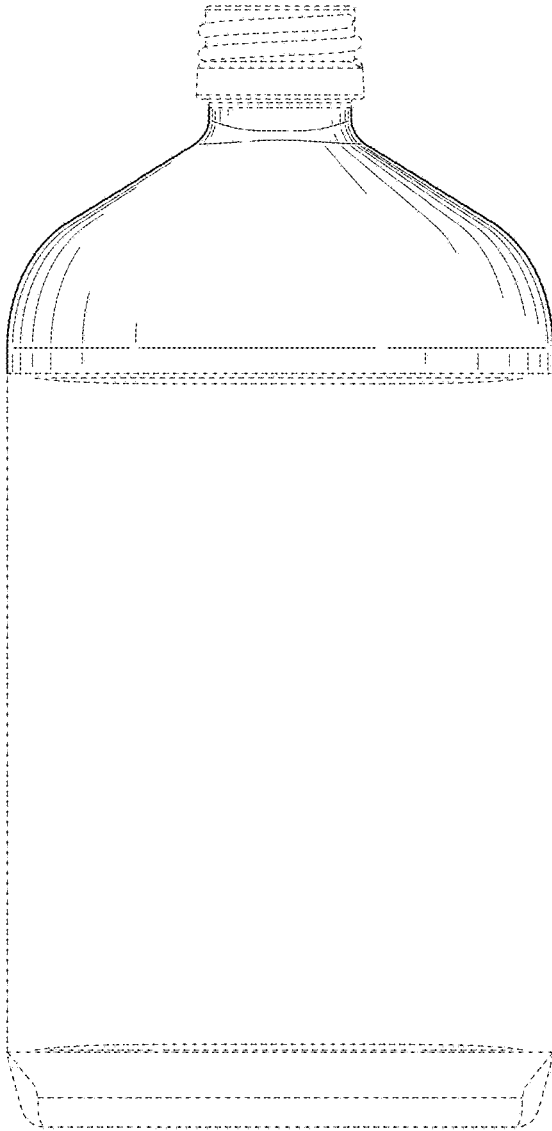

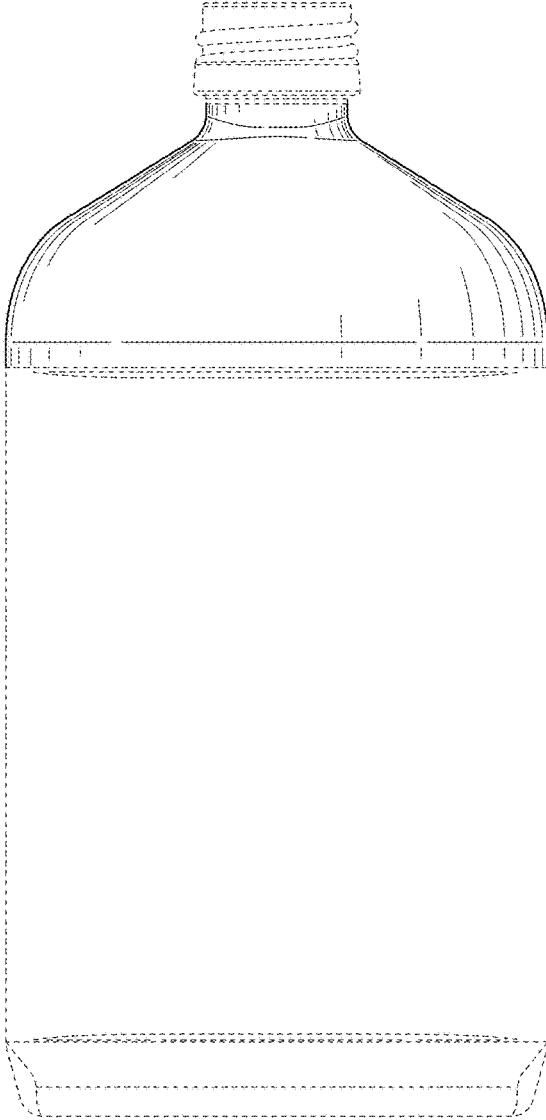

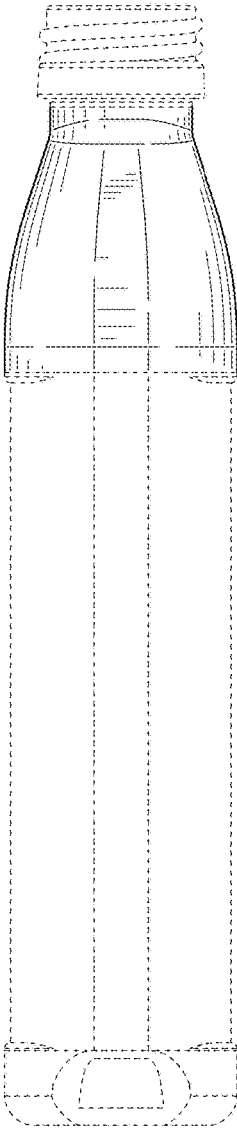

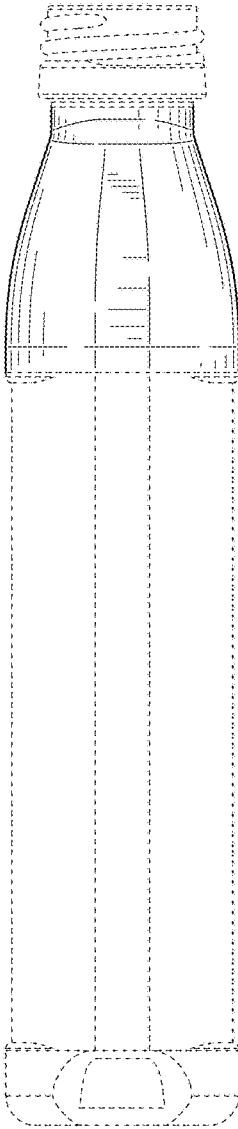

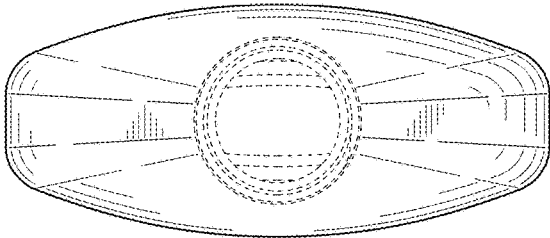

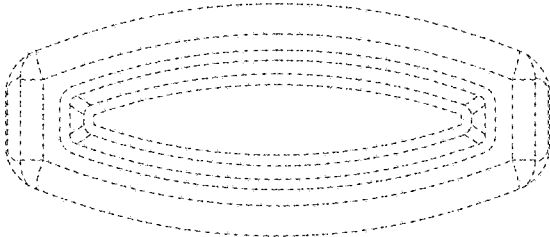
