

(57) Abstract: A computer system, products and methods for identifying a trend or an operational metric in a fleet of vehicles. The system may include at least one computer processor and computer readable storage medium with computer code and memory for storing GPS data for a plurality of vehicles. The system may include one or more processors programmed to receive GPS event data transmitted from a plurality of GPS devices, each GPS device associated with a vehicle. The system may include analyzing at least one trend for a GPS event history, processing the GPS event data, and providing for a graphic user interface a representation of associated trends.
