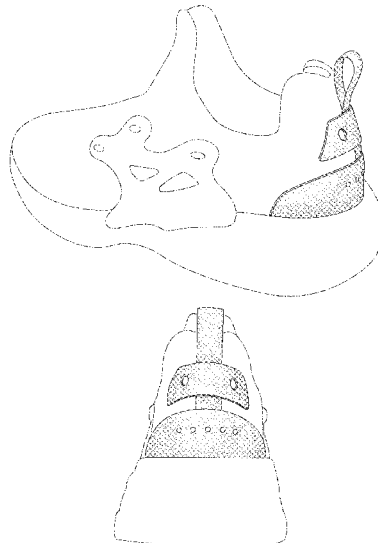
(57) **CLAIM**

The ornamental design for a shoe, as shown and described.

DESCRIPTION

FIG. 1 is a rear perspective view of a shoe showing my new design;
FIG. 2 is a side view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a second rear perspective view thereof; and,
FIG. 5 is an opposite side view thereof.
The seven unshaded regions within the shaded area that are demarcated by solid lines form no part of the claimed design. The broken lines depicting the remainder of the shoe show features that form no part of the claimed design.

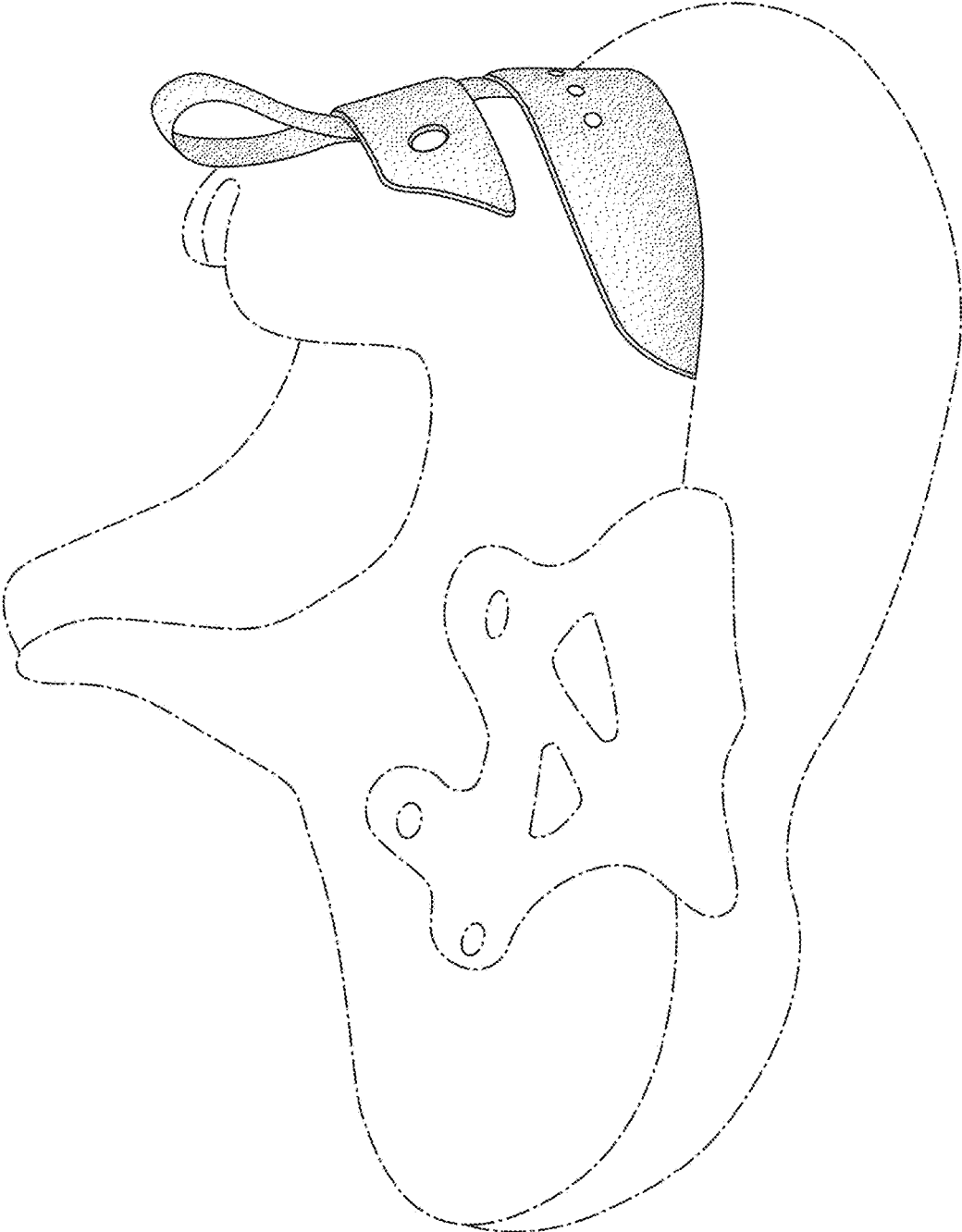

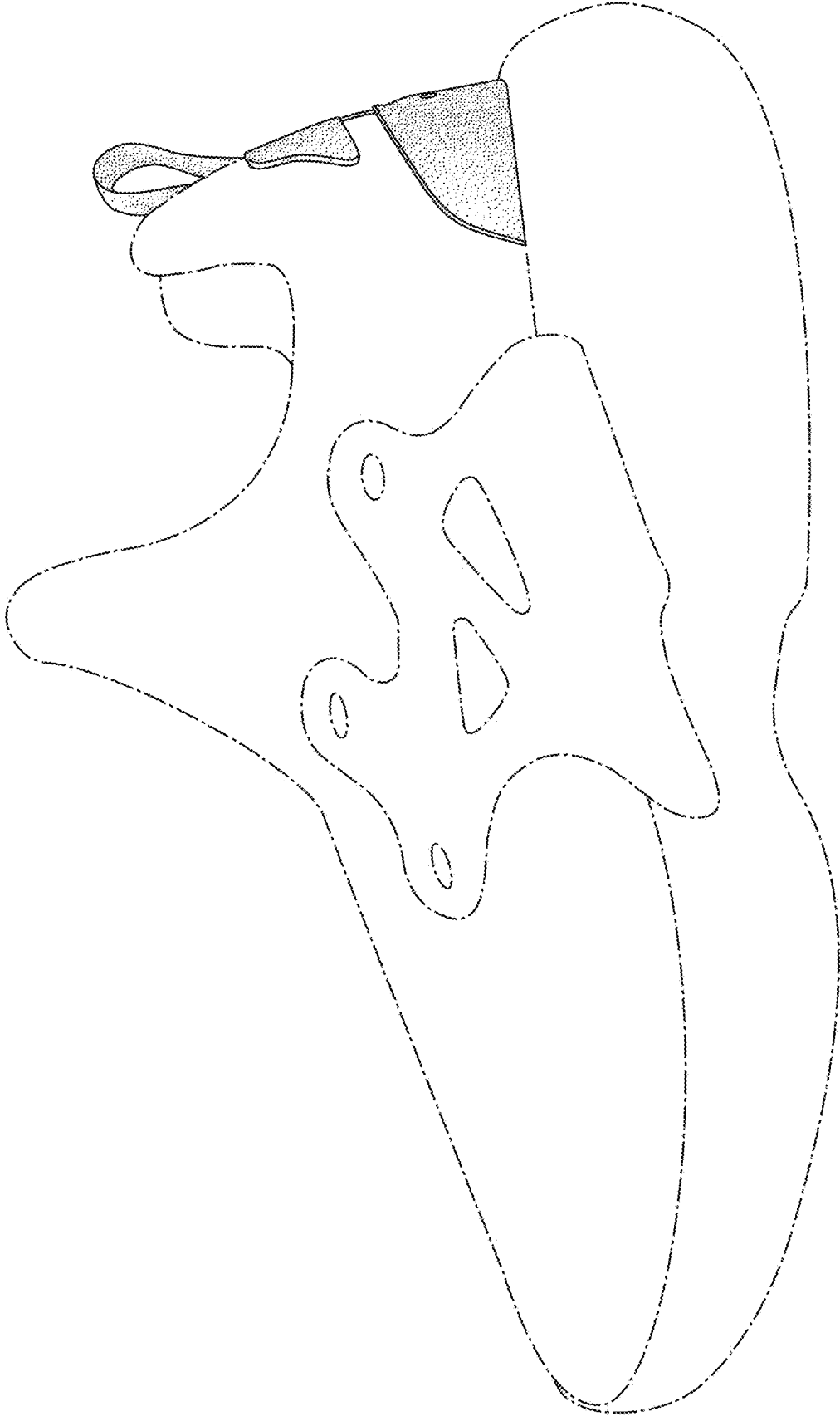

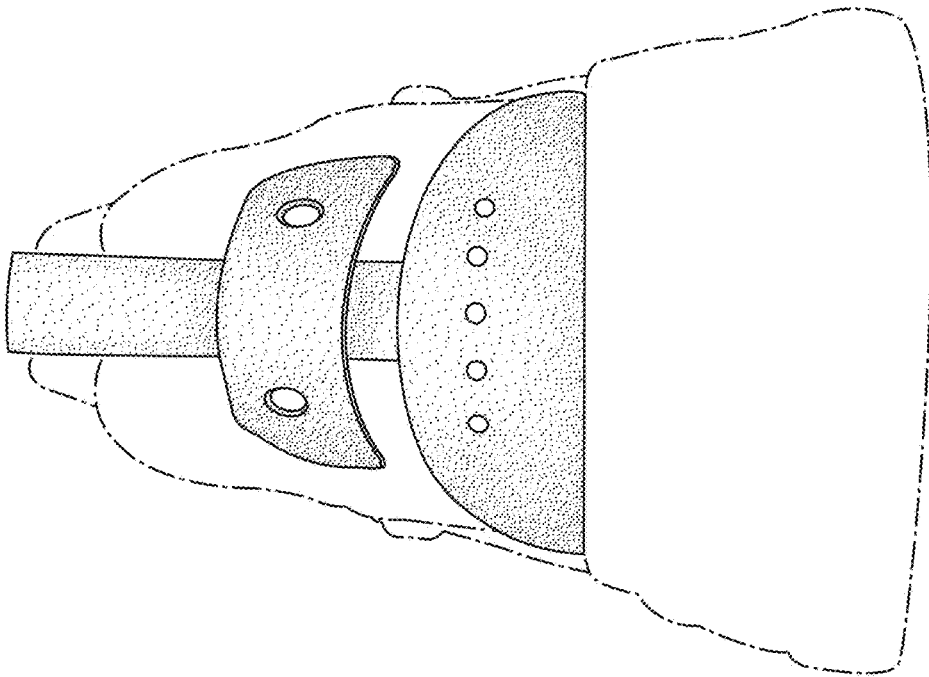

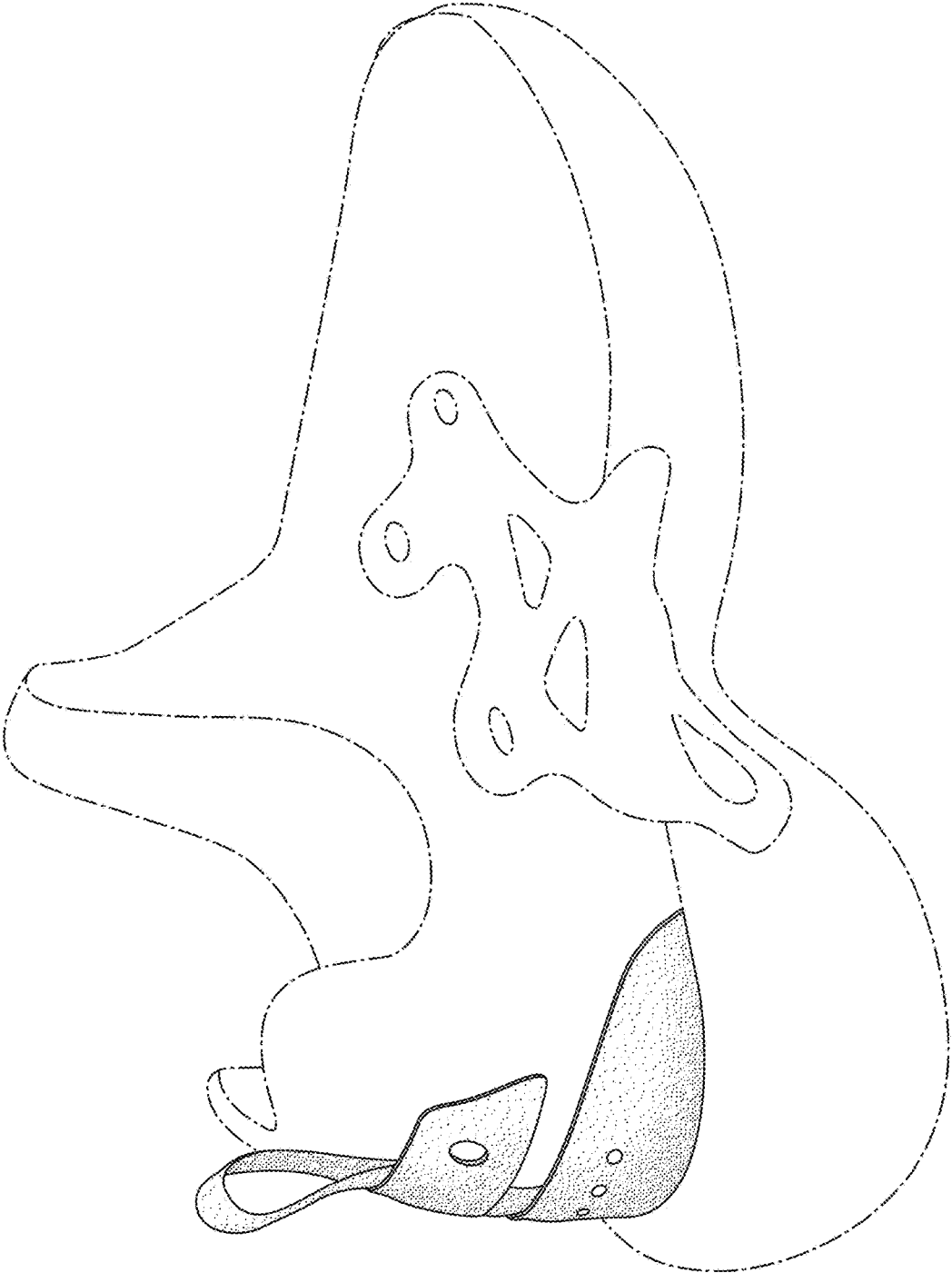

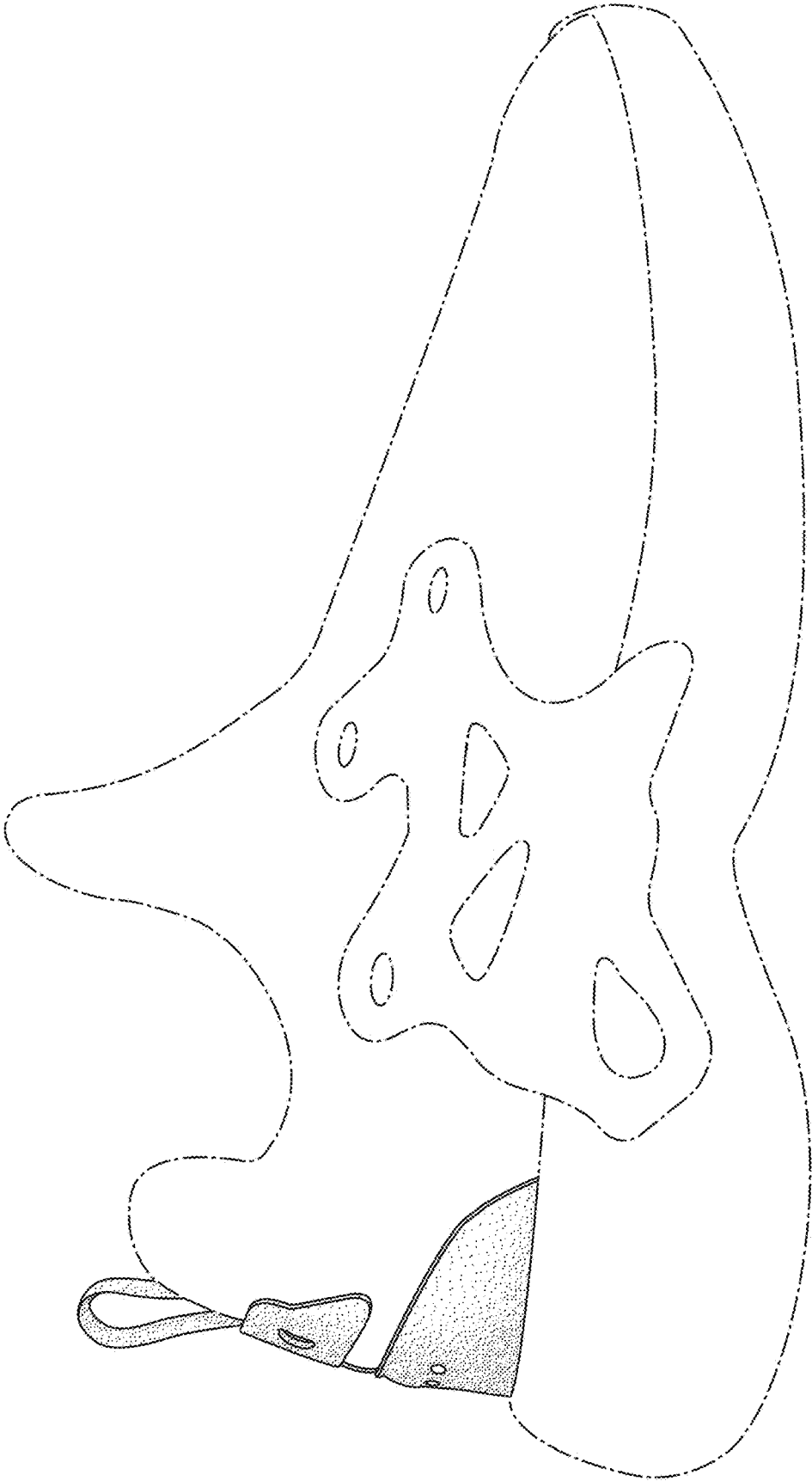
