(57) **CLAIM**

The ornamental design for an antiperspirant and/or deodorant product, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of an antiperspirant and/or deodorant product showing the new design;

FIG. 2 is a top plan view of the antiperspirant and/or deodorant product of FIG. 1;

FIG. 3 is a front elevation view of the antiperspirant and/or deodorant product of FIG. 1, the rear elevation view being a mirror image thereof;

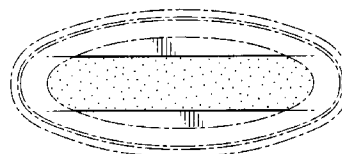
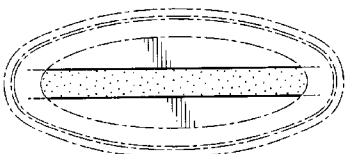
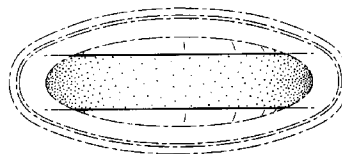
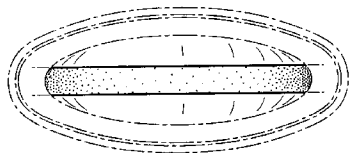


FIG. 4 is a side elevation view of the antiperspirant and/or deodorant product of FIG. 1, the other side elevation view being a mirror image thereof;

FIG. 5 is a perspective view of a second embodiment of the antiperspirant and/or deodorant product;

FIG. 6 is a top plan view of the antiperspirant and/or deodorant product of FIG. 5;

FIG. 7 is a perspective view of a third embodiment of the antiperspirant and/or deodorant product of FIG. 1;

FIG. 8 is a top plan view of the antiperspirant and/or deodorant product of FIG. 9;

FIG. 9 is a front elevation view of the antiperspirant and/or deodorant product of FIG. 7, the rear elevation view being a mirror image thereof;

FIG. 10 is a side elevation view of the antiperspirant and/or deodorant product of FIG. 7, the other side elevation view being a mirror image thereof;

FIG. 11 is a perspective view of a fourth embodiment of the antiperspirant and/or deodorant product;

FIG. 12 is a top plan view of the antiperspirant and/or deodorant product of FIG. 11;

FIG. 13 is a perspective view of a fifth embodiment of the antiperspirant and/or deodorant product;

FIG. 14 is a top plan view of the antiperspirant and/or deodorant product of FIG. 13;

FIG. 15 is a front elevation view of the antiperspirant and/or deodorant product of FIG. 13, the rear elevation view being a mirror image thereof;

FIG. 16 is a side elevation view of the antiperspirant and/or deodorant product of FIG. 13, the other side elevation view being a mirror image thereof.

FIG. 17 is a perspective view of a sixth embodiment of the antiperspirant and/or deodorant product; and,

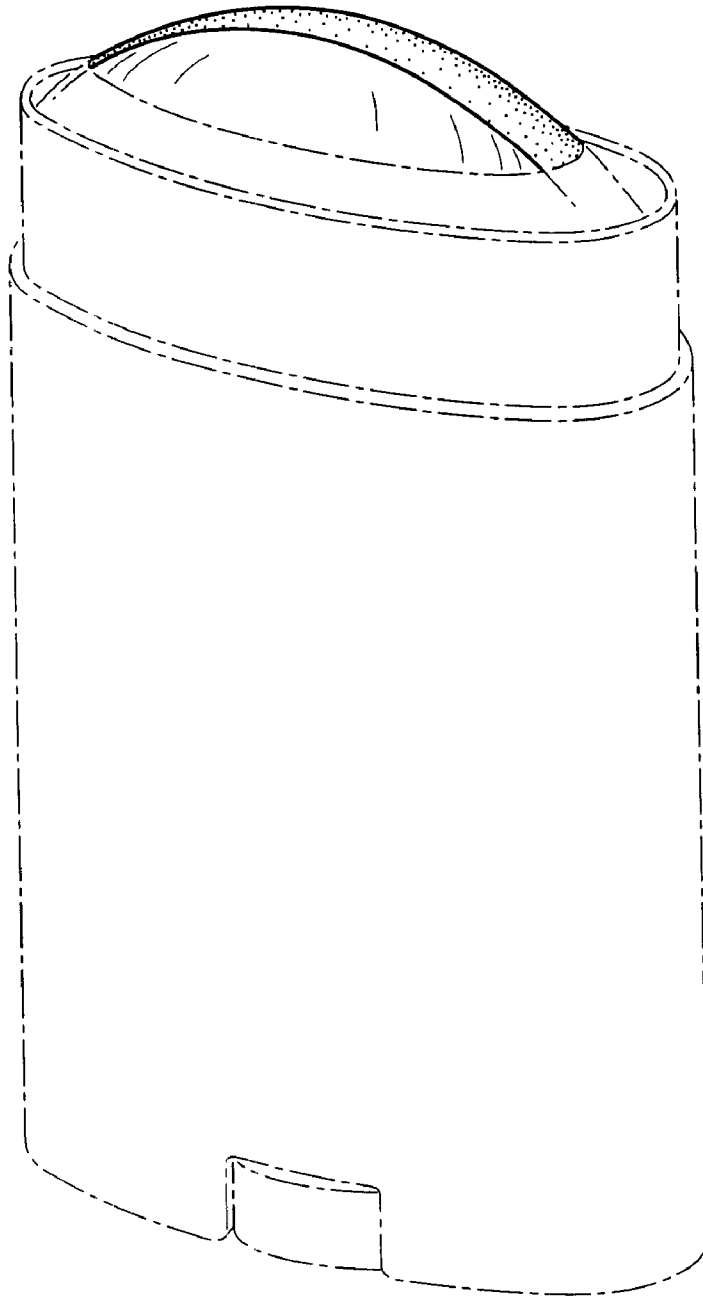
FIG. 18 is a top plan view of the antiperspirant and/or deodorant product of FIG. 17.

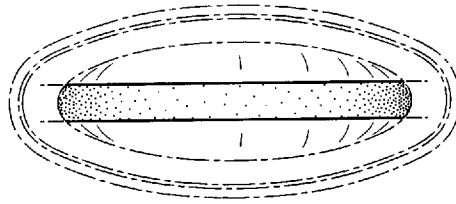
The stippling represents a surface having a color that contrasts with the color of the surface that does not include stippling.

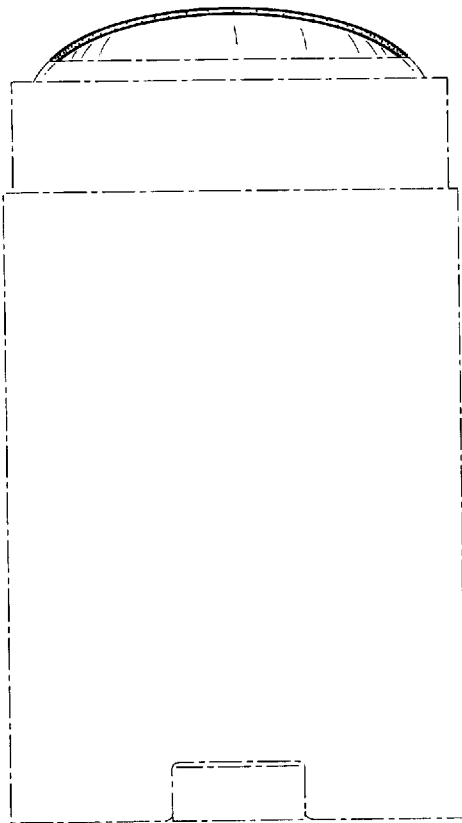

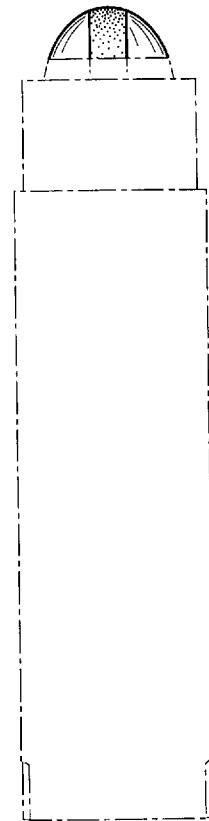

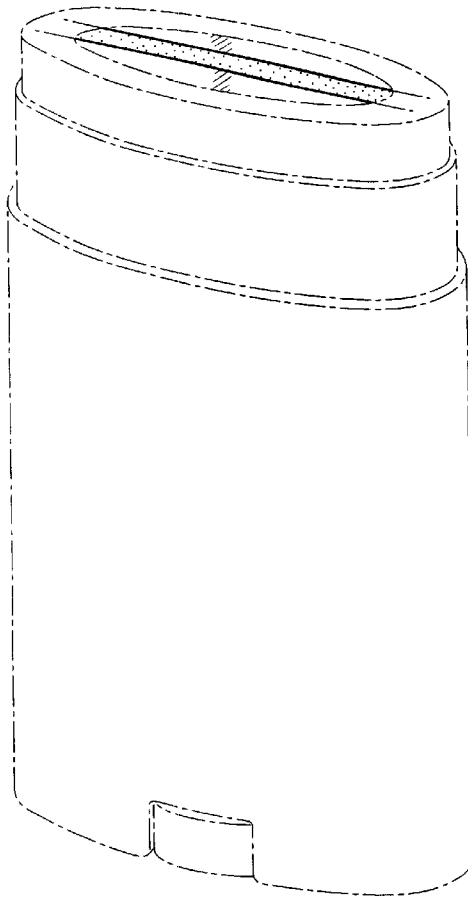

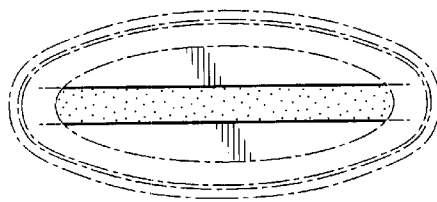

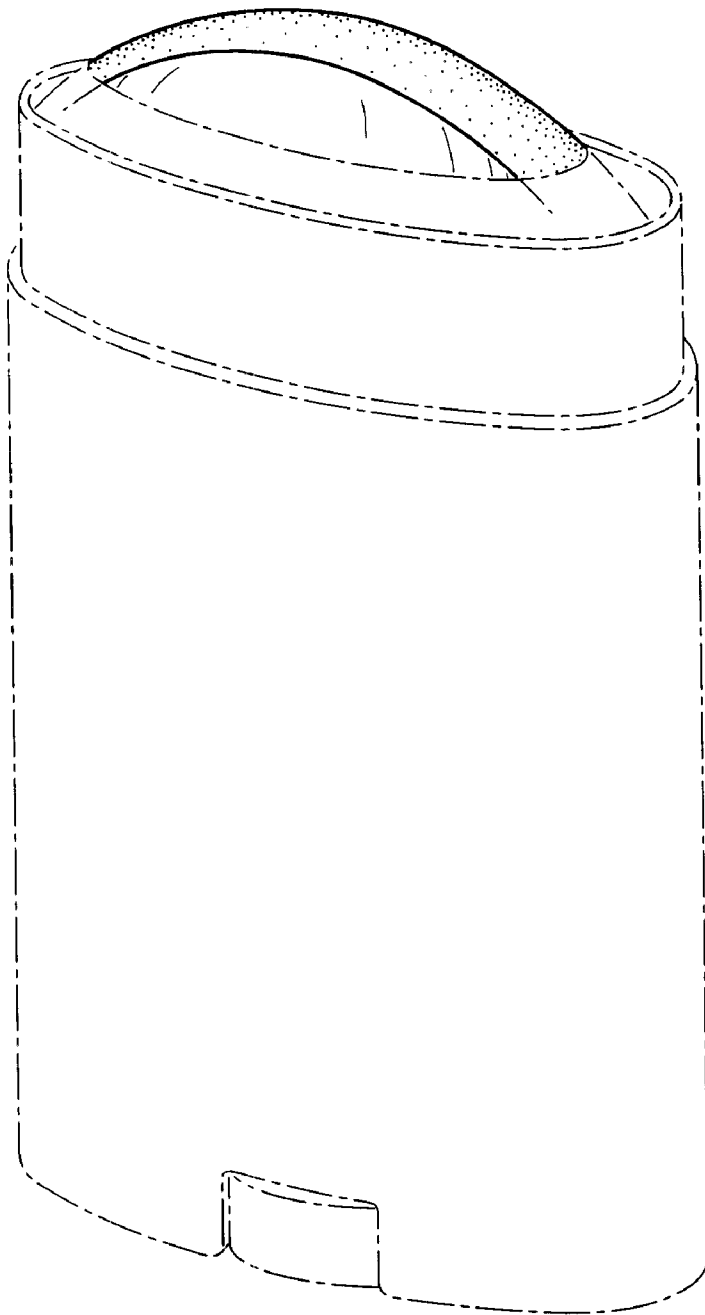

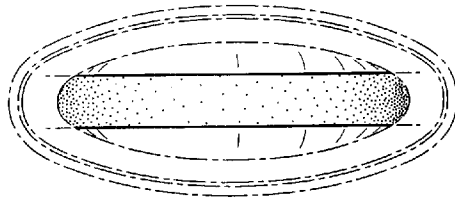

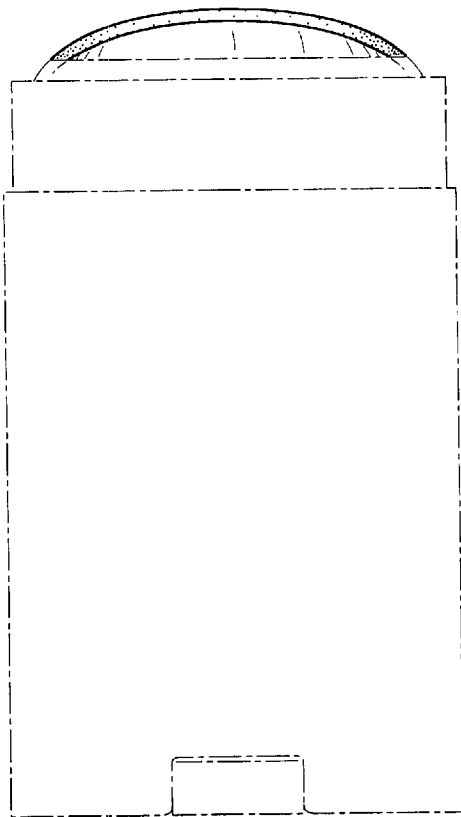

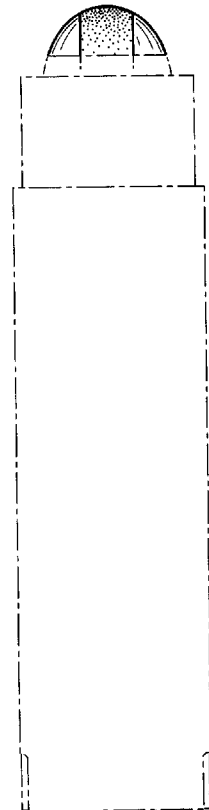

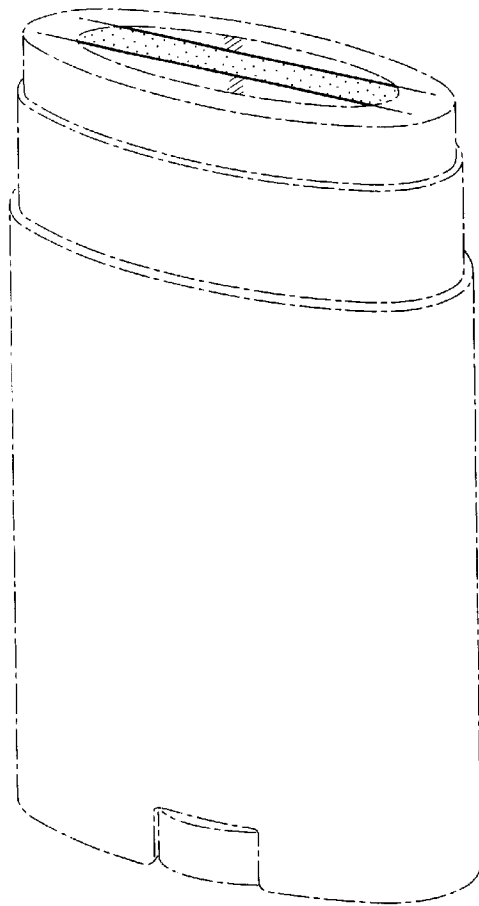

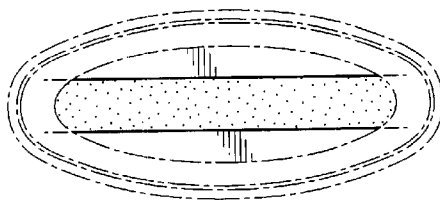

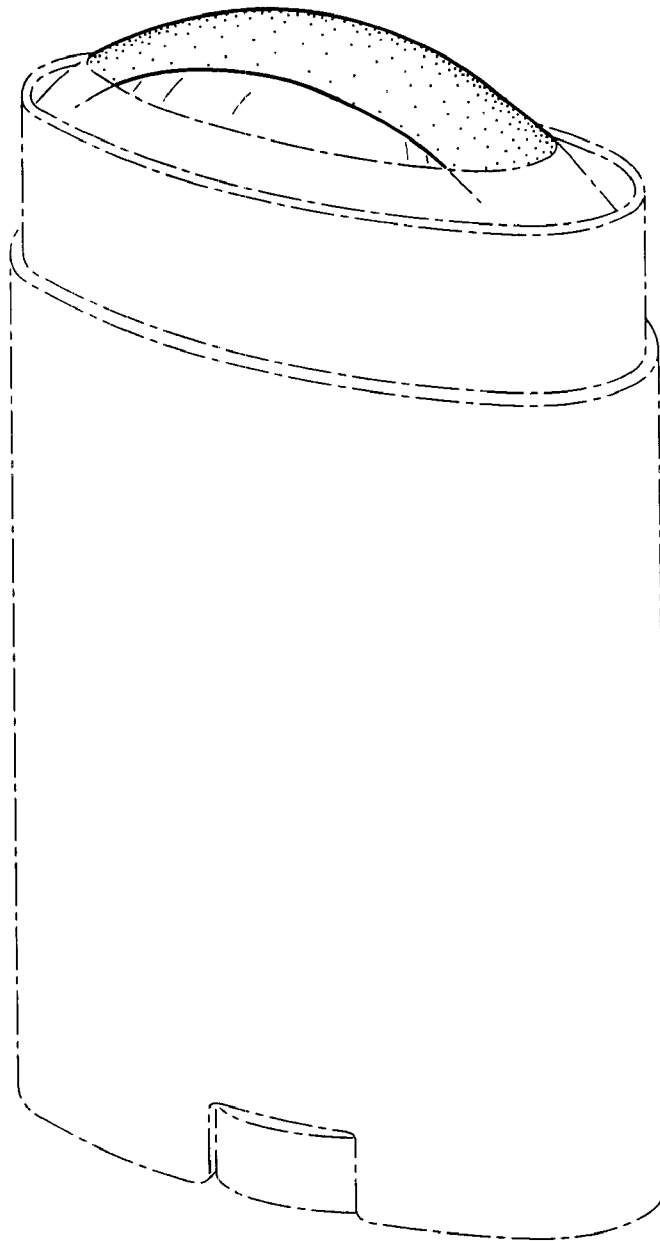

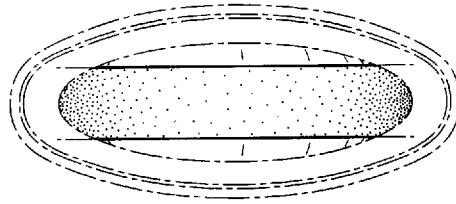




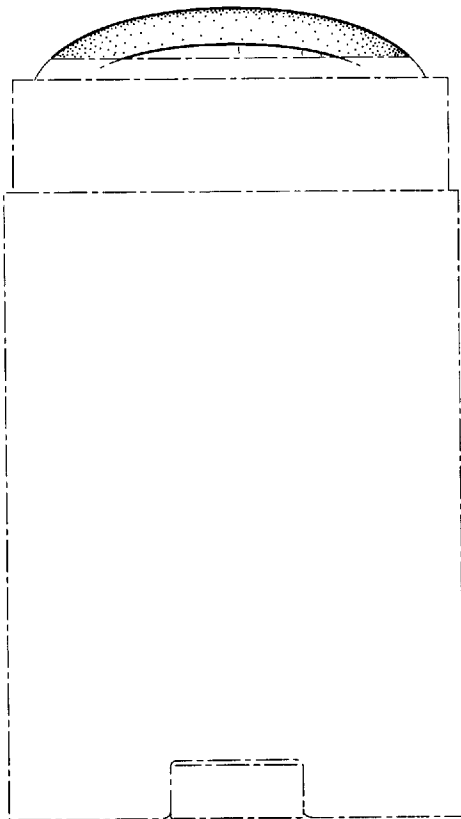

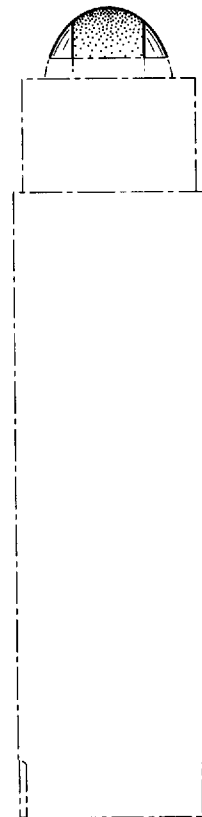

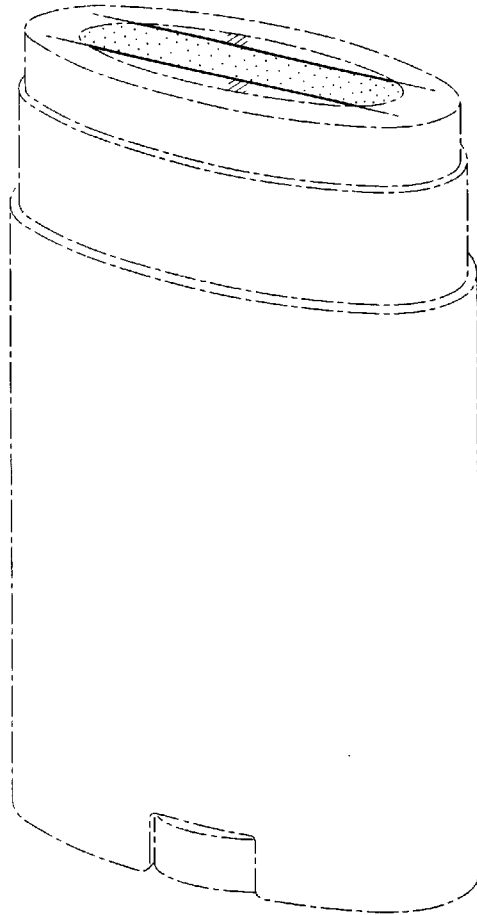
