**DESCRIPTION**

1. Massage device

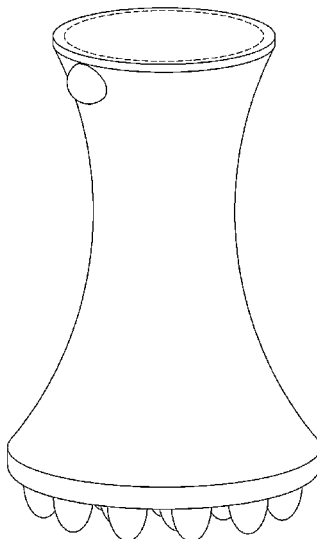

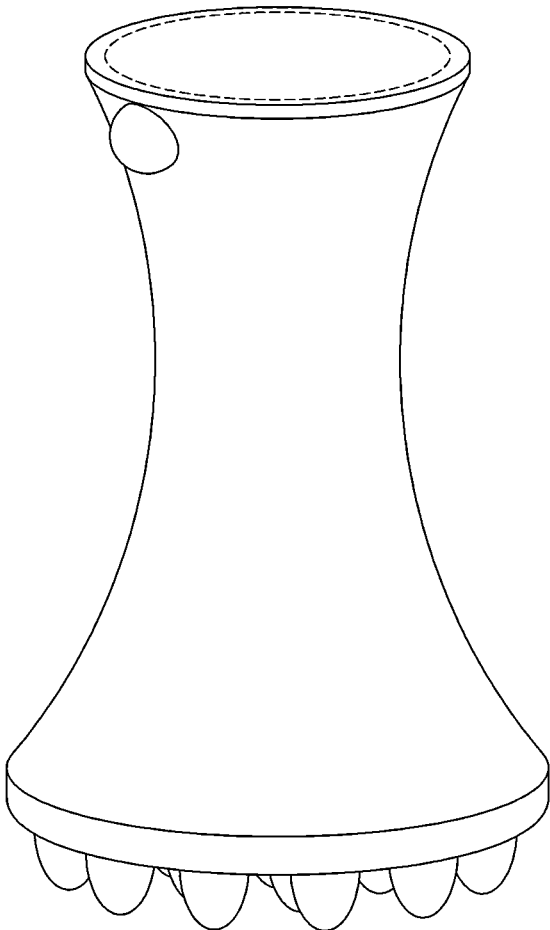

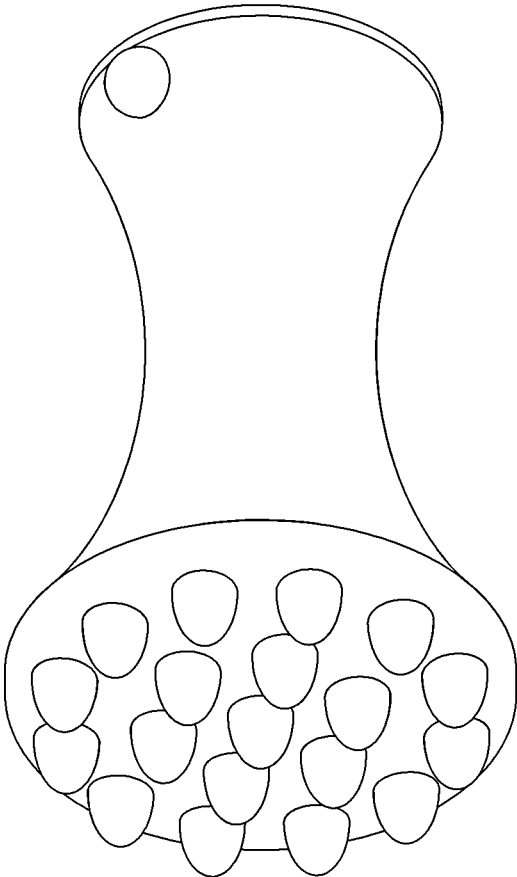

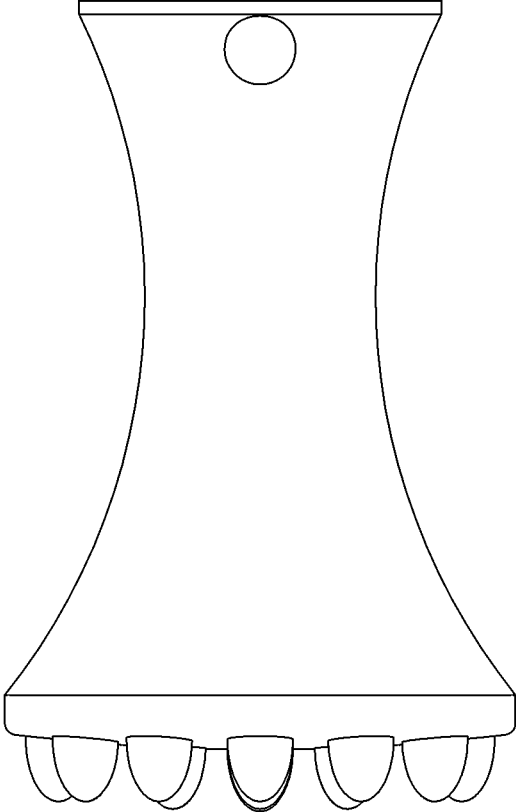

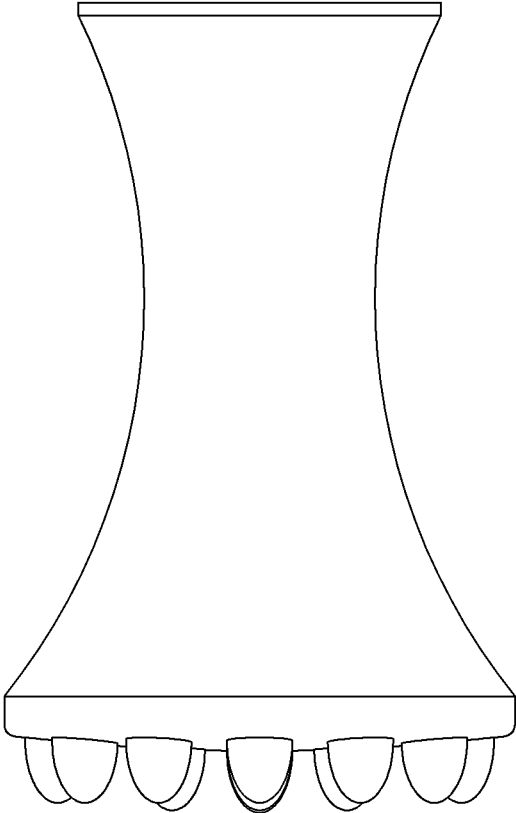

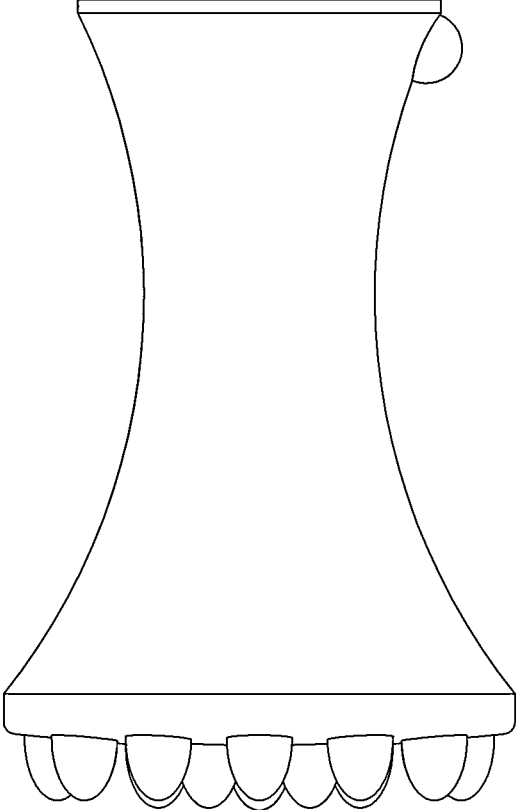

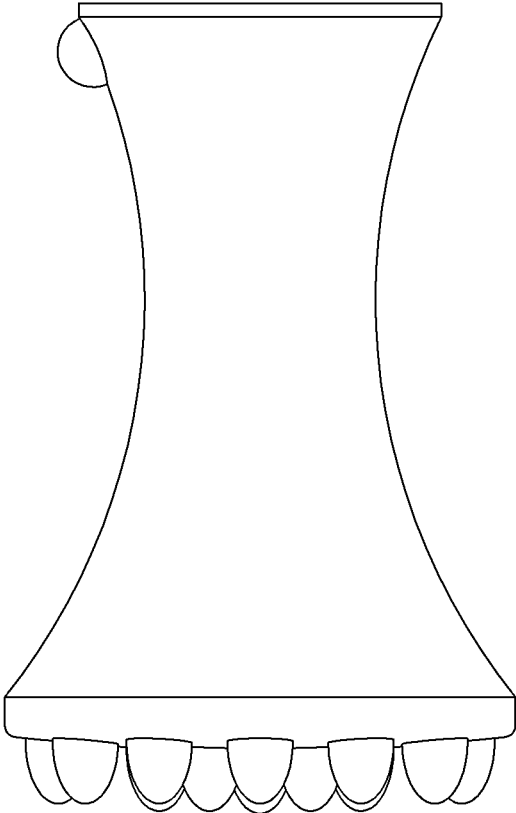

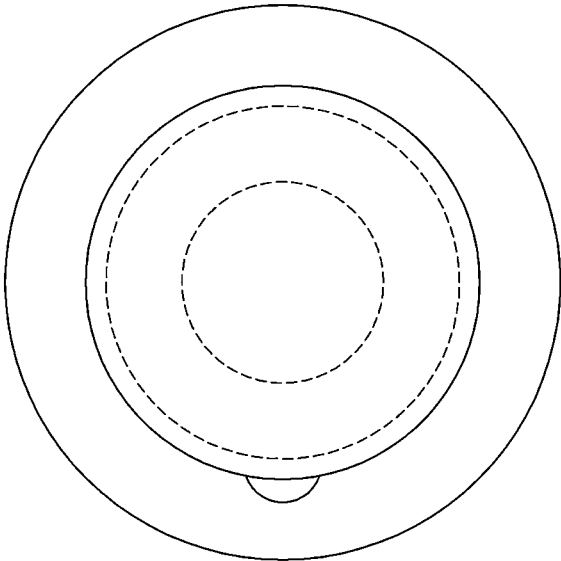
