The ornamental design for a substrate with camouflage pattern, as shown and described.

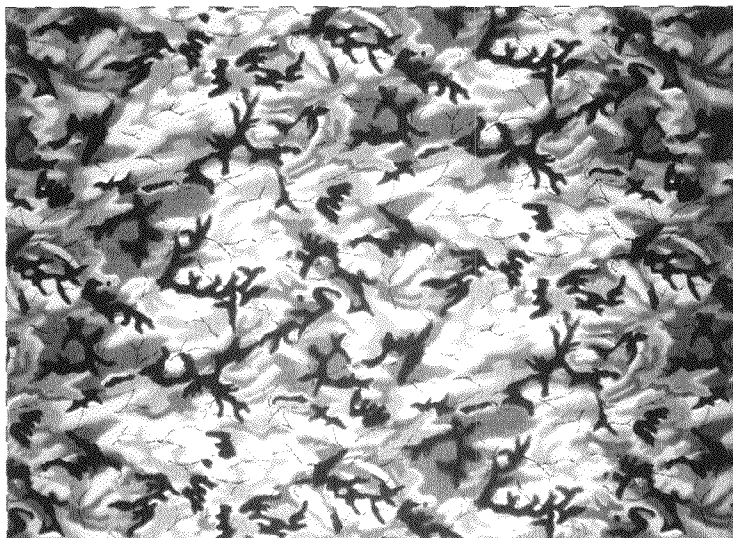
DESCRIPTION
