DESCRIPTION

FIG. 1 is a front view of a roller for cosmetic purposes showing my new design;
FIG. 2 is a rear view thereof;

FIG. 4 is an enlarged bottom plan view thereof;

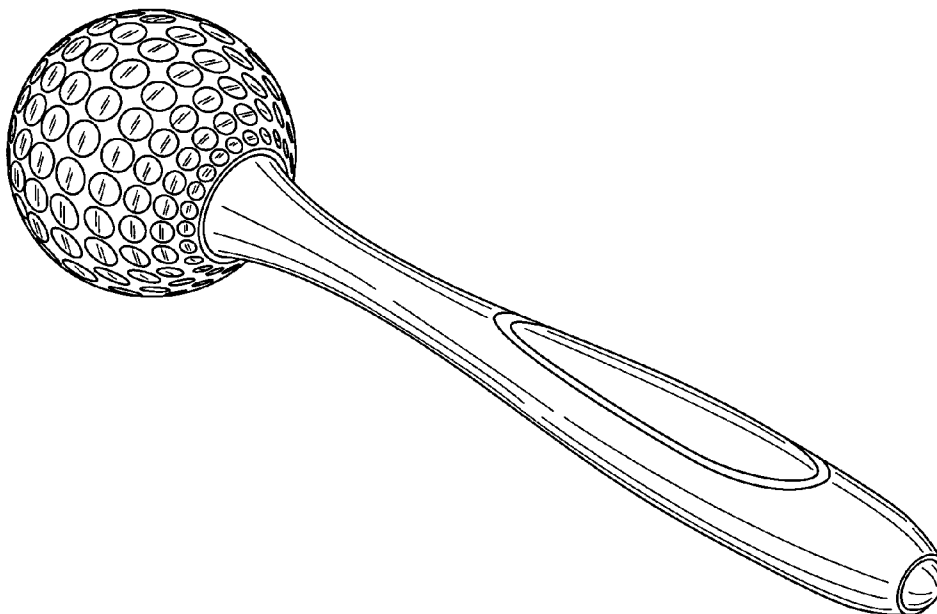

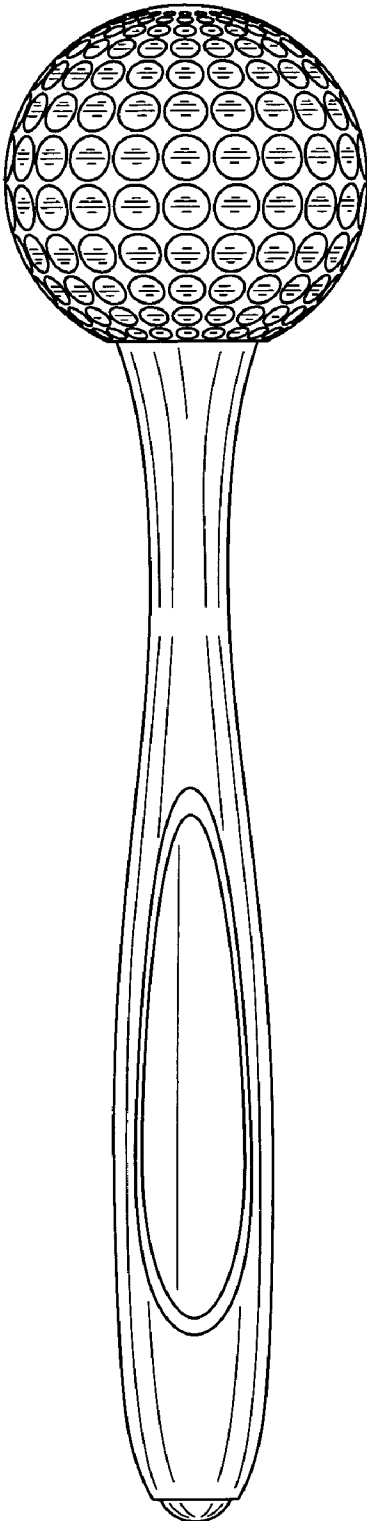

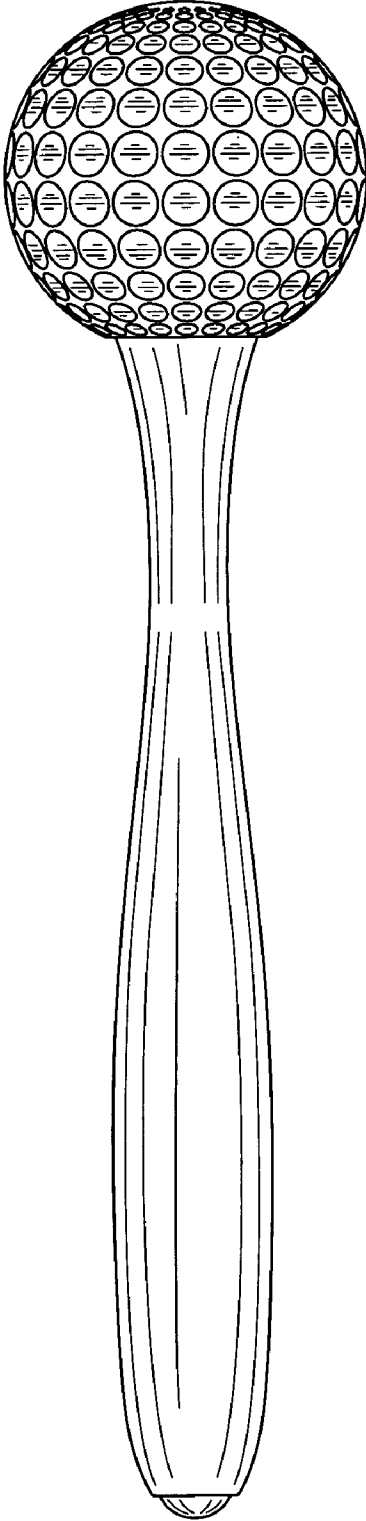

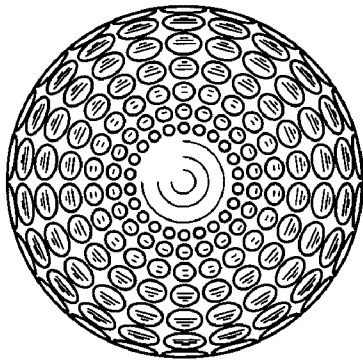

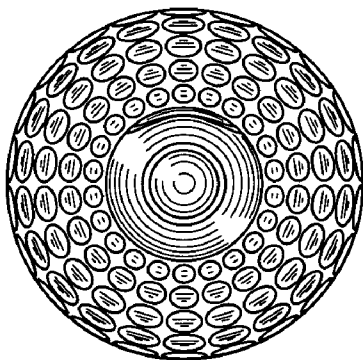

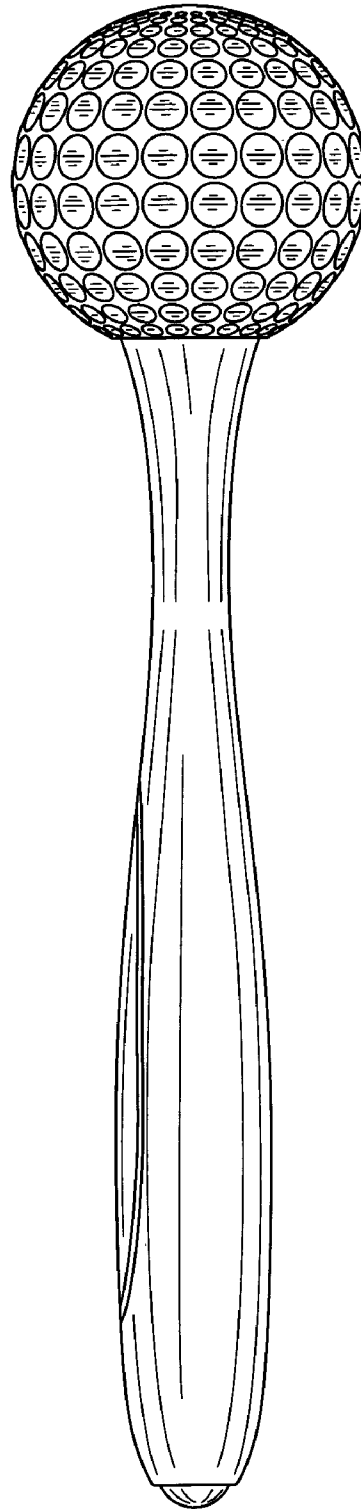
