The ornamental design for a portion of a vehicle front bumper, as shown and described.

**DESCRIPTION**

FIG. 3 is a top plan view thereof;

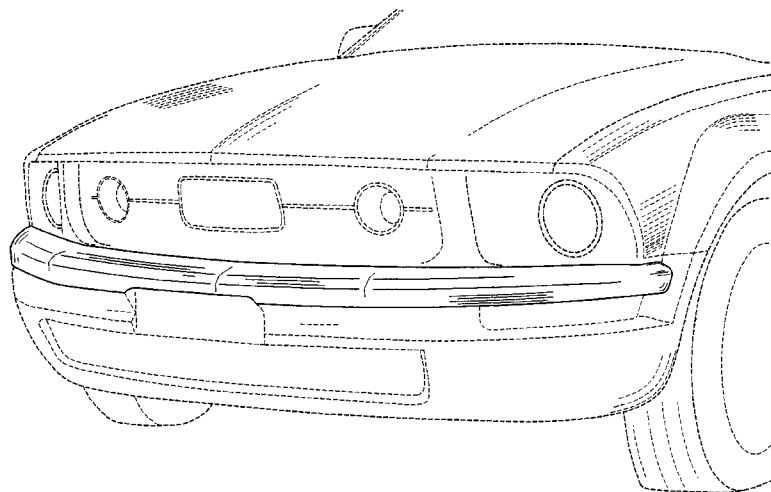
FIG. 4 is a front elevational view thereof;

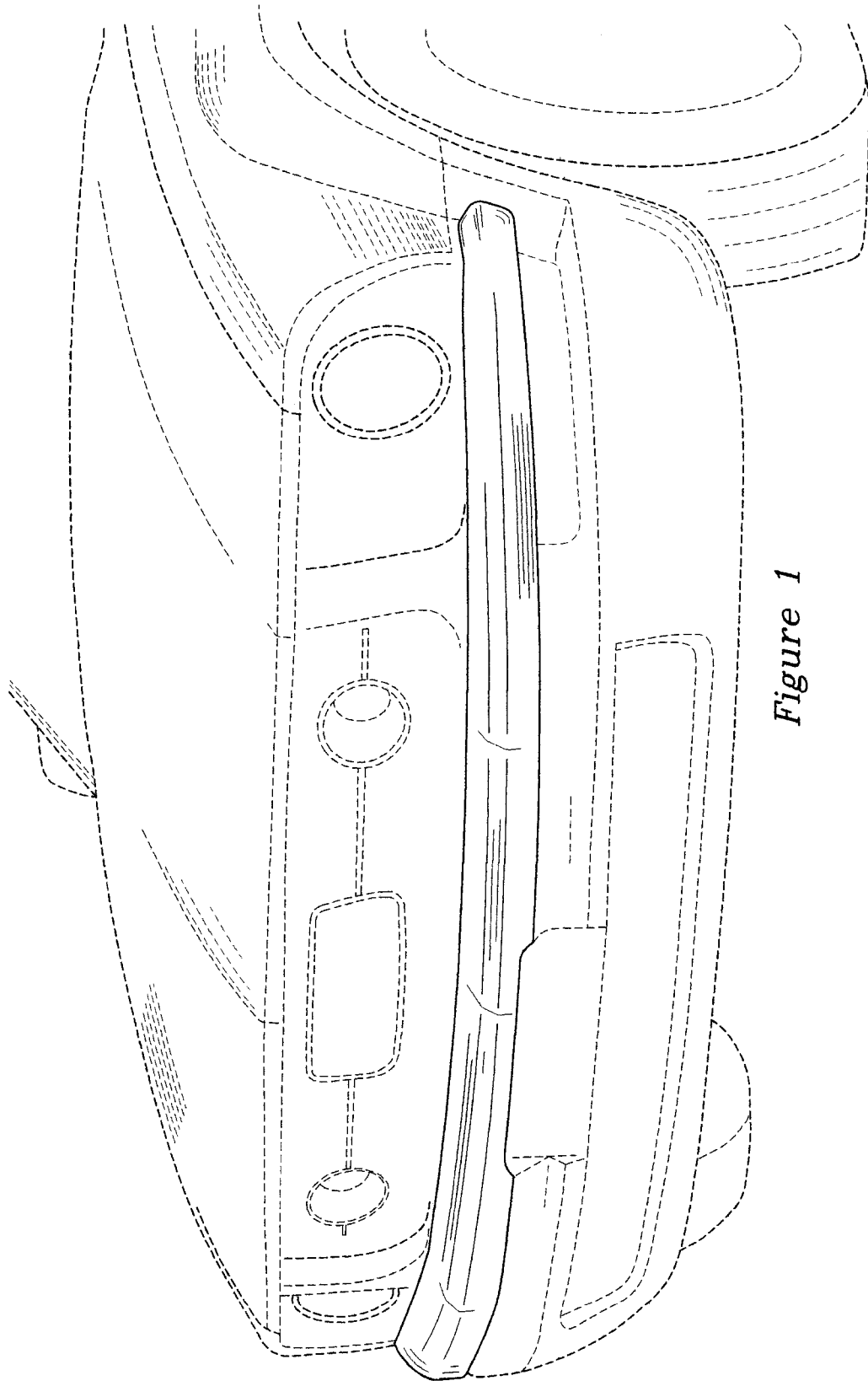
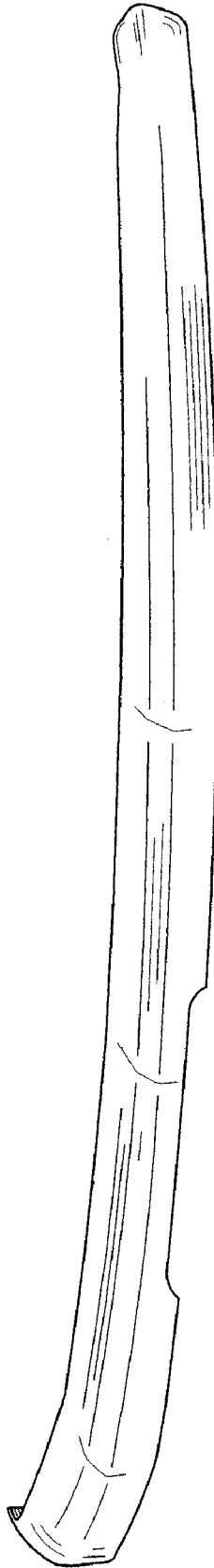

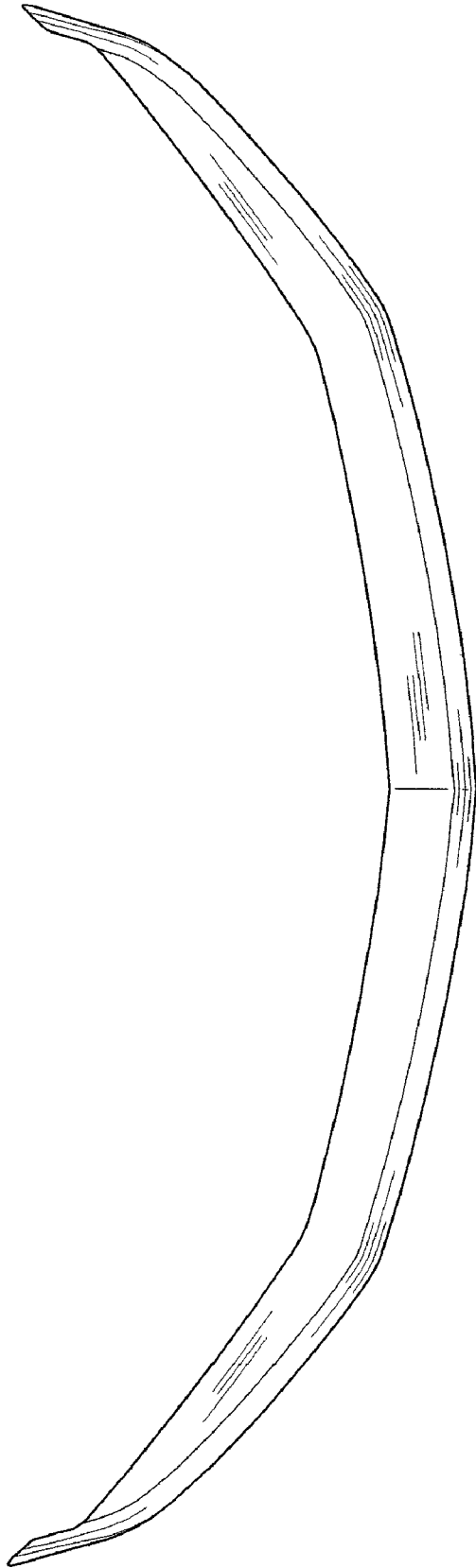
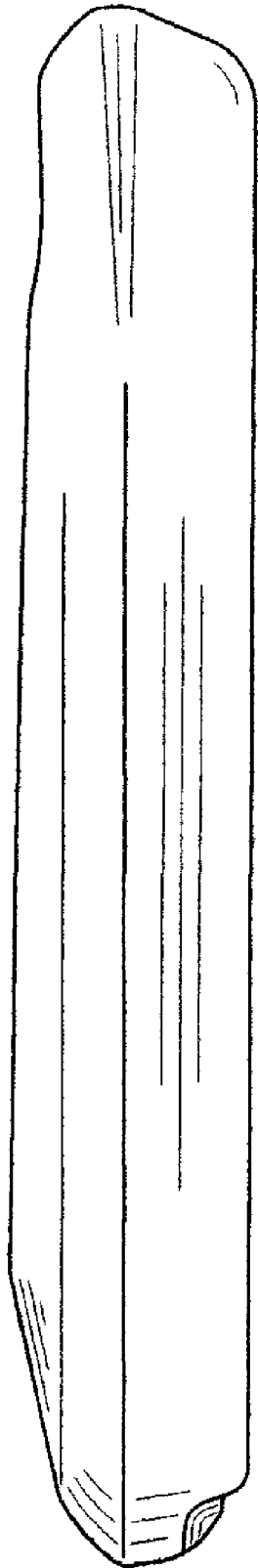

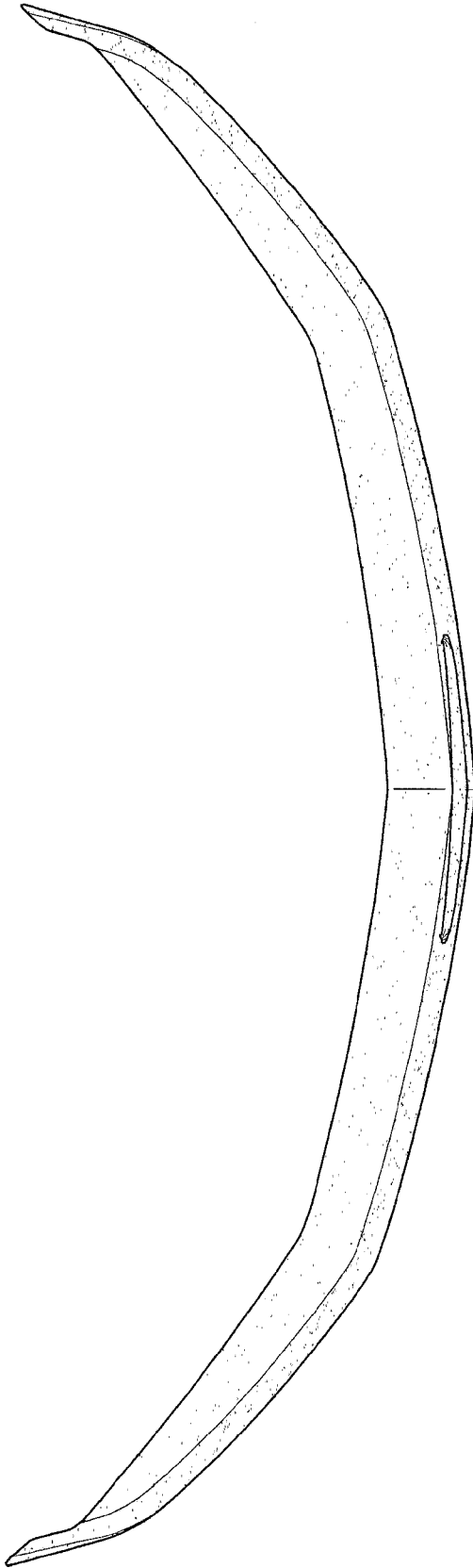

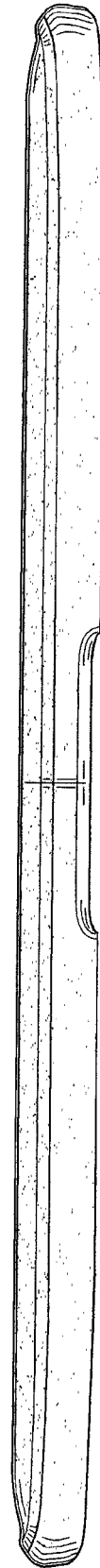
