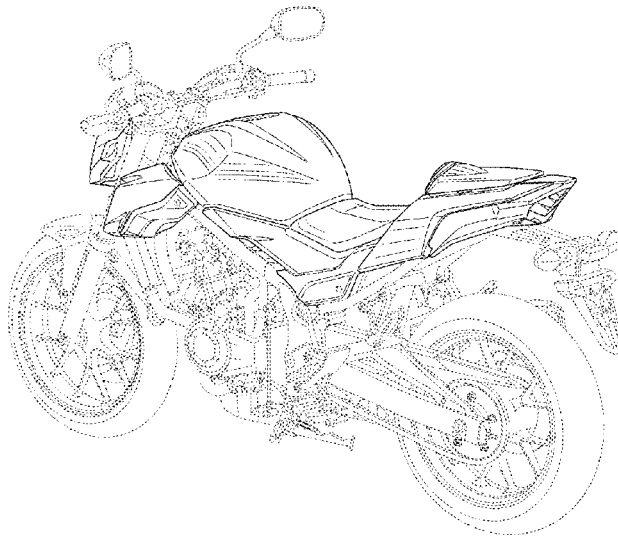
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a front elevation view of a motorcycle and/or replica thereof showing our new design;

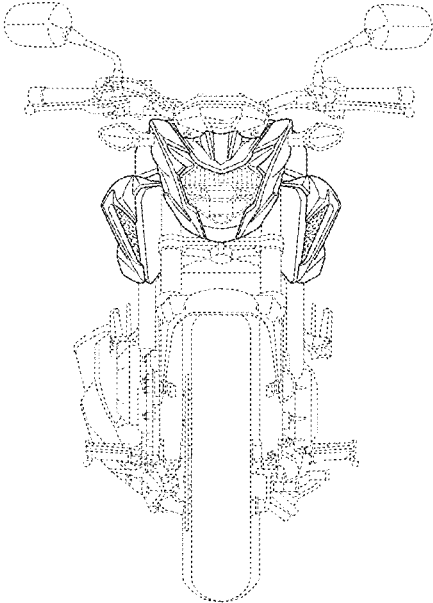

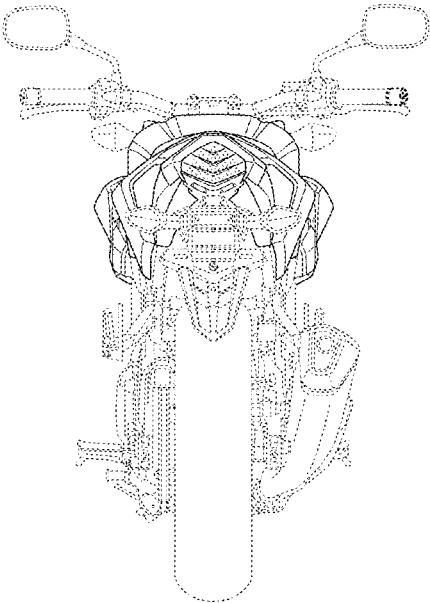

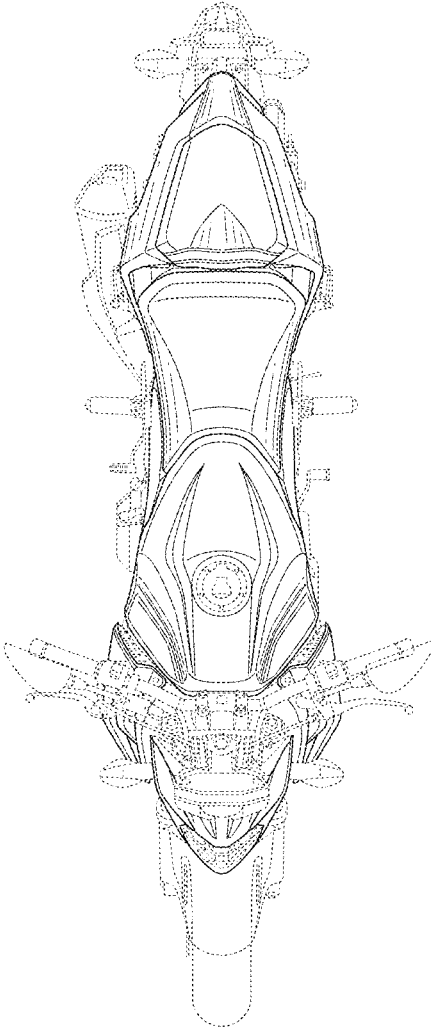

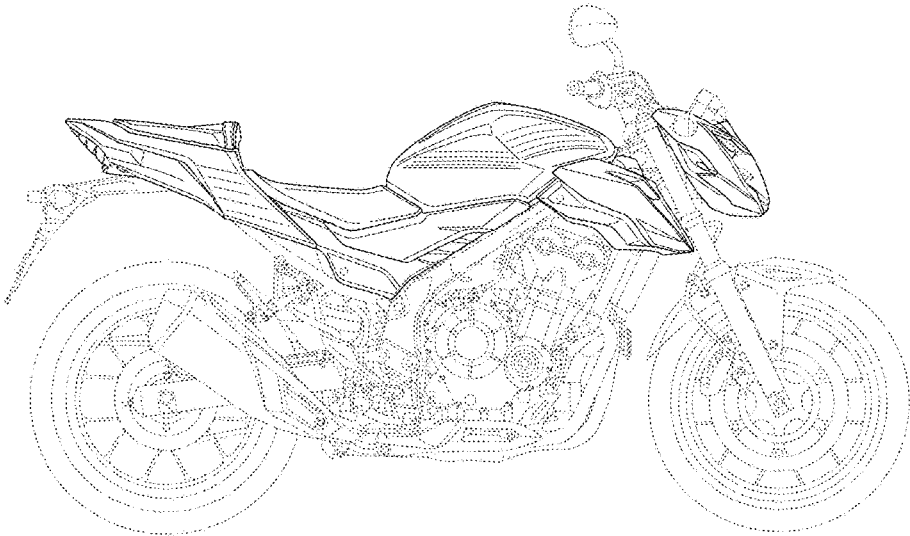

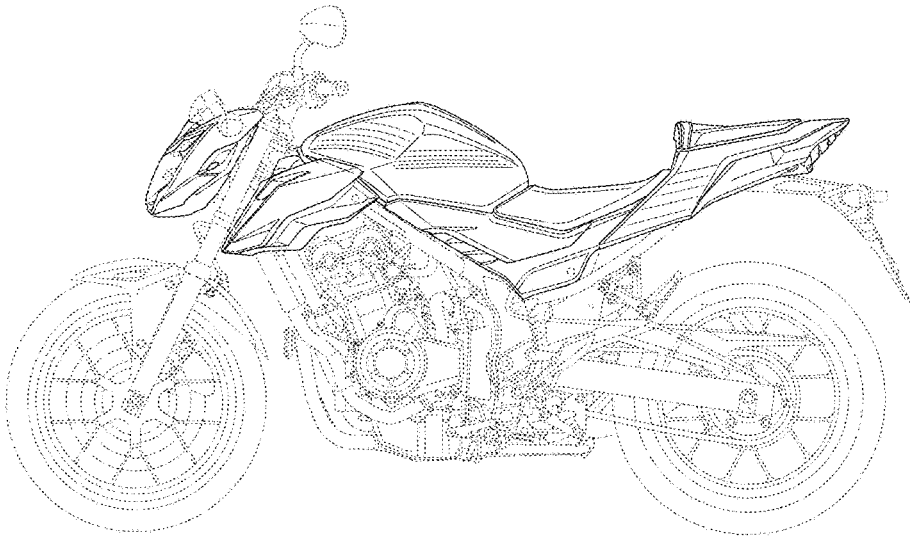

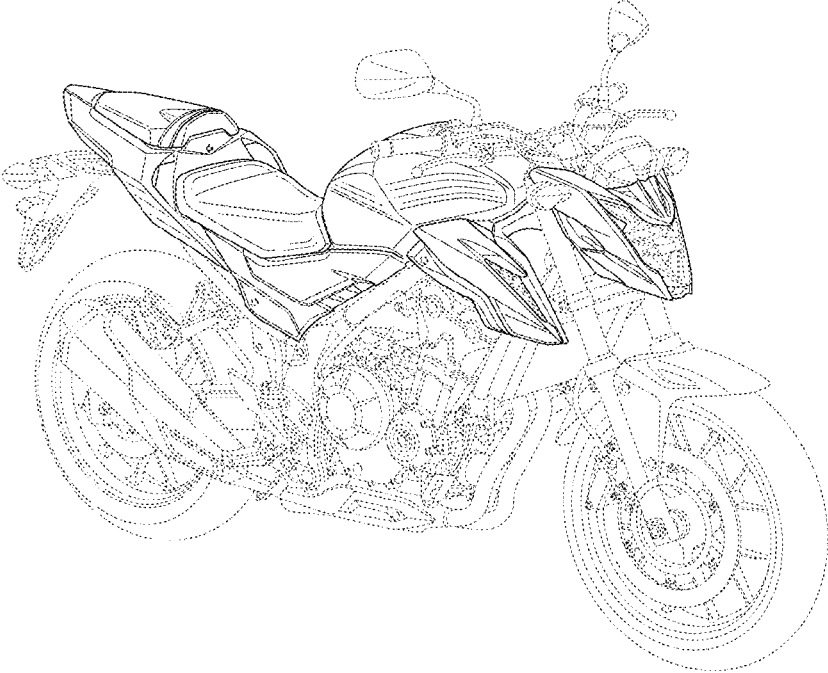

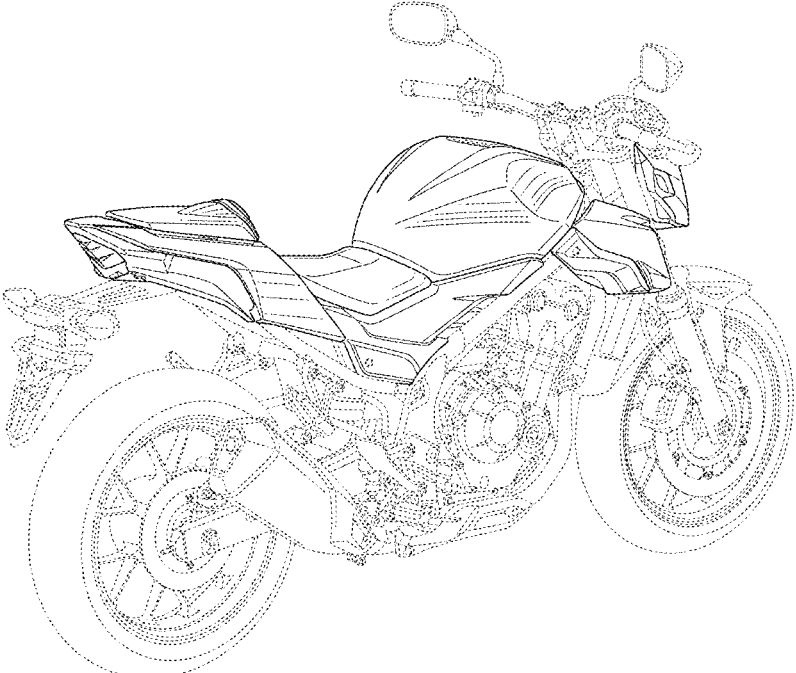

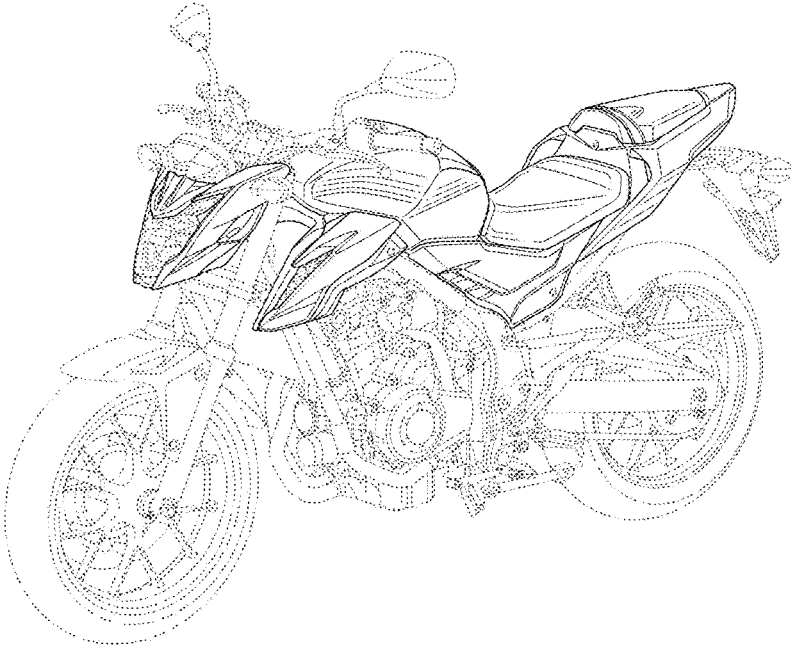
