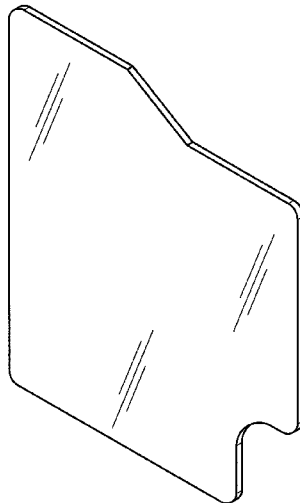
(57) **CLAIM**

I claim, the ornamental design for a driver shield main panel, as shown and described.

DESCRIPTION

FIG. 1 is a perspective front view of a main panel for a driver shield, showing my new design;
 FIG. 2 is a top elevation view thereof;
 FIG. 3 is a front elevation view of the main panel, with the back elevation view being a mirror image of the front elevation view;
 FIG. 4 is a bottom view thereof;
 FIG. 5 is a left elevation view thereof; and,
 FIG. 6 is a right elevation view thereof.

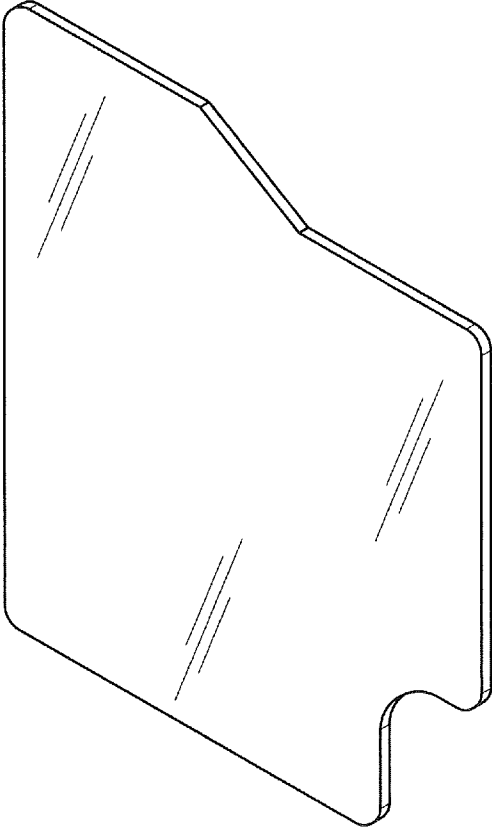

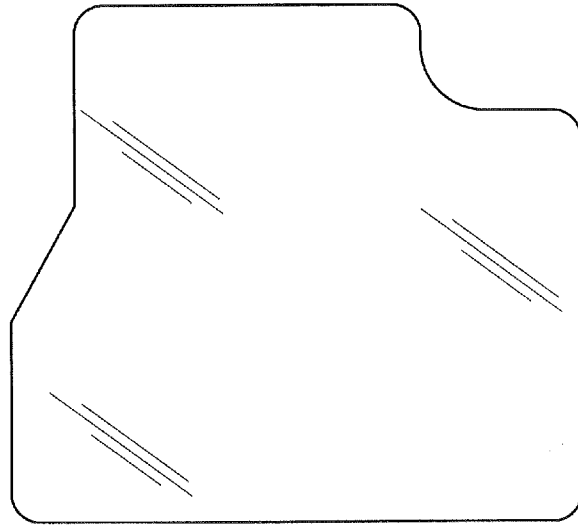
