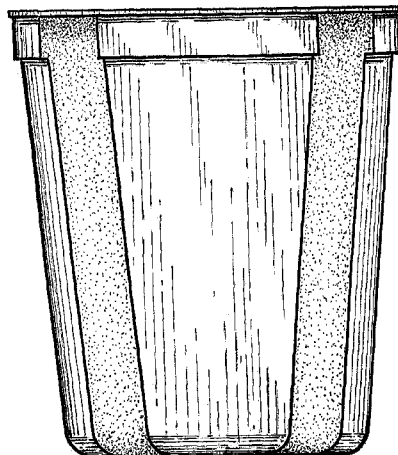
(57) **CLAIM**

I claim the ornamental design of nestable containers, as shown.

DESCRIPTION

FIG. 1 is a side elevational view of a nestable container; FIG. 2 is a top plan view of the embodiment of FIG. 1; FIG. 3 is a bottom plan view of the embodiment of FIG. 1; FIG. 4 is a perspective view of the embodiment of FIG. 1; FIG. 5 is an elevational view of another embodiment of a nestable container; FIG. 6 is a top plan view of the embodiment of FIG. 5; FIG. 7 is a bottom plan view of the embodiment of FIG. 5; and, FIG. 8 is a perspective view of the embodiment of FIG. 5.

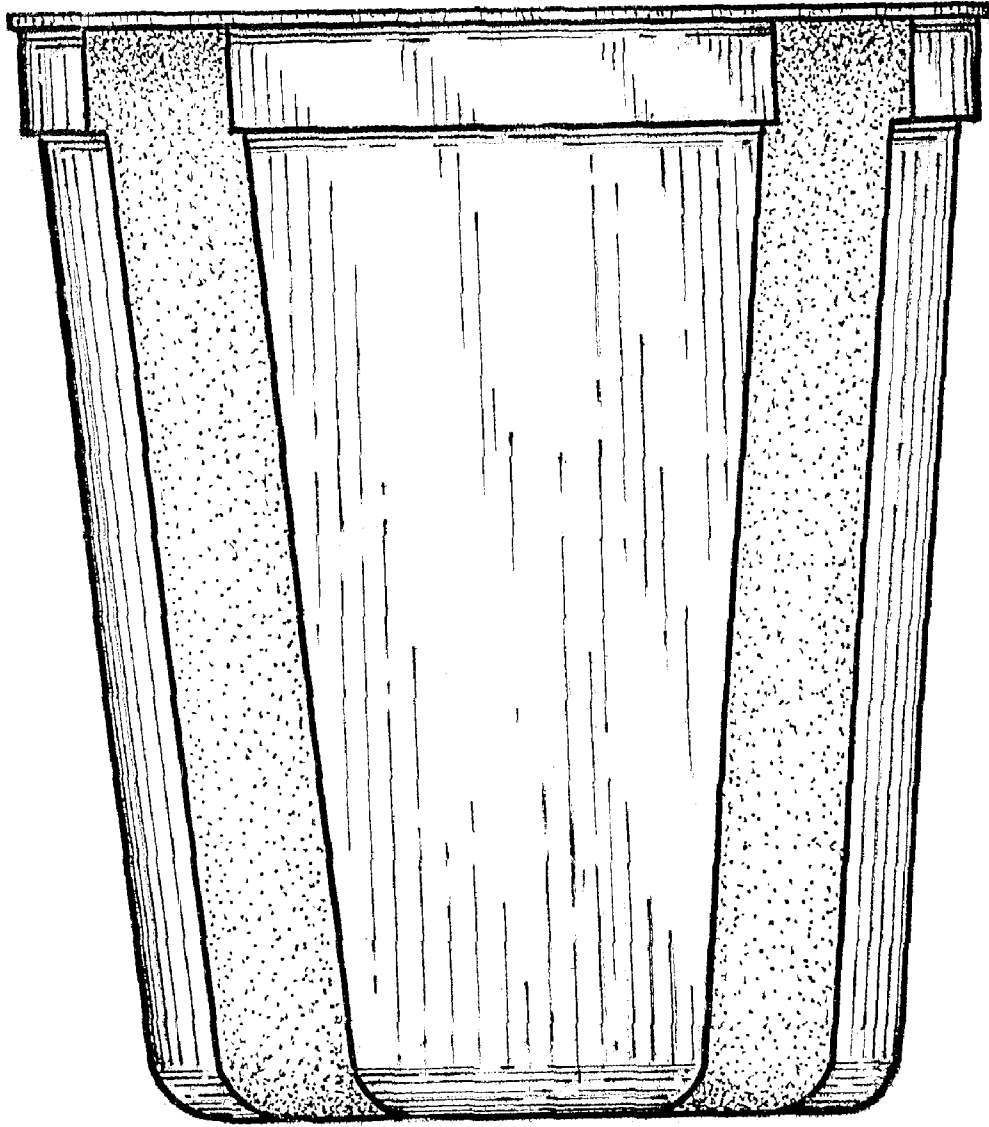

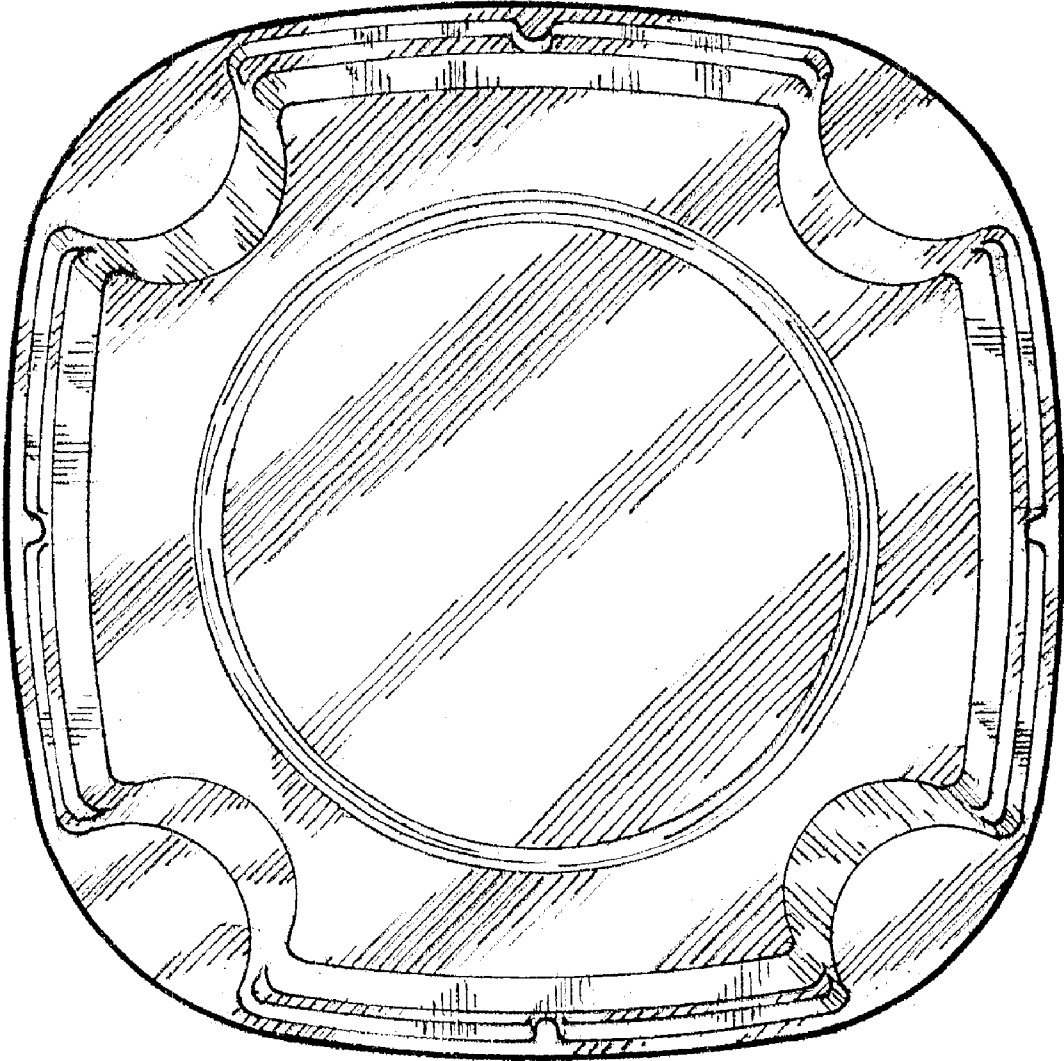

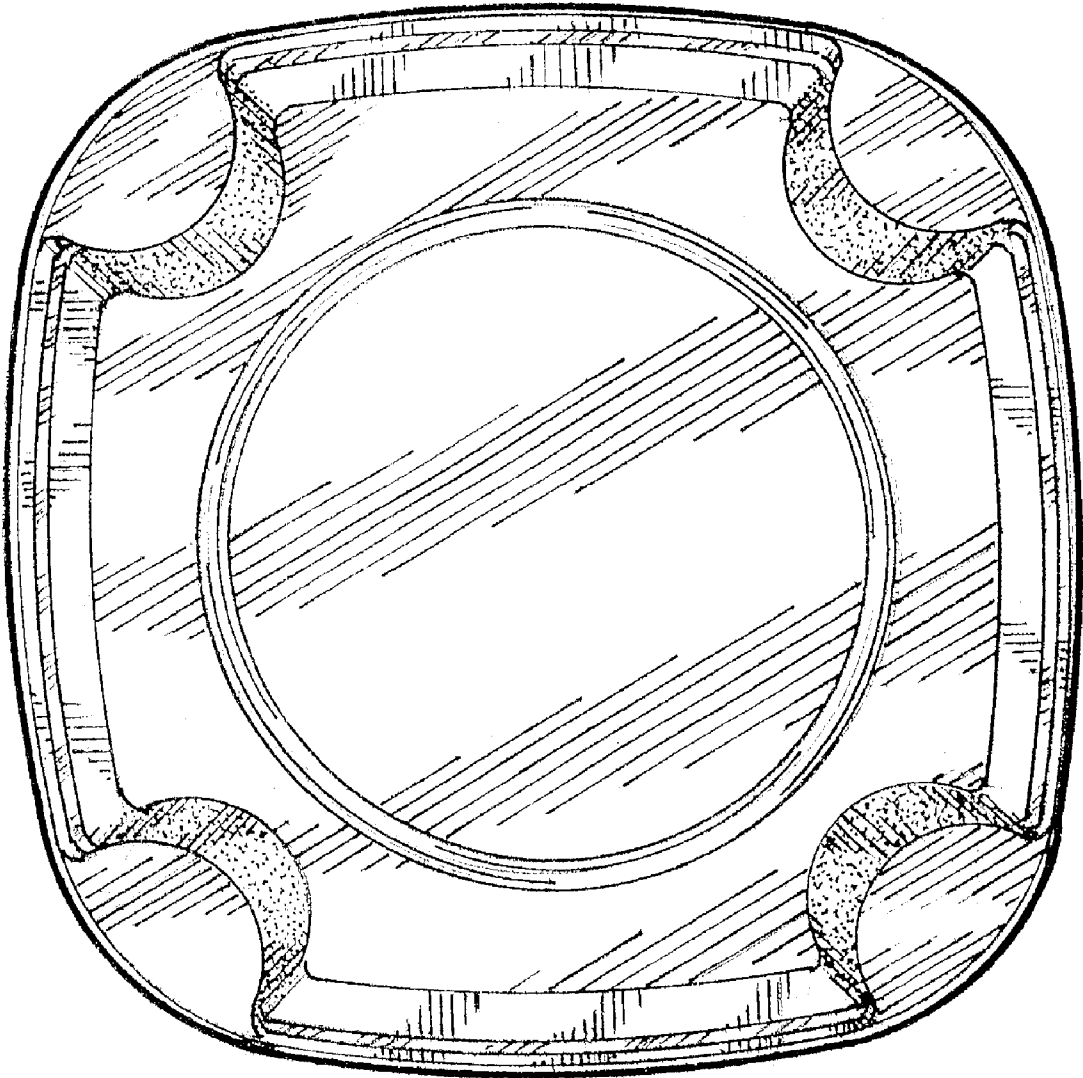

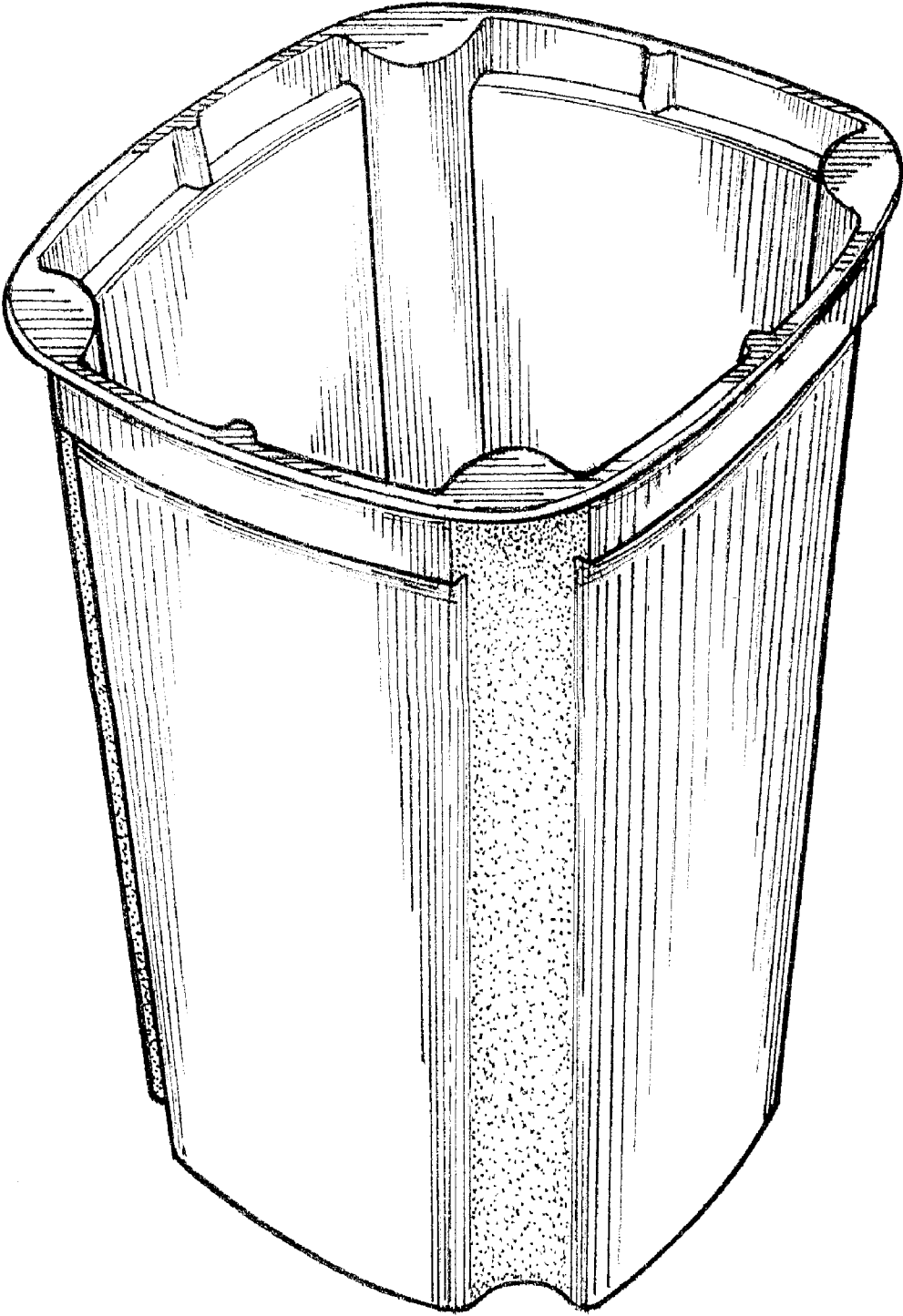

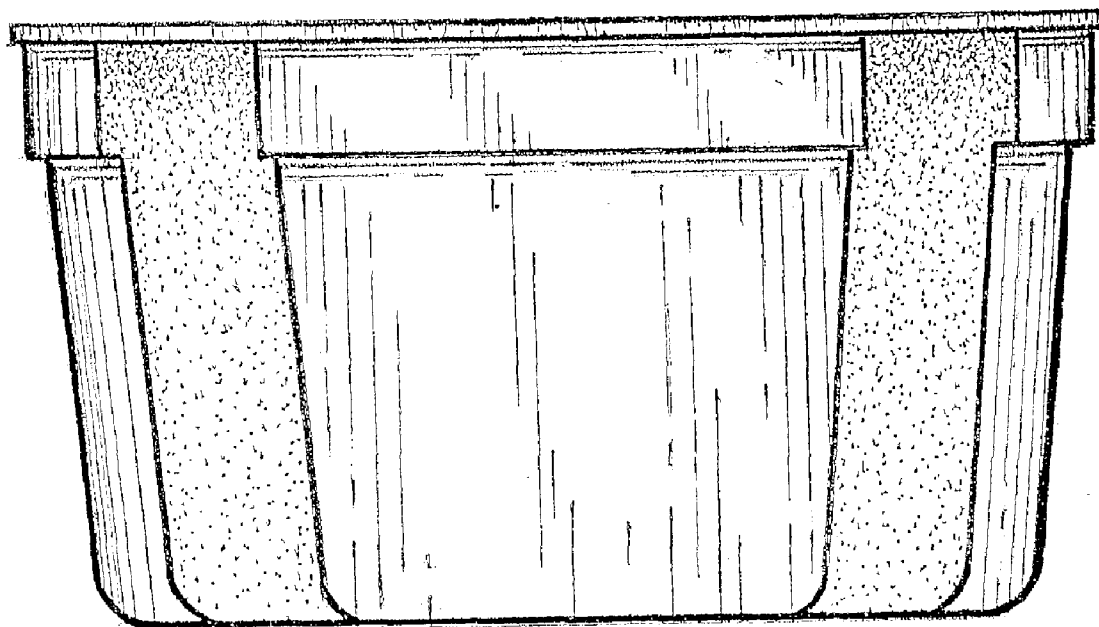

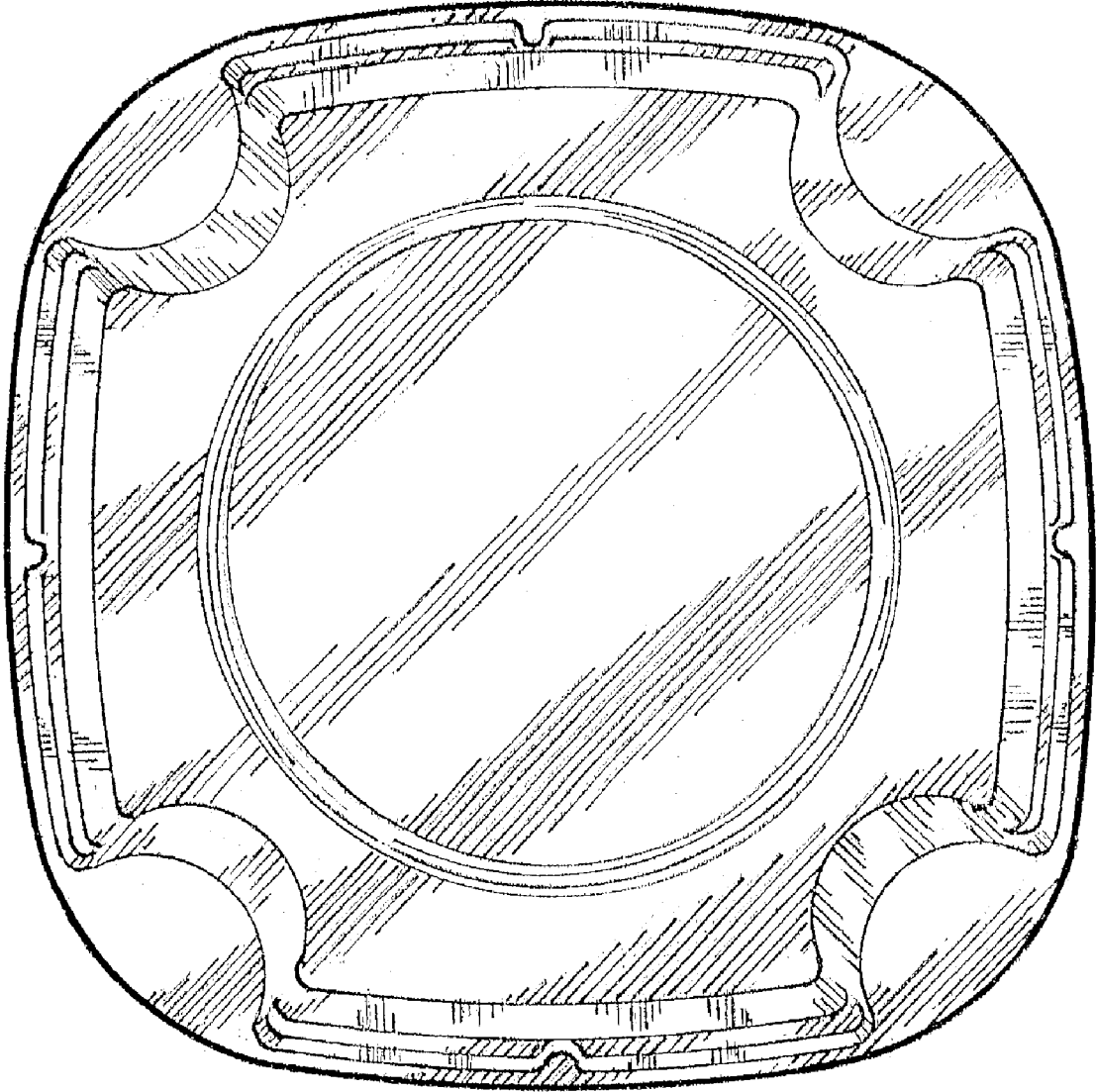

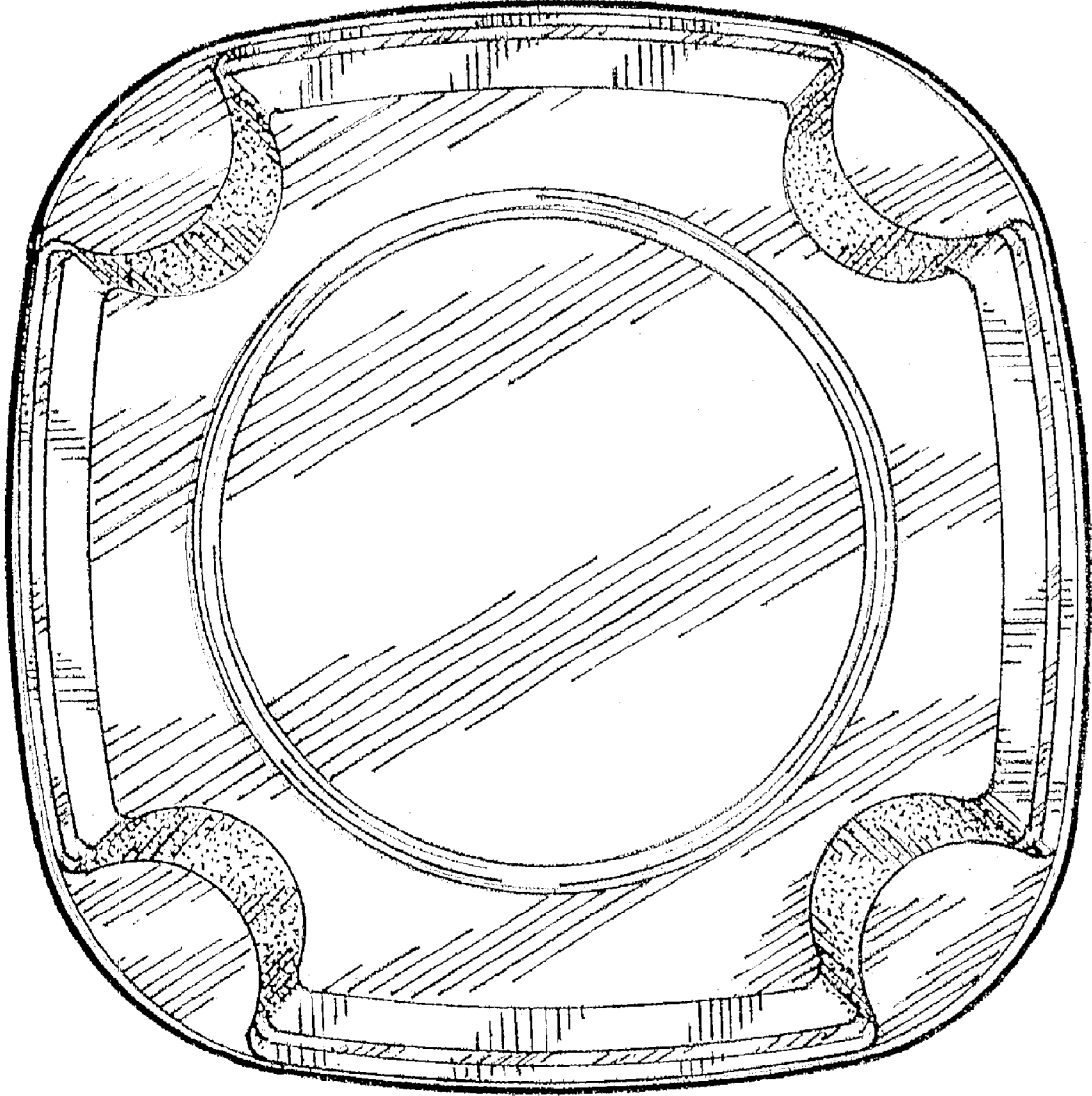

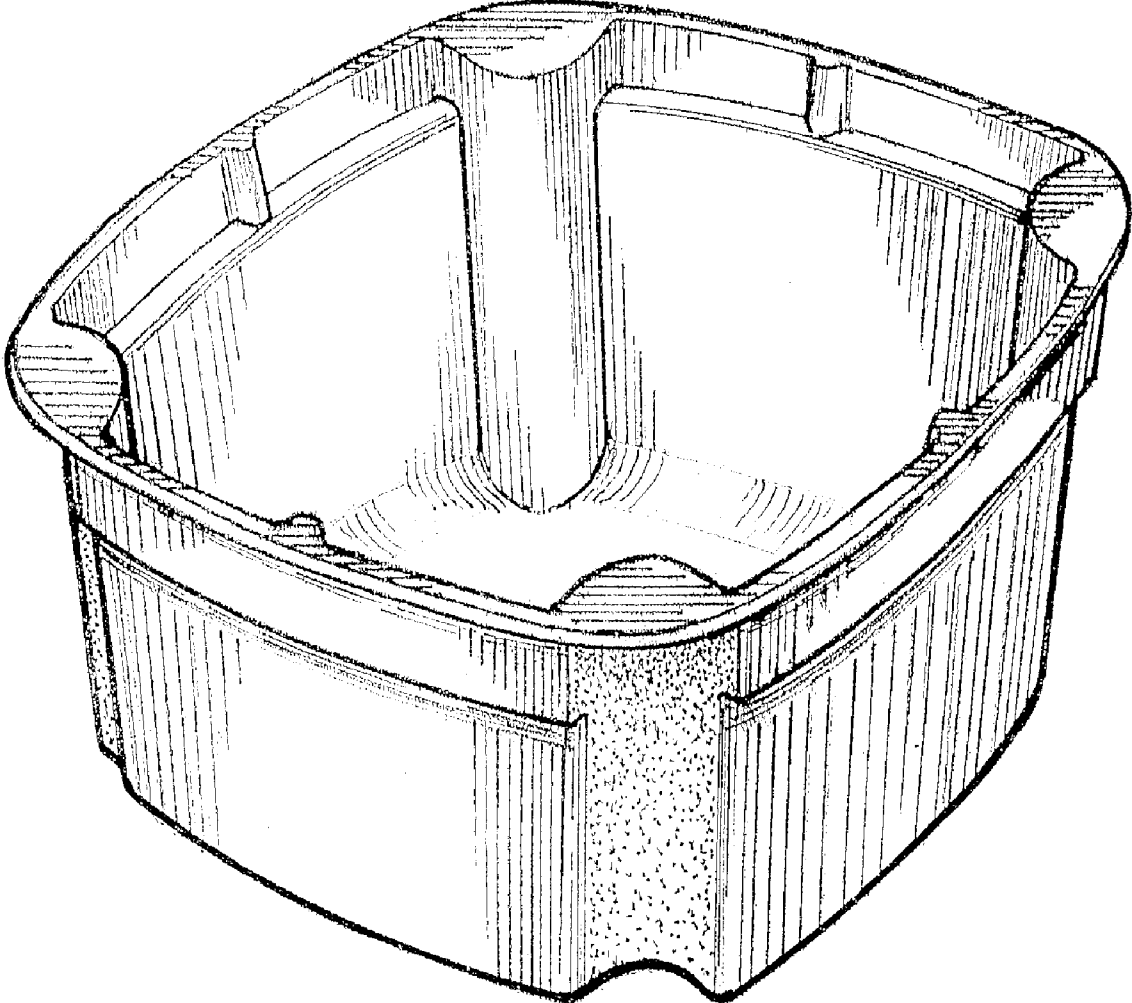
