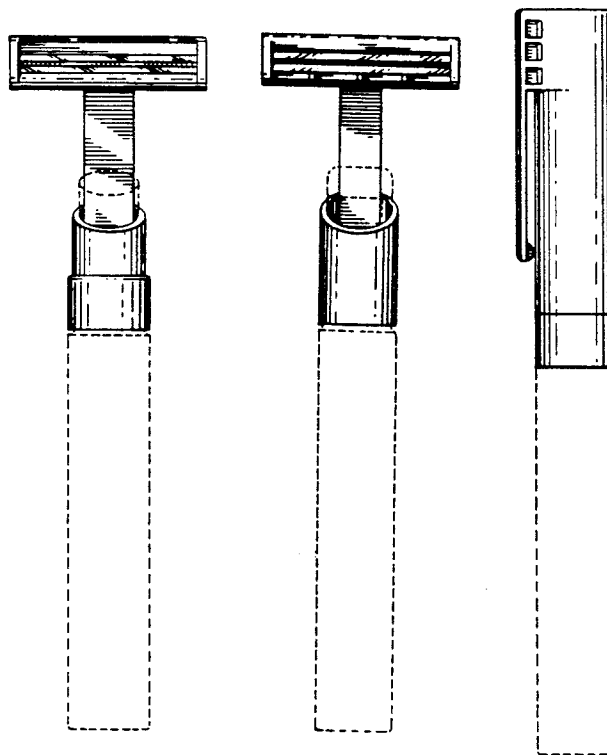

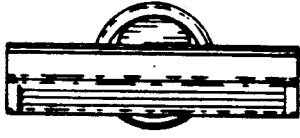
[57] **CLAIM**

The ornamental design for a combined razor and cap therefore, as shown and described.

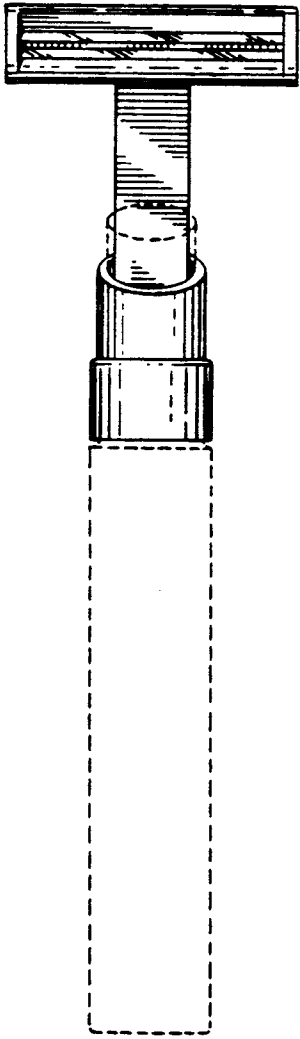
**DESCRIPTION**

FIG. 1 is a front elevational view of a combined razor and cap therefore showing our new design with the cap element removed for clarity of illustration;  
 FIG. 2 is a right side elevational thereof, the left side being a mirror image;  
 FIG. 3 is a rear elevation thereof;  
 FIG. 4 is a top plan view thereof;  
 FIG. 5 is a bottom plan view thereof;  
 FIG. 6 is a front elevational view thereof;  
 FIG. 7 is a front elevational view of a second modified embodiment;  
 FIG. 8 is a right side elevational view thereof, the left side being a mirror image;  
 FIG. 9 is a rear elevation thereof;  
 FIG. 10 is a top plan view thereof;  
 FIG. 11 is a bottom plan view thereof;  
 FIG. 12 is a right side elevational view of the assembled article, the left side being a mirror image;  
 FIG. 13 is a front elevational view thereof;  
 FIG. 14 is a rear elevational view thereof;  
 FIG. 15 is a top plan view thereof; and,  
 FIG. 16 is a bottom plan view thereof.  
 The broken line disclosure shown in FIGS. 1-3, 6-8 and 12 is for illustrative purposes only and forms no part of the claimed design.

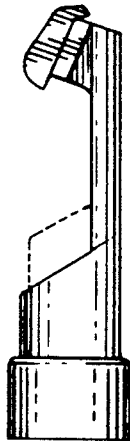




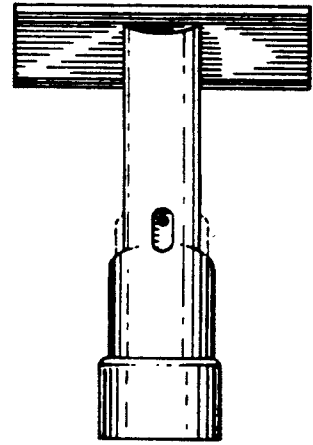

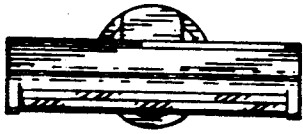

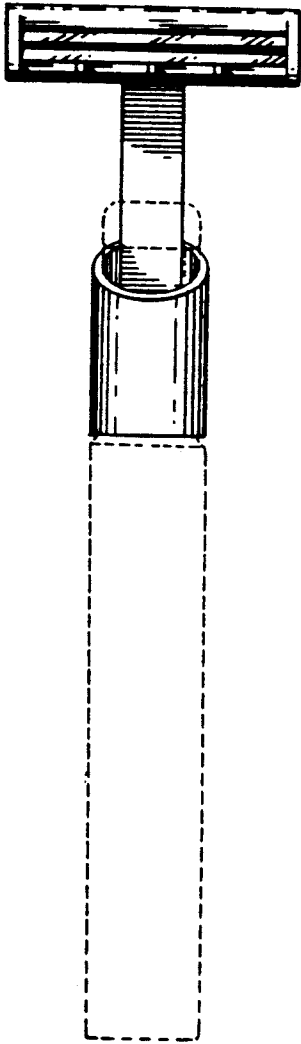

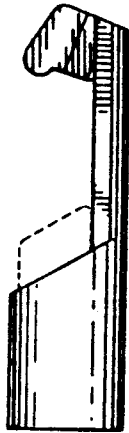

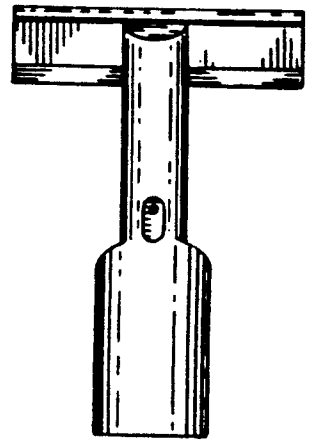

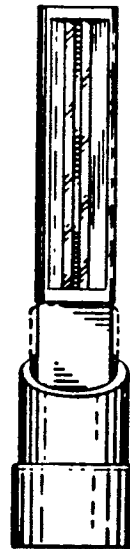

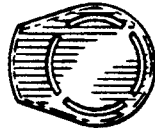

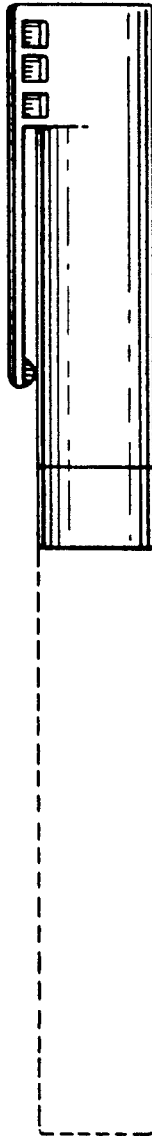

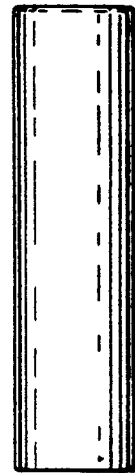
