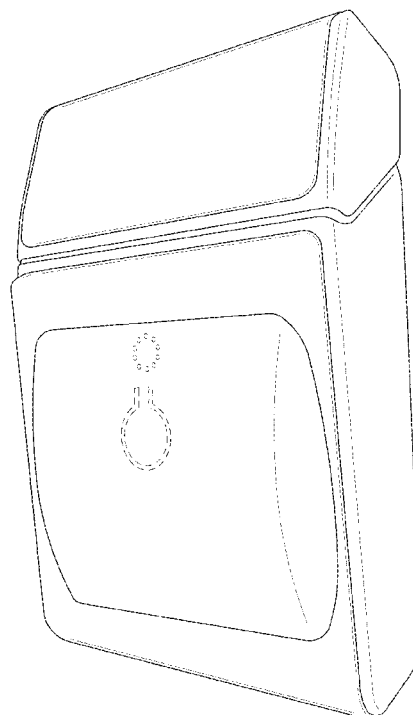
1. Cigarette case

The broken lines shown in the drawings illustrate portions of the cigarette case that form no part of the claimed design.

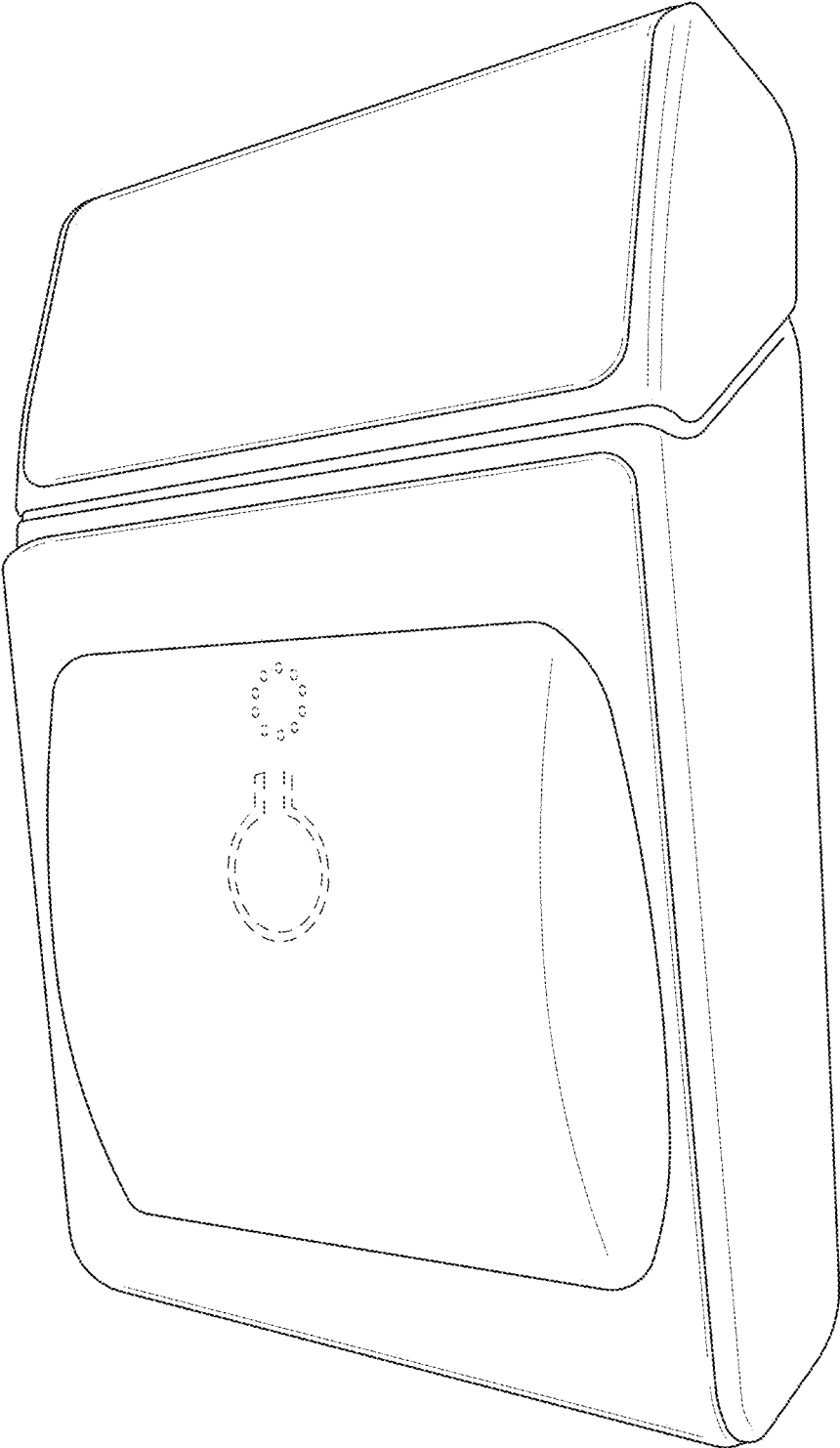

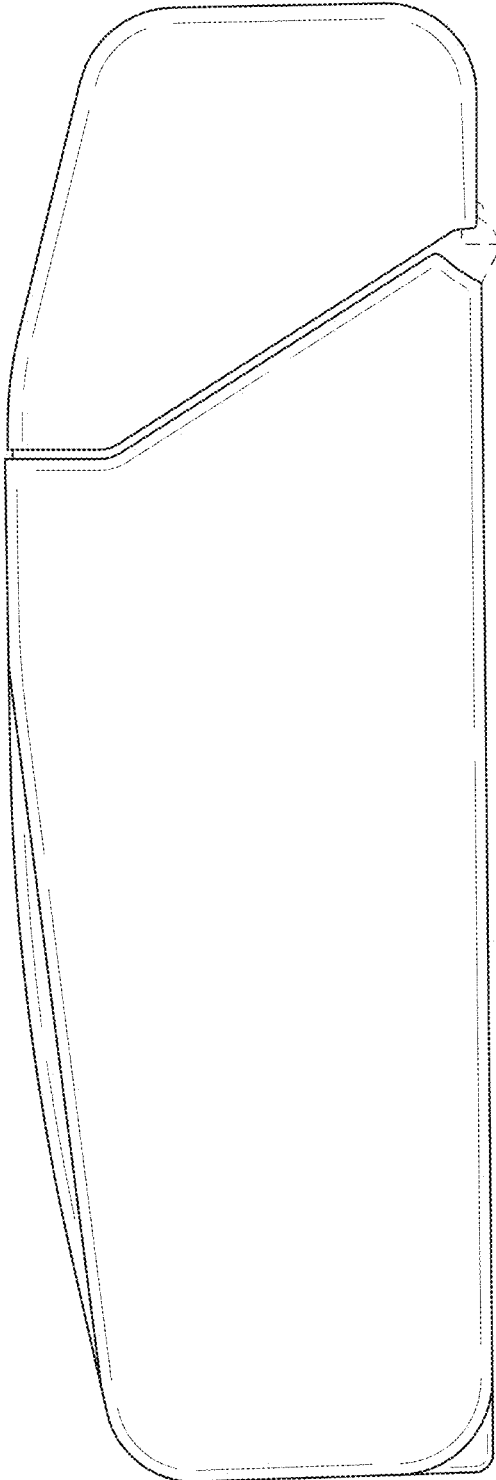

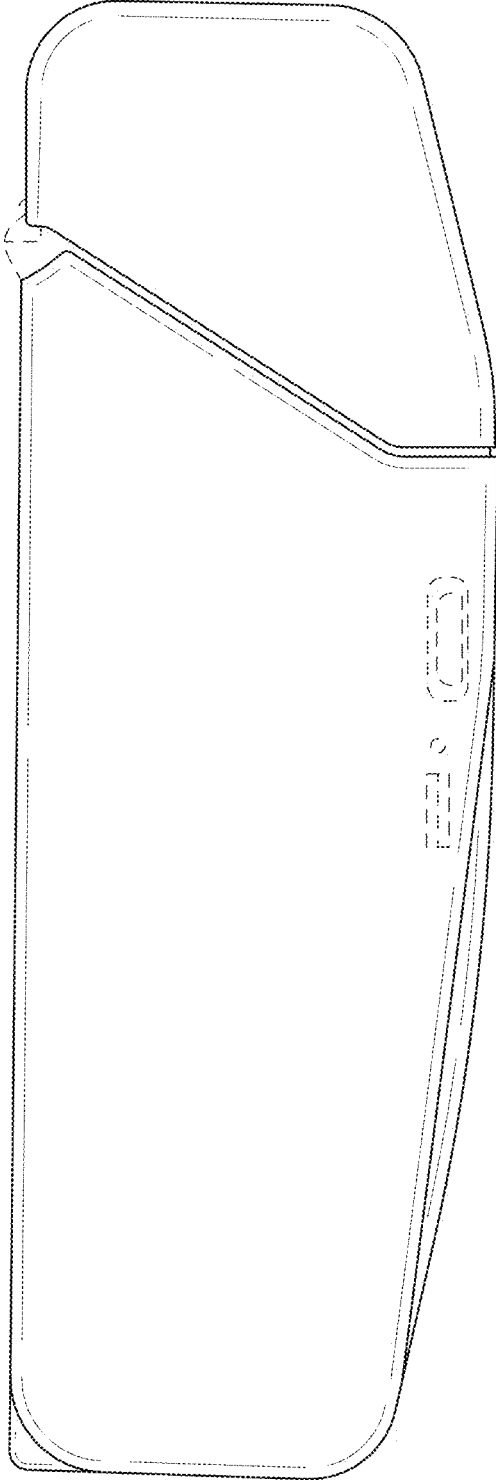




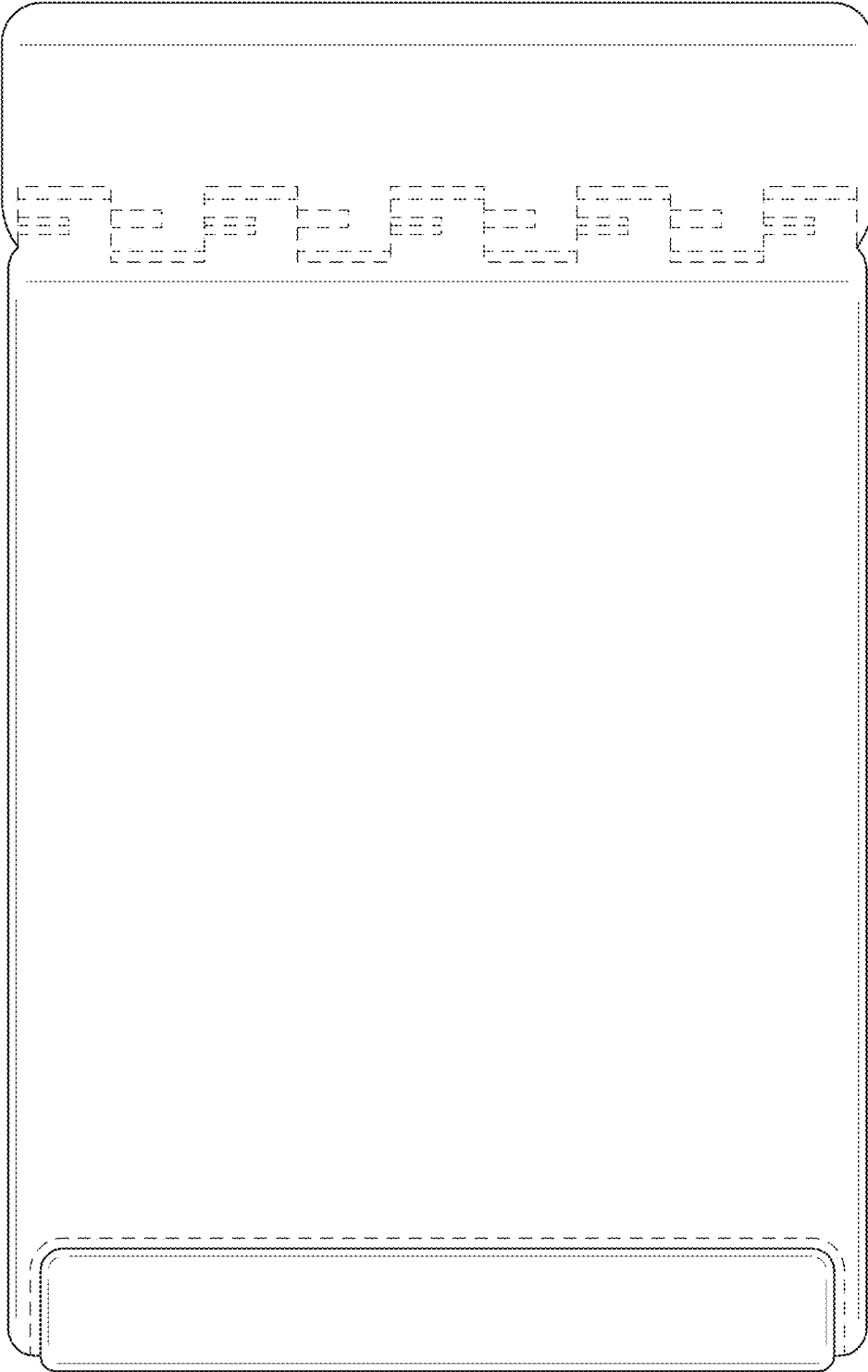

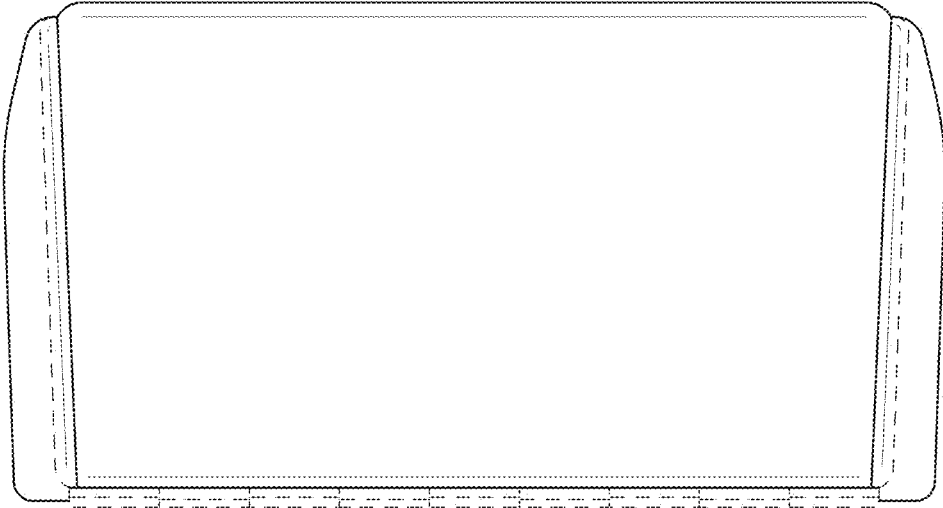
