DESCRIPTION

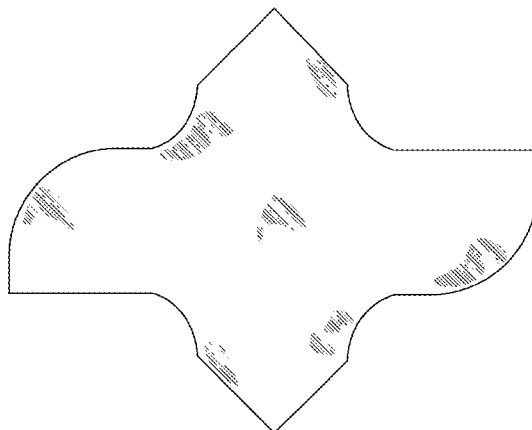
FIG. 1 is a top view of a wrapping sheet in accordance with one embodiment of the present design;

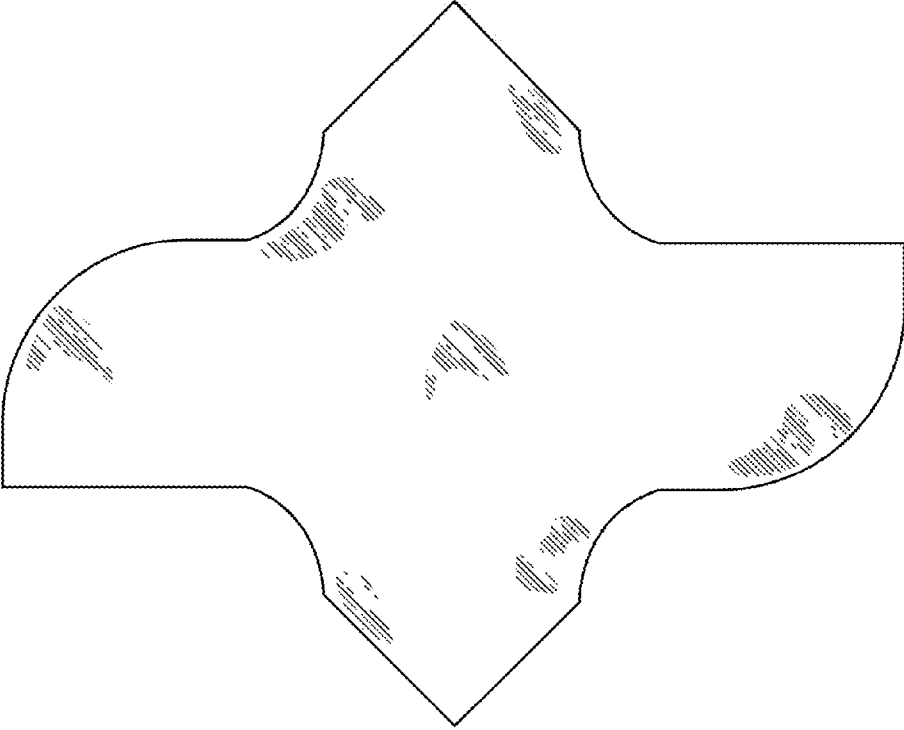

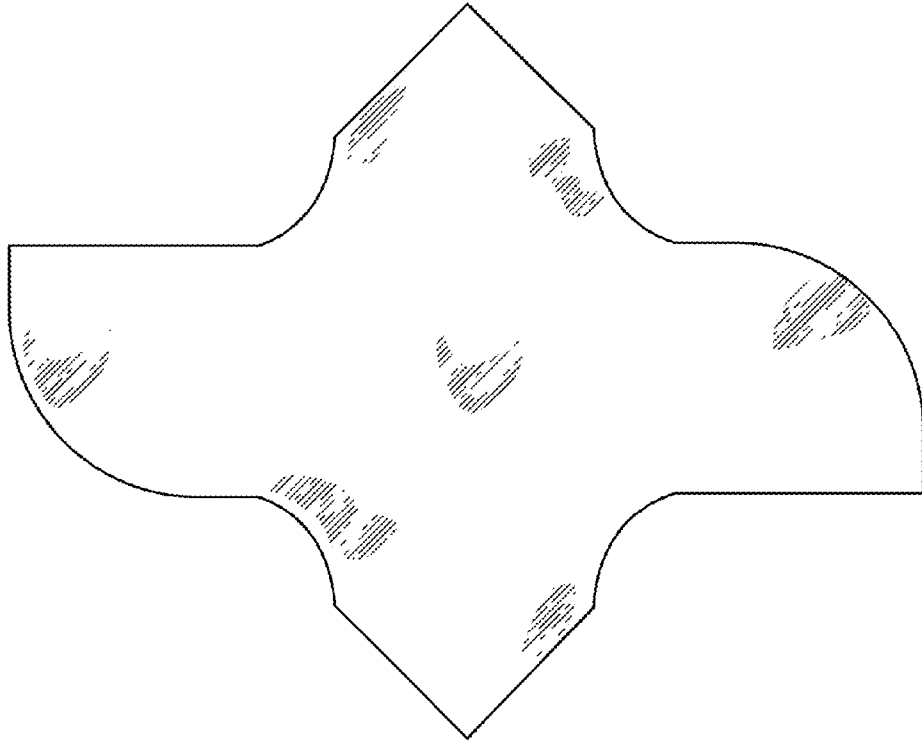

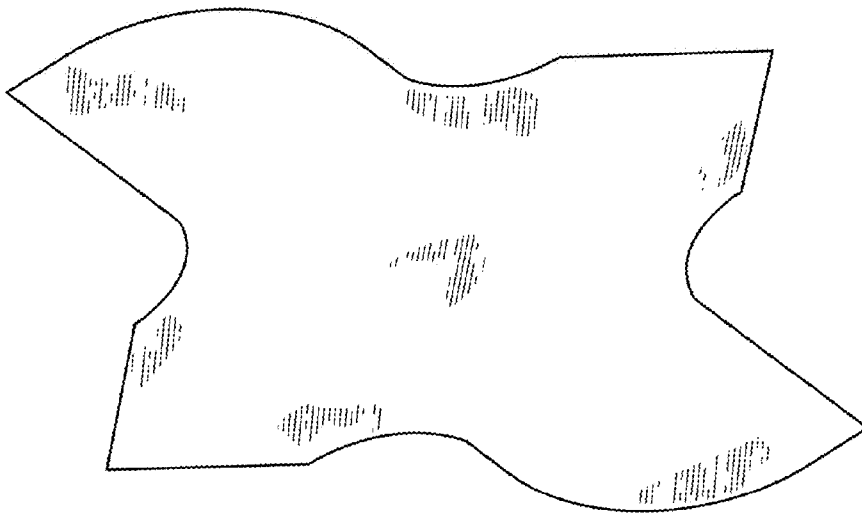

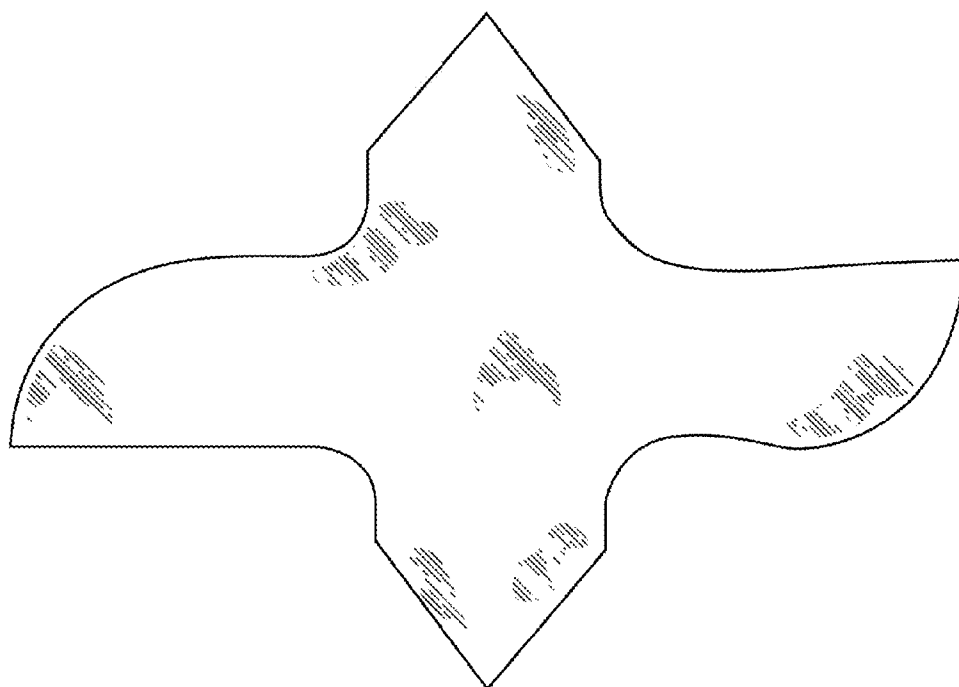

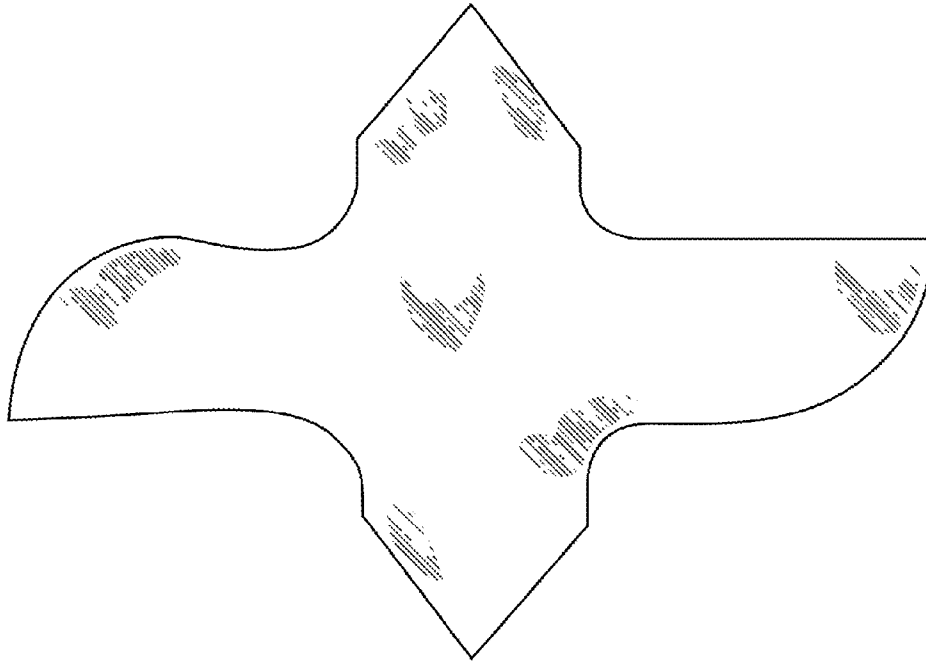

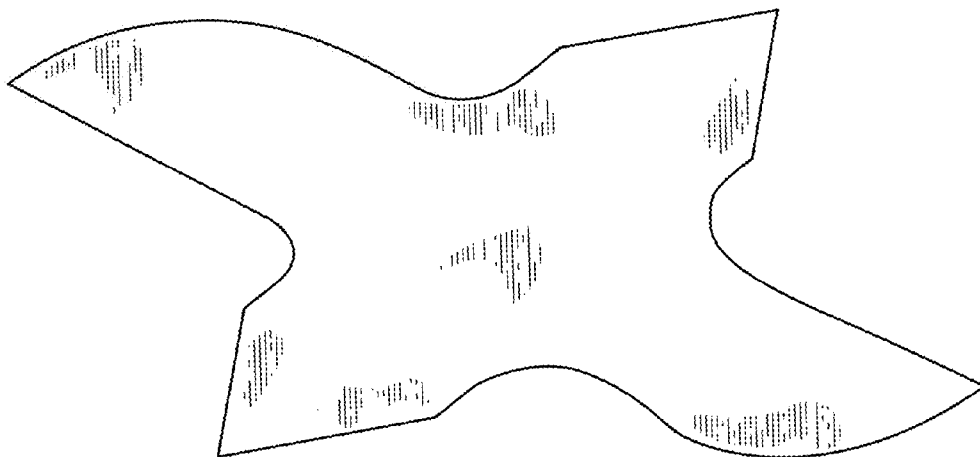
