FIG. 1 is a perspective view of the lace band for footwear embodying the new design showing the lace band incorporated into an article of footwear;

FIG. 2 is a perspective view of the lace band for footwear;

FIG. 3 is a front view thereof;

FIG. 4 is a right side view thereof;

FIG. 5 is a left side view thereof;

FIG. 6 is a top view thereof;

FIG. 7 is a perspective view of an alternative embodiment of the lace band for footwear embodying the new design showing the alternative lace band incorporated into an article of footwear;

FIG. 8 is a perspective view of the alternative embodiment of the lace band for footwear;

FIG. 9 is a front view thereof;

FIG. 10 is a right side view thereof;

FIG. 11 is a left side view thereof; and,

FIG. 12 is a top view thereof.

The claimed design extends only through the shaded portions of the drawings. FIGS. 1-12 show features of the lace band for footwear and the article of footwear in phantom lines. These features are shown for environmental purposes, and do not form any part of the claimed design.

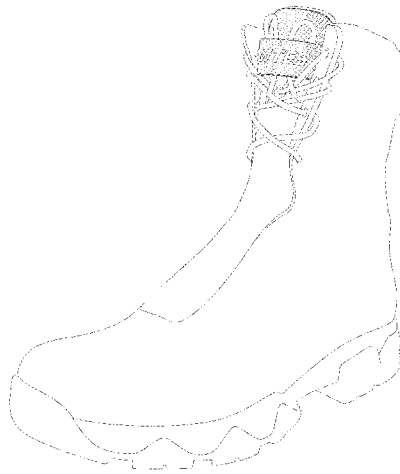
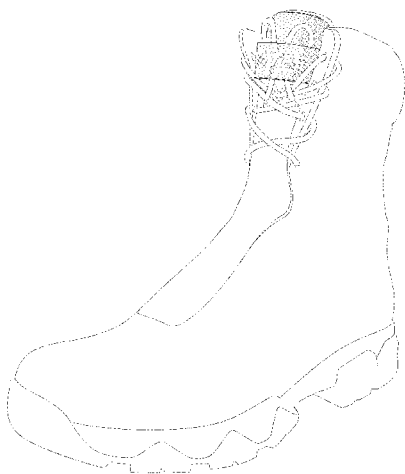

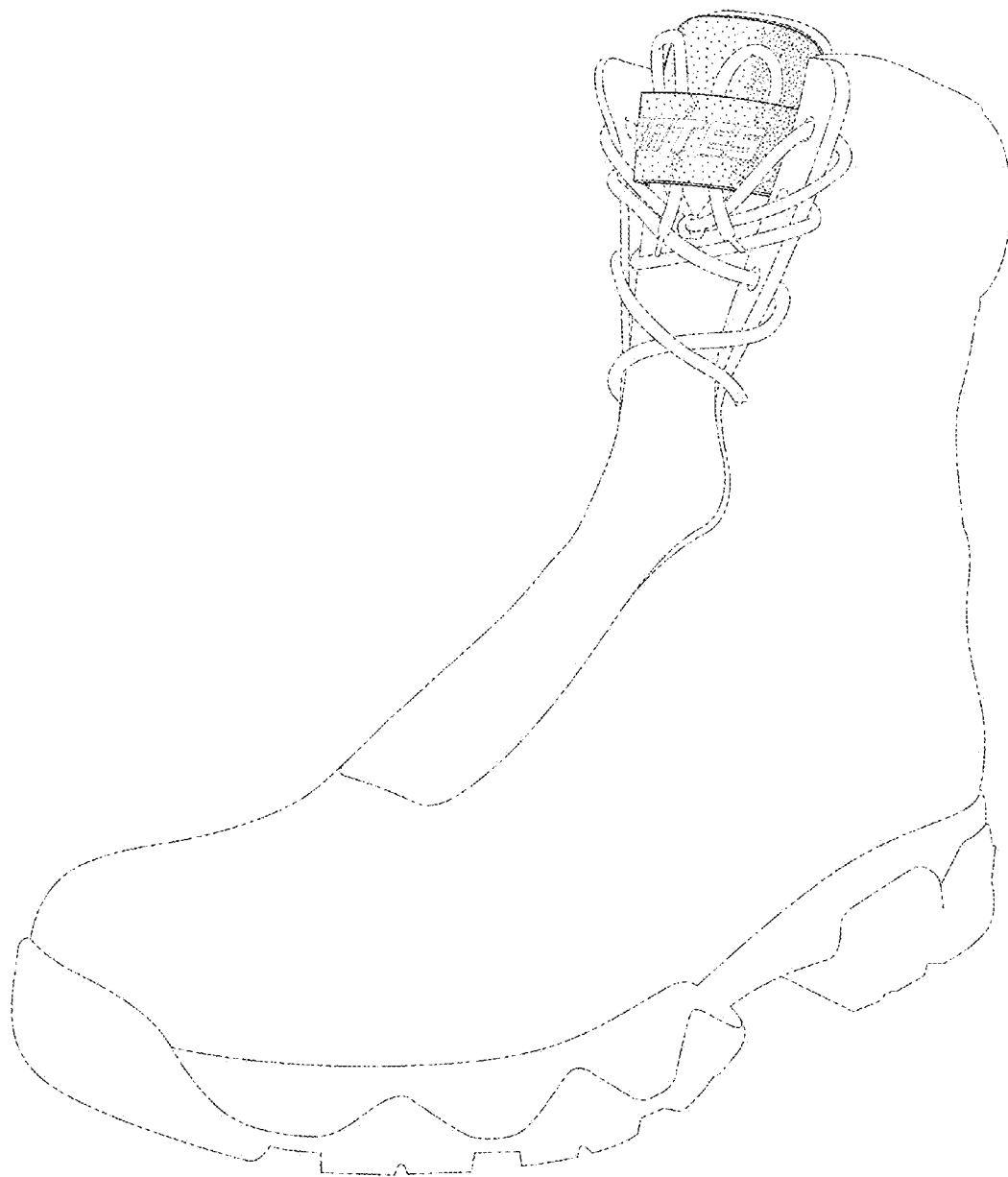

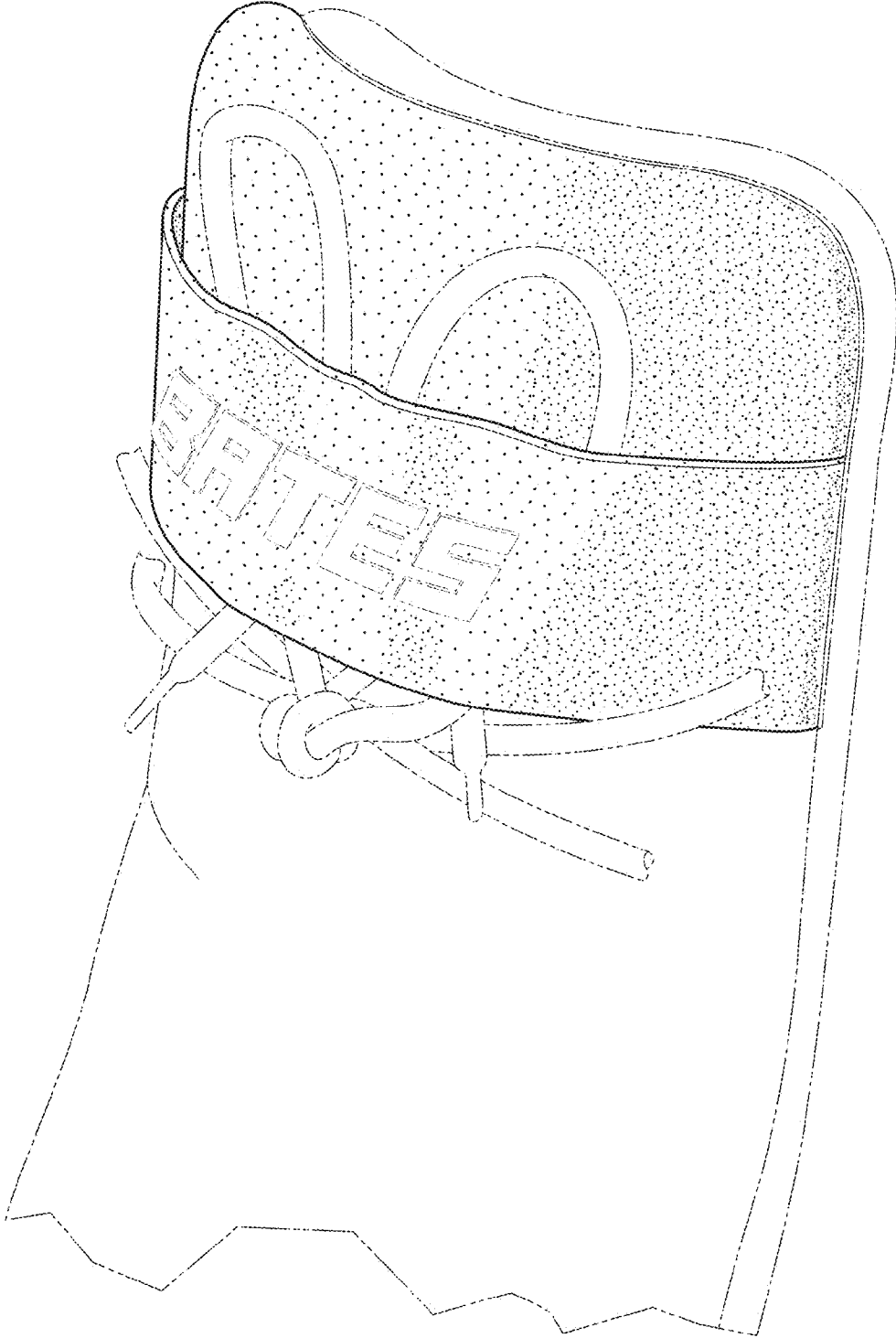

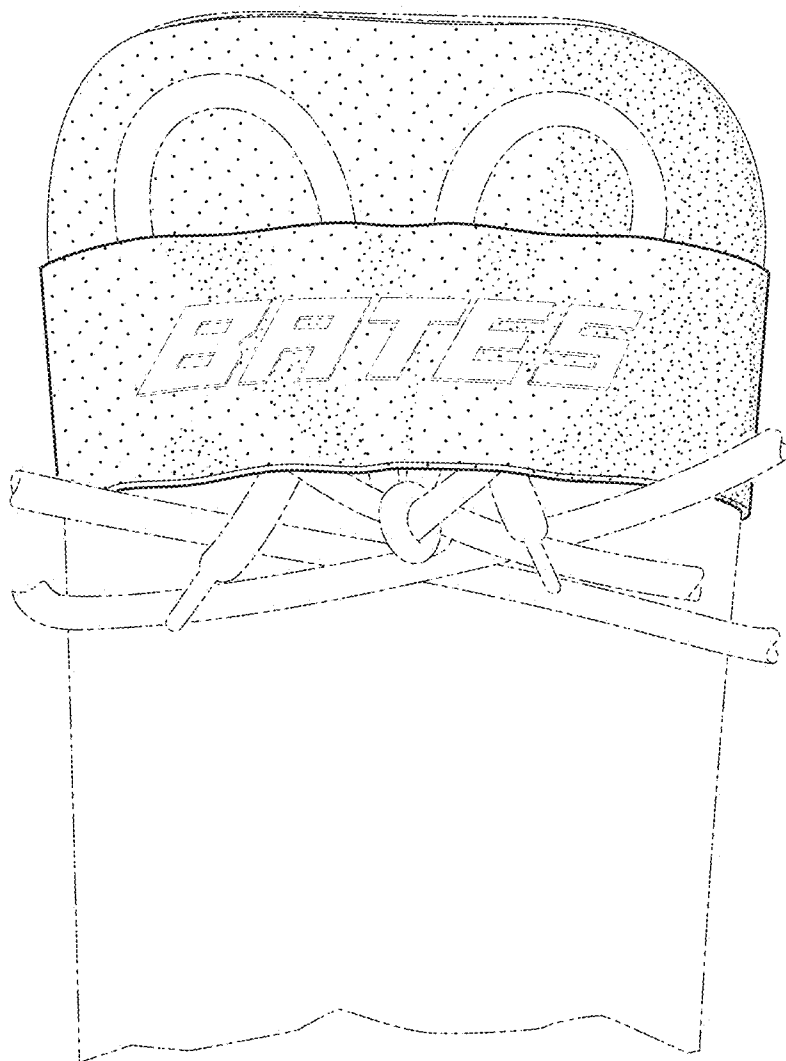

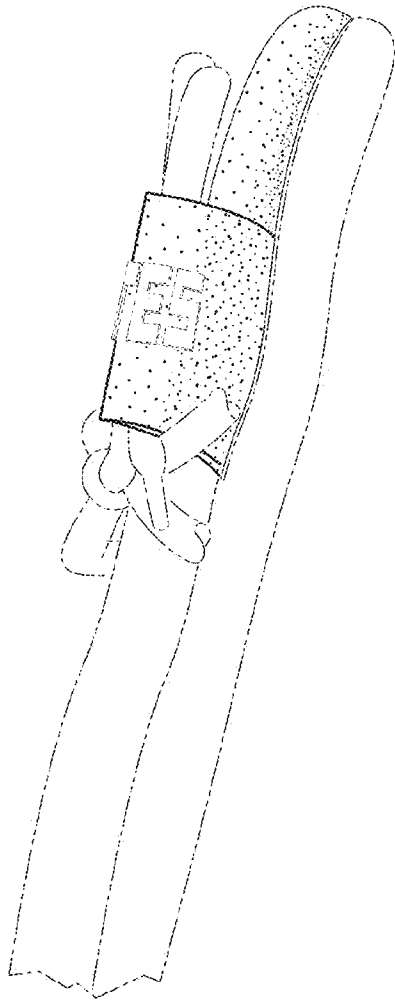

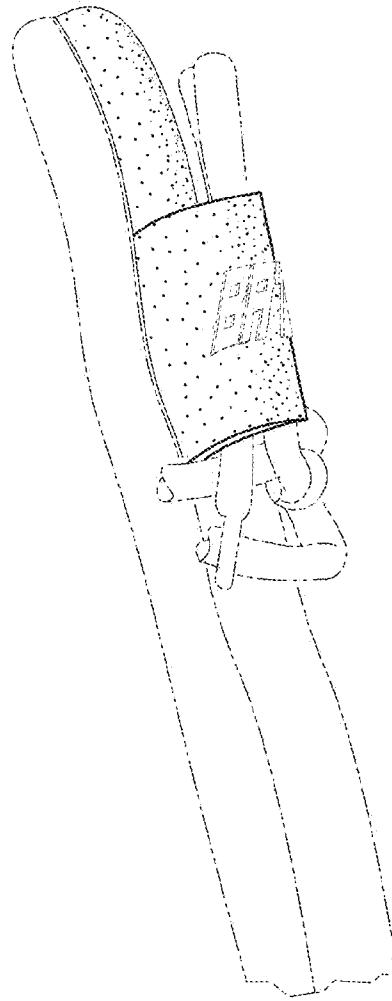

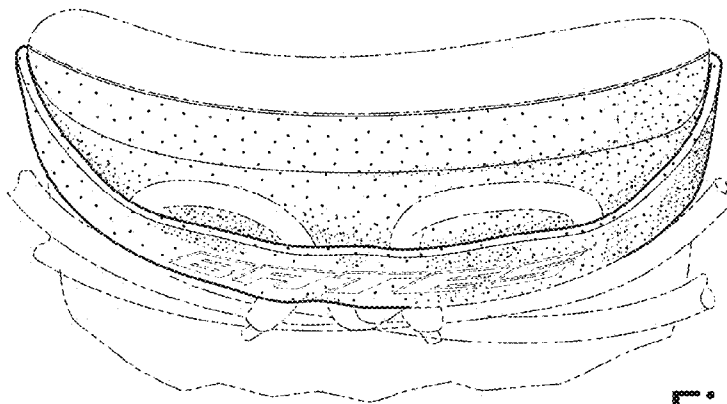

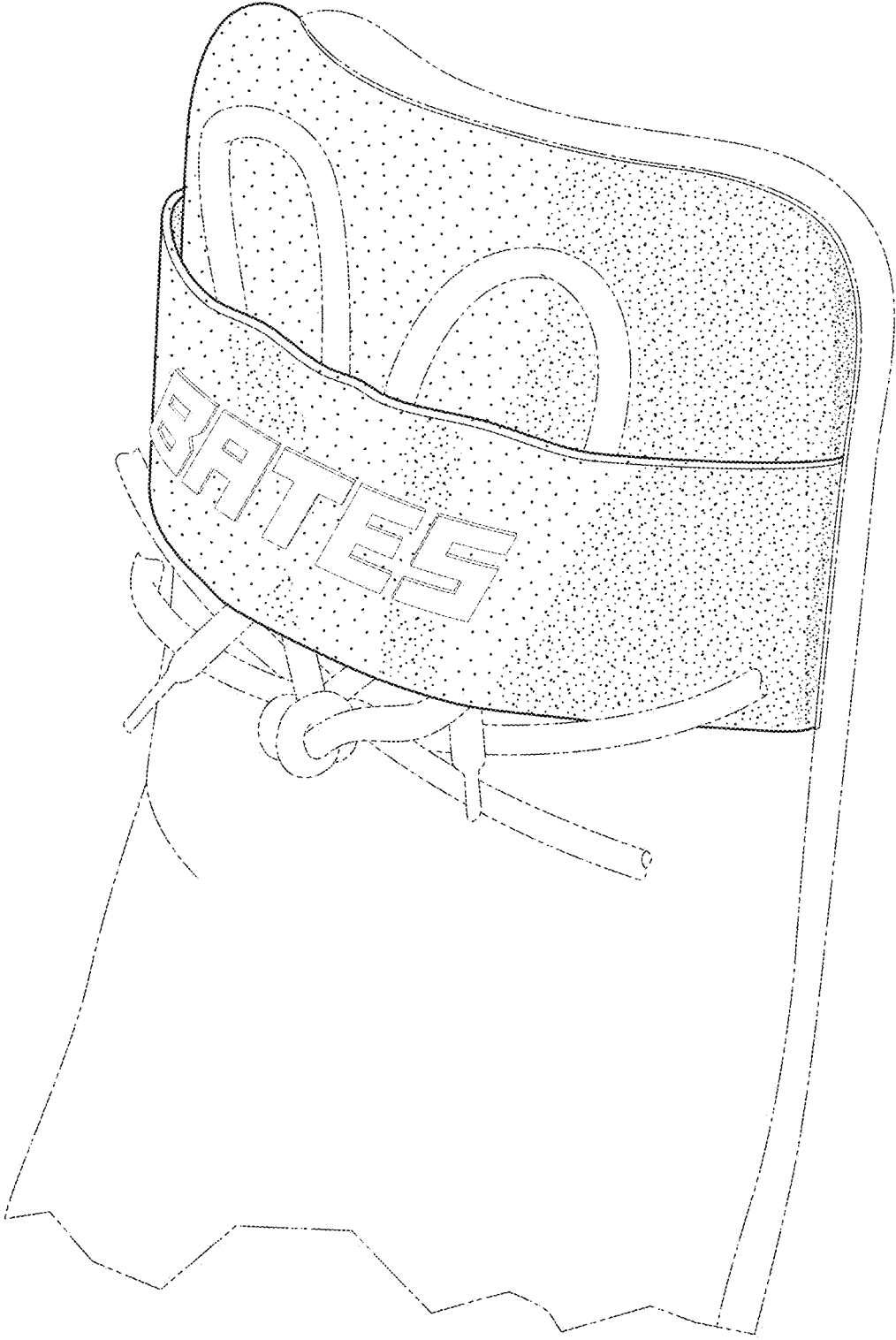

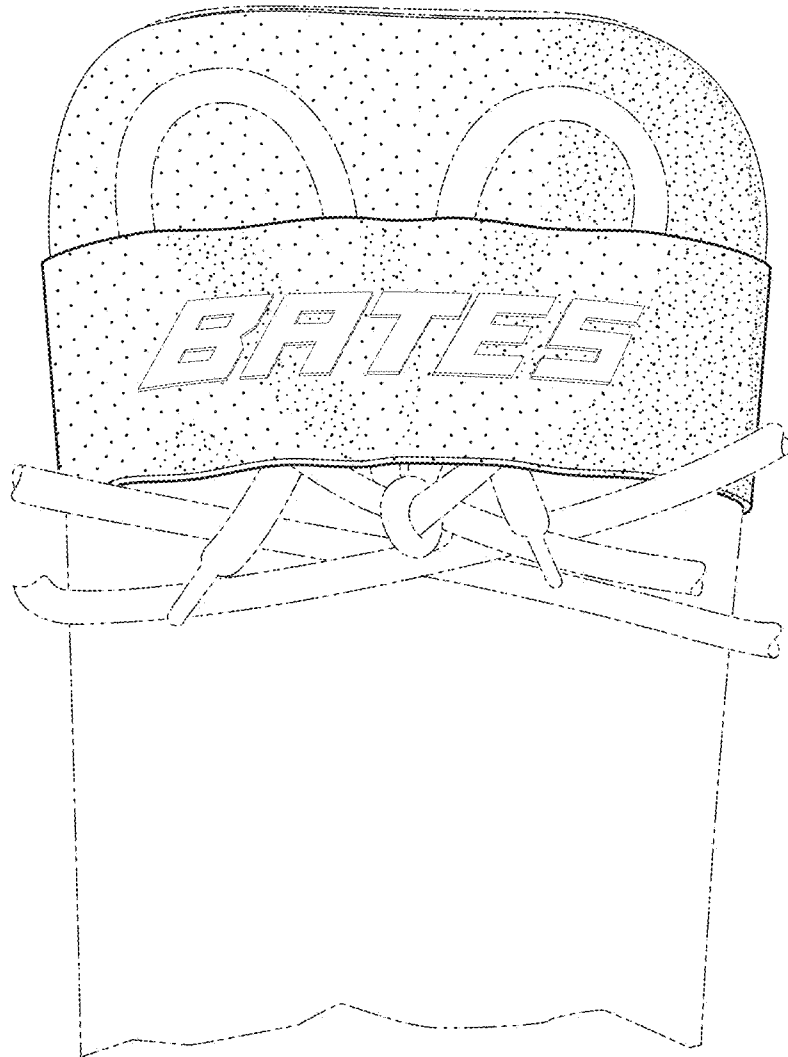

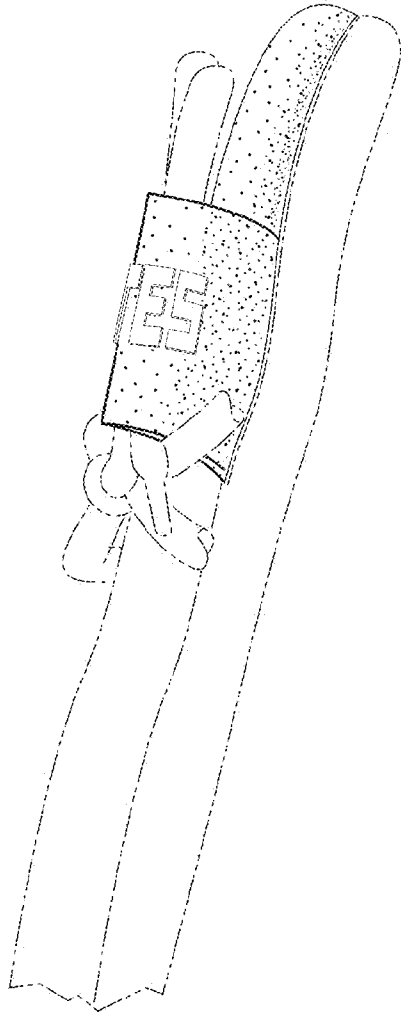

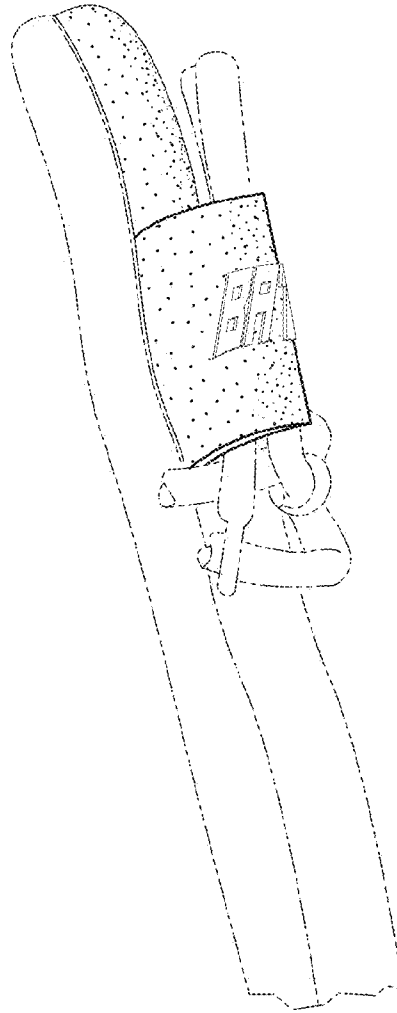

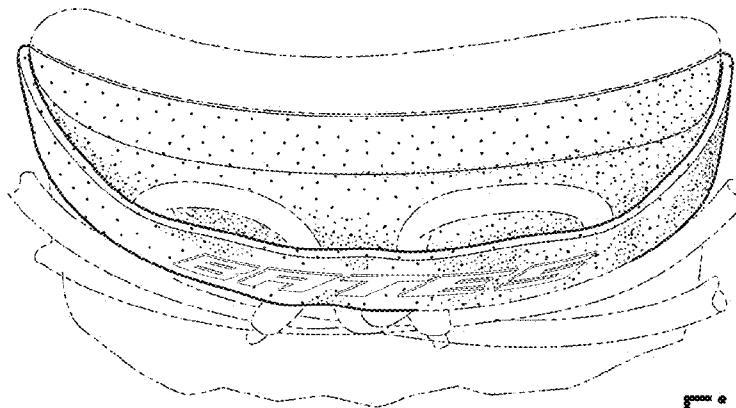
