(57) **CLAIM**

The ornamental design for a pelvic floor exerciser, as shown and described.

DESCRIPTION

FIG. 1 is a is a perspective view of a pelvic floor exerciser showing my new design from the forward end and two adjacent sides;

FIG. 2 is a separate product of the sides opposite the sides shown in FIG. 1;

FIG. **3** is a is an exploded perspective view thereof similar to FIG. **2**, shown with the end cap at the rearward end removed;

FIG. **4** is a side elevation view thereof shown from one side; FIG. **5** is a cross sectional view taken along line **5-5** of FIG. **4**. FIG. **6** is a side elevation view thereof, rotated 45 degrees

from the side shown in FIG. 4; FIG. 7 is a cross sectional view taken along line 7-7 of FIG. 6.

FIG. 8 is a side elevation view thereof, rotated 90 degrees from the side shown in FIG. 4;

FIG. **9** is a side elevation view thereof, rotated 135 degrees from the side shown in FIG. **4**;


FIG. **10** is side elevation view thereof, rotated 180 degrees from the side shown in FIG. **4**;


FIG. **11** is side elevation view thereof, rotated 225 degrees from the side shown in FIG. **4**;


FIG. **12** is side elevation view thereof, rotated 270 degrees from the side shown in FIG. **4**; and,


FIG. **13** is side elevation view thereof, rotated 315 degrees from the side shown in FIG. **4**.
















