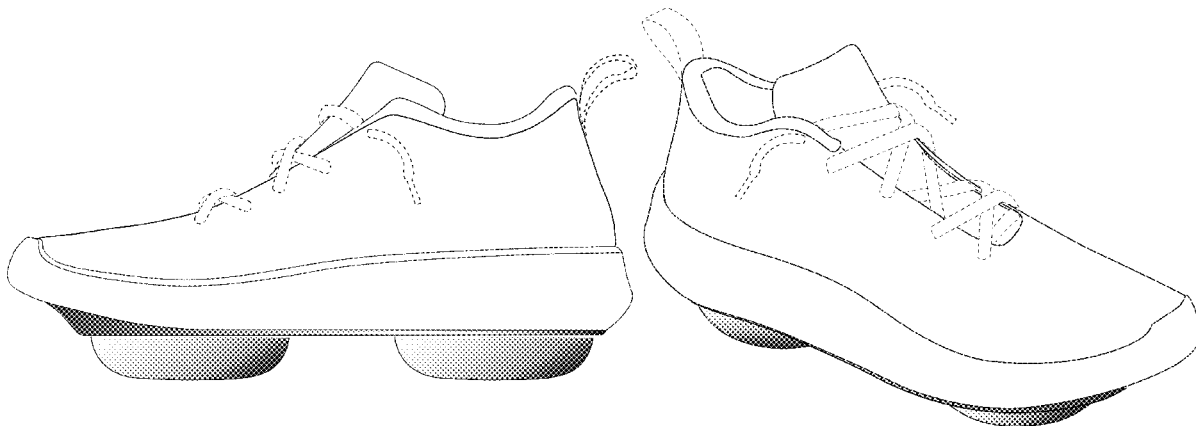
(57) **CLAIM**

The ornamental design for a shoe, as shown and described.

**DESCRIPTION**

FIG. 1 is a left view of a shoe in accordance with the new design;  
FIG. 2 is a right view thereof;  
FIG. 3 is a rear view thereof;  
FIG. 4 is a front view thereof;  
FIG. 5 is a top view thereof;  
FIG. 6 is a bottom view thereof of a shoe with half-dome portions removed, showing recessed slots;  
FIG. 7 is a bottom view thereof of a shoe in accordance with the new design;  
FIG. 8 is an isometric view thereof; and,  
FIG. 9 is an exploded isometric view thereof.  
The broken lines in the figures show portions of the shoe that form no part of the claimed design.

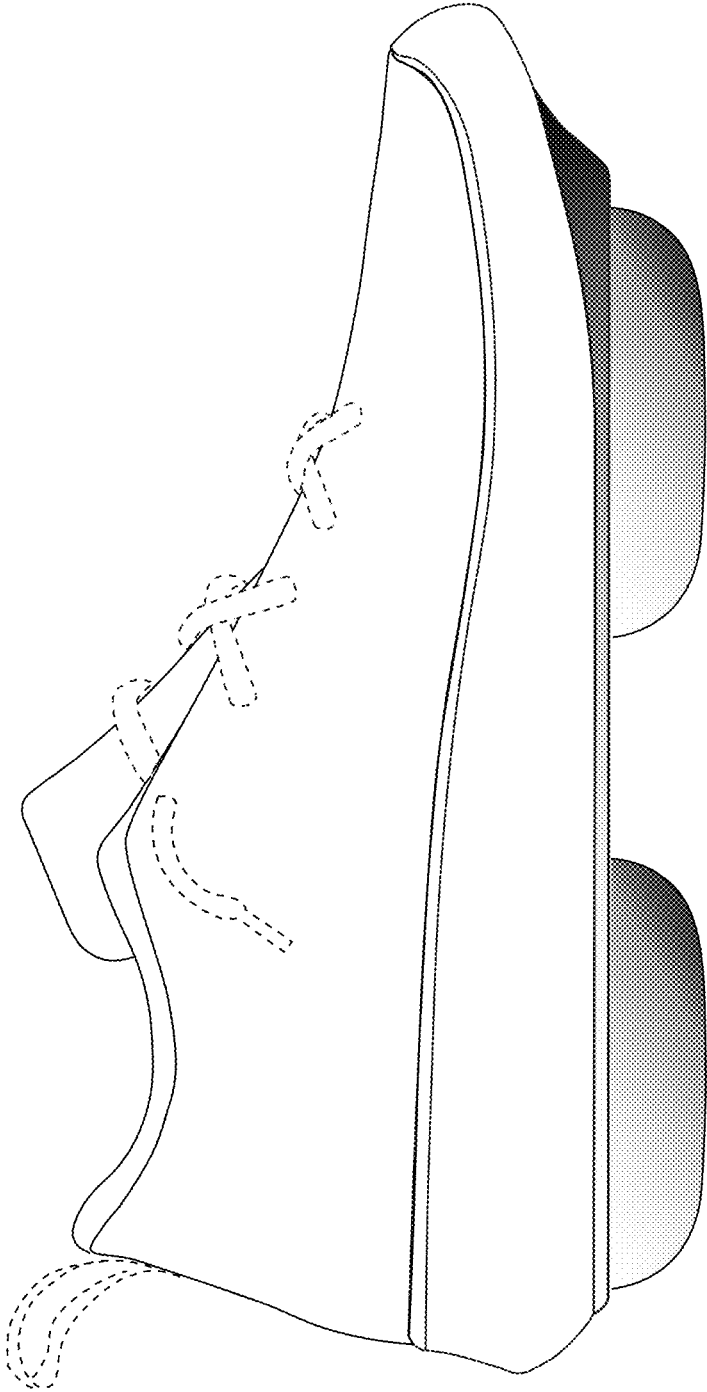

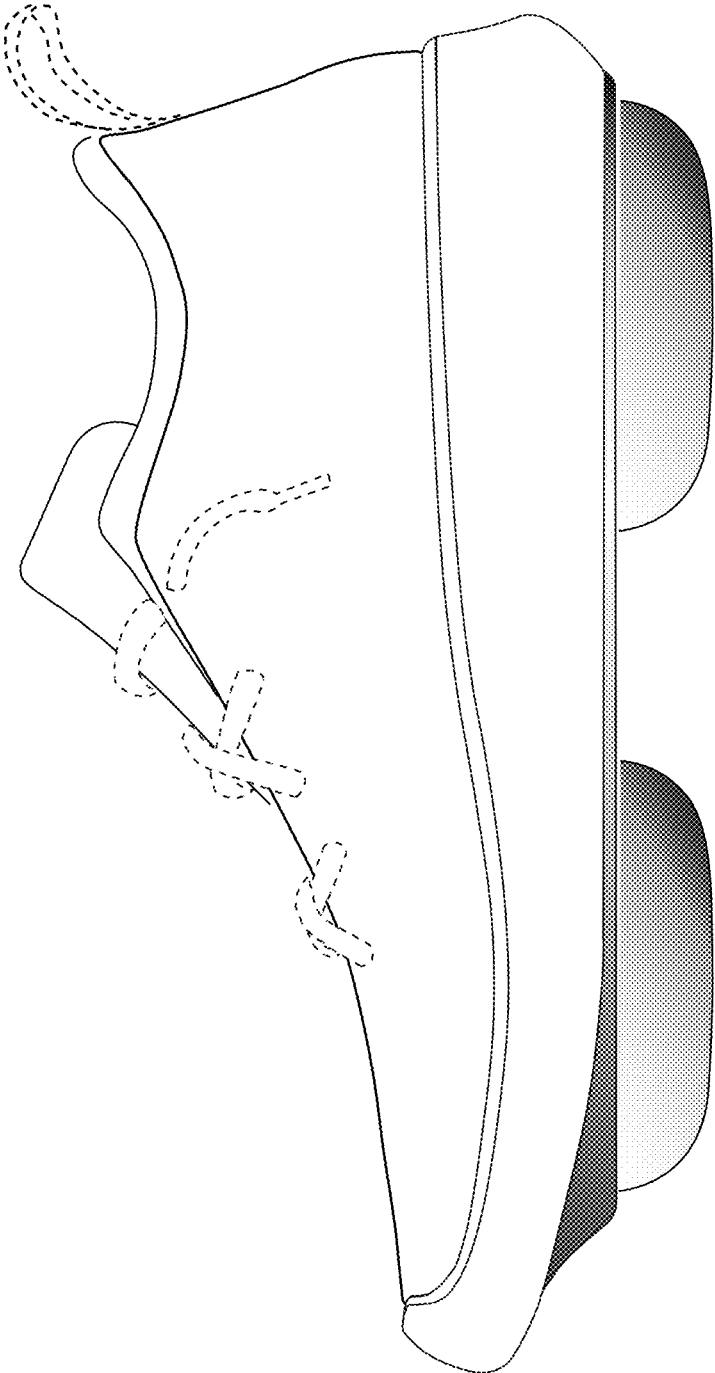

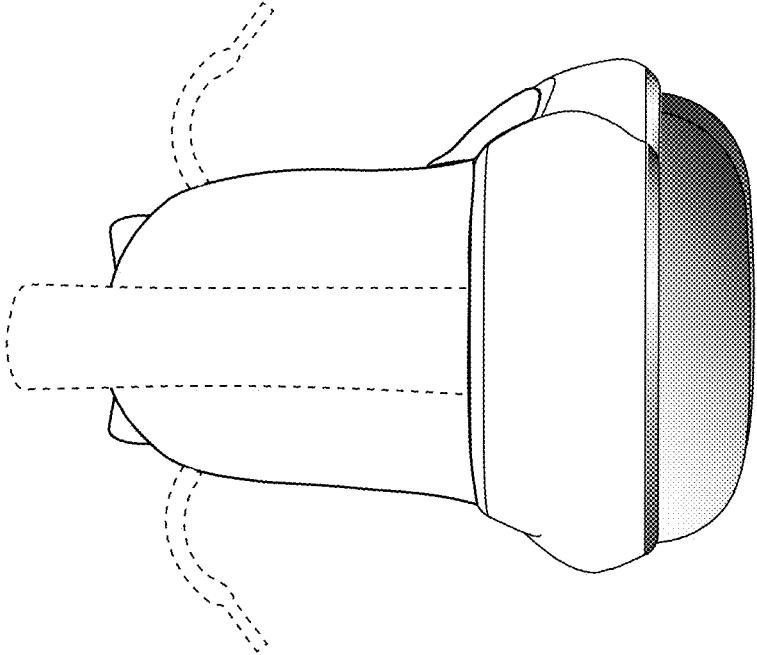

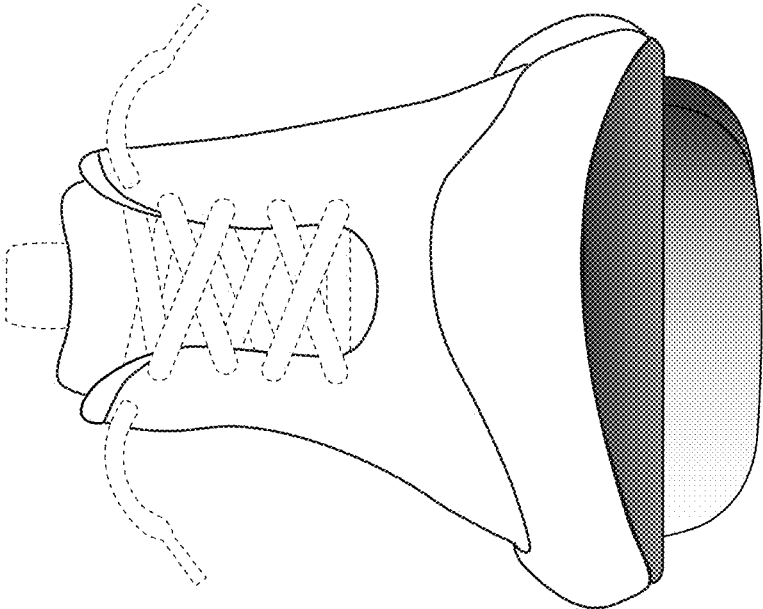

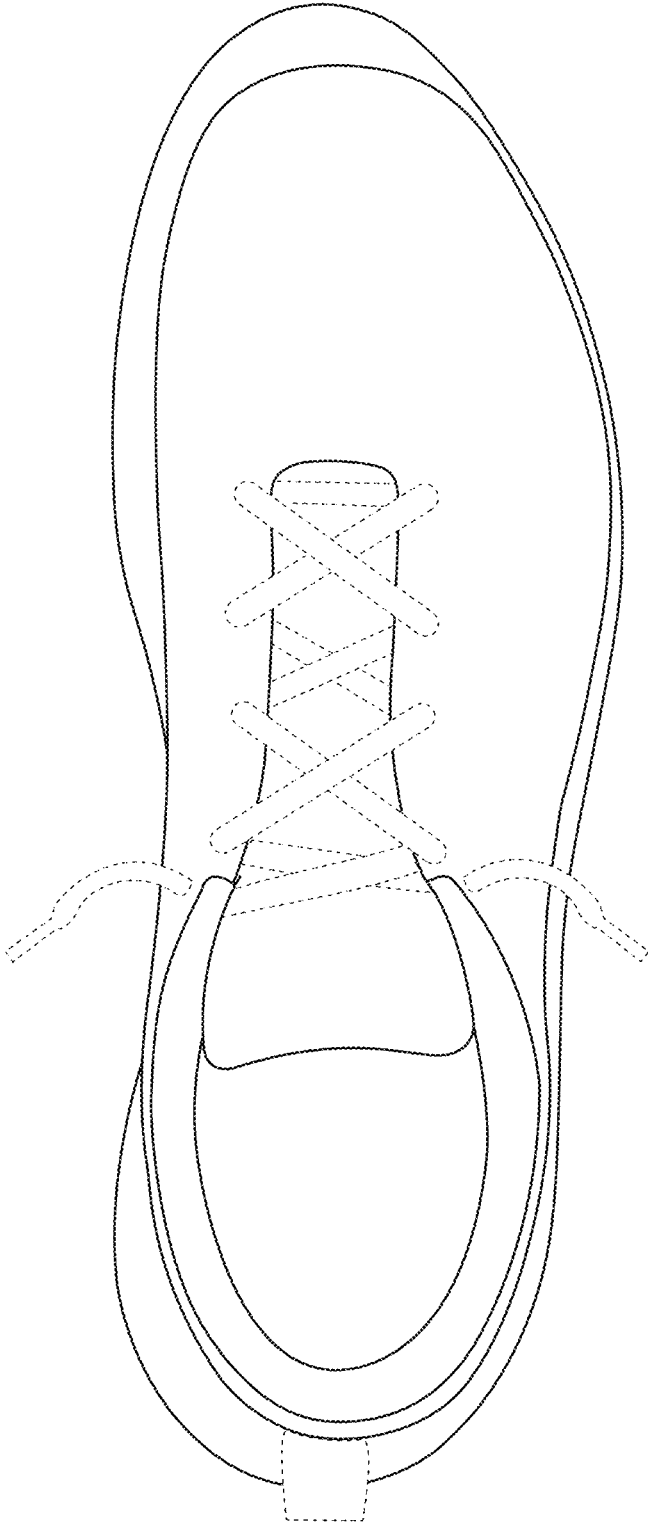

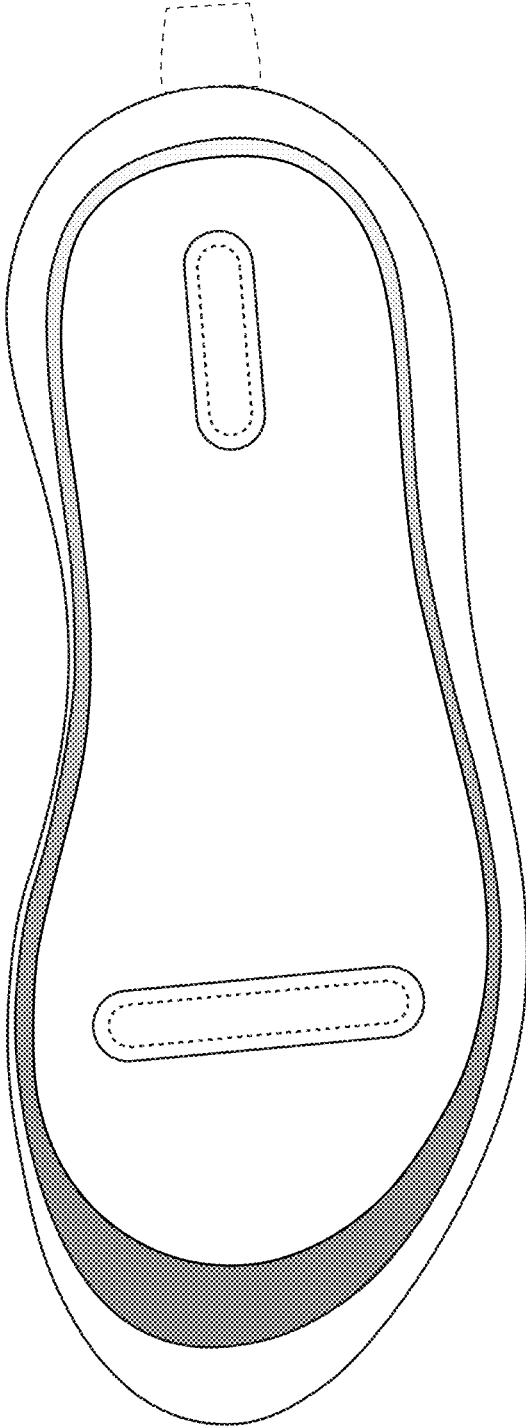

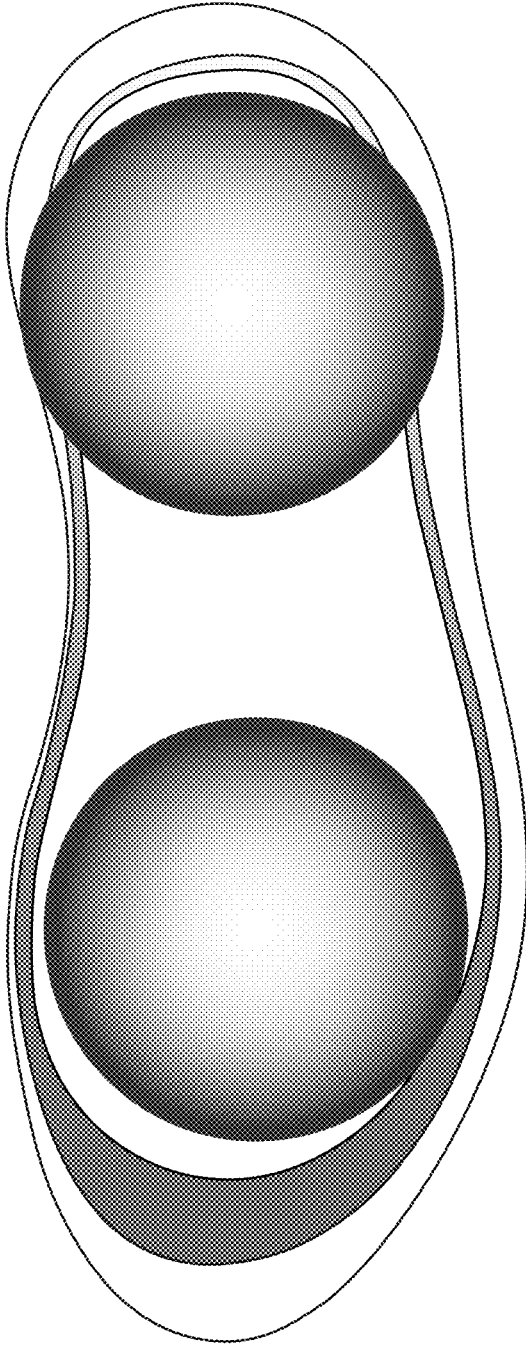

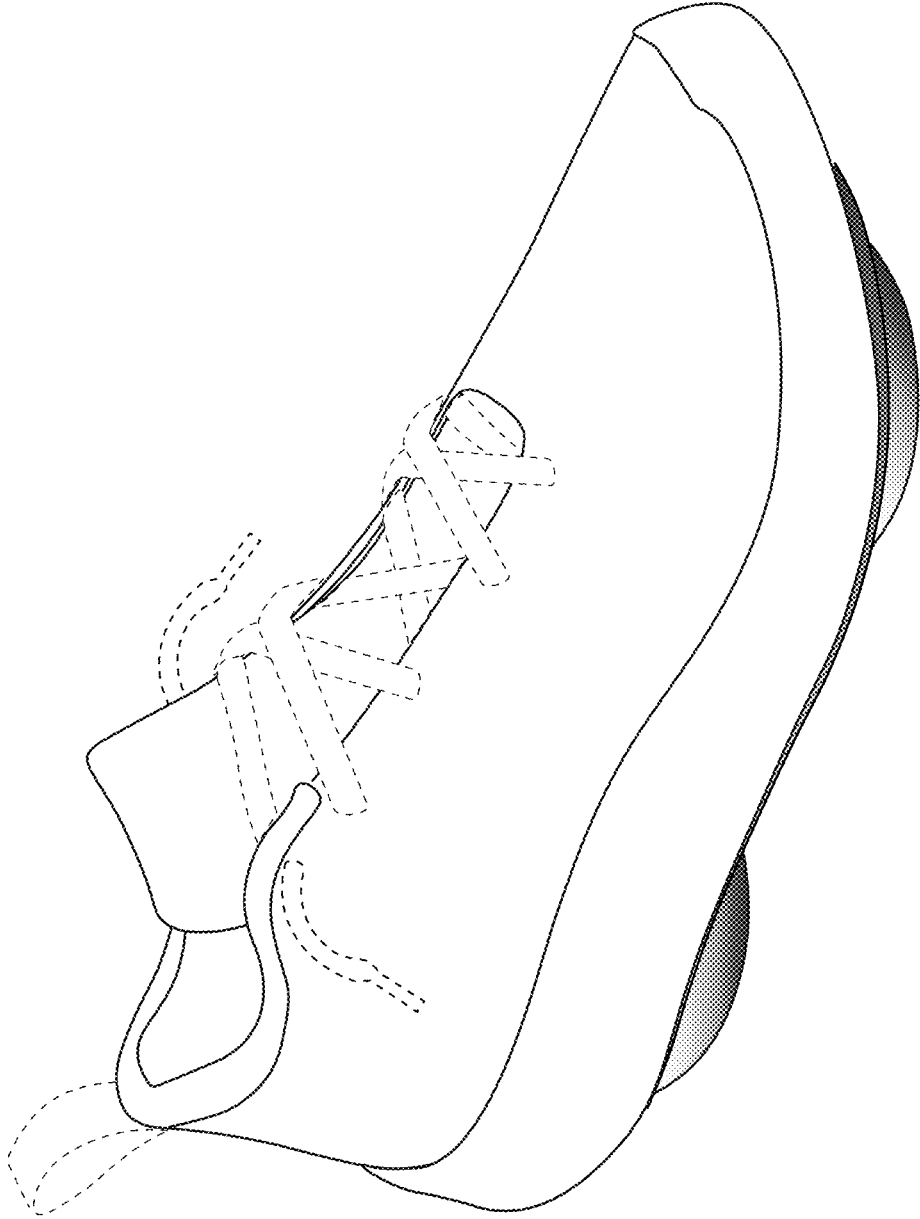

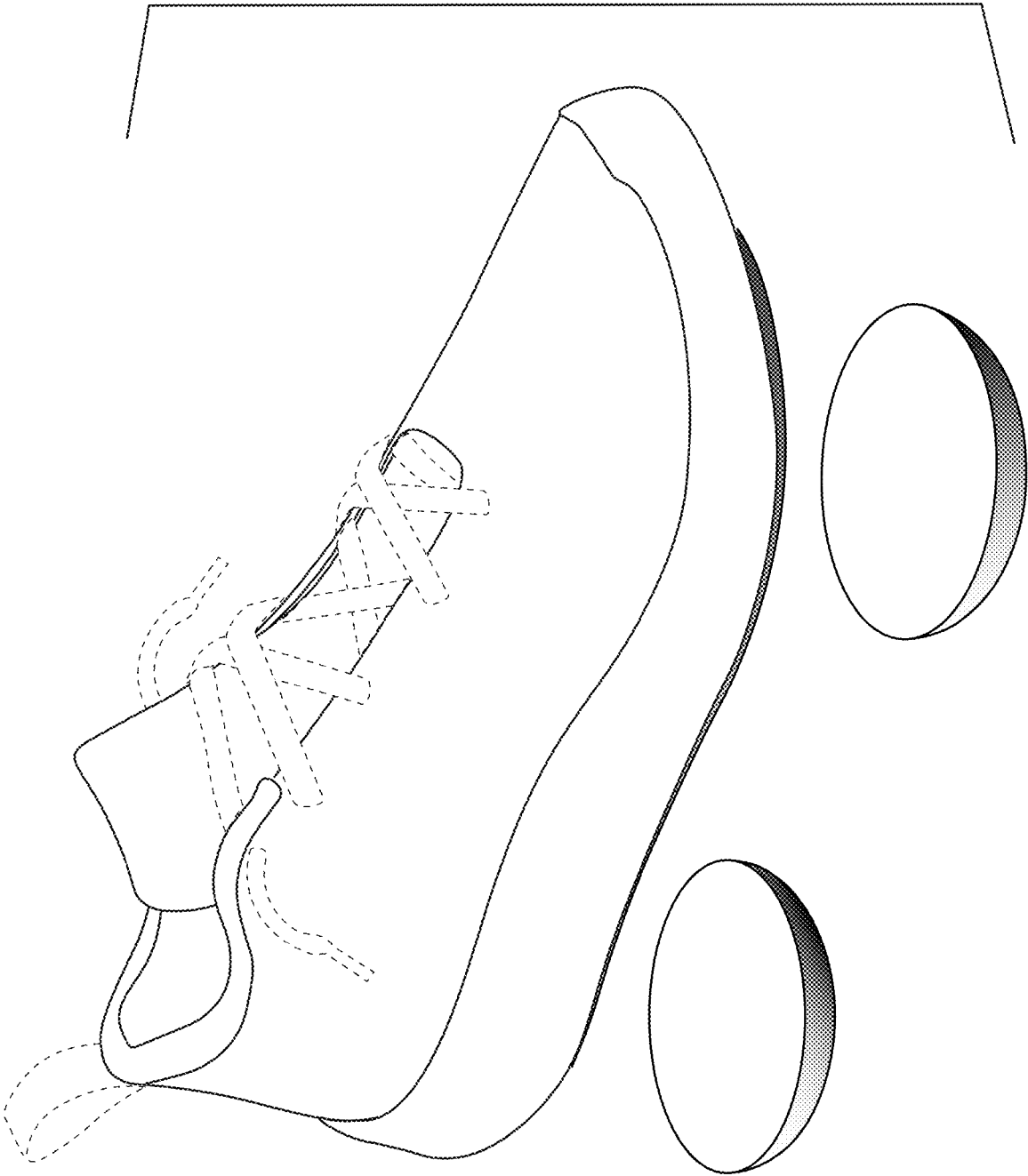
