(57) **CLAIM**

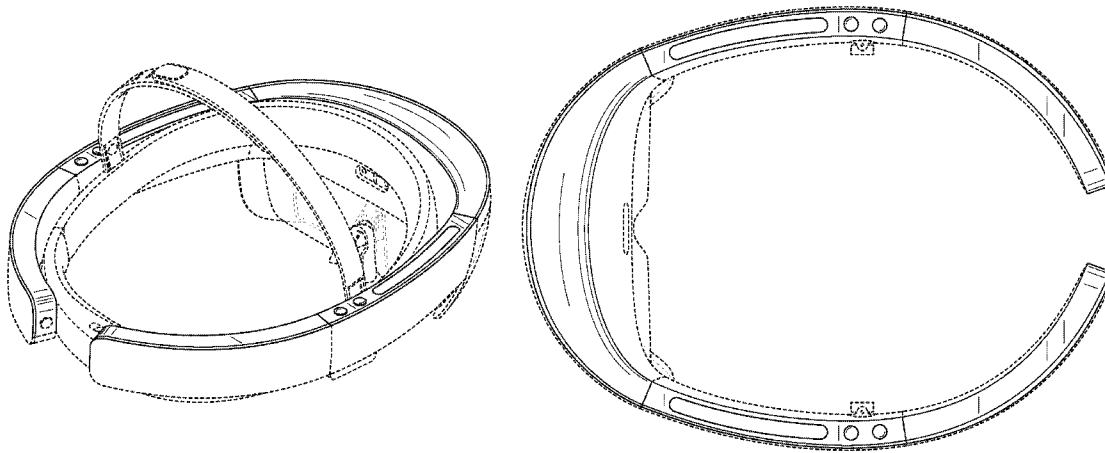
The ornamental design for a headset with visor, as shown and described.

DESCRIPTION

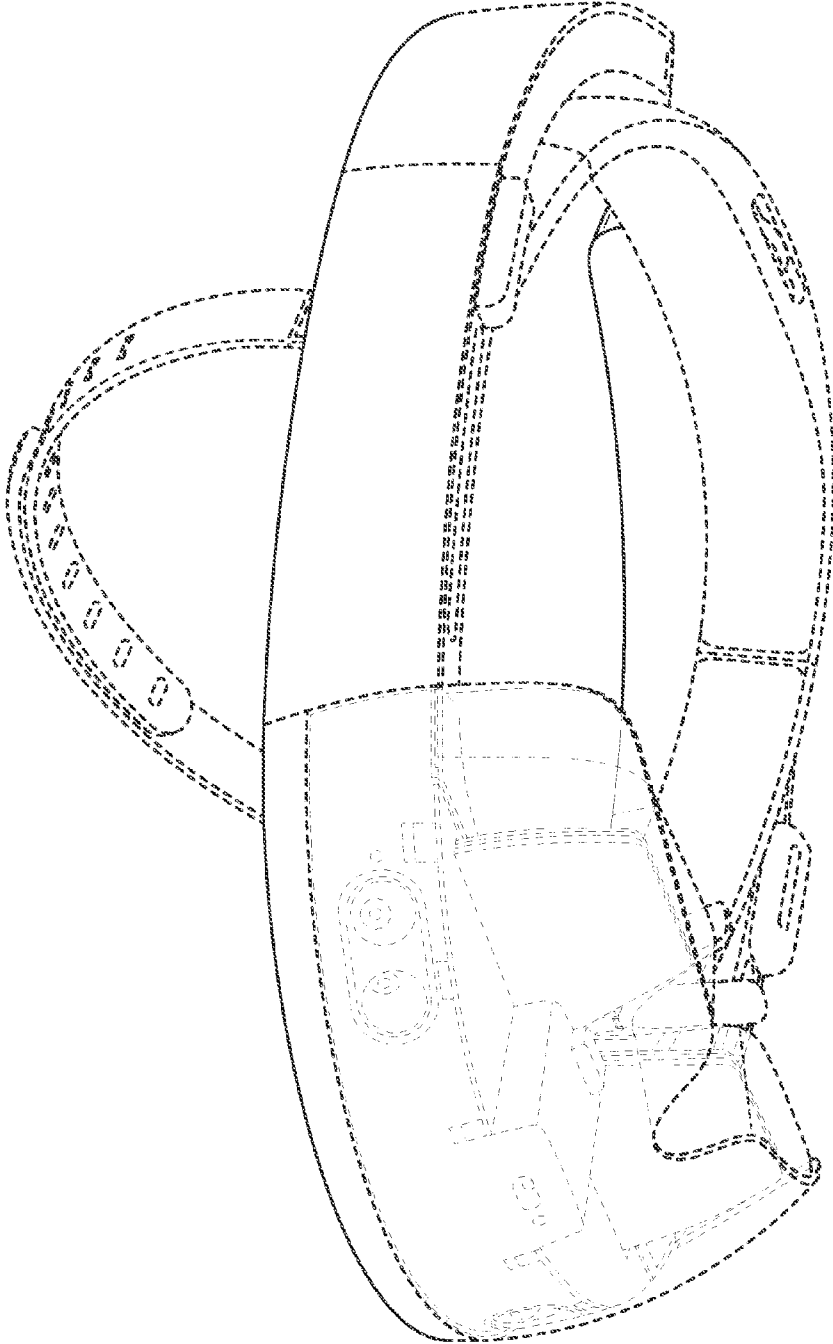

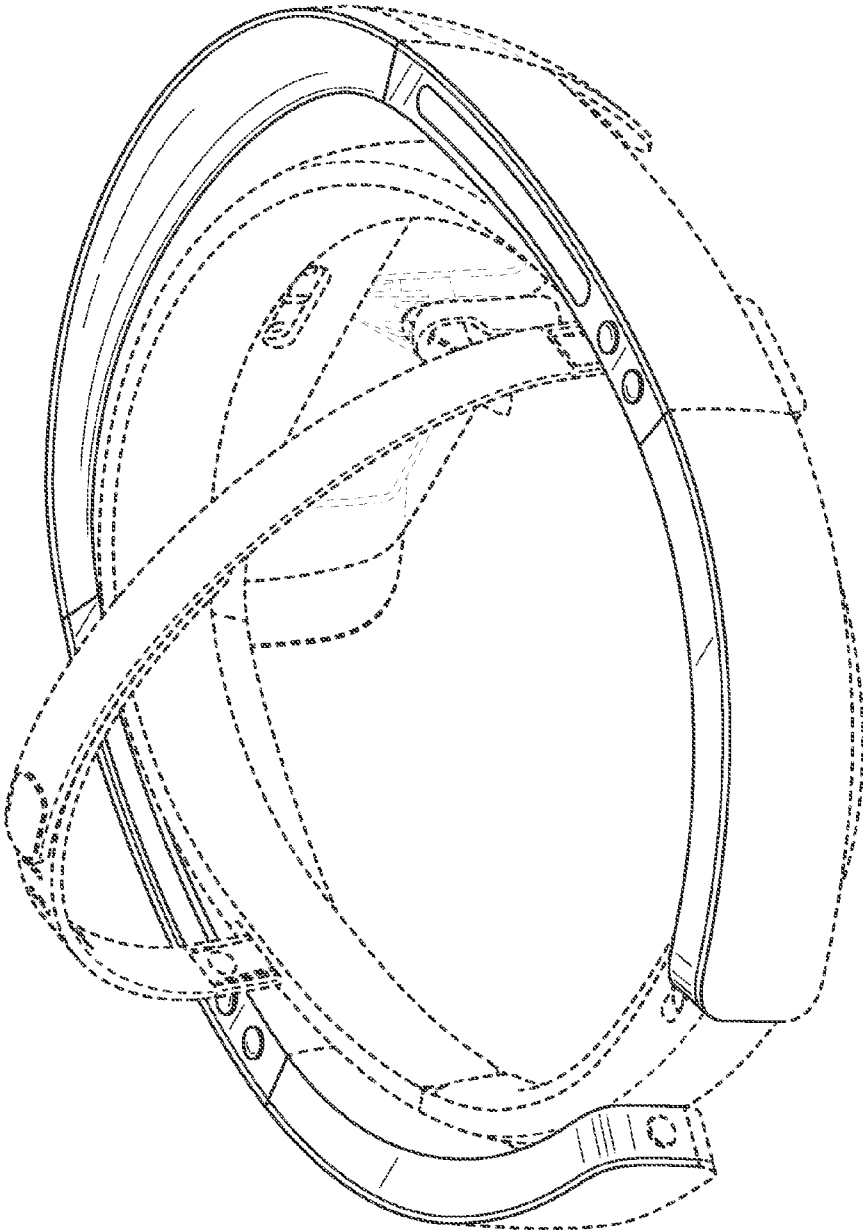

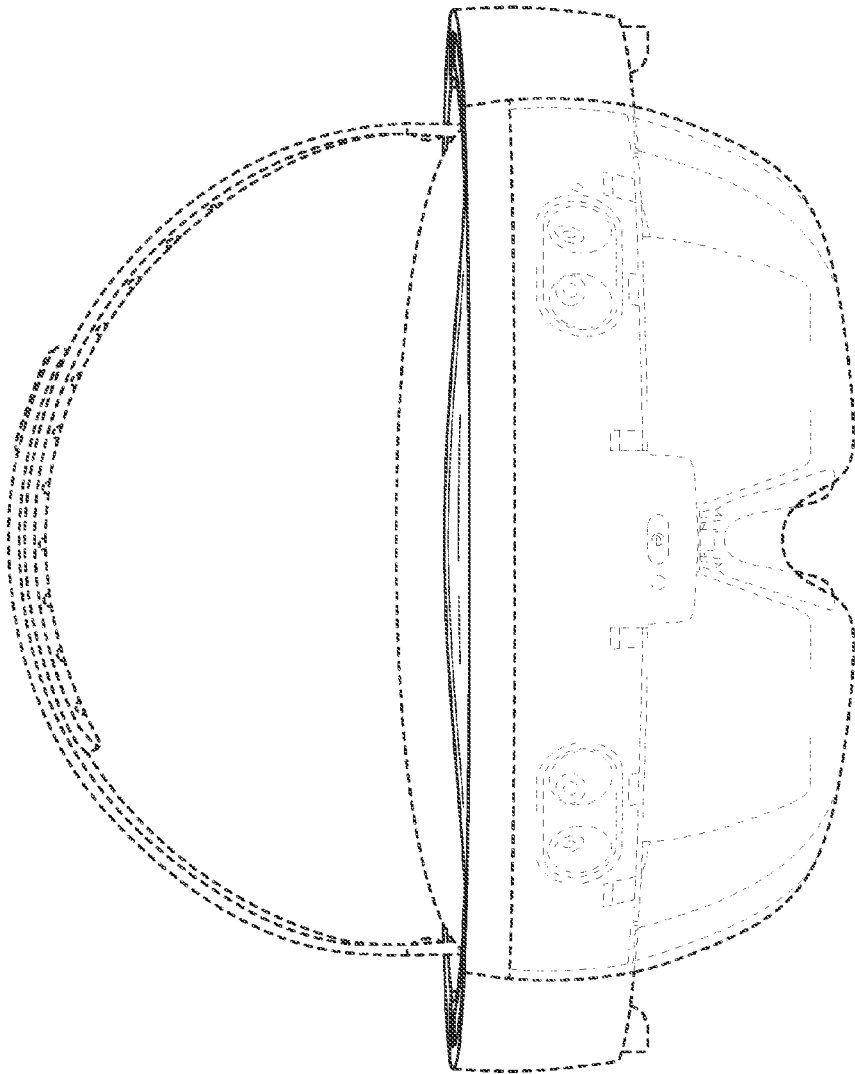

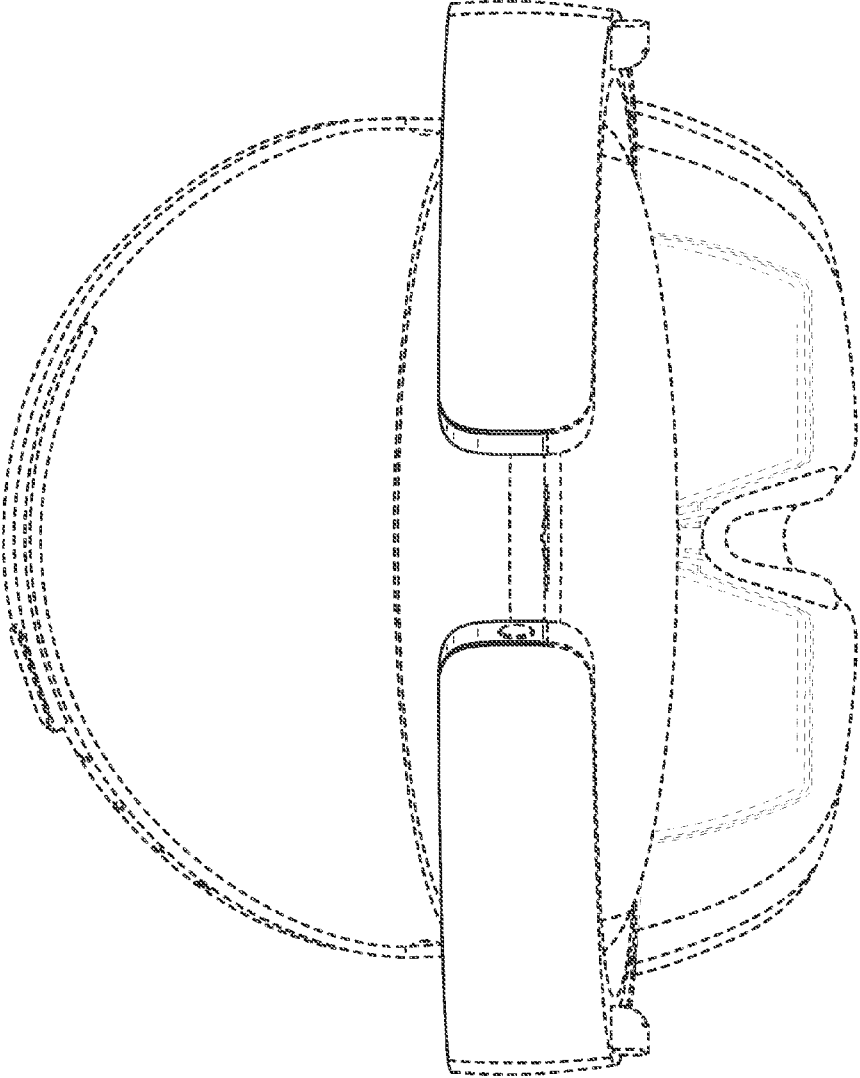

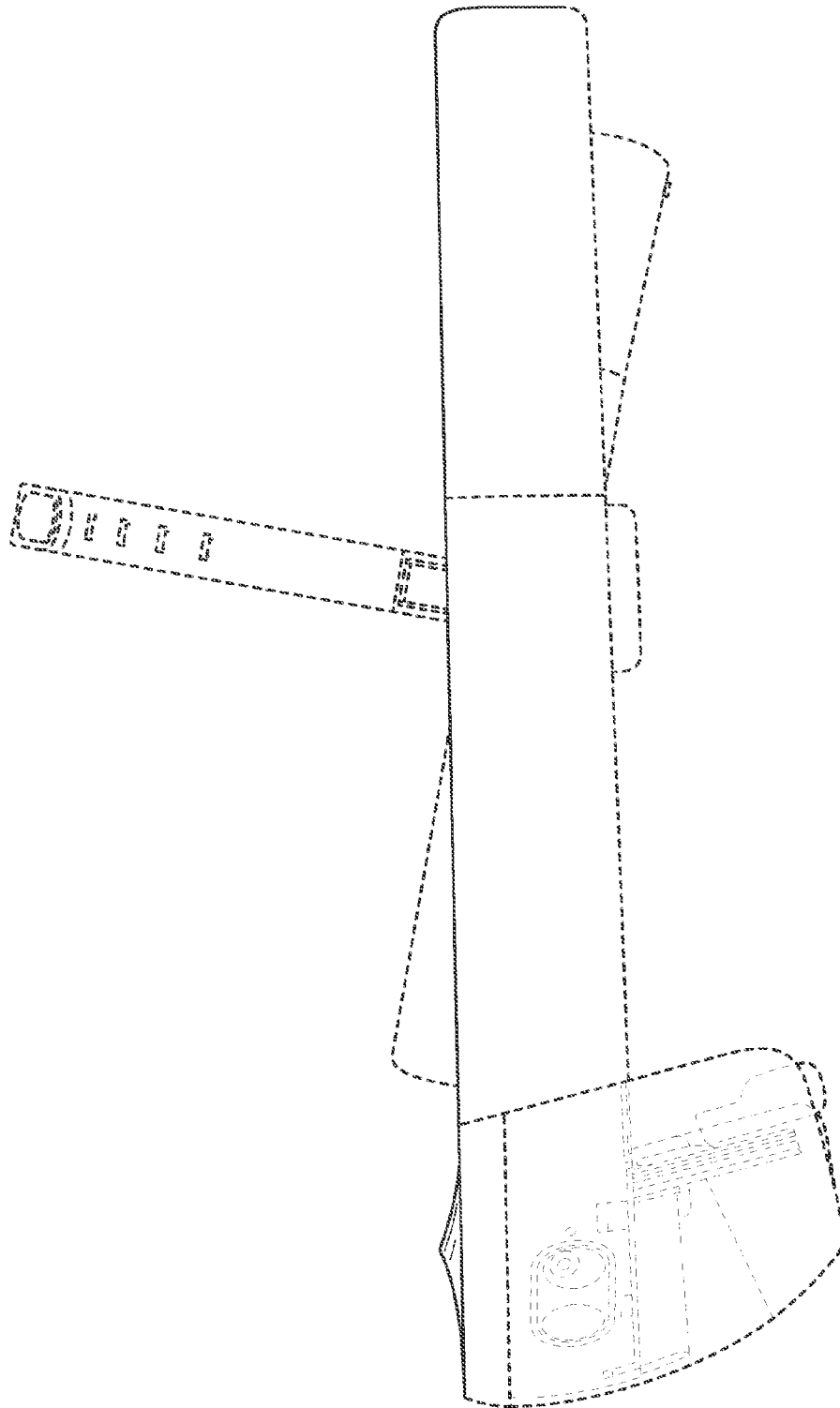

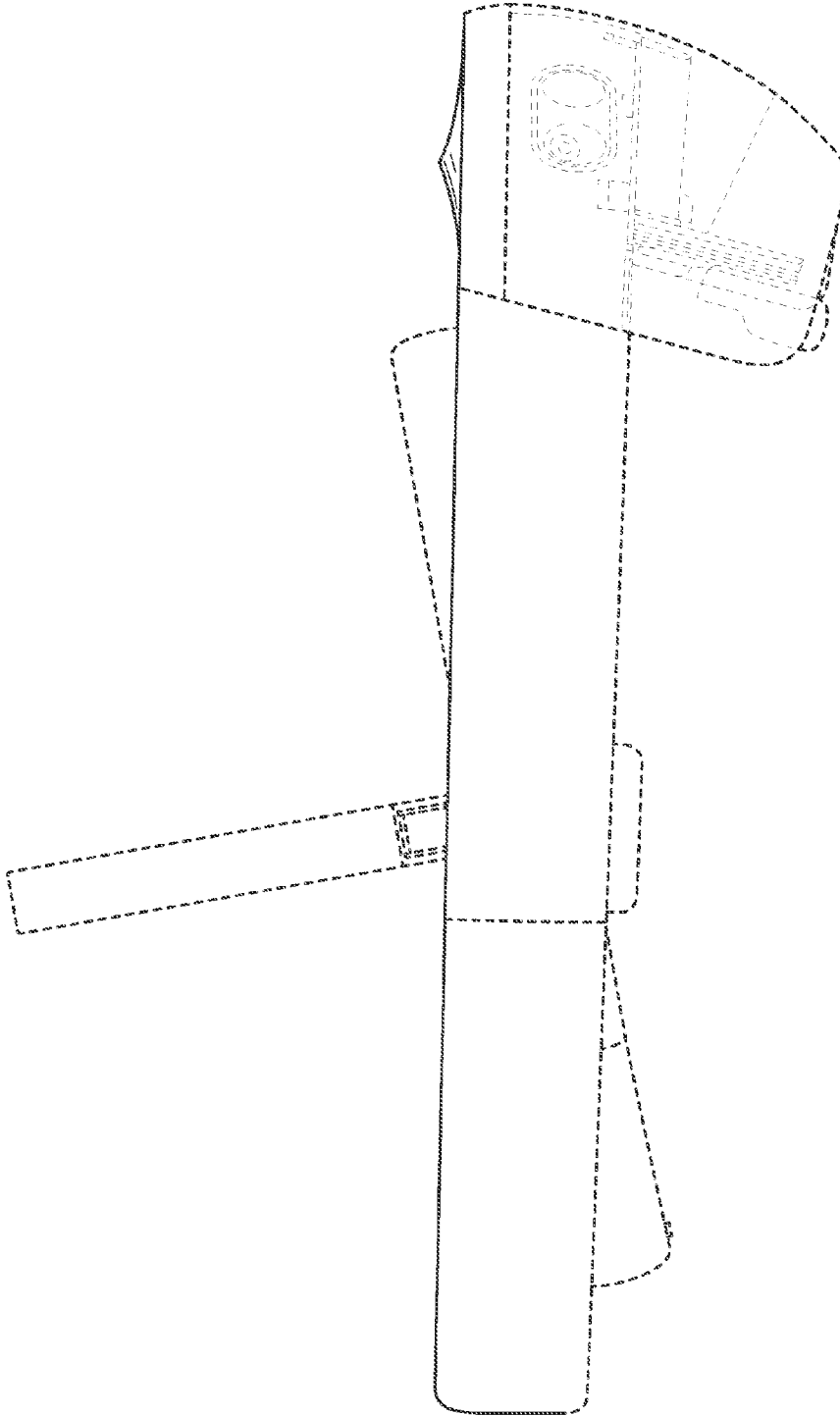

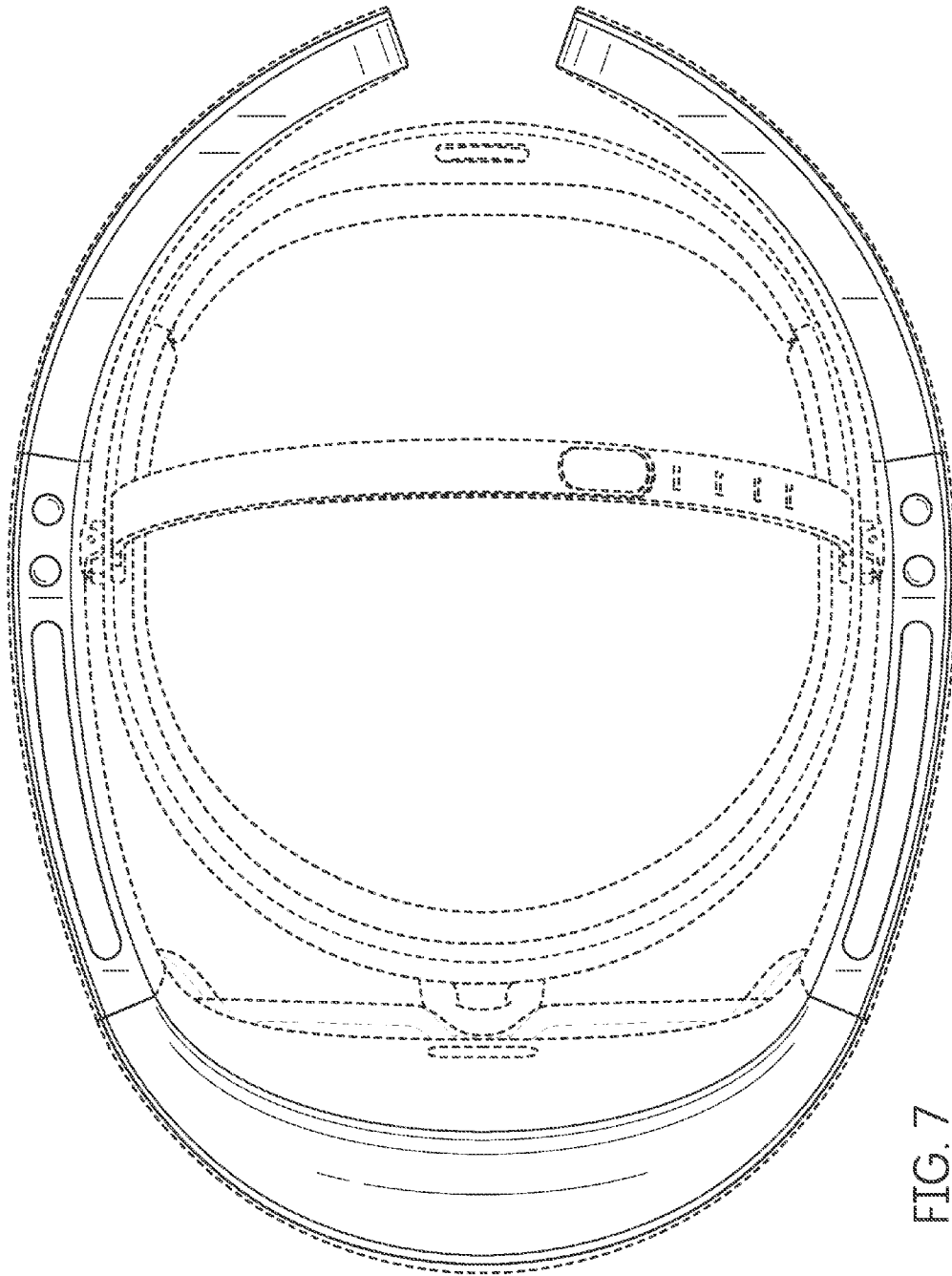

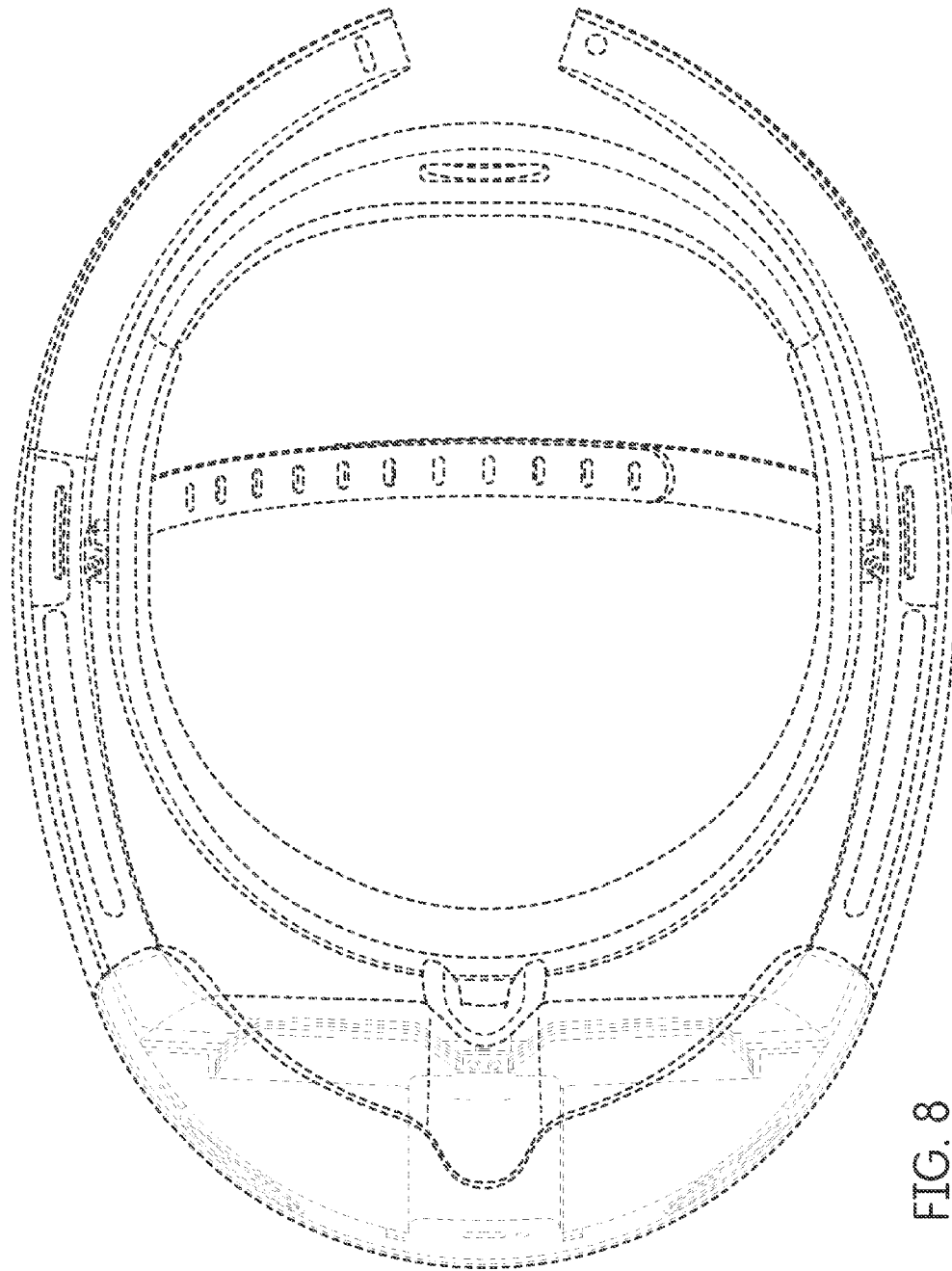

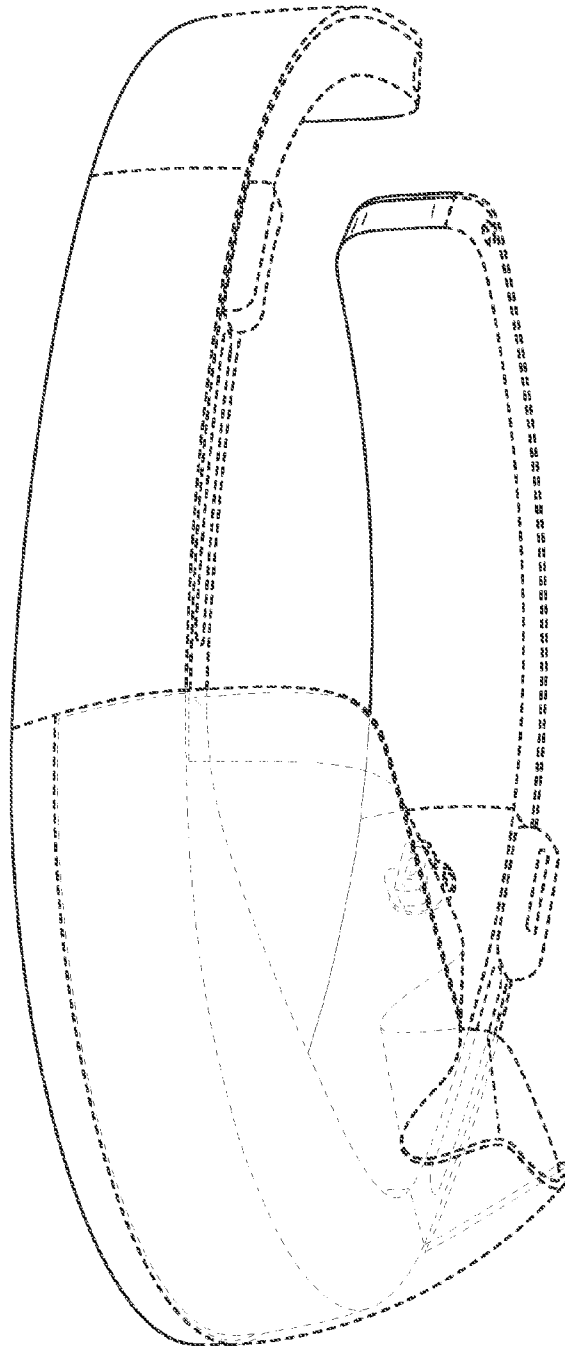

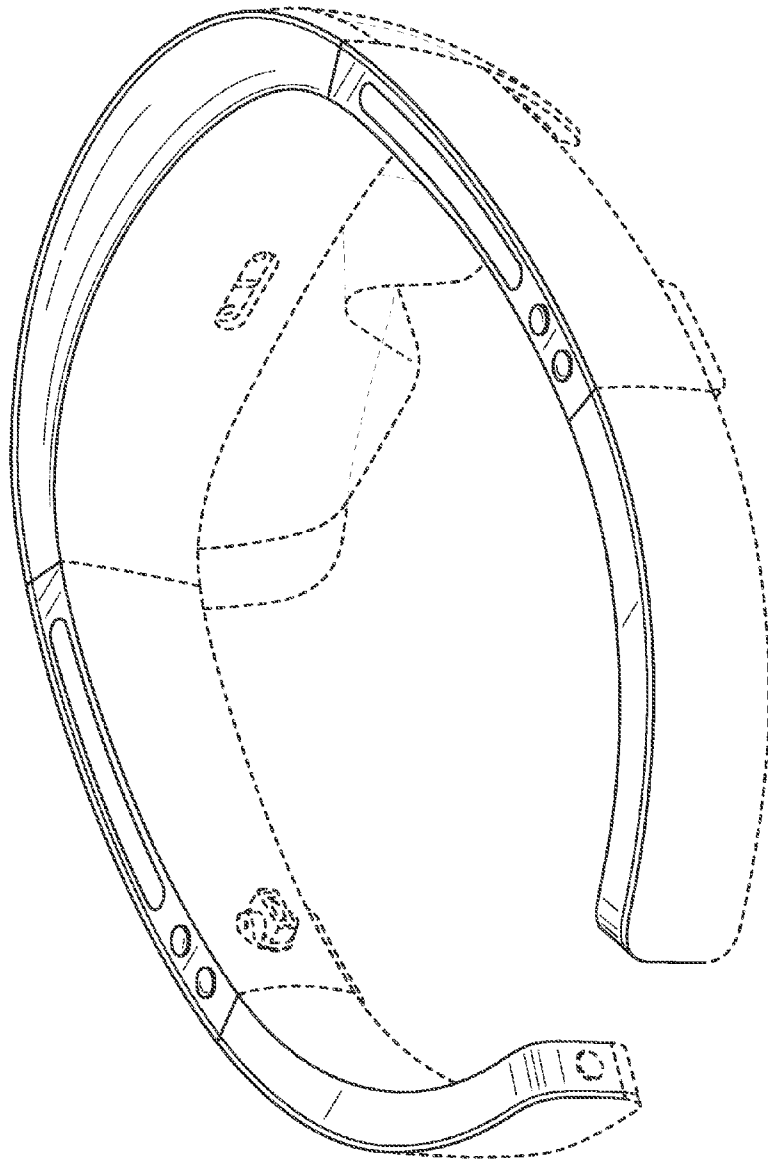

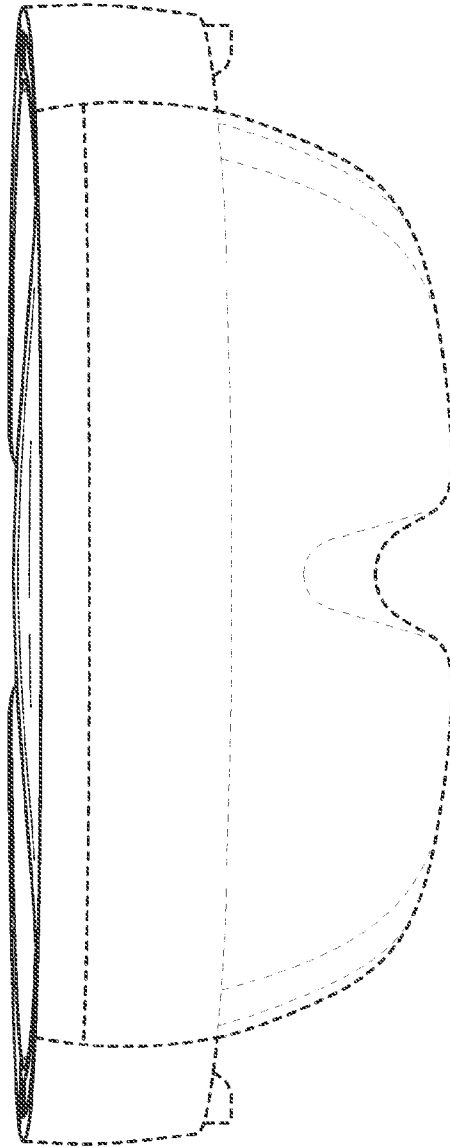

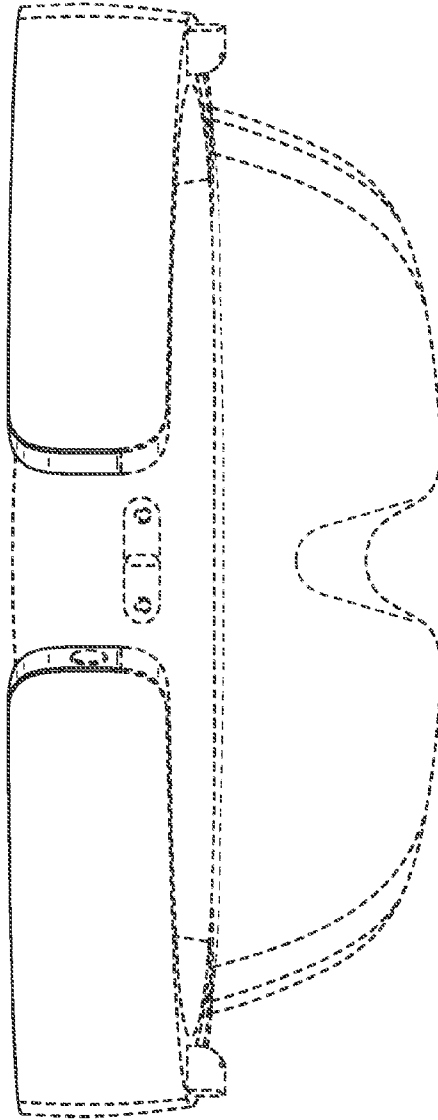

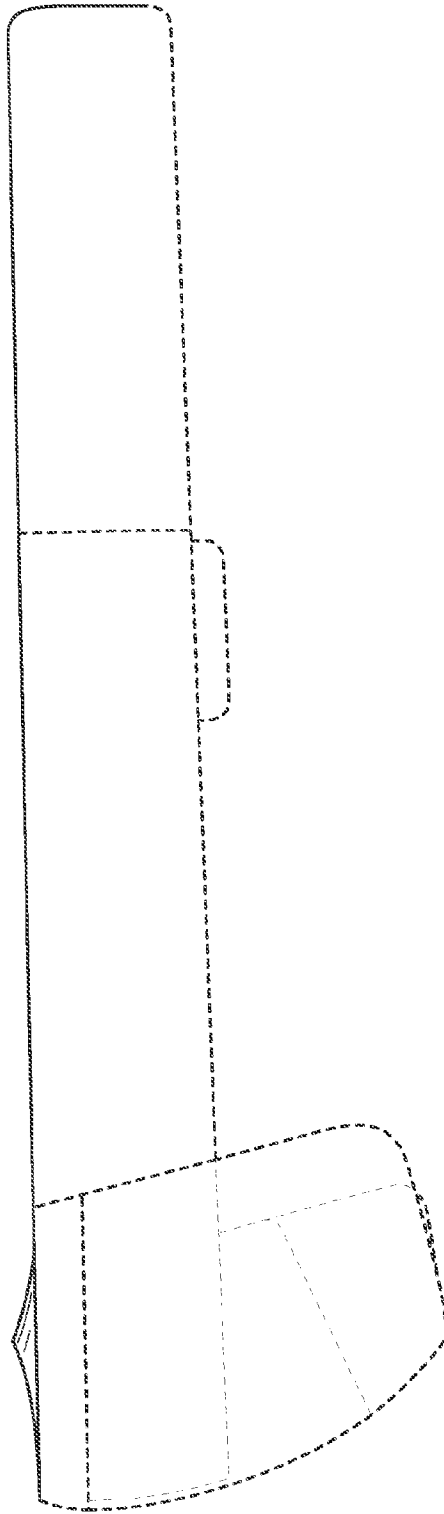

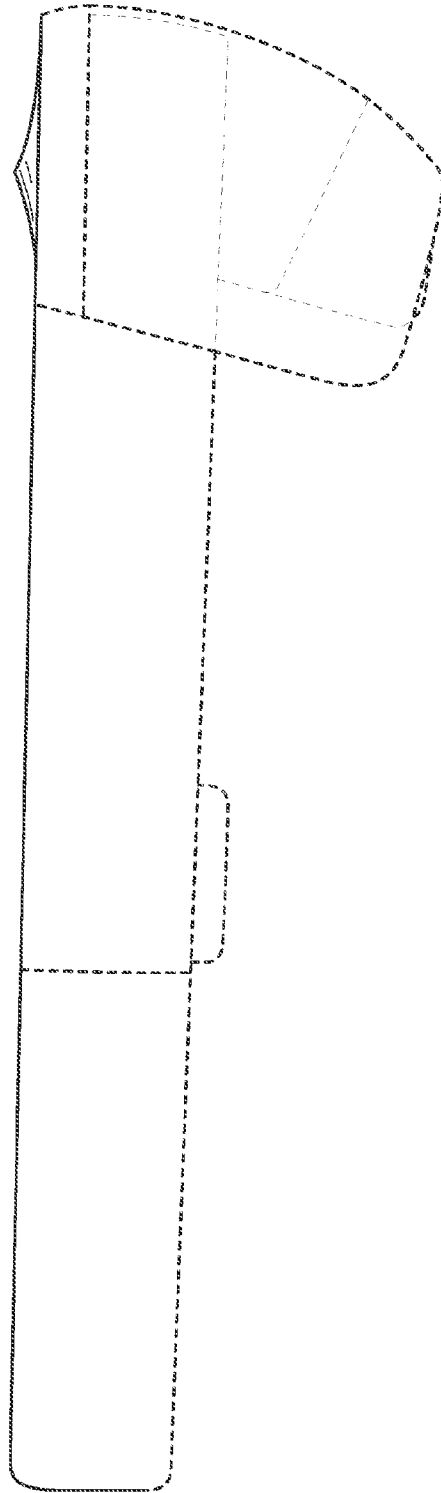

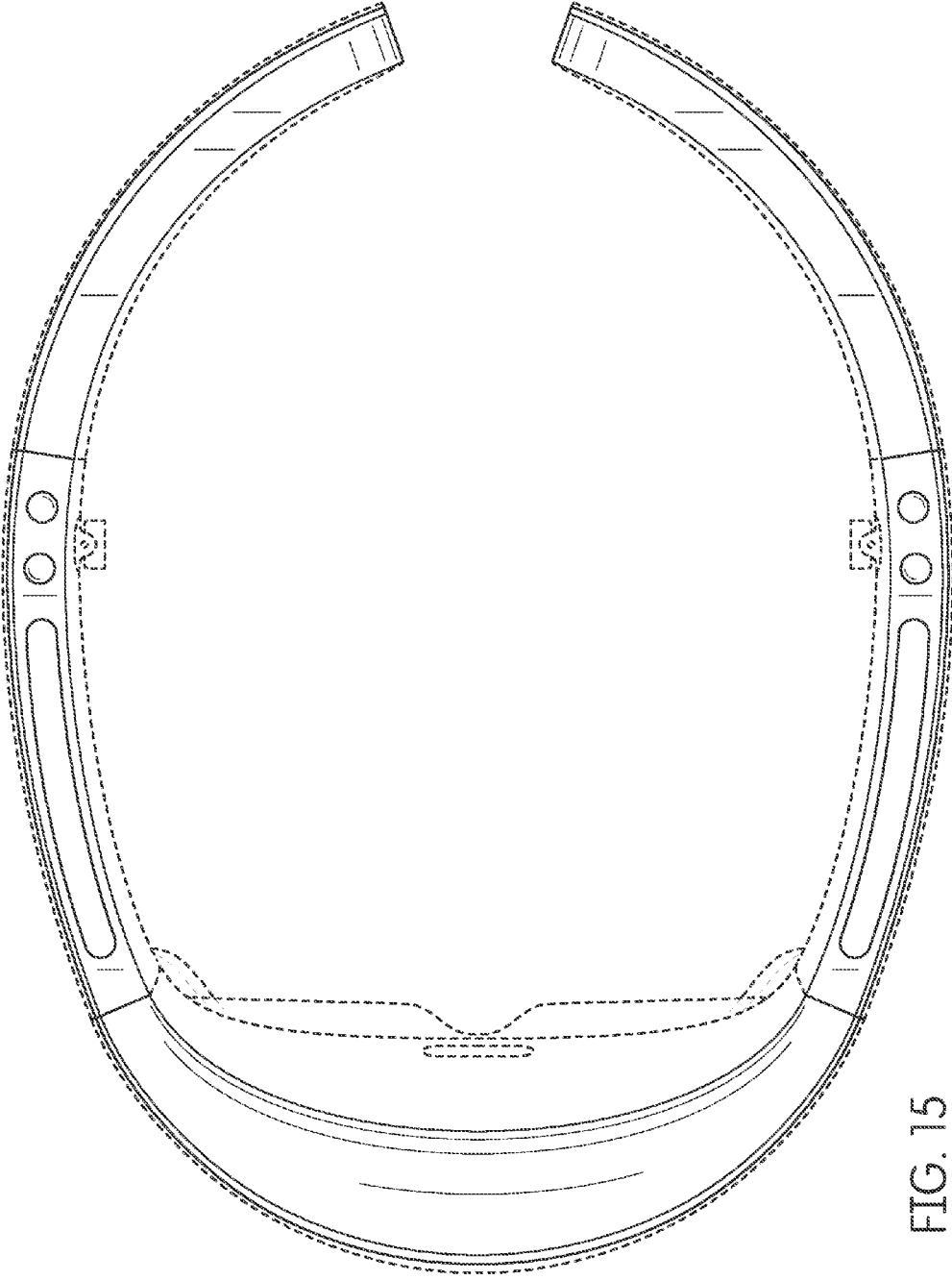

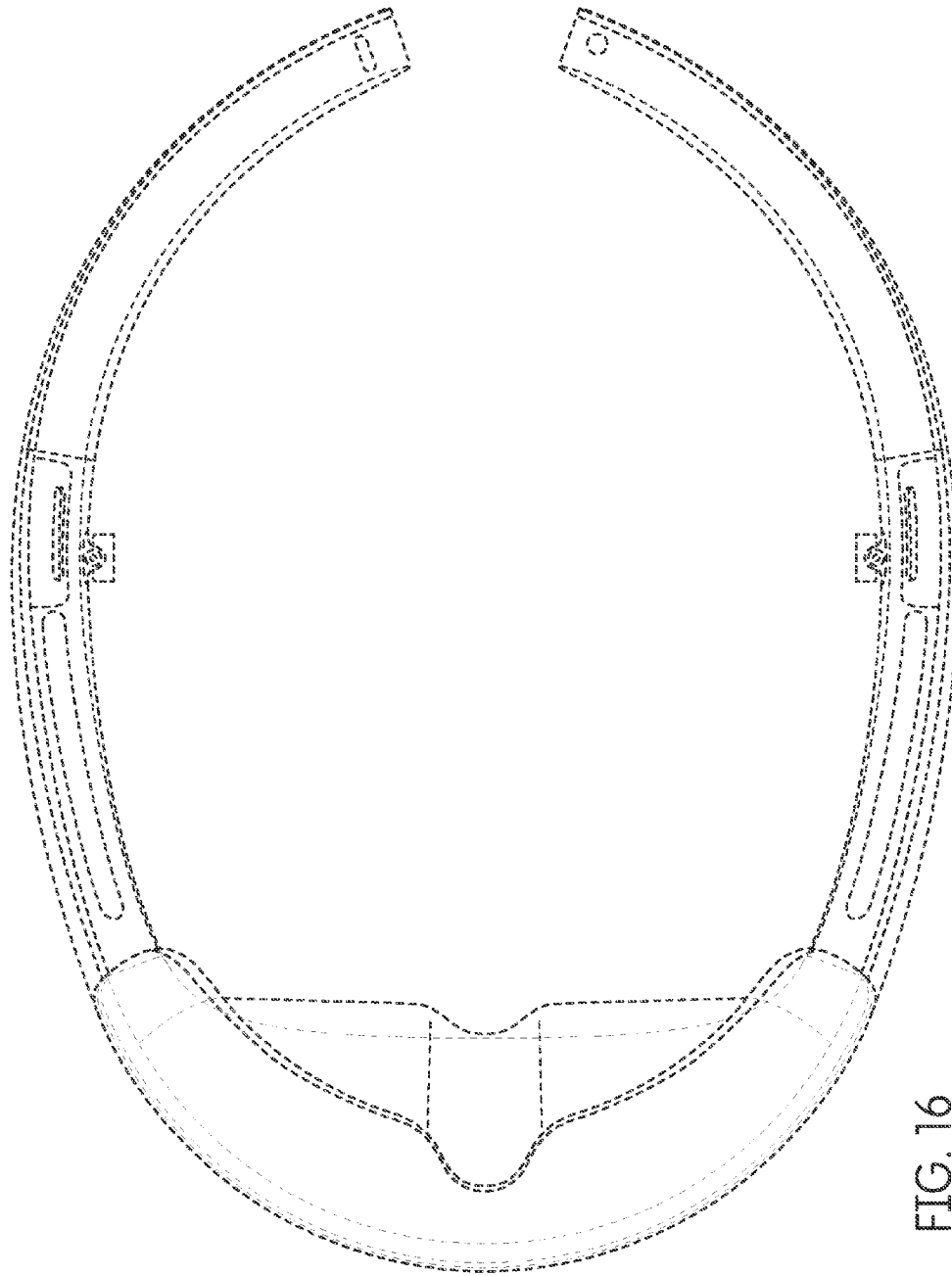
