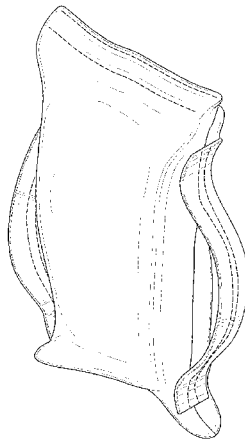
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a perspective view of an exercise bag.  
FIG. 2 is a front view of the exercise bag of FIG. 1.

FIG. 4 is a right side view of the exercise bag of FIG. 1.

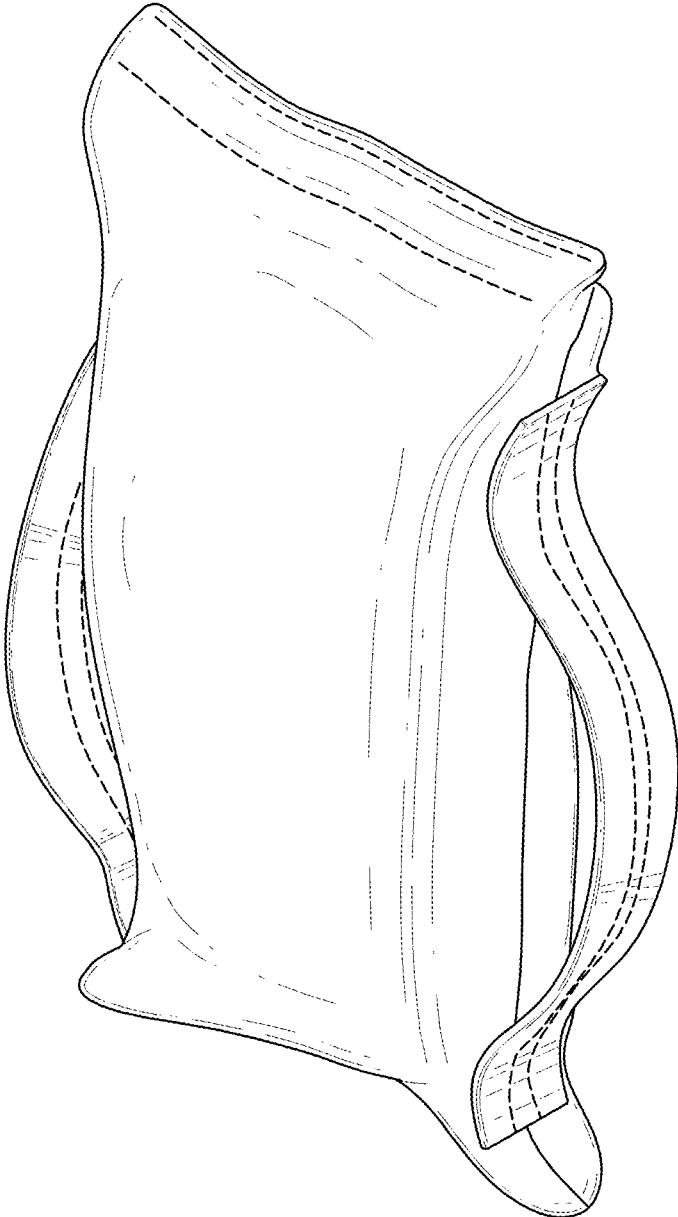

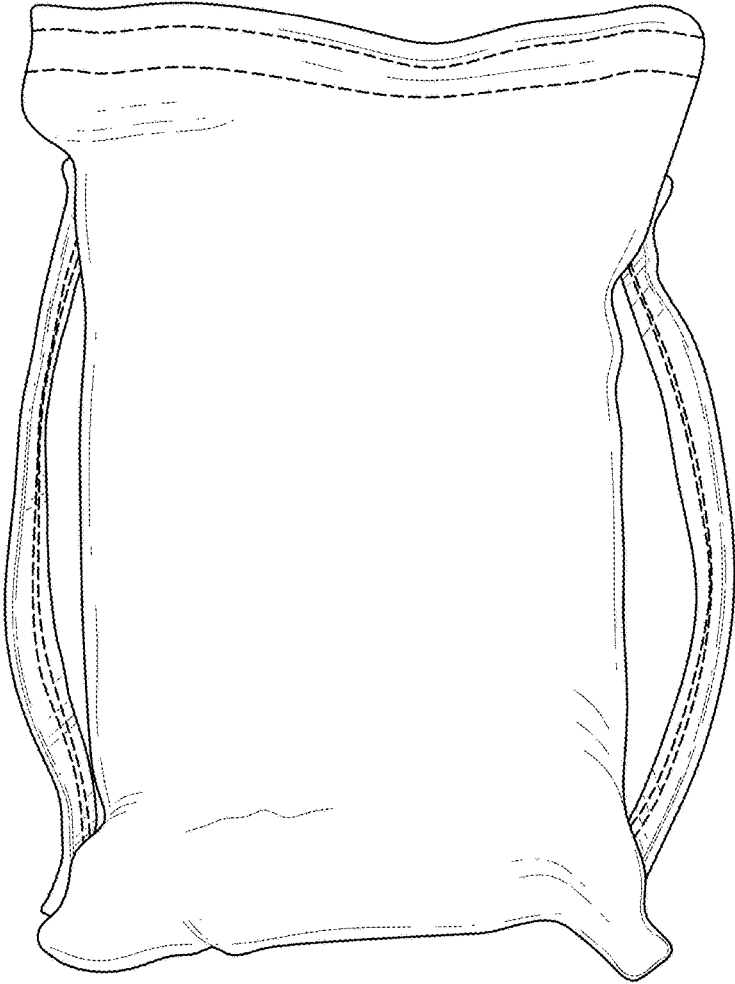

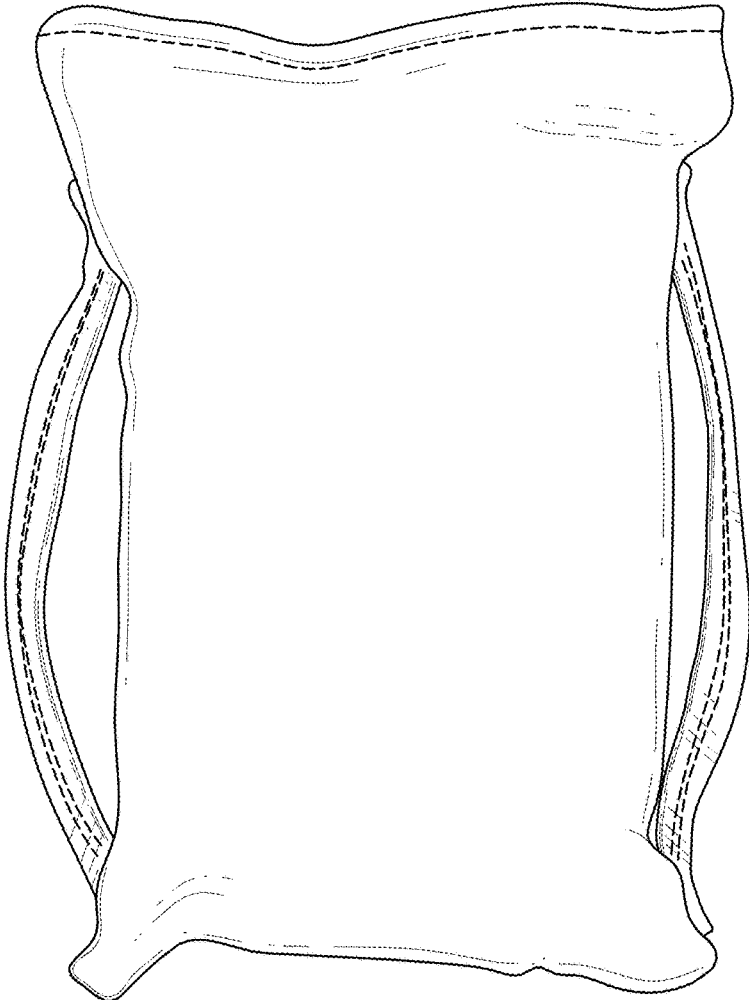

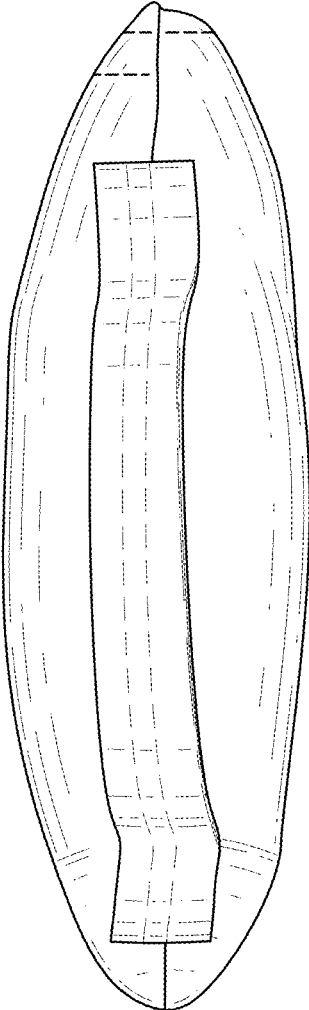

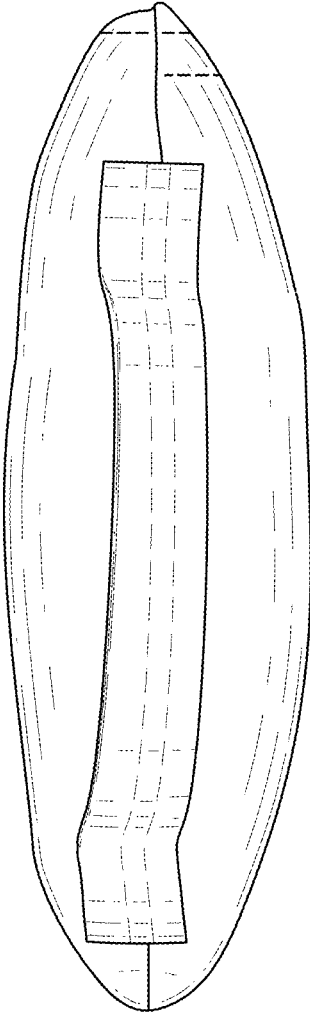

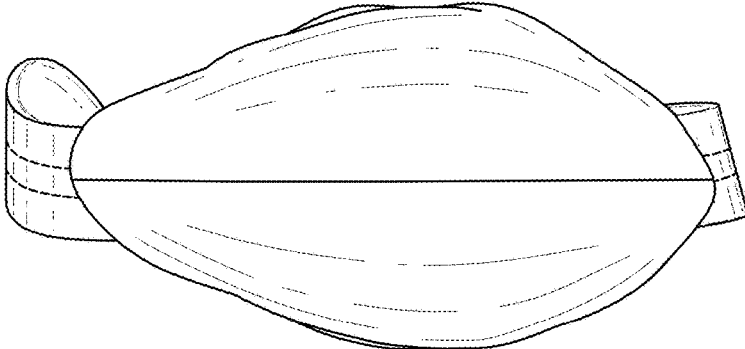

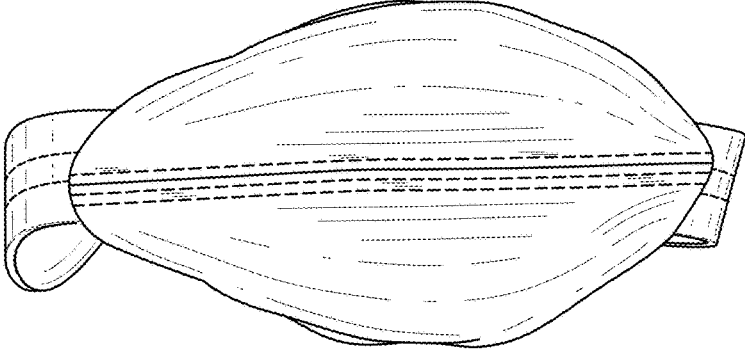
