DESCRIPTION

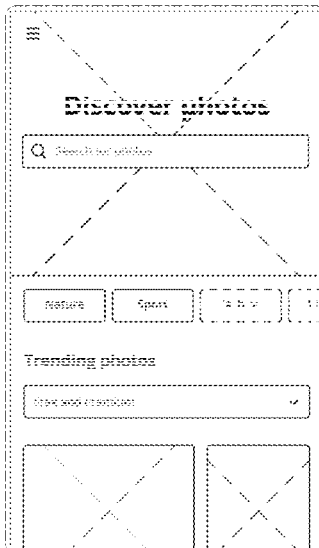
The single view is a front view of a display screen or portion thereof with a graphical user interface.
