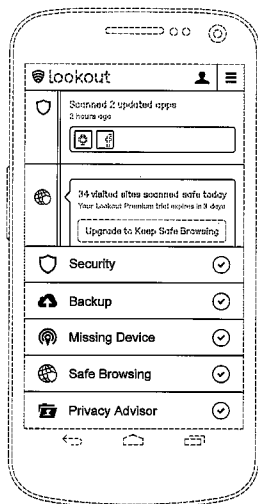
FIG. 1 is a front view of the first state in the sequence of a

FIG. 2 is a front view of the second state thereof; and,

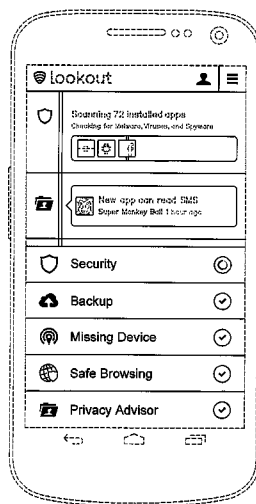
FIG. 3 is a front view of the third state thereof.

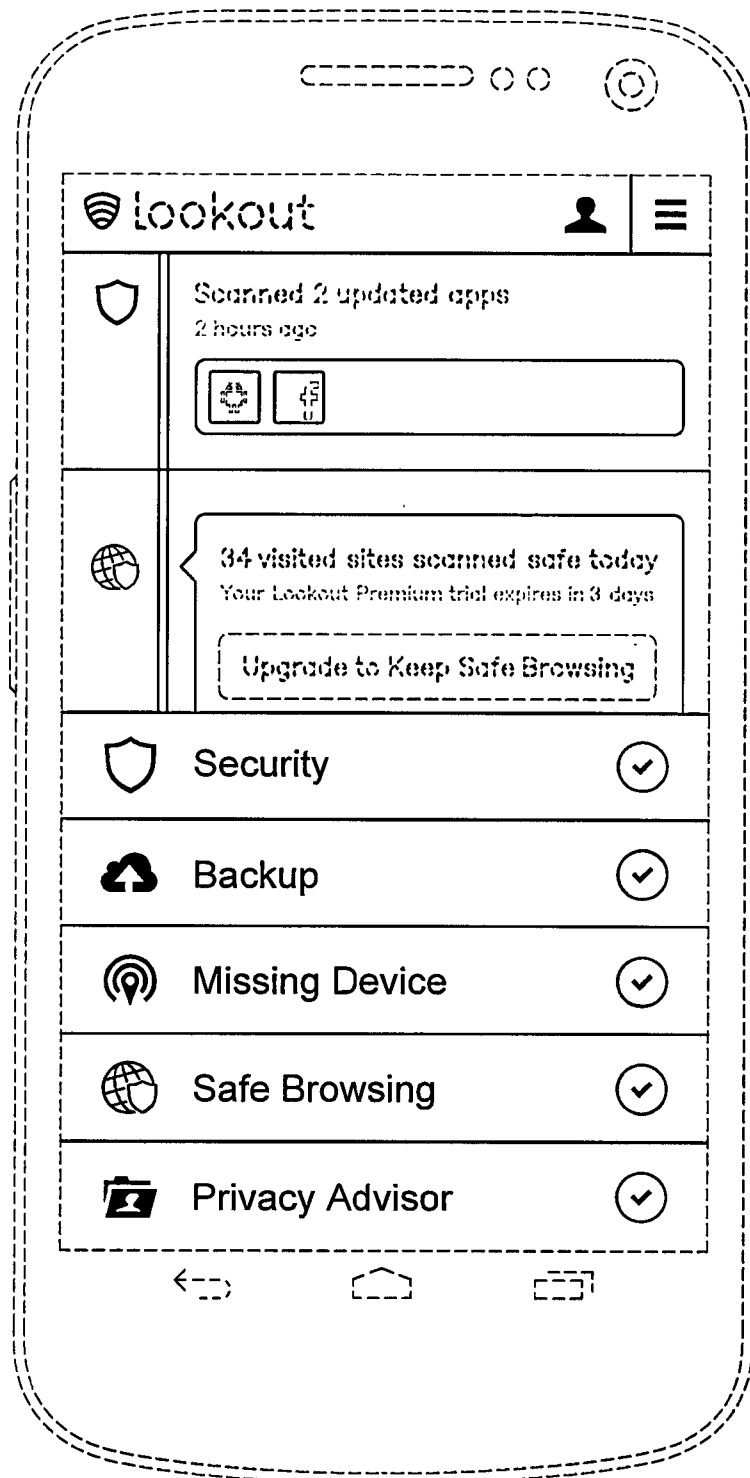

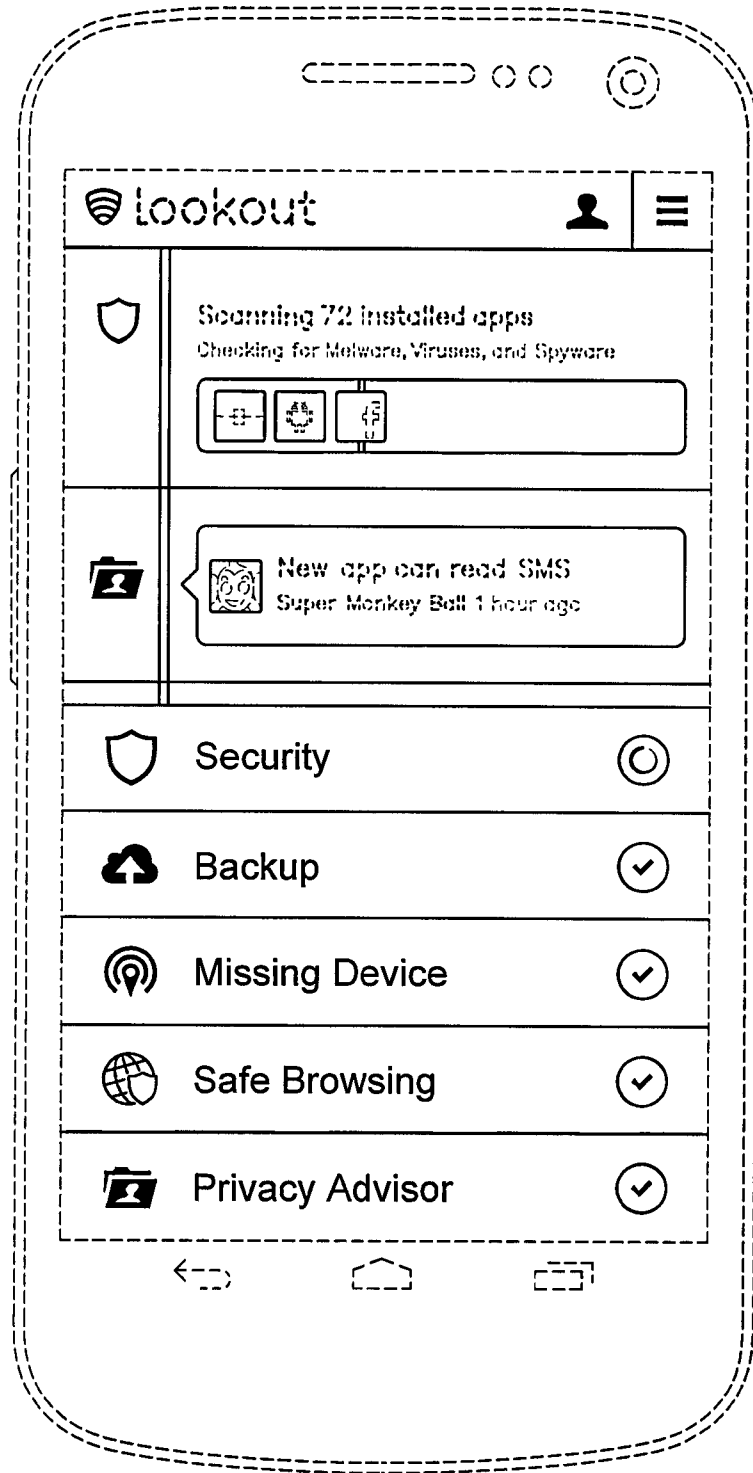

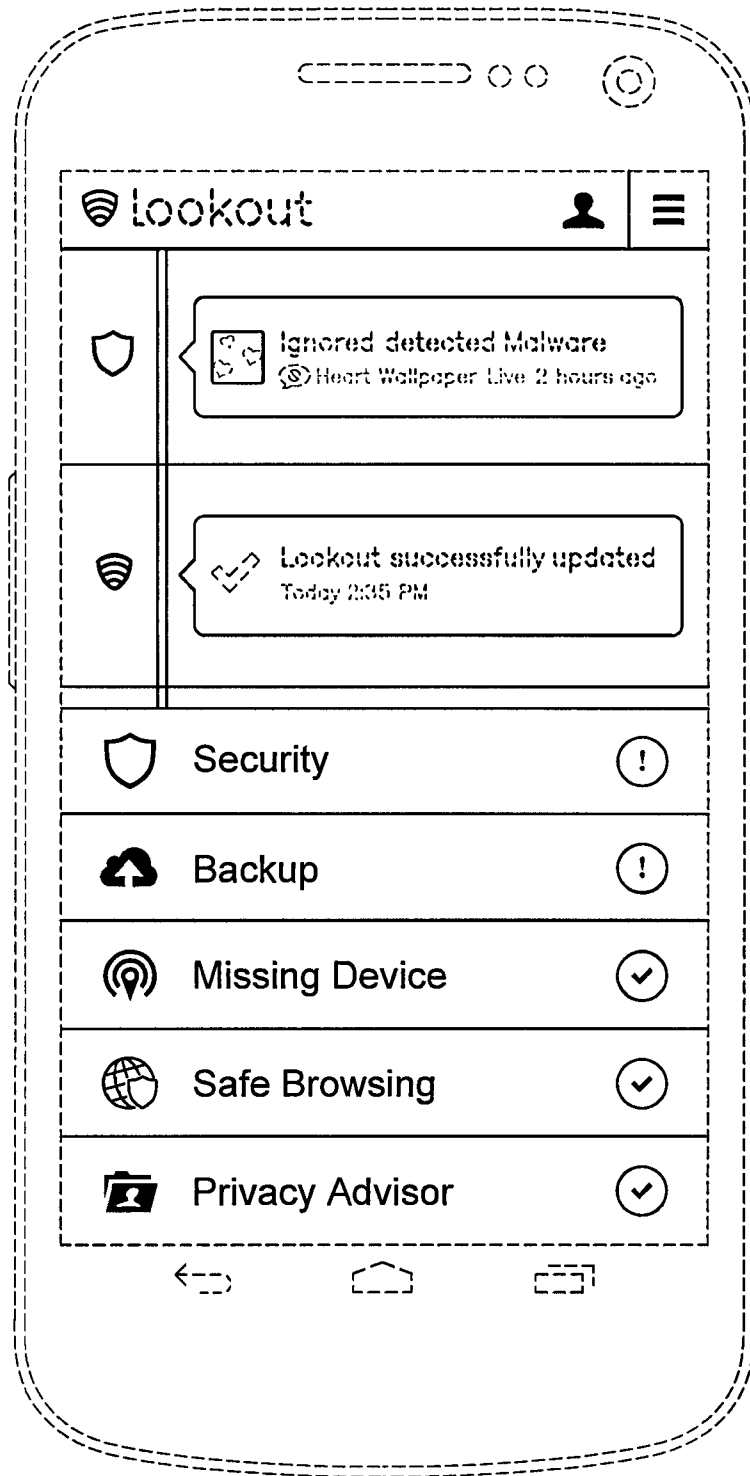
