**DESCRIPTION**

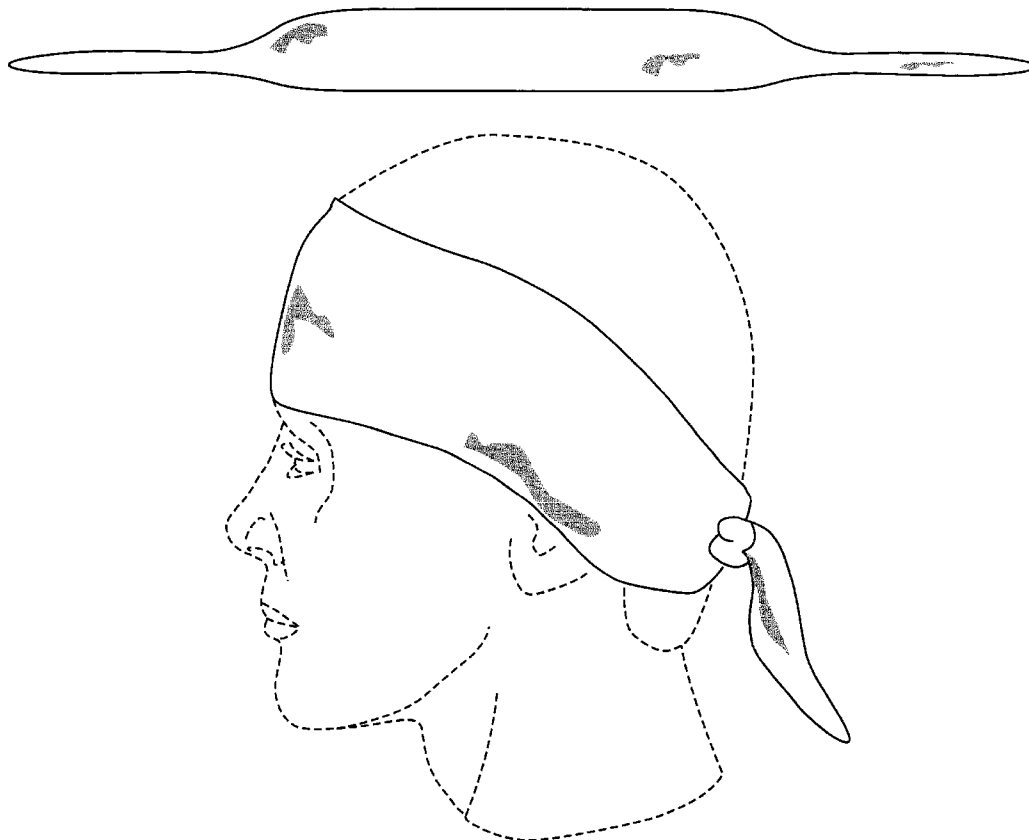
FIG. 1 is a front view of an ornamental design for a headband.

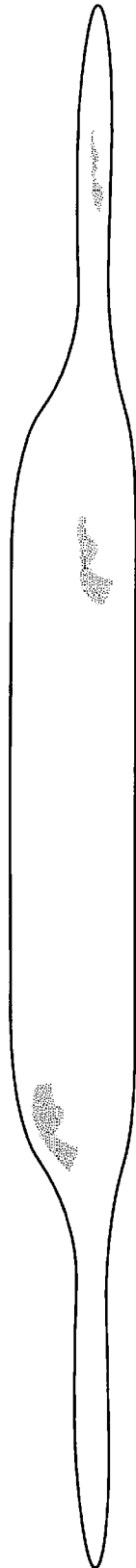
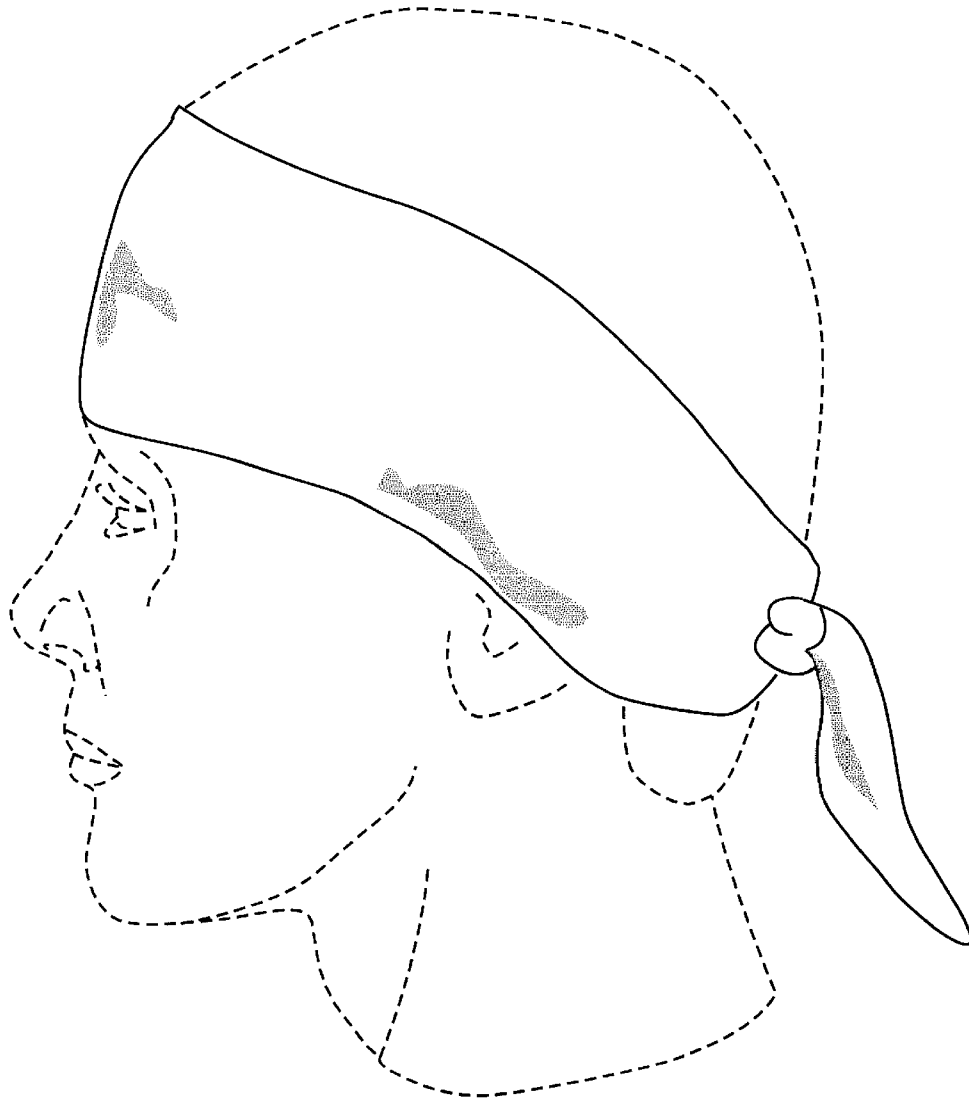
