**DESCRIPTION**

FIG. 1 is a perspective view of a package showing our new design.

FIG. 2 is a top plan view thereof.

FIG. 3 is a left-side elevational view thereof, the right-side elevational view being identical thereto.

FIG. 4 is a front elevational view thereof, the rear elevational view being identical thereto; and,

FIG. 5 is a bottom plan view thereof.

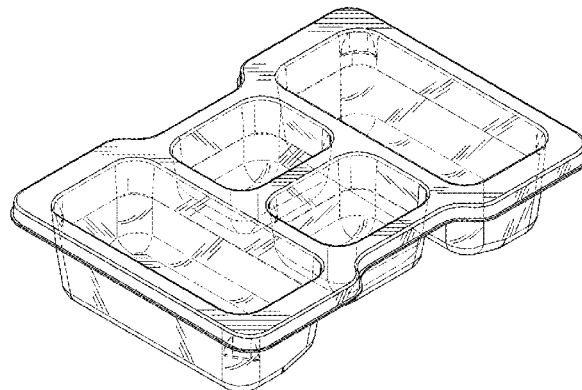
The broken lines shown illustrate portions of the package that form no part of the claimed design.

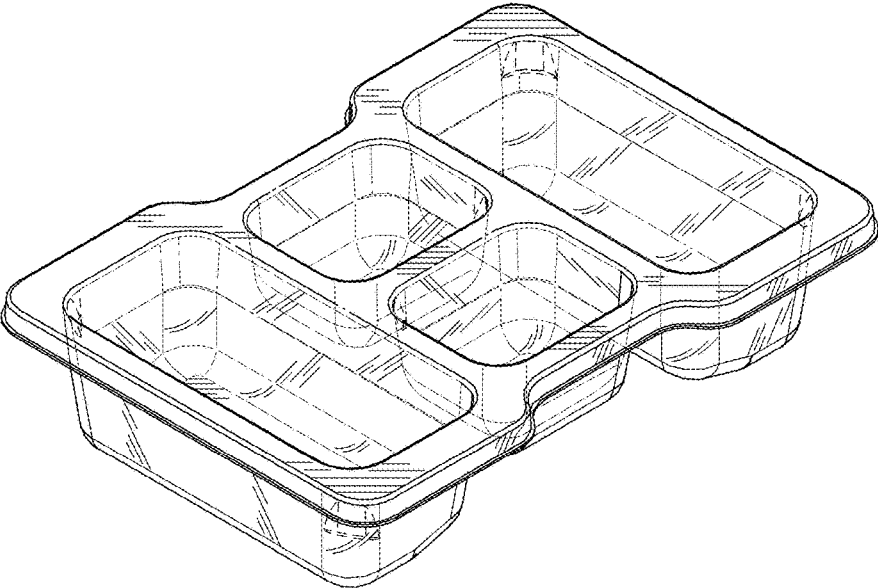

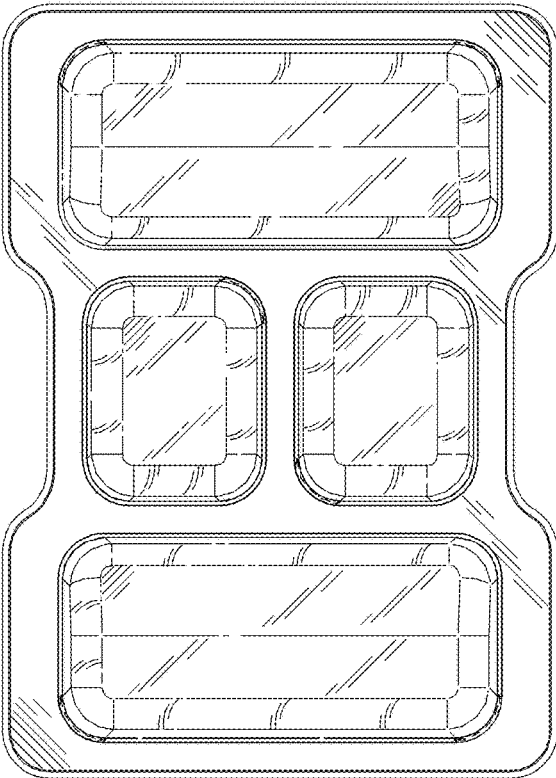

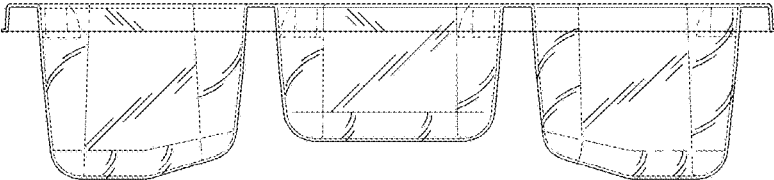

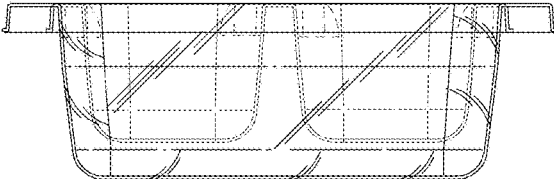
