(57) **CLAIM**

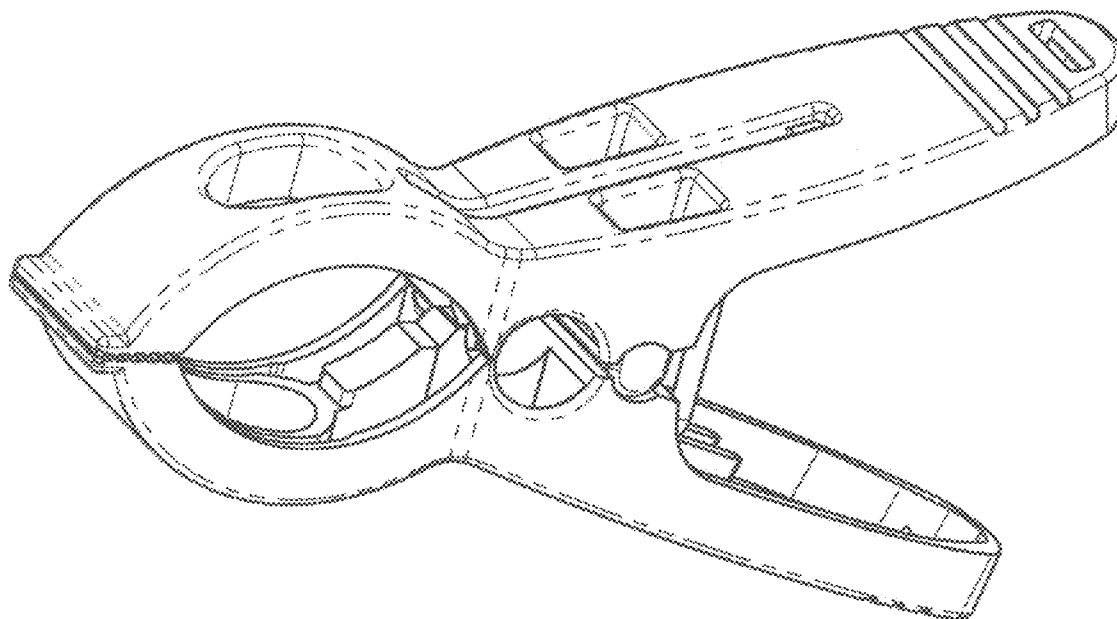
The ornamental design for a call bell stabilizer, as shown and described.

**DESCRIPTION**

FIG. 1 is an enlarged top, front, left side perspective view of a call bell stabilizer showing my new design; FIG. 2 is a right side elevational view thereof, the left side elevational view being a mirror image thereof; FIG. 3 is a front elevational view thereof; FIG. 4 is a rear elevational view thereof; and, FIG. 5 is a top plan view thereof, the bottom plan view being a mirror image thereof.

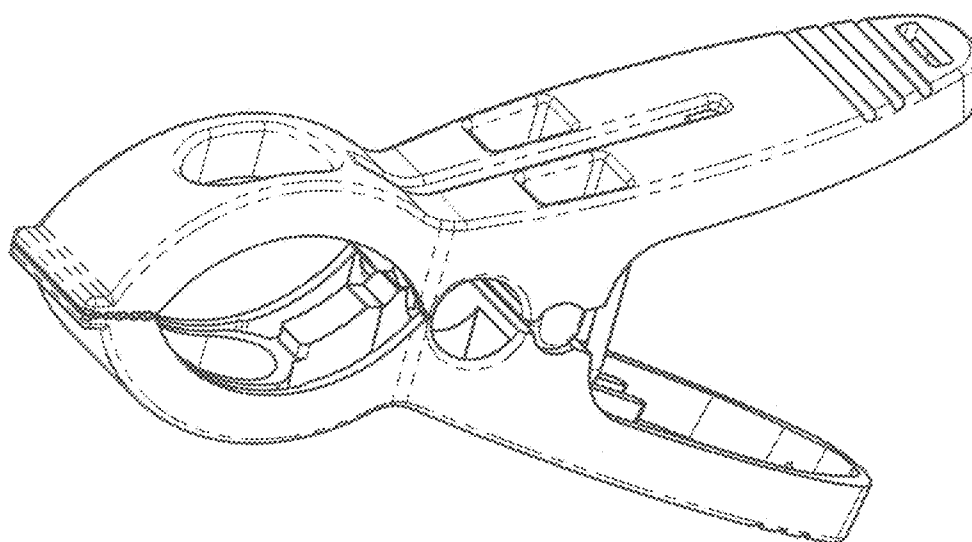

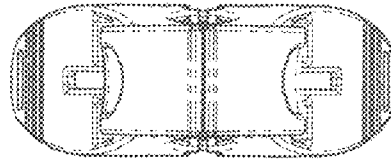

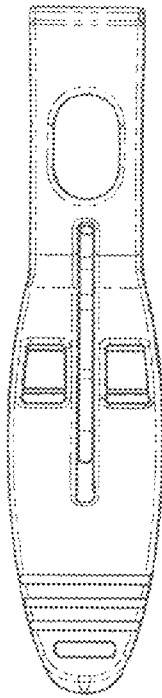

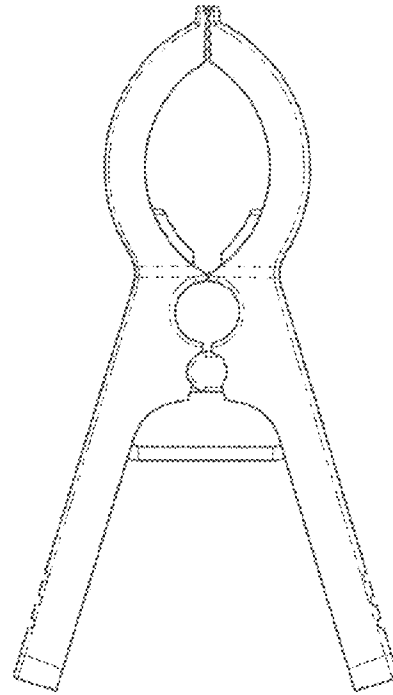

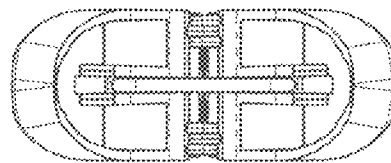
