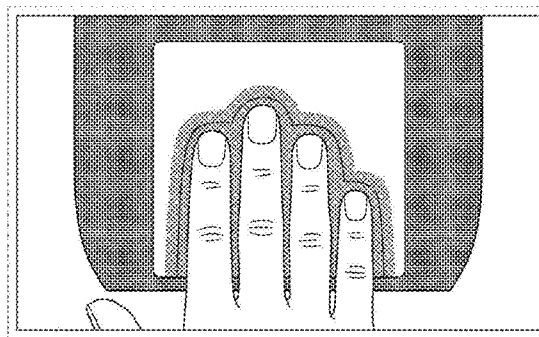
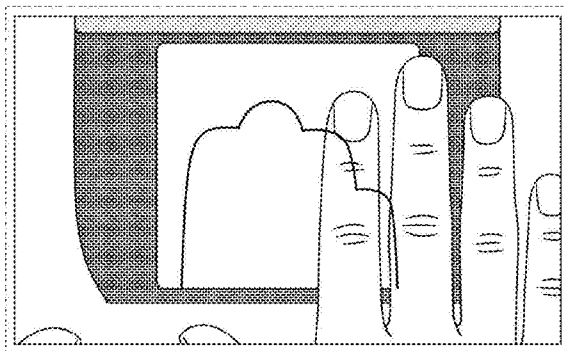
The ornamental design for a display with animated graphical user interface, as shown and described.

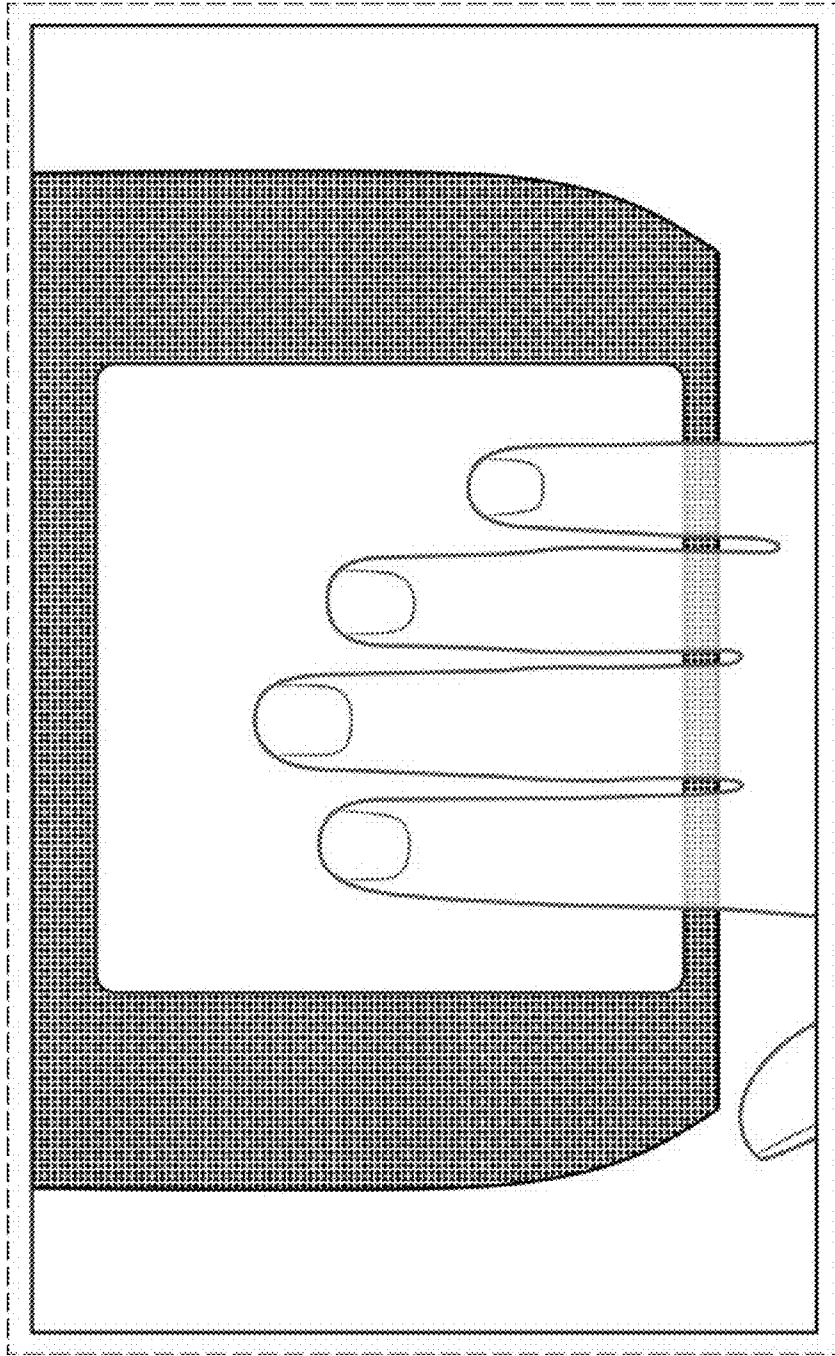

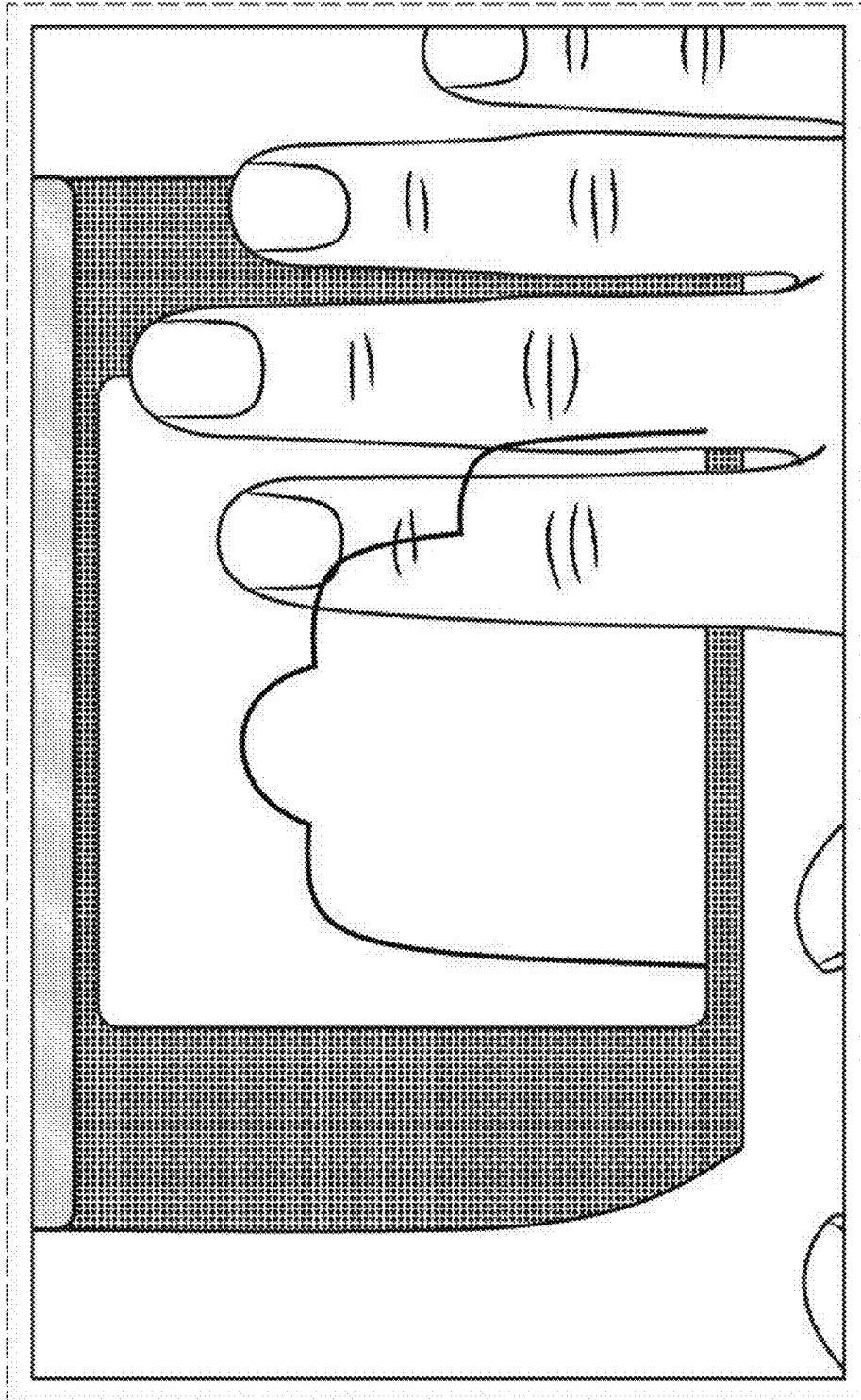

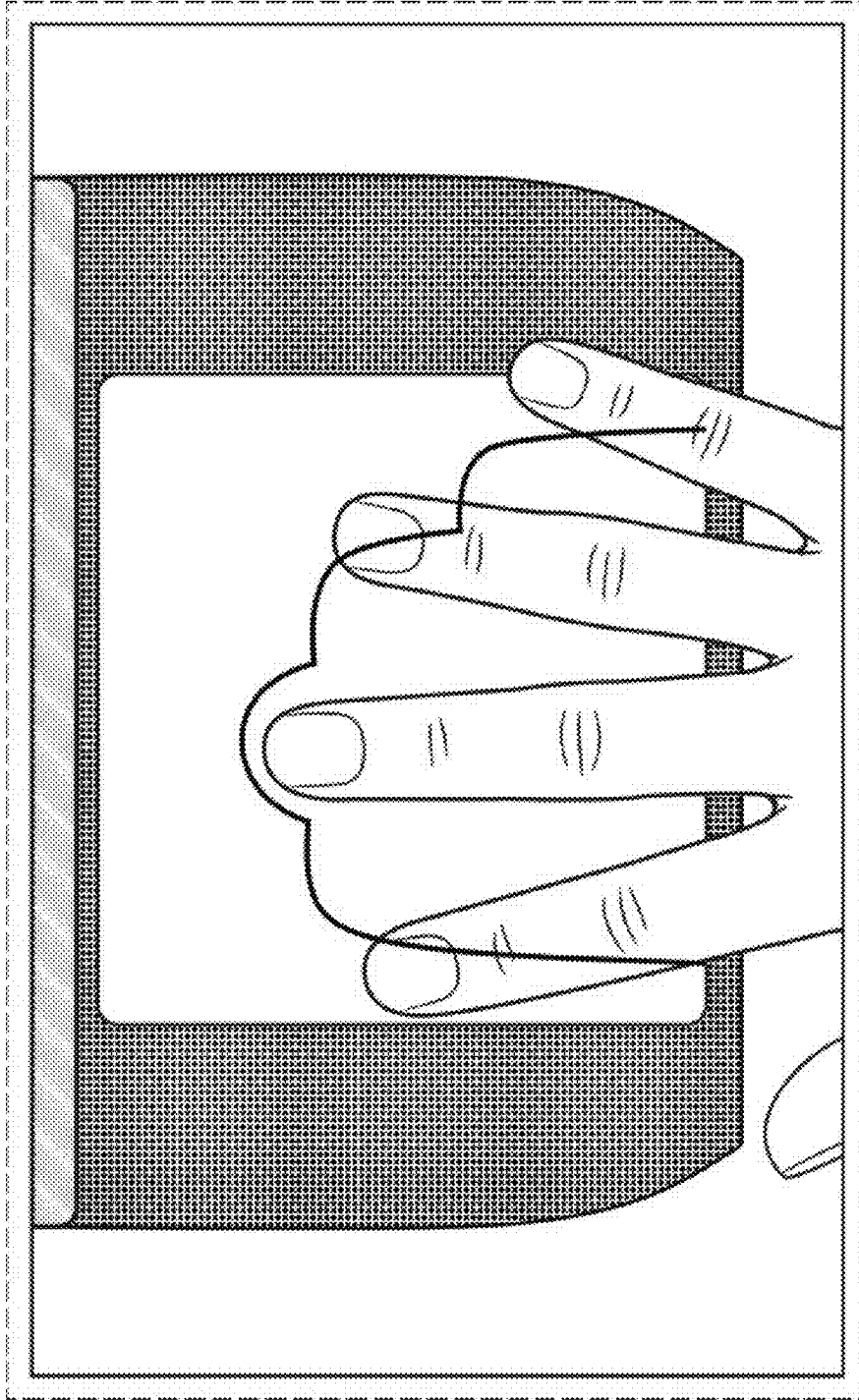

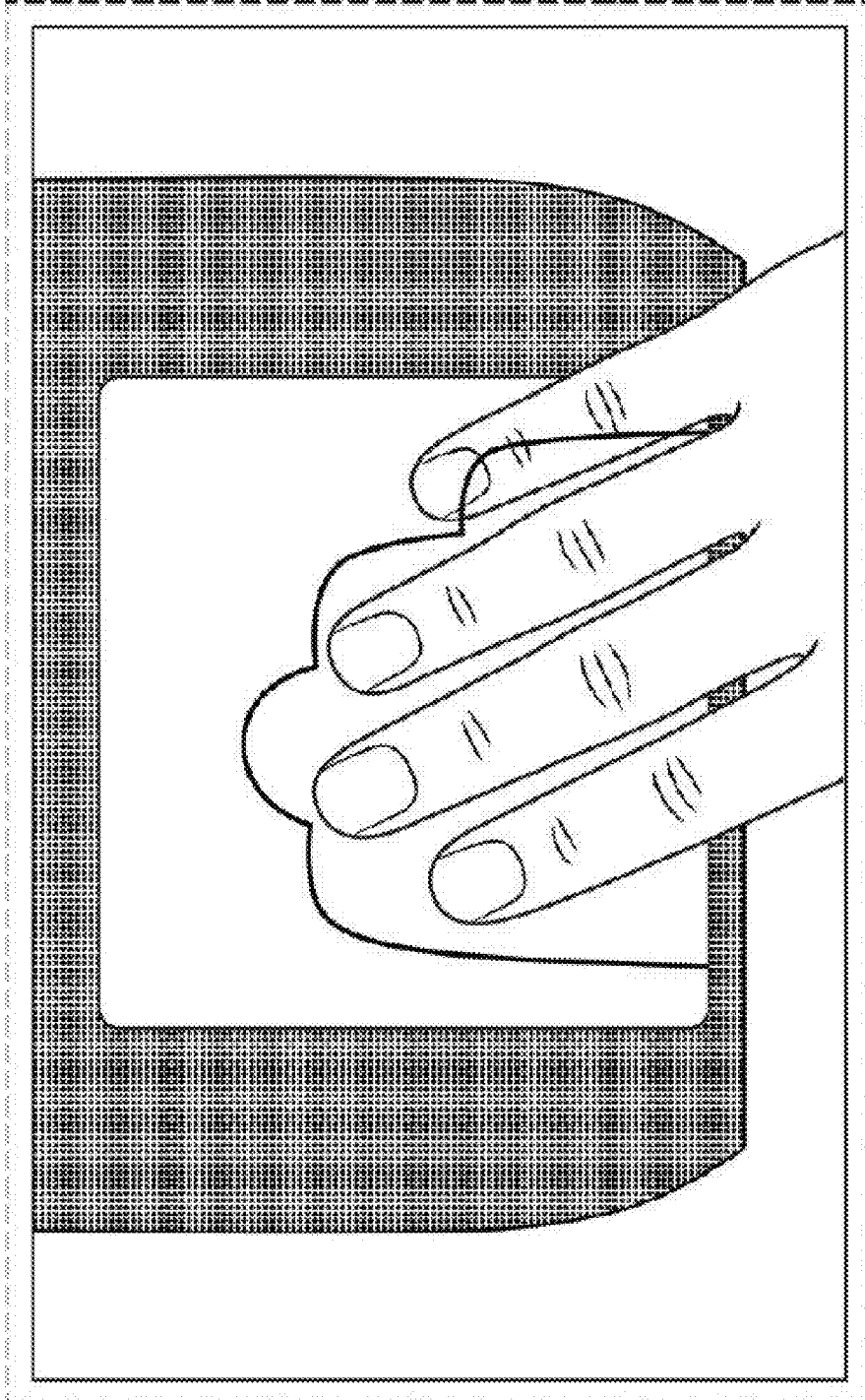

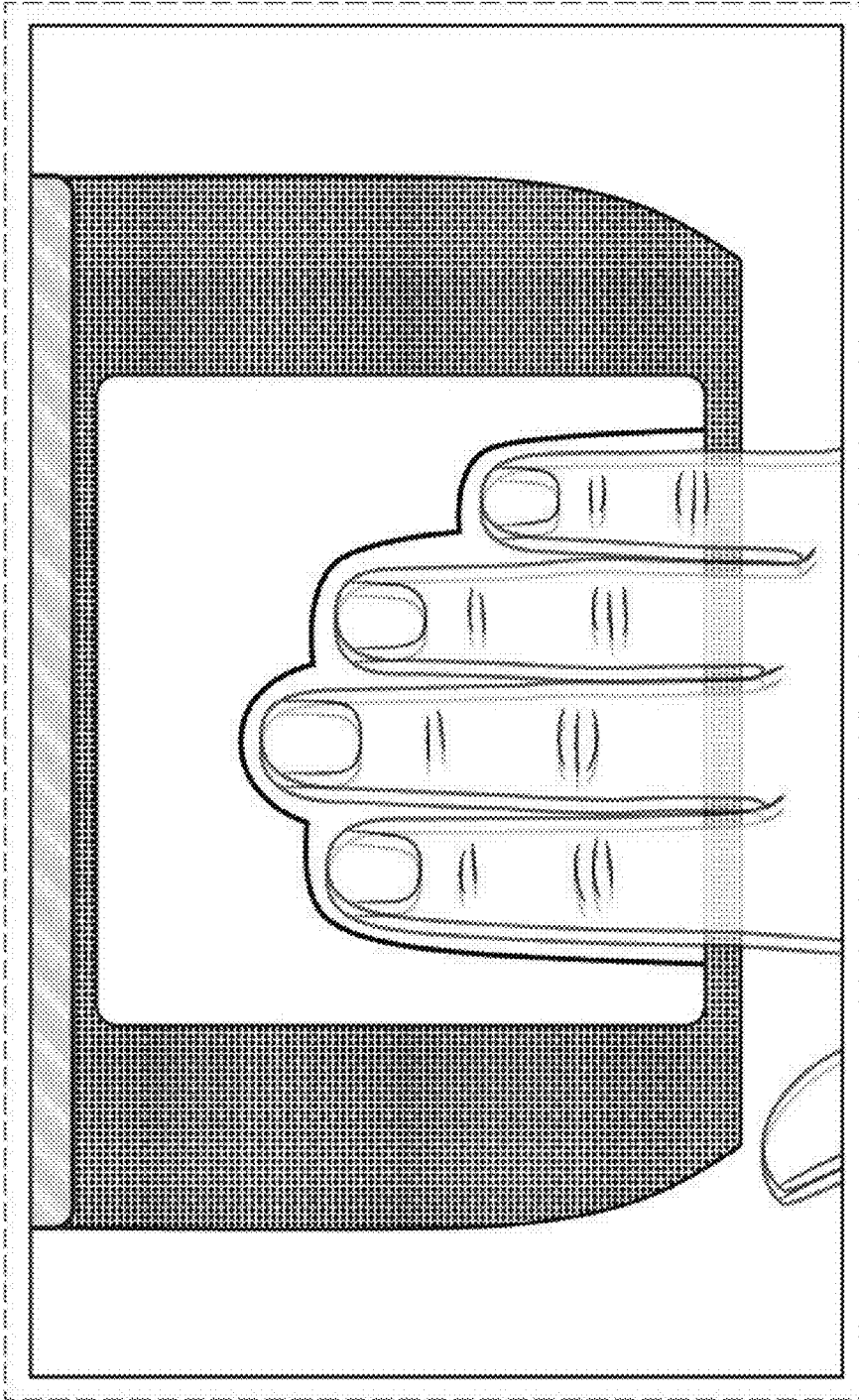

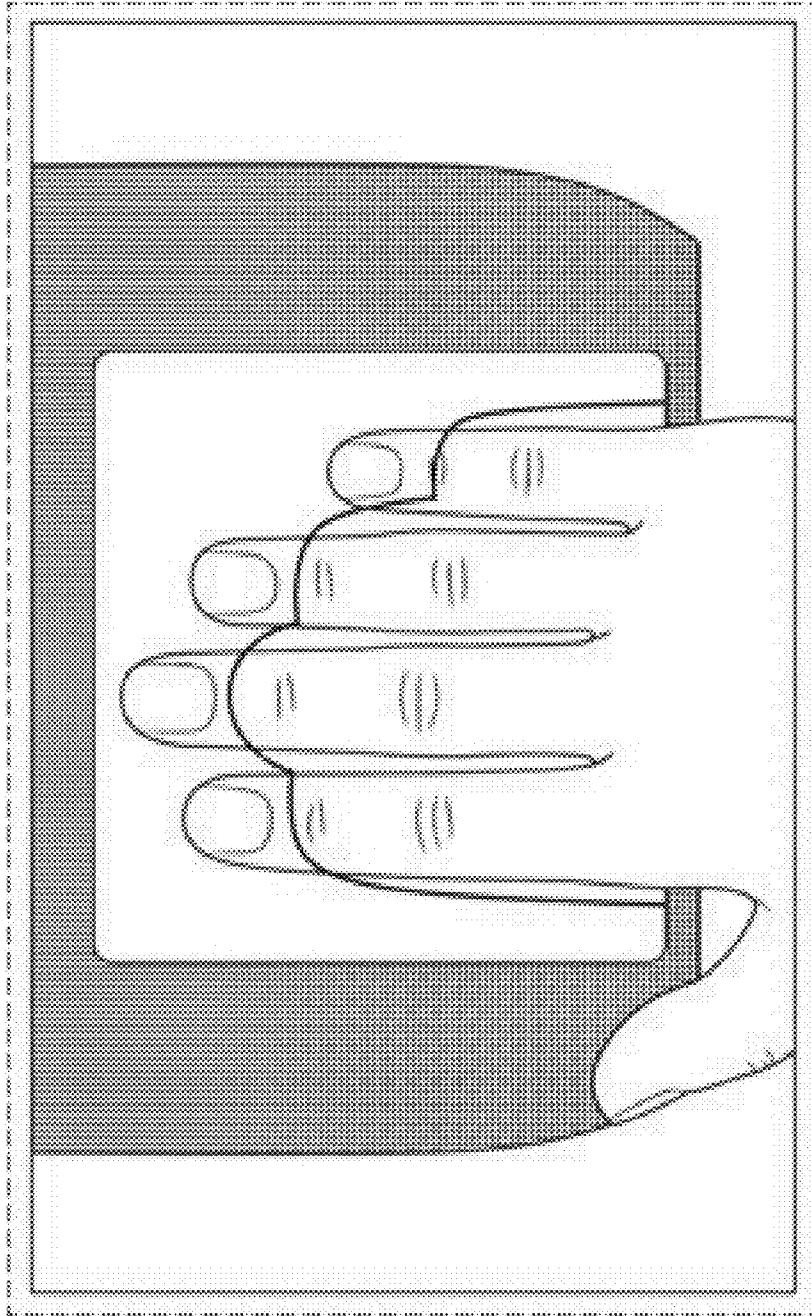

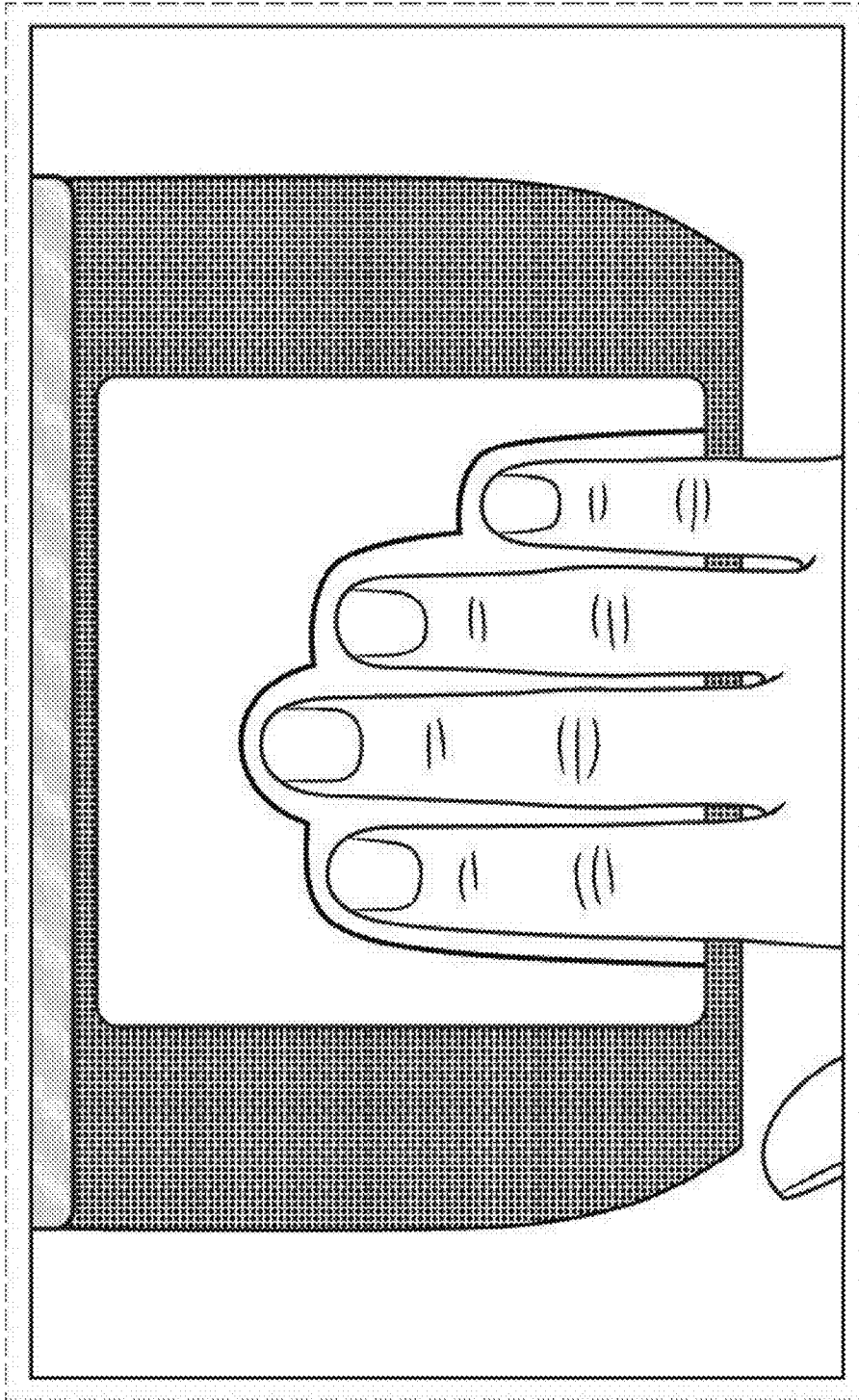

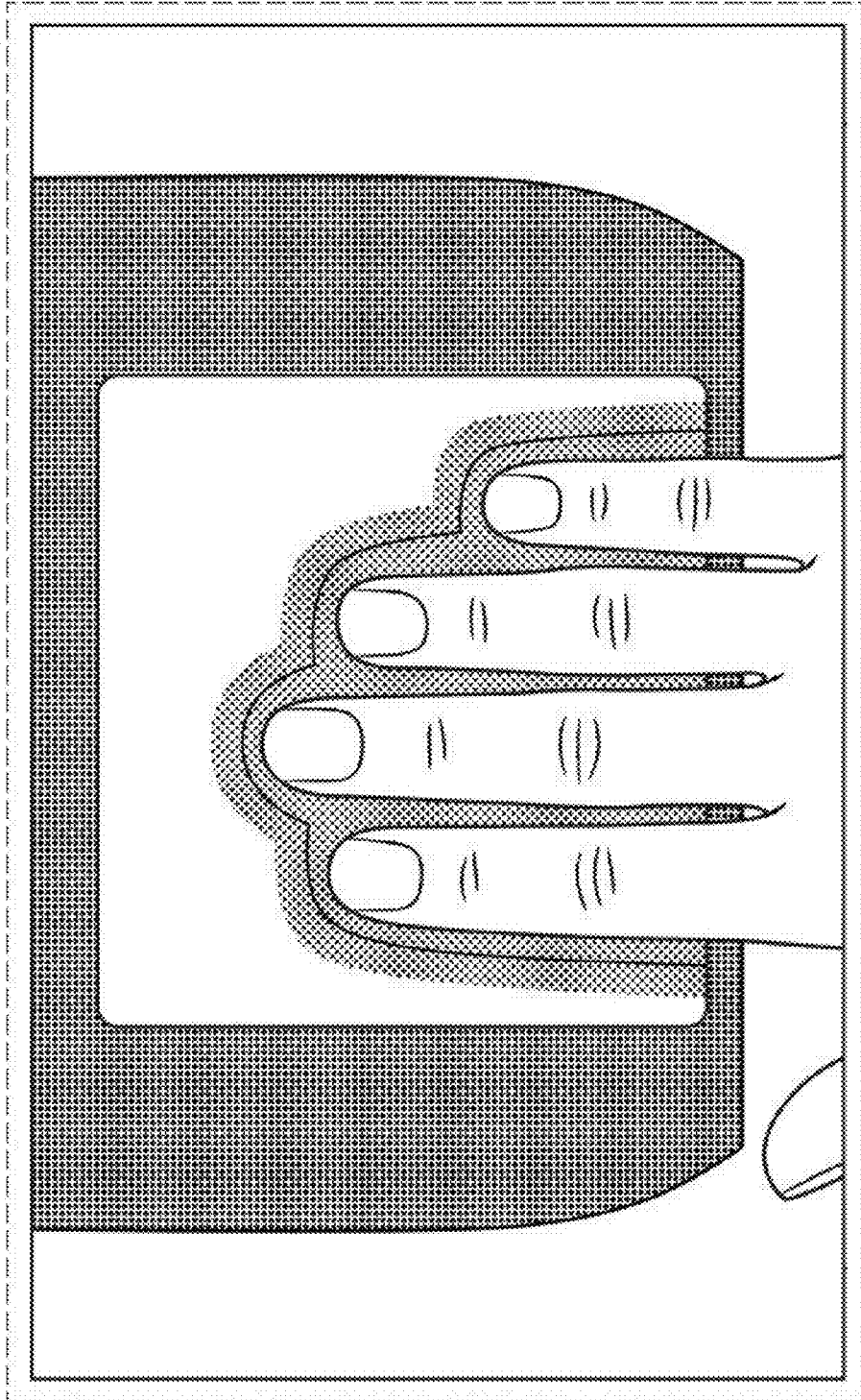

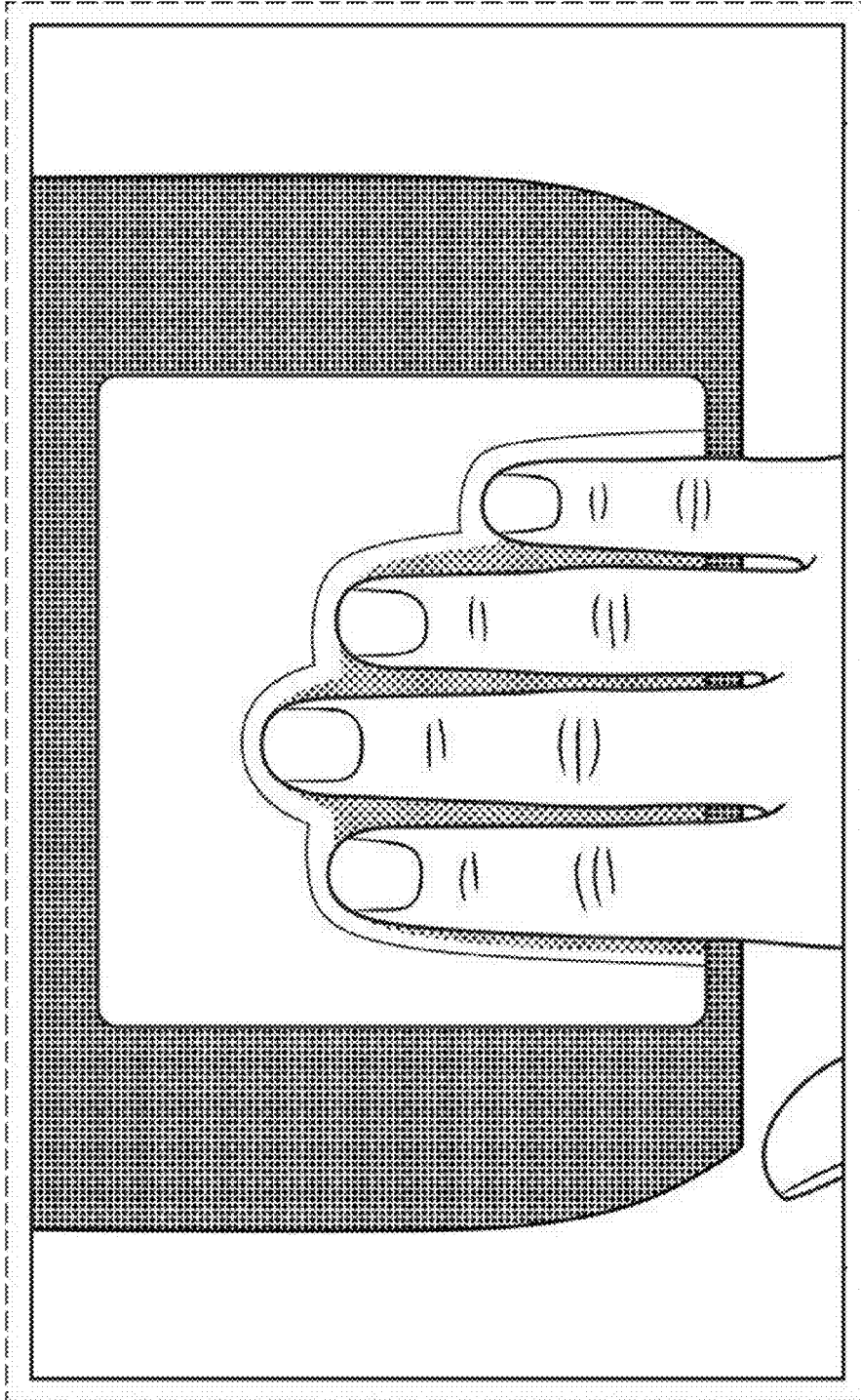

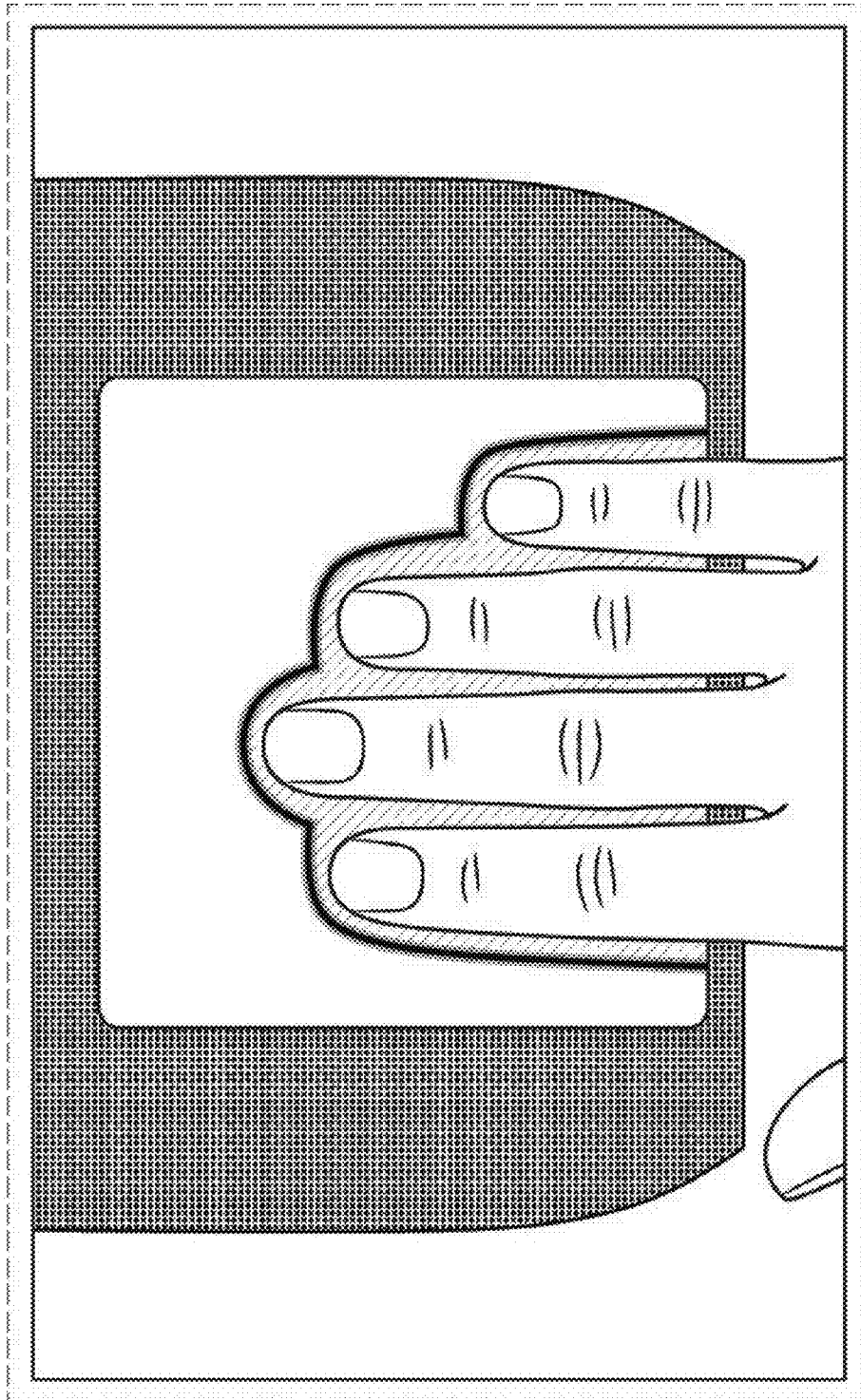
