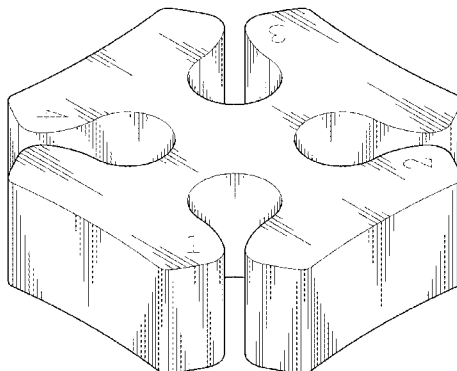
The ornamental design for a “hair styling tool,” as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a hair styling tool showing my new design;

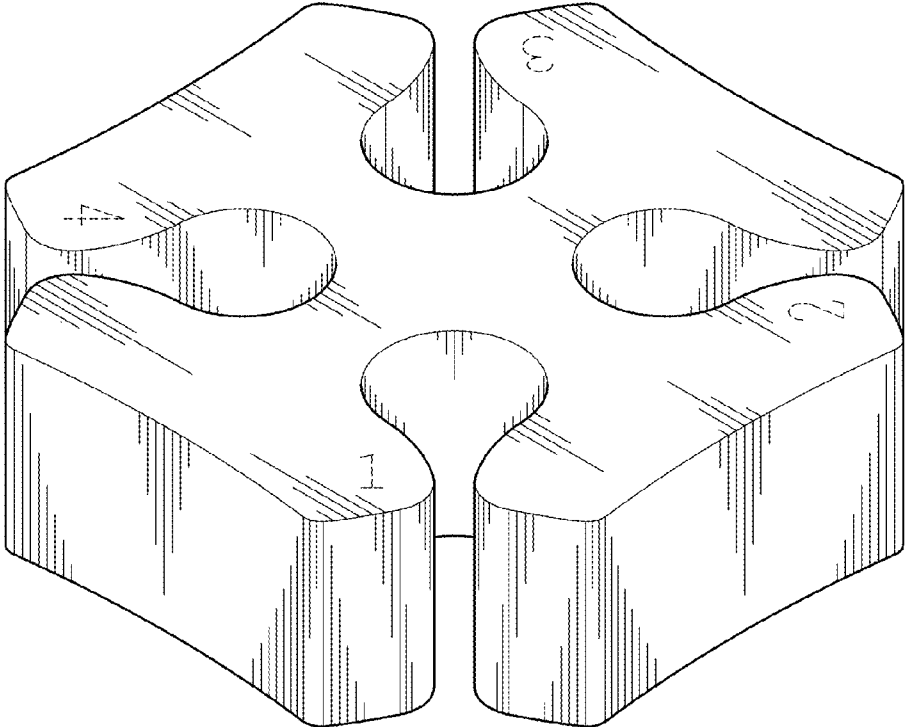

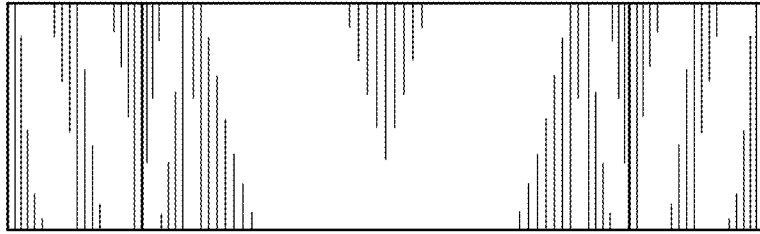

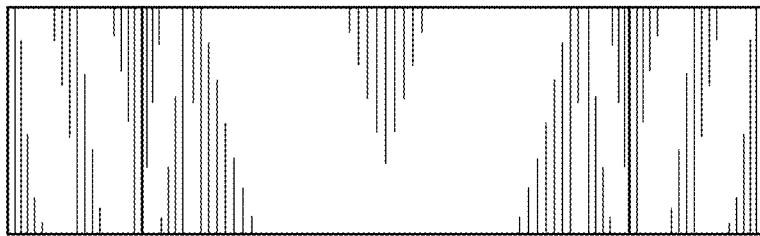

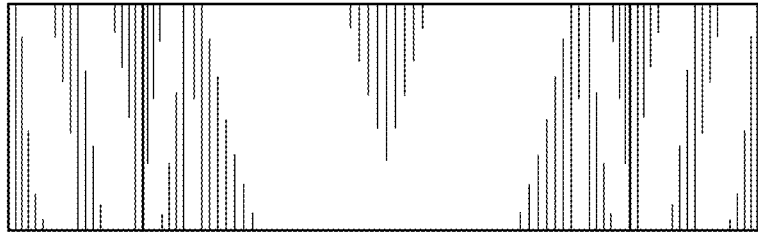

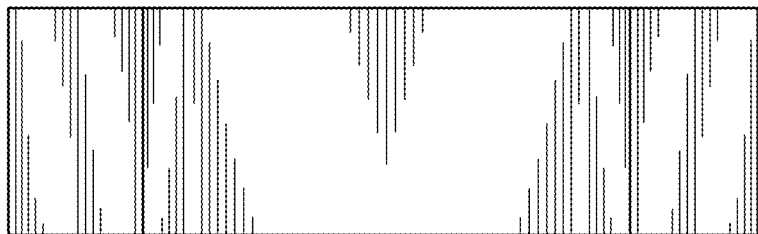

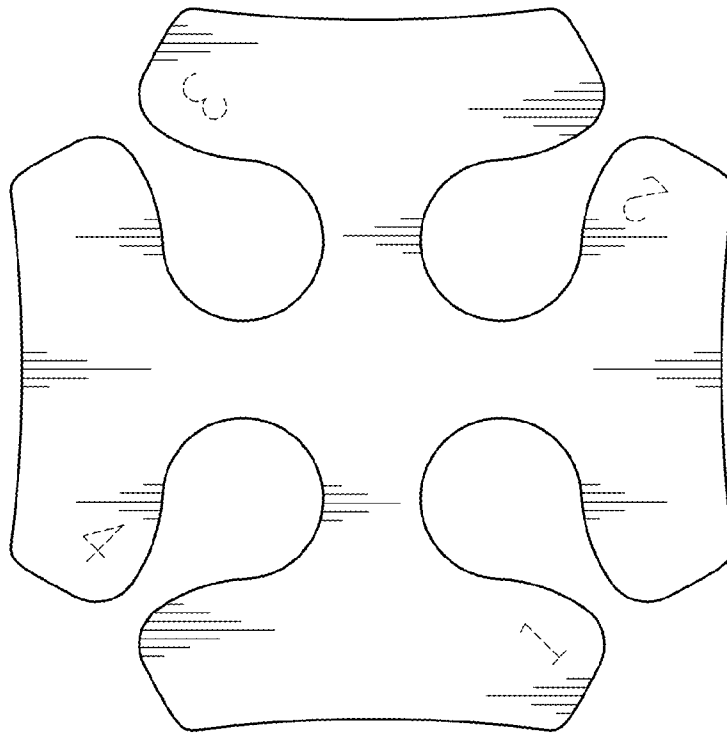

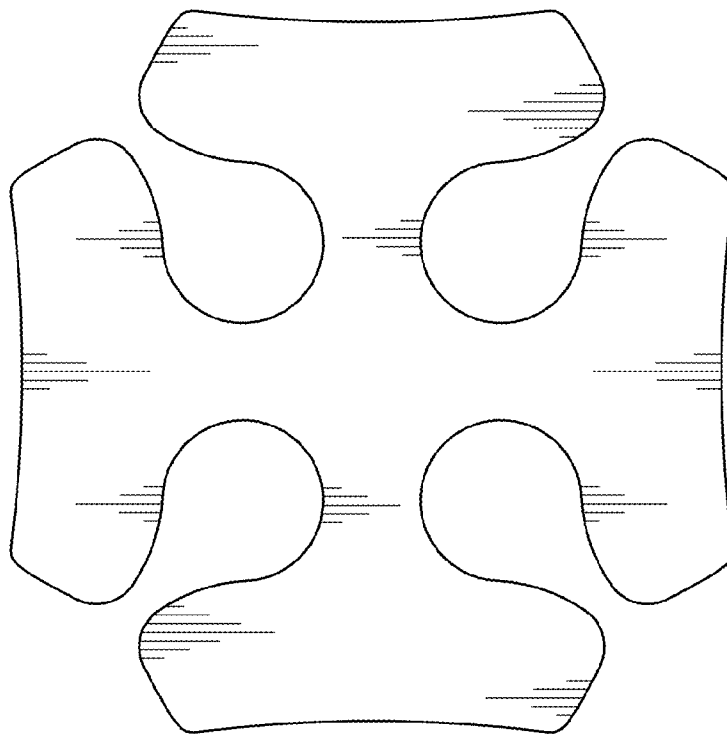
