DESCRIPTION

FIG. 1 is a top, front and right side perspective view of a personal digital assistance showing my new design; FIG. 2 is a top, rear and left side perspective view thereof; FIG. 3 is a front elevational view thereof; FIG. 4 is a rear elevational view thereof; FIG. 5 is a top plan view thereof; FIG. 6 is a bottom plan view thereof; FIG. 7 is a left side elevational view thereof; FIG. 8 is a right side elevational view thereof; and, FIG. 9 is a top, front and right side perspective view thereof in an operated state.

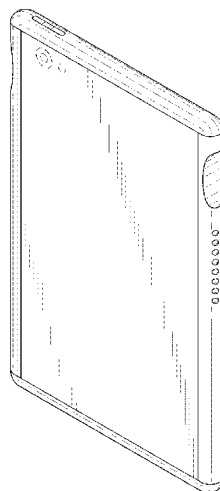
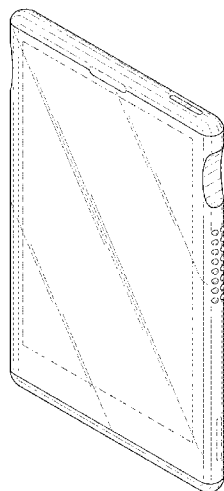

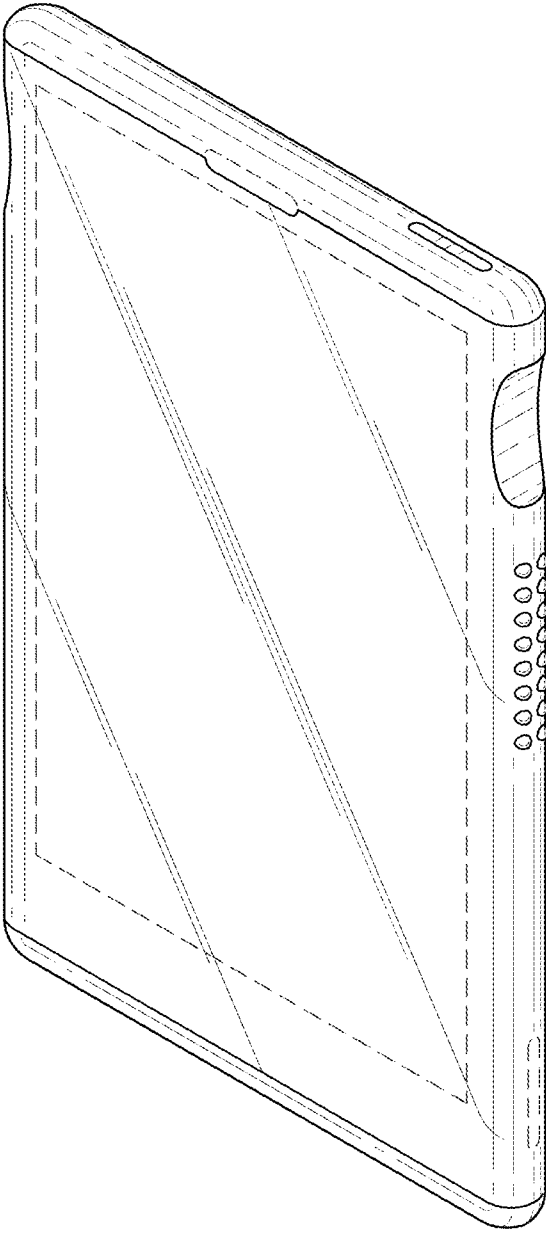

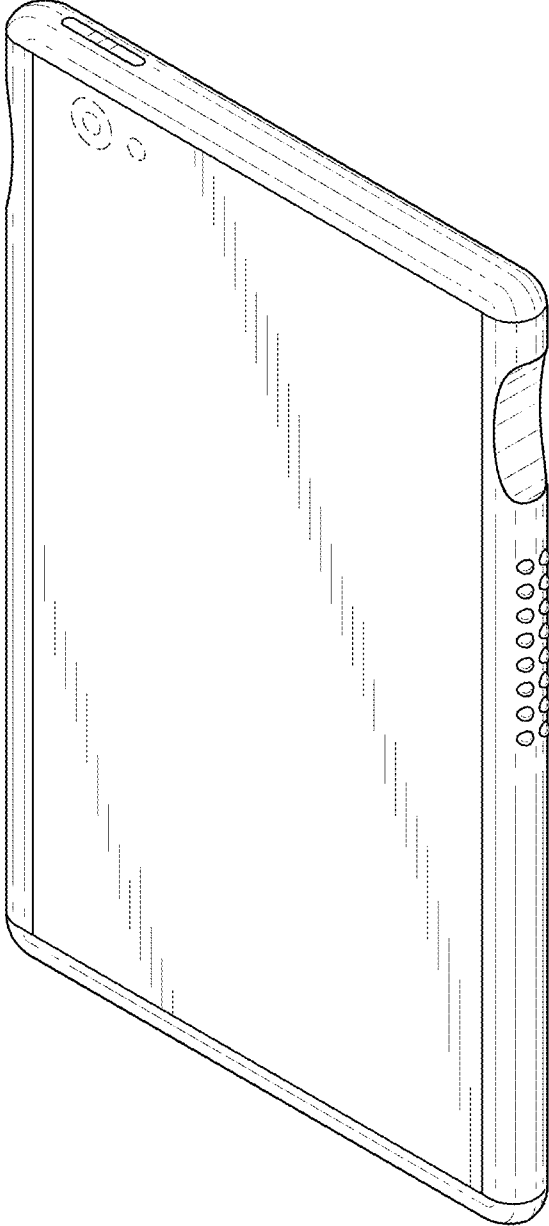

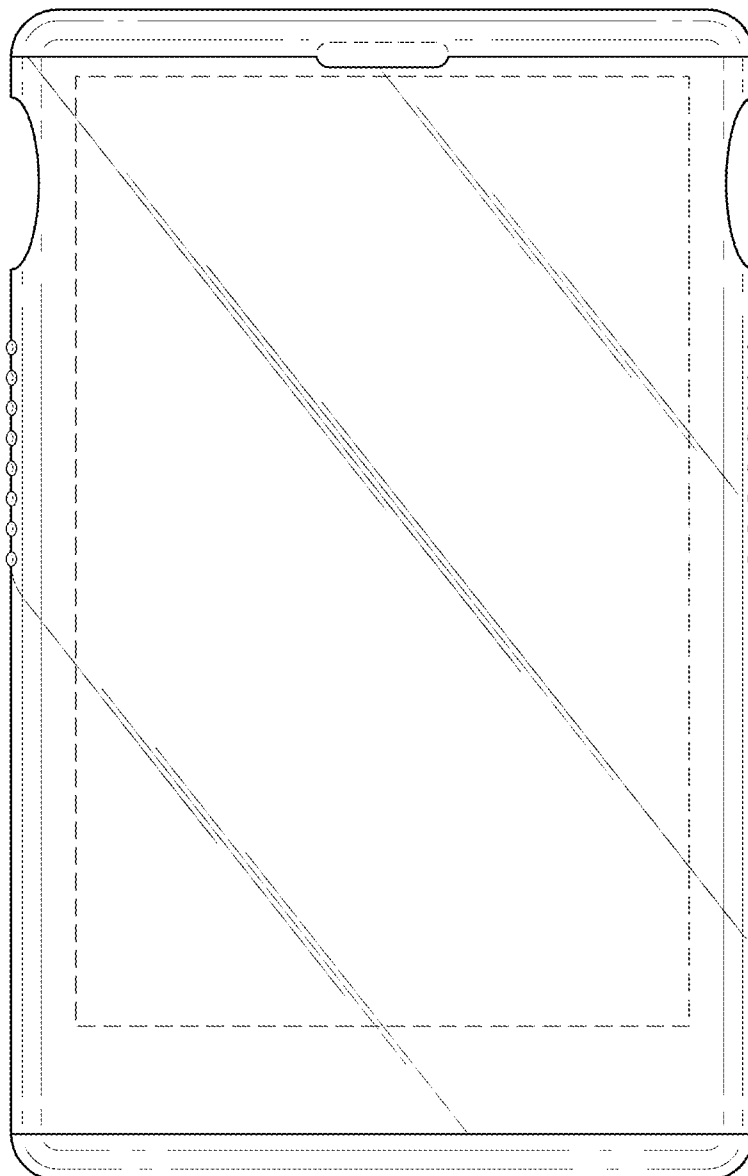

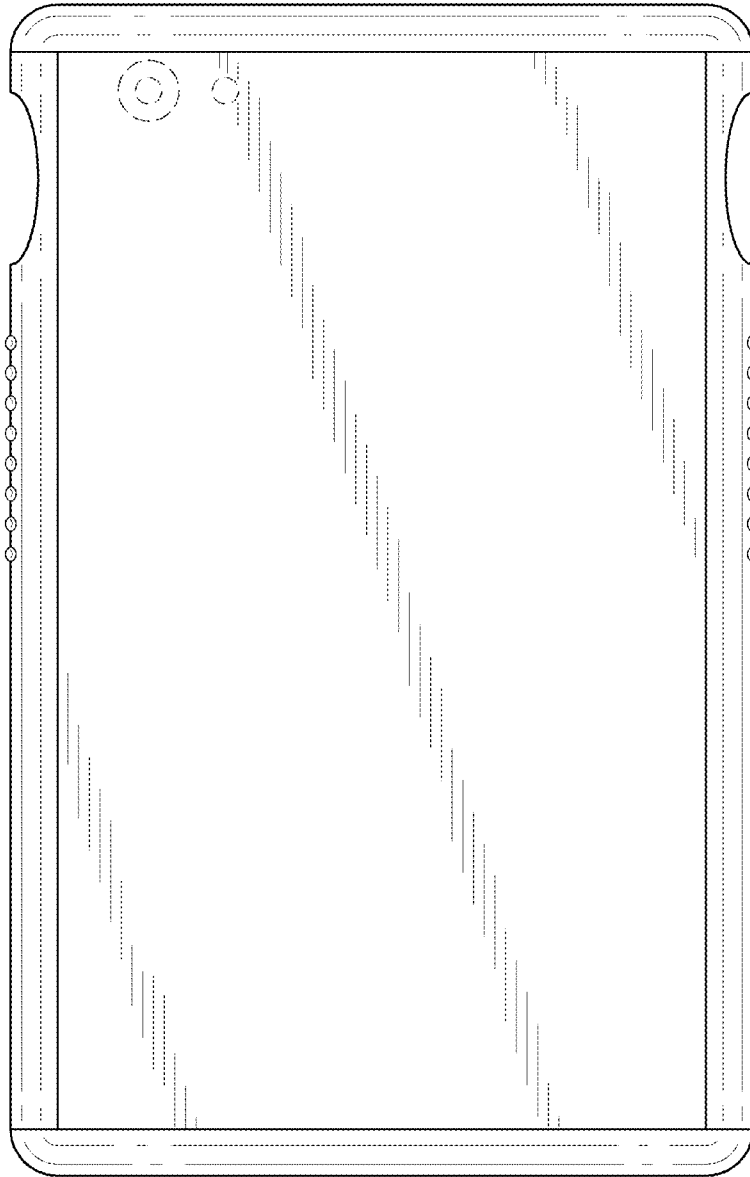

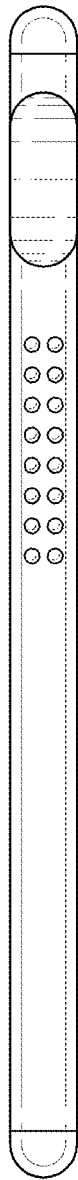

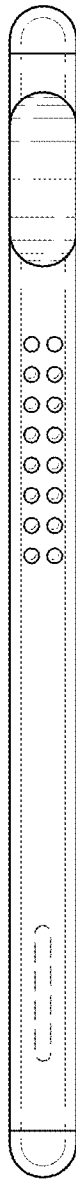
