The ornamental design for a floor lamp, as shown and described.

DESCRIPTION

1.1 is a perspective view of a floor lamp, showing my new design;

1.2 is a front view thereof;

1.3 is a rear view thereof;

1.4 is a left view thereof;

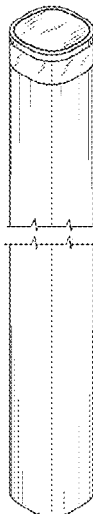
1.5 is a right view thereof;

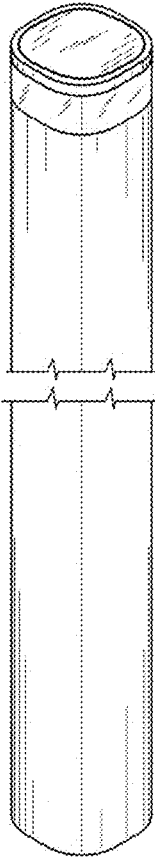

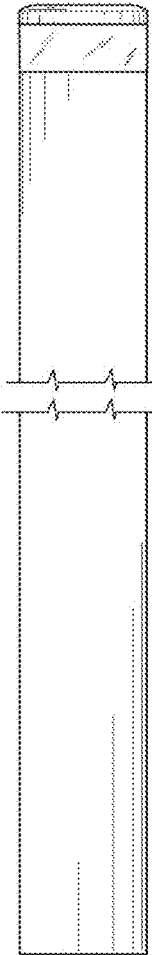

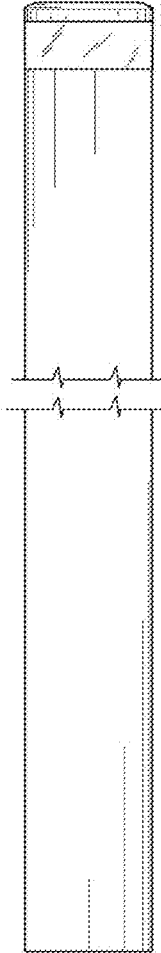

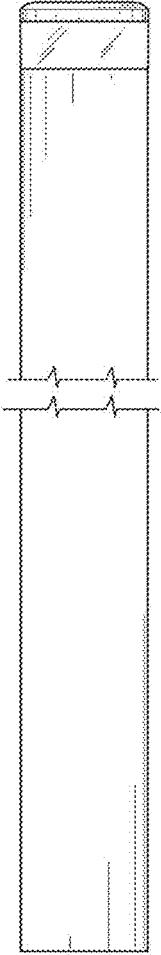

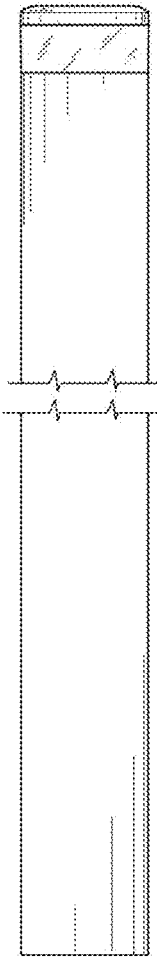

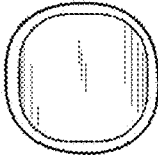
