FIG. 3 is a back view of the watch.

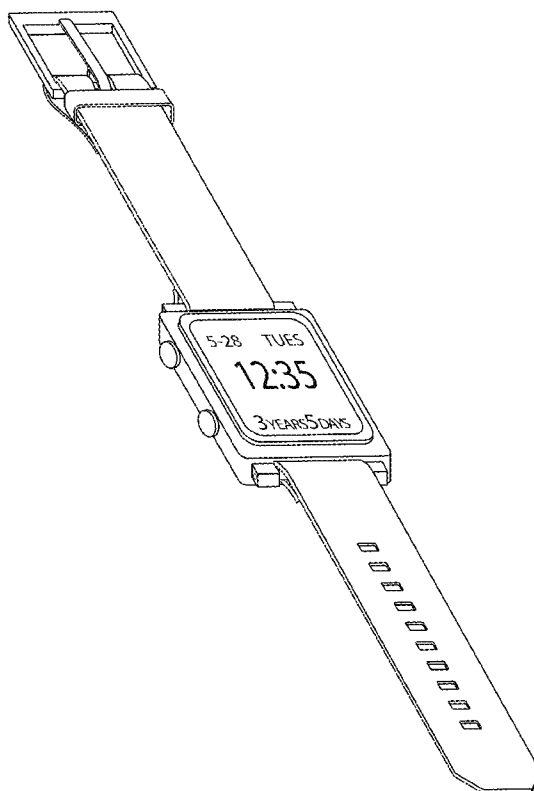
FIG. 4 is a right-side view of the watch.

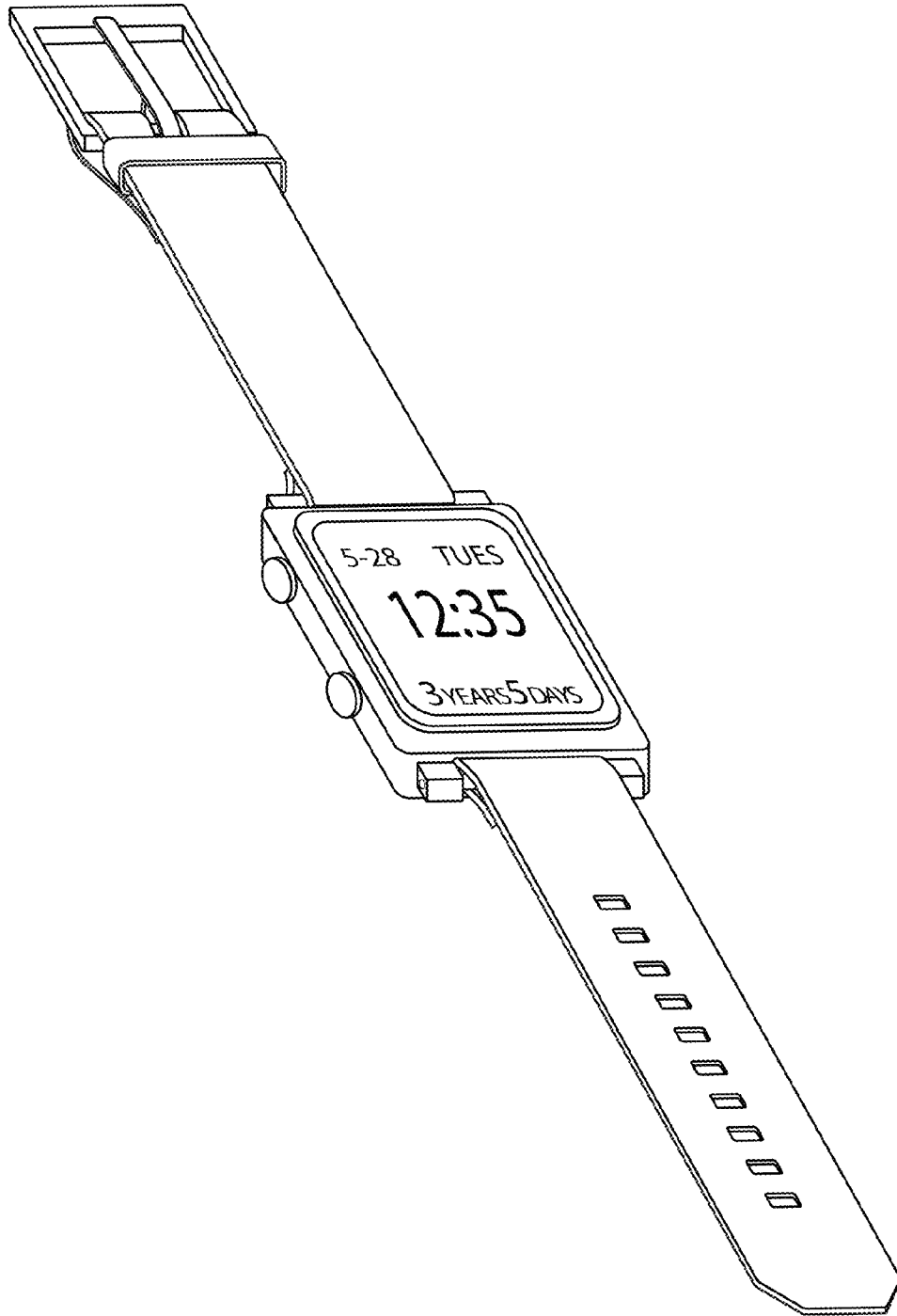

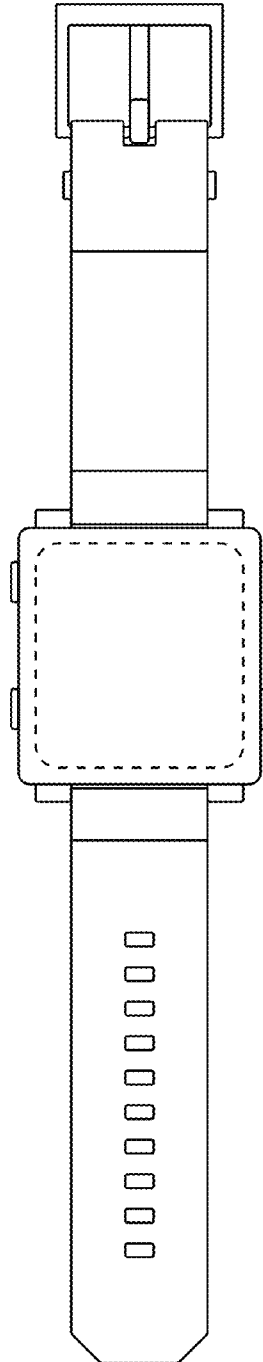

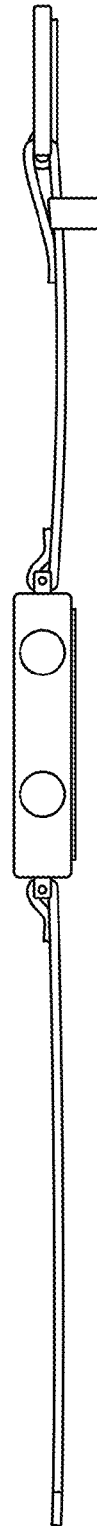

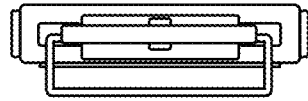

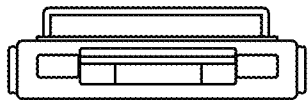
