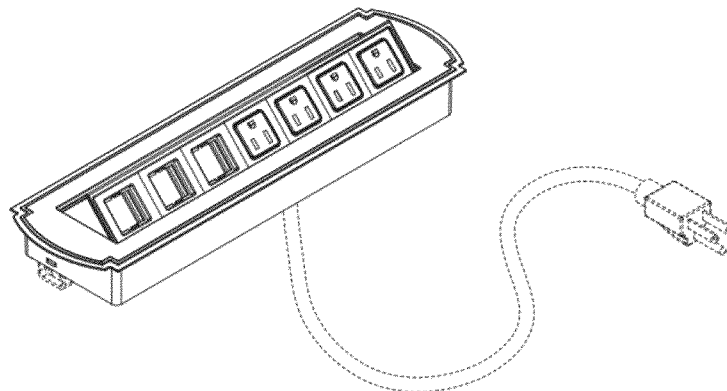
(57) **CLAIM**

I claim, the ornamental power and data center, as shown and described.

DESCRIPTION

FIG. 1 is a rearview of my power and data center in accordance with my invention;
FIG. 2 is a top plan view thereof;
FIG. 3 is a left-side elevation view thereof;
FIG. 4 is a front elevation view thereof;
FIG. 5 is a right-side view thereof;
FIG. 6 is an underside view thereof;
FIG. 7 is a perspective view thereof, showing my power and data center in open configuration; and,
FIG. 8 is a further perspective view thereof, showing my power and data center in a closed configuration.
The broken lines shown in the drawings represent portions of the power and data center that form no part of the claimed design.

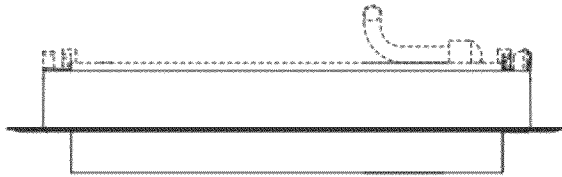

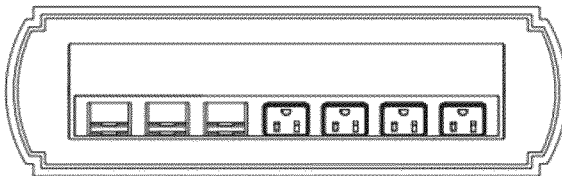

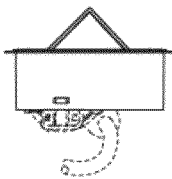

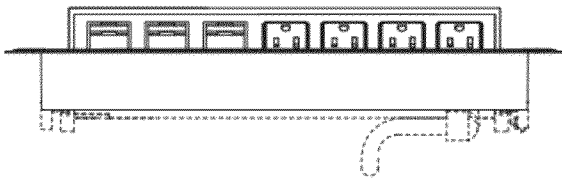

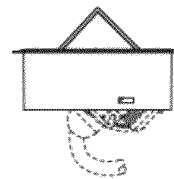

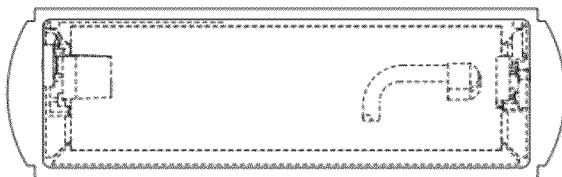

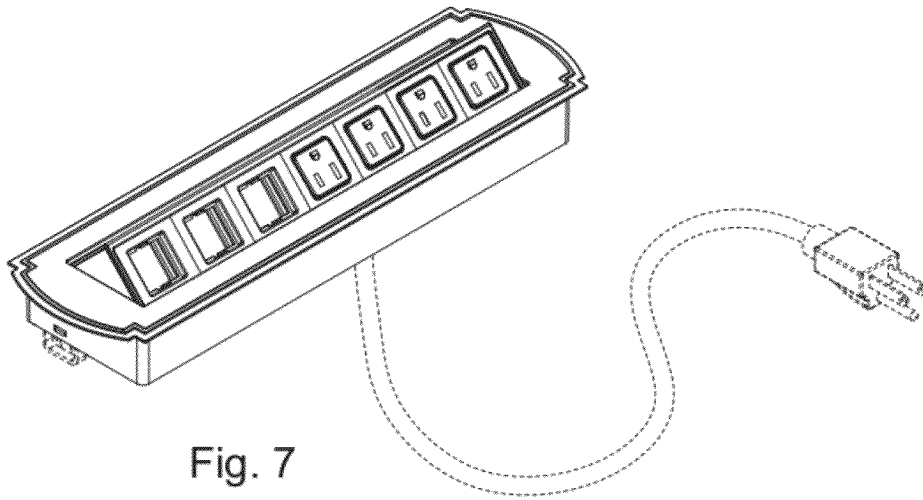

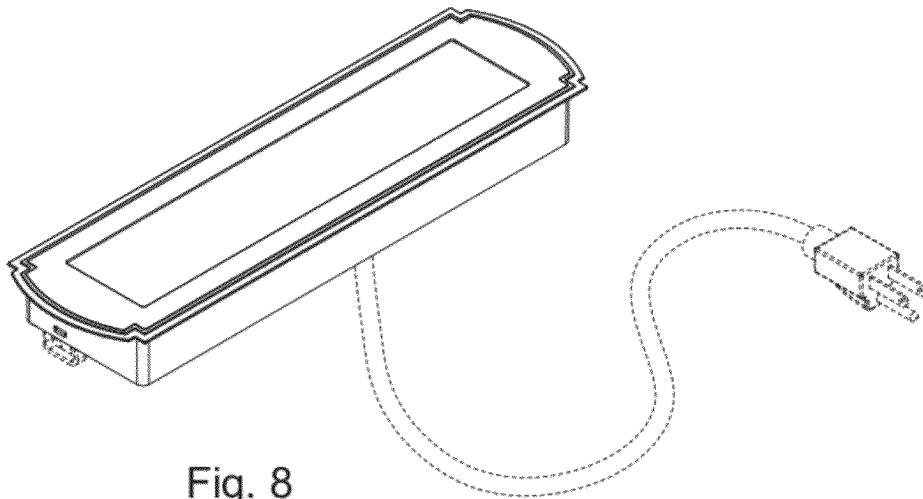
