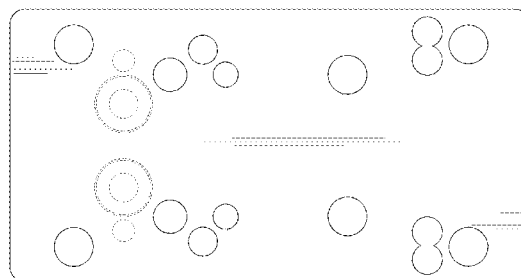
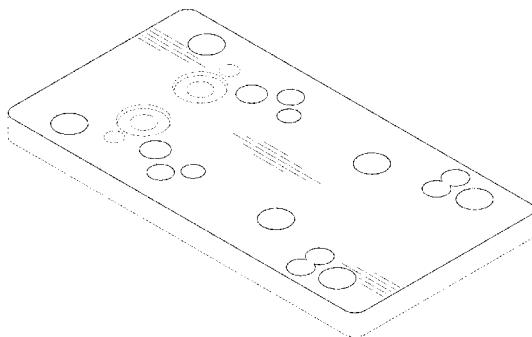
(57) **CLAIM**

The ornamental design for an plate for a firearm, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of an plate for a firearm showing our new design;  
FIG. 2 is a side view thereof;  
FIG. 3 is an opposite side view thereof;  
FIG. 4 is a front view thereof;  
FIG. 5 is a rear view thereof;  
FIG. 6 is a top view thereof; and,

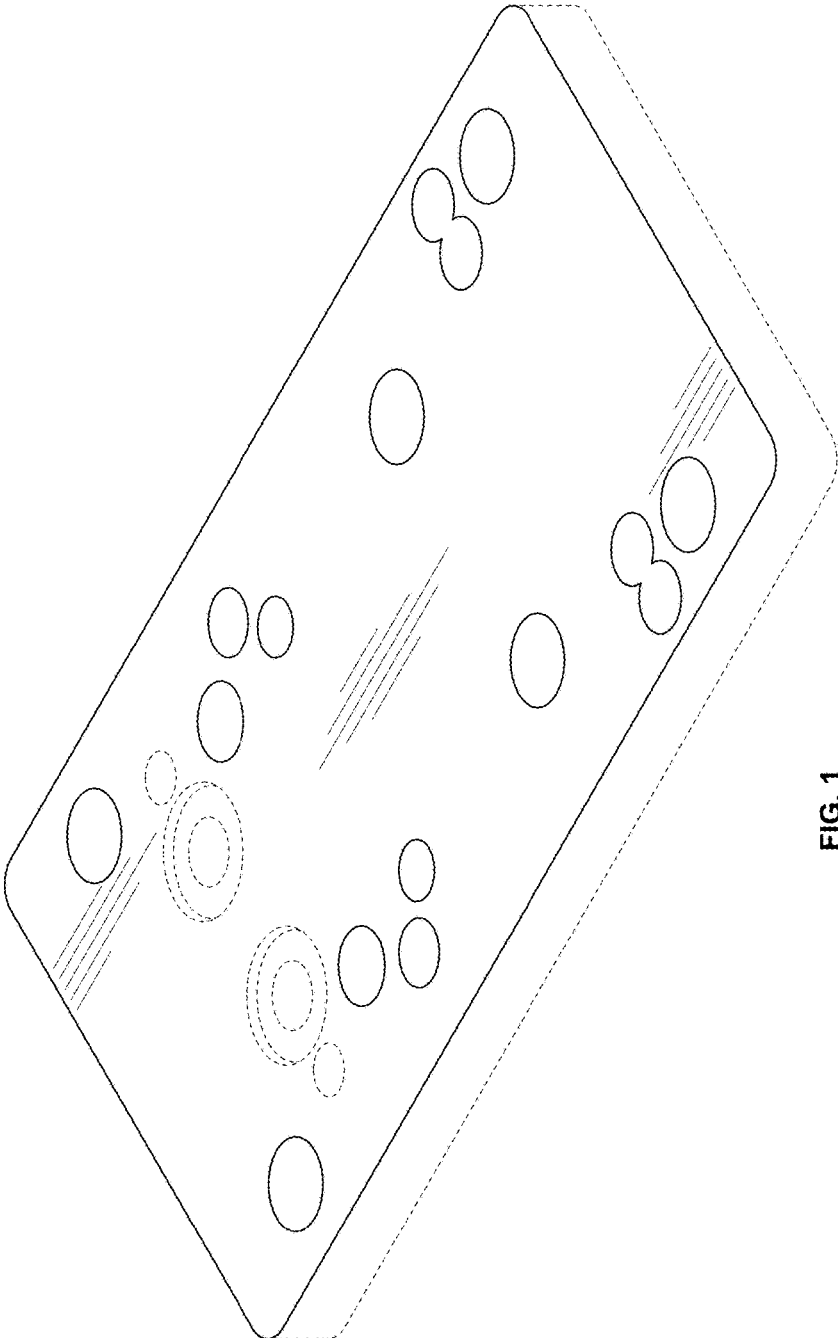

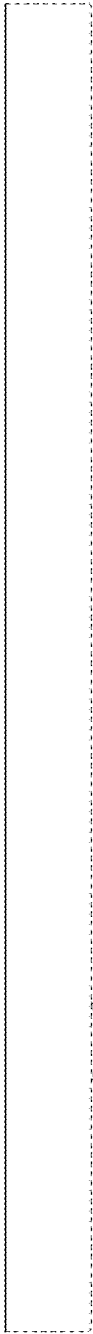

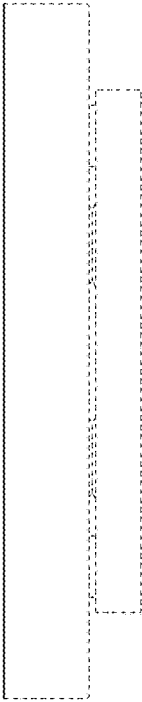

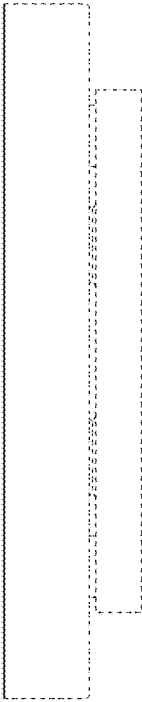

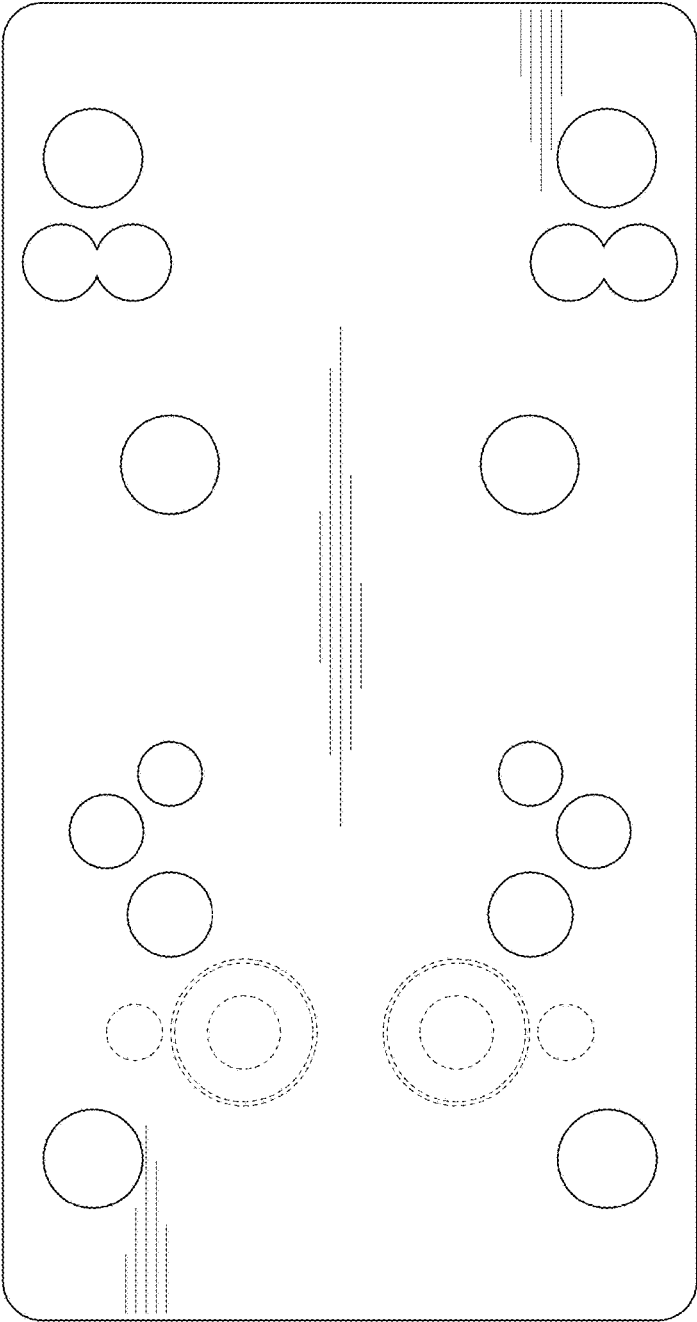

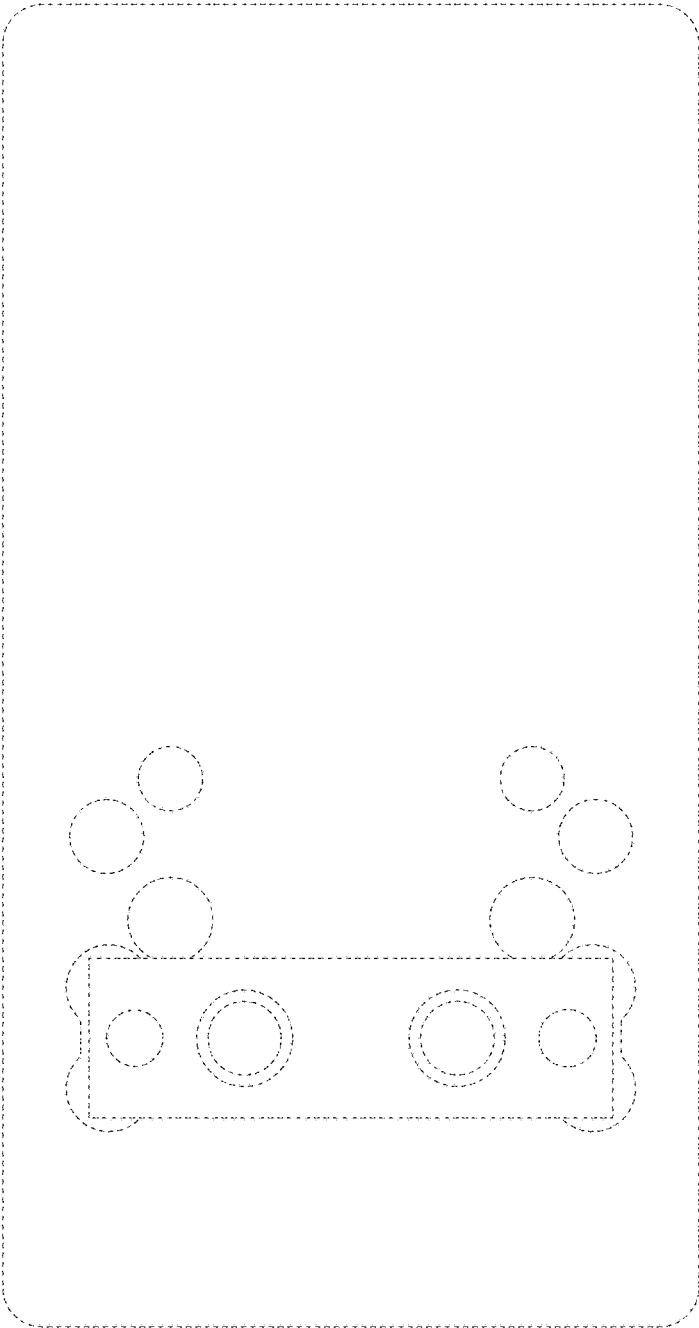
